Oyster Bay and Hempstead Town Boards will hold a Oyster Bay and Hempstead Town Boards will hold a joint public hearing in the Oyster Bay Town Annex at 65 Broadway, Hicksville; on Dec 27, starting at 9:30 AM, upon proposal to increase and improve the Hicks-ville Water District supply system. The legal notice of the hearing appears in this issue of the Mid-Island HERALD.

It proposes additional storage and pumps on Kuhl Ave, purchase of property at Bethpage Rd to replace wells 1, 2 and 4; lime treatment plant at Plant 8; gas chlorina-tors at Plants 7 and 8 and at wells 6 and 10; several installations of transmission mains; construction of a new Administration Building at Dean St. and Brewster Pl. The engineer's estimated total cost of the project is one million dollars.




