CURRENT COMMENT

Why Not Tear Down Houses?

THIS OBSCURE WEEKLY takes violent exception to the remarks by William H. McCaffrey of Plainville, speaking before the Northwest Civic Assoc of Hicksville, Tuesday night. He shared the platform with Edwin Fehrenbach, Republican candidate for the State Assembly to succeed John J. Burns.

Mr. McCaffrey was very obviously aiming for headlines when he made what he described as a "dramatic announcement". We might have been a little confused to find him, a candidate for the Assembly, sounding like he was running for the office of supervisor or a councilman. He had plenty of advice for the Town Board and his "dramatic" demand was that the Town immediately stop home building to keep school taxes from rising any higher.

As a former Plainview Board of Education trustee, he knows or should know what factors contribute to develop the school tax rate. The rate is determined by the people of the individual school district by what they vote to tax themselves for. Influencing an individual rate are such factors as assessable real estate in a given district.

It would be illegal for the Town Board to refuse a building permit on a parcel of land where the application meets the legal requirements of the Building Code as to floor space, structural details, set-back, etc. Refusal to issue a building permit would have the Town Board in Court in a matter of minutes and the Courts would toss the whole crazy scheme out the window.

As for the "obscure weekly", Mr McCaffrey was most unpleasant -- and a little silly for a candidate who seeks newspaper space to promote his candidacy. He said the zone changes are put over on the public by placing an innocuous public notice in an obscure weekly". We have published notices of zone change hearings in the past and hope to do so in the future. In addition, Mr McCaffrey is apparently unaware of the fact that the town requires the service of special notice by mail upon all adjacent property owners.

Other suggestions by Mr McCaffrey for keeping down school tax rates: limit the size of families, in effect; halt home building for ten years. The only solution he did not advocate was to tear down the existing houses and drive away the homeowners with their families of small children.

How long does it take to grow a tree? New homeowners know more about that than most people. They are either buying a tiny tree and looking forward hopefully to the day when it will be sufficiently tall to shade and adorn their bare property, or, if they are in a hurry, they are buying a large one and paying a huge sum for the years of care the nurseryman has given it.

How long does it take Mother Nature to assemble a woodland, with shrubs and ferns and wild flowers in their seasons, growing under feathery pines, lacy hemlocks, and giant oaks reaching to heaven? For how many years do the leaves have to turn to a blaze of red, orange, and gold in the soft, blue haze of October, and then drop softly to the earth, to build up the "forest floor" that supports the treasures of the woodland; to grow great mats of trailing arbutus, and bearberry, or heather?

How much time would it take to attract the bird population that fills the woods with joyous sounds and flashing color; the woodthrush that sings a vesper hymn at twilight, the chickadee who bids you "drink your tea," and the bright blue jay that chases a bit of flame that is the oriole? If it could be done, it would take more than one life-

time to bring together all the lovely things that make any woods a benediction to the spirit of man.

And how long does it take a bulldozer to destroy all this beauty? One day. In a few hours all the ferns, the bayberry, the Indian pipe and pink ladyslippers, along with the beautiful, big trees which are the homes of birds and small animals, become a muddy mass of withering vegetation and are destroyed forever.

Recently active years ago this area was full of little woods and shrubby meadows where youngsters could explore the wonders of nature and roam in happy freedom. Now there are only a few left. Soon there may be none. Every boy and girl should have the experience of building a fire in the open and cooking a bit of food over it as his remote ancestors did; of hearing the wind play a symphony through the trees on a golden autumn afternoon, as he shuffles through piled-up banks of dried leaves; of standing, among the gray trunks with their bare branches as the snow falls silently about him; and of sitting beside a campfire as the glory of the sunset fades into twilight. There is something about the magic of a fire and the contact with Mother Earth that satisfies some deep, primitive hunger in every human being.

While we are petitioning for playgrounds with swings and slides and baseball diamonds, let us remember that the children need a woods, too.

Taxes are payable by cash, certified check or Post Office Money Order. Uncertified checks will be subject to collection only.

When sending for bills please state the Section, Block and Lot numbers in accordance with the Nassau County Land and Tax Map, and also give the School District location.

AN EDITORIAL Needed: A Community Centre

Perhaps there shall come a time, when, as a prerequisite to being able to develop new communities, builders, will have to provide communal recreation centers. Town planning has become an important factor in terms of community needs, it is an added attraction to potential purchasers of homes in a buyers market.

No Antidote for Little Theatre Bug

In the past decade science has discovered many anti-toxins for battling the most vicious and contagious diseases that have plagued mankind for countless ages but no one has ever found an antibody able to counteract being bitten by the little theatre bug. This is the "malady" Birchwoodite John Havens is "suffering" from.

John Frederick Havens, born, as he put it, "inauspiciously" in Jersey City, spent his early years moving from place to place. His father, a building contractor, transported his family to those areas in which he was currently working so that John's childhood and schooling were split up among such divergent towns as Mineola, N. Y., Bethlehem, Pa., Fairfield and New Haven, Conn. as well as many others. He credits Mineola and Bethlehem 50-50 for his high school diploma.

Played 'Mae West'

Shortly after entering Columbia University "The bug bit" and John found himself enmeshed, but willingly, in the college little theatre group. Through Columbia College and Columbia Law School he was very prominently active in all the Variety Shows. One of these well-known revues featured John, with suitable padding, doing an impersonation of the famous Mae West.

For some time after graduation neighbor Havens devoted himself towards getting established in his chosen profession but he was somewhat disrupted by a little fracas called World War II. John and his wife Michalena, (her folks were expecting a boy) were living in Mineola, Mrs. Havens was working

as a clerk-steno at Mitchell Field and Mr. Havens was employed by Sperry. In 1945, while living in the Westbury section of Long Island, he came back to little theatre working with a group associated with the Hicksville Adult Education Program.

He is now a lawyer working for the Queens County Savings Bank as a specialist on mortgage loans. All his spare time is devoted almost exclusively to expressing his passion for the theatre in many ways.

Currently John is the president of "CAST" (Community And Suburban Theatre) an organization formed in 1953, whose membership consists of 40 little theatre groups active on Long Island. He is also editor and chief cook and bottle washer for the organization's newspaper, "Callboard". "CAST" acts as a clearing house for information as well as a source of help with production problems for its members. They hold monthly meetings and a yearly conference at which many kindred problems are discussed.

As if this didn't keep his busy enough, John has recently become vice-president of the Nassau-Suffolk Civic Theatre an organization formed with the purpose of activating a local repertory movement. Andrew Billings, an equally rabid little theatre devotee, is the organizer and president.

But, all must always have something, like many others, that is somehow dearer and holds a extra special significance. This, to John Havens, is the exclusive group of little theatre aficionados called "Plays and Players", Inc.

Composed of only 20 members they have brought out excellent productions of such well-known plays as "The Moon is Blue", 1954; "The Curtain Rises"; "King of Hearts"; with John in the supporting lead; and "See How They Run" in which he played the Rev. Toop. The last two were produced in 1957. "Plays and Players" is a non-profit enterprise with the plays run for the benefit of many worthwhile organizations including PTA, Kiwanis and veterans.

John is a good-looking man with a sort of country boy expression of unassuming shyness in his smile. This personality characteristic made him a "natural" for the lead in PTA's production of "The Moon is Blue" at the Hampton Star Theatre in West Hampton, L. I. Stir 1 tablespoon melted shortening into batter.
Dip teaspoon into hot shortening then dip up a spoonful of batter.
Quickly immerse spoon into hot shortening and drop off the batter.
Turn doughnuts when edges are browned. Drain well over pot then place on tray covered with absorbent paper.
