

Last Chance To Register This Saturday

HICKSVILLE—With only 208 registered and qualified to vote next month for school trustees and upon the district budget, friends of school candidates today prepared to put on a big push for registrations this Saturday. The final day for registration is Saturday, Apr. 22, at Nicholai St. School, between 4 and 9 p. m.

The initial registration was considered disappointingly low by supporters of the three candidates since it represents a little more than a 10th of the number of voters believed eligible.

All persons who wish to vote upon the budget on May 2 and for school trustees on May 3 at the

high school must be registered. All previous registrations have expired, the Board of Registration and Canvass warns, since a new electoral year has begun. Those registering now will be eligible to vote upon all special propositions which may be offered during the next 12 months. Those who registered to vote on the school bus question or more recent library proposition must also register again.

There are three candidates for two vacancies on the school board here: Robert Corcoran, Harry Ermenwein and George McIntosh, and no other candidates appear likely unless a write-in vote is

attempted. Voting for trustees takes place between 4 and 9 p. m. on Wednesday, May 2, in the high school auditorium.

Election of a library trustee for a five-year term takes place on Tuesday night, May 2, at the annual school meeting. Joseph Heim is an unopposed candidate for re-election.

The school and library budgets for 1950-51 will be voted upon at the high school on May 2 also.

This year is expected to see the first local use of voting machines in a school election.

Qualifications for voters are again published in this issue of the Herald on page 11.

'Economy Budget' And \$10,000 Item Highlight Hearing

HICKSVILLE—Inclusion of \$10,000 in the proposed school district budget for "contingencies," although labeled as "other expense of maintenance," was warmly debated at the preliminary hearing upon the budget at the high school, Wednesday night. The meeting, attended by about 150 persons, also saw the presentation of a private "economy budget" by Trustee Lawrence Eisenhauer which was outspokenly protested by Trustee Lawrence C. McCaffrey.

The \$10,000-item which was the topic of considerable discussion at the annual meeting last year but survived a vote then, was challenged last Wednesday night by Herman A. Werneburg who called it "10,000 nothing" and suggested that its appearance in this year's budget be reconsidered.

Need for Cushion

Eisenhauer defended its inclusion for use in the event of emergency "as a cushion". G. F. Wennagel, former board member, commented that a contingency fund appeared a necessity although no such specific division appeared in the budget.

Henry C. Brengel, board president who conducted the hearing, answered that "we can't use that word any more". He forestalled a call for a vote on this item by a show of hands, sought by Eisenhauer, saying the voters could take it out at the May 2 annual meeting if they so desired.

Dr. Charles Masek, board member who resigned in February, defended the item also and said he felt it should be \$20,000 "so you can really run a school system as it should be run".


Square Dancing This Saturday

IN OUR OPINION:

Home Owners Complain--No Dirt

PETITIONS ARE TODAY circulating in all the new home developments of Hicksville, requesting the Oyster Bay Town Board to prosecute several developers as violators of the Town Topsoil Ordinance. The petitioners believe there are violations of the ordinance.



The petition states "the property surrounding our homes has been ruthlessly stripped of its natural vegetative cover and supply of organic material, rendering most all of our property unproductive for lawns and gardens, thus lowering land values."

"Bare earth has been left for the most part or covered so lightly as to allow the rains and wind to carry it off."

The petitioners call attention to the section of the town ordinance which states "there shall be left upon the surface of the land from which top soil is removed not less than six inches of topsoil."

As new home owners of the township, they are addressing their plea to the town fathers.

The petitions are being circulated by the Hicksville Civic and Community Assoc. through its Topsoil Committee headed by William L. Geyer of 21 Grove St.

Meanwhile, residents of the Frank Homes section have begun an effort—independent of the petitions—to see if they cannot bring group legal action against their developer. A committee of four of the residents have been inciting their neighborhood to win support for their plan.

And on the local scene we note with pleasure that Governor Dewey has signed a bill which will authorize the Town of Oyster Bay to clean up vacant lots if the owners refuse to do so. The Town can move in, on complaint, remove rubbish and debris, and put the cost on the offender's tax bill.

The passage of this legislation is especially appropriate with the approach of clean-up week the end of this month.

And also on the local scene we note a warning from the County Health Dept. in its latest monthly periodical: "The Tick season is near". It will be recalled there was considerable agitation about tick control in this area last year, with little success. In the interval, a good part of the suspected area has been dug up and become the site of new homes.

However, the warning is timely. If an infected tick has been attached to the body as long as six hours, it is possible that Rocky Mountain spotted fever will develop. The common carrier in the eastern part of the United States is the dog tick—Dermacentor variabilis, according to the health department.

In removing tick, bare hands should not be used. A small piece of cloth, cotton or paper held between the fingers will afford adequate protection. Since dogs are carriers of ticks, they should be inspected frequently and all ticks removed from them with a small pair of pinners.

Those persons seriously interested in having a community softball league conducted for them this year might appeal for aid to the parties responsible for the operation of the Board of Education's proposed Summer Playground program.

It could be possible that a small part of the \$1,544.00 budget appropriation would be channeled to such a venture if enough interest and proof were presented early that such a program would be used by a number of residents.

A prime advantage of a softball loop operating under the Playground director's wing would be that he could, without argument, limit participants to residents of the area. Thus importations from other villages would be blocked and the league could retain a strictly local flavor.

Another advantage of such a league would be in that it would have the authority to command and banish those players who did not comport themselves properly.

In noting that the School Board budget goes into such detail as to even list the expected revenue from overdue library books, it brought to mind a question asked us many times by sports followers.

Their question has been "just where does the revenue from ticket sales for high school football and basketball games go?"

For their information, we have found out that after the umpiring expenses takes its big bite the remaining monies are placed in a "general fund."

That fund takes care of cleaning and preserving team uniforms and, when needed, provides for an extra athletic trip for a practice or extra game not provided for in the athletic transportation appropriation setup in the budget.

In other words, the revenue from athletic contests goes right back into continuing the athletic program and not to some other department of the school system as so many were inclined to believe.

Two practice softball games are on tap for the high school field, Sunday afternoon. Botto Bros. will attempt to work out some of the kinks against Oyster Bay and the Empire Diner Club will meet Huntington.

Bottos is pretty well set in the matter of its personnel but the Empire Club is still a question mark. Empire is expected to play in the Hempstead league which will operate Sunday mornings.

Empire and Botto staged a practice game last Sunday and it was evident in the two-run victory of the latter that the pitchers — Bill Bordinuk, Joe Smith and Jim Barone — were away ahead of the batters.

The Nationals also held their first practice on the high school grounds Sunday as they prepared to retain their berth in Jones Beach competition. Pitchers George Cheslock and Danny Wysloveski again headed the candidates with Peter Zeher heading the list of promising newcomers.

Yet to be heard from are the Hicksville Farmers. But many of the players now working out with other teams — such as Charlie Van Wickler, Jim Barone, Mel Voehries and Jerry McGunnigle — are expected to be in the fold once the season gets under way.

Bottos, Farmers and Nationals are all after a Jones Beach berth this season. Landing a place will be difficult this season. The demand will be greater than ever and berths fewer.

This season the league will have only twelve teams instead of the usual 16. Another change will see only one nine inning game being played a night instead of the past policy of holding two seven inning encounters.

It is our belief that the new policy will prove a lesser attraction to the many persons who look forward to watching the games at the Seashore stadium.

With the pitcher moved farther from homeplate, hurling will be less effective and don't be surprised when the games become sloppier in the last two innings.

Softball is a seven inning game!

Mrs. Janet Magill made the comment, "you really have to pad a budget to come out even at the end of the year."

Walter Eichler, another ex-board member, said a little later in the evening that he did not want to be petty regarding \$300 piano repair items, etc. but asked if "perhaps somewhere you might feel that you have taken us a little beyond the earning ability of the community." He wanted to know if the board felt that every item was fully justified and emphasized "teachers salaries and bus service."

Mrs. Edna Kuhne Sutton, board member, in reply to Eichler said that long hours had gone into preparing the budget and that even a final Sunday morning had been devoted to a complete re-examination of each item but that "honestly we can't find a place to cut down."

When Mrs. Sutton concluded, Eisenhauer arose to present his plan which he said would shave \$90,000 off the budget and cut the anticipated tax rate by \$6. He was apparently not joined in this view by the other board members: Brengel, McCaffrey and Mrs. Sutton.

He began by confessing that the anticipated \$27.70 per \$1000 rate had amazed him and he felt it is out of line. He emphasized that he gave his personal opinion and not that of the School Board.

He enumerated: \$3,000 for business manager—will save money but district could get by without such a person for a couple of more years; \$8,000 of teachers' salaries—budget is providing not only a \$200 mandatory increase in teacher salaries, but in some cases increments as high as \$352, or a total of \$8,000 "above the state mandate"; \$5,000 for summer school—a good thing, but district got along without it before, even if district will get some money back from state; \$2500 for lighting in Nicholas School—agreed that lighting is not what it might be, but it's too much money to spend on a building that is not going to be kept "too long"; \$45,000 for transportation of pupils—such buses cost 27c per \$100 of the tax rate, and \$2700 on Albrecht note—could finance in yearly installments as 10-year bond issue, instead of paying entire note in this budget.

His suggestions for cutting the budget were:
Eliminate business manager \$3,000
Eliminate summer school 5,000
Curtailed teacher salaries 8,000

"It could be made a \$21.70 per \$1000 tax rate if the taxpayers wanted it," Eisenhauer concluded. Werneburg replied that he felt the budget is adequate. He protested that his previous effort to take out the \$10,000 "contingency" had been branded as picayune.

McCaffrey Replies
McCaffrey went down the line to defend each item assailed by Eisenhauer. The business manager, he felt, will save the district money. At present there are no adequate inventory records, for example. On teachers' salaries he pointed out that the budget is only putting the teachers up one-third toward the scale previously adopted by the district and filed with the state. He cited the provisions of the budget as only "being fair and square" with the faculty.

The summer school, McCaffrey continued, will be a definite aid to the community and that money will come back to the district as a result. The improved lighting in Nicholas School he said is essential "even if we only use the building for six or seven years more." The present lighting, he declared is below 50 per cent of the state's requirements of 20 foot candles. A recent test showed that lighting in Nicholas registers only 8 foot candles.

He had nothing to say on the bus question but opposed a 10-yr. bond issue on the Albrecht property note because the addition of pupils—such buses cost 27c per \$100 of the tax rate, and \$2700 on Albrecht note—could finance in yearly installments as 10-year bond issue, instead of paying entire note in this budget.

Earlier in the evening it was brought out, as the result of a question from the audience, that the School Superintendent and each principal will receive \$300 salary increases next year. Salaries next year for each will be: E. H. LeBarron, superintendent, \$8800; Mabel Farley, high school
