

# Levitt Rejects 'Established Community'

William J. Levitt, president of Levitt and Sons, Inc., of Manhasset, made it clear today that he has no intention of providing any schools for the new homes he is building in Hicksville.

He also made it plain that he denies the existence of Hicksville where his homes are rising, despite the fact that about 2,300 of these dwellings are going up in the Hicksville School District,

Hicksville Water District, Hicksville Fire District and Street Lighting District. Levitt made his views on the situation known in a letter to Lawrence A. Roman as president

of the Hicksville Civic and Community Assoc. (see text of letter below). There is even a strong hint that his project may absorb Hicksville and that he will not stop after the 2,800-home project

in Oyster Bay Township is completed. He sees an ultimate population of 70,000 for "Levittown." With 11,000 homes now in the Levitt section of Island Trees (continued on page 16)

# New Vote On School Bus June 13

HICKSVILLE—Voters of the district will have a new opportunity to decide upon the question of transporting students to local schools on Tuesday night, June 13. Acting upon a petition filed with the Board of Wednesday night, the School Trustees have set the new date for a special meeting when the vote will be taken. An appropriation of \$45,000 for transportation of children was voted out of the budget at the annual meeting last week, 106 to 51.

Legal advertising for the special meeting will start next week and new registration days for persons not previously enrolled will be fixed by the board, it was learned.

Final Discussion May 25  
Meanwhile, the Civic and Community Assoc. announced that it will sponsor a round-table discussion on school transportation at its next general meeting, Thursday night, May 25. Speakers will include Lawrence O. Eisenbauer, Lawrence C. McCaffrey and James Condon. Eisenbauer and McCaffrey are members of the school board and Condon is chairman of a special Emergency Committee formed this week by voters interested in having bus service re-established. A fourth person will be invited.

The civic meeting will be open to the general public and is expected to bring forth a full discussion of the question. It will take place in the firehouse and

## \$20 Million Assessment Will Cut Tax

HICKSVILLE—The anticipated tax rate for the school district, quoted at \$2.77 per \$100, at the annual meeting last week by a member of the Board of Education, was challenged this week. Harry Woods of 199 Lee Ave. told the Herald, after checking with the County Assessment Dept. at Mineola, that the school district valuation as of May 1 is unofficially at \$20,157,420, which is a gain of more than \$3 million over the current \$18,700,000. He calculates the school tax for 1950-51 at about \$2.18 per \$100 including the transportation item of \$46,000. The rate is officially set by the School Board each year in August by resolution.

Elimination of the bus appropriation was the major event of the annual school meeting, May 2, at the high school. The sum of \$45,000 was estimated by the School Board as the amount needed to transport children from the kindergarten thru the sixth grade who live a half mile or more from Nicholas St., East St. and St. Ignace Schools.

Book Standing Vote  
Eisenbauer had clarified the bulk

of the argument against the bus appropriation for the coming term, claiming he knew of no accident where a child was injured on the way to school and adding "I personally do not approve of busses." Louis Uhlstein of Murray Rd. made the motion to take out the fund which was duly seconded. A vote of standees showed 109 in favor and 51 opposed to dropping the service.

# Columbia Urges 20-Rm School Near Lee Ave

HICKSVILLE—The School Board should take immediate steps to acquire a 10-acre site near the Frank and Halstone Homes at Lee Ave and Farm Lane for a 20-room elementary school and plan to add about 12 classrooms to East St. School. These are the recommendations of Columbia University in its interim report to the school district.

## School Board Ready To Hire Architects

HICKSVILLE—The Board of Education has selected Karpf and Johnson of 268 E 148th St., New York, as architects to work on the proposed addition to East St. grade school. It was learned this week. Adolph H. Knappe and A. Henry Johnson, members of the American Institute of Architects, have designed the new Curtis Place and Massapequa Schools.

A portion of the interim report was made public by the Board of Education today, supplementing a preliminary report which was published in the Herald in January. The report reaffirms early suggestions and proposals "pointing out the need for acquiring at an early date a number of school sites to care for the impending growth in school population certain to result from heavy residential construction completed and in process."

Further substantial construction is expected and the Institute of Field Studies, Teachers College, Columbia, after several months of study now predicts a local population of 22,000 to 24,000 in 1951. It is estimated at 11,000 to 12,000 today.

Levitt is expected to build 2,300 units and Columbia finds at least 700 more dwellings will go up during the year.

"Even at a slower rate, a population of 30,000 may be anticipated before 1955." And 30,000 population would mean 8,500 public school pupils for Hicksville in 1960.

## Old Bethpage Fights Sand Process

OYSTER BAY—Twenty property owners of Old Bethpage, all members of the civic association, protested the application of Broad Hollow Estates, Inc., to erect and operate and maintain a sand and gravel processing plant in their community. They appeared at the Zoning Appeals Board hearing on the application here, Thursday night.

The petition suggests that sand and gravel would be removed from 410 acres of adjoining land in Suffolk County. The Board reserved decision on the application.

Various people from Old Bethpage took turns in voicing objections.

A. Goldstein claimed that the processing plant would be a menace to children's safety (citing hazards created by previous industrial operations within the community). He also stated that property values would be depressed. W. Gasser, who would be the nearest resident, produced pictures of his home to illustrate the high character of local homes. Gasser stated that he had carefully chosen his home because of

the prevailing high zoning of Old Bethpage.

C. W. Kopf claimed that it was an imposition on the community to let an operator process sand and not even originating in Nassau County. Disputing the appellant's claim that the processing plant had to be located in Nassau, Kopf said it seemed very strange that a

suitable site could not be found for it in the adjacent 410 acres in Suffolk County. He also took sharp issue with counsel's claim that there would be no noise or inconvenience to the community, saying that the truck traffic alone would be a great source of annoyance as well as a sure way to (continued on page 2)

## Levitt's Letter to Civic Association

LEVITT AND SONS, INC.  
MANHASSET, N. Y.

May 8, 1950

Dear Mr. Roman:

I am acknowledging your letter of May 2. Your premises and facts are not quite correct. We are not building anything "in an established community." We have taken a vast amount of vacant farm land and created what amounts to the largest municipality on Long Island. There is even a suggestion on foot to make a city out of Levittown. As a matter of fact, all maps now bear the name of Levittown covering an area many times the size of Hicksville. The ultimate population of Levittown will be close to 70,000 as against an 8,000 population of Hicksville when we first commenced.

The question of school facilities is a state function and far beyond the capacities of private individuals or firms. The analogy to the Trump project is illogical and poorly made. Mr. Trump merely built a few apartment houses and set aside certain basement facilities for nursery groups. There is not the remotest comparison in his problem and the problem of Levittown.

If education is to be the province of the private builder then we should not stop at the construction of buildings for such purposes. We should also purchase the supplies, engage the staff, and administer the huge undertaking that we have sponsored. I think that any sensible citizen will quickly agree that such a program would create a paternalistic system that has no place in this country.

Under the circumstances your suggestion must be rejected and I cannot continue any further correspondence on the subject.

quickly ruin local roads.

T. Duffy continued the objections with a statement that the nearby Nassau County Tubercular Sanatorium and the Bethpage State Park would surely look with disfavor upon the granting of such a petition.

During the proceedings, a letter from the Town Board was read, advising the Zoning Board of Appeals that the granting of such a variance would be tantamount to a change in zoning and therefore undesirable.

Amplifying their contention that such an industrial undertaking would reduce property values, E. Rowehl, a veteran who

had recently built his own home, next related how he was able to secure a mortgage for only one-third the value of his home because of its proximity to another local sandpit which has been illegally operated. The Old Bethpage Civic Assoc. has been fighting this latter sand pit for over a year. At present the pit has been closed by court order since February, pending final settlement.

Kopf then closed the residents' case by stating that the whole community was unalterably opposed to the granting of any variance for industrial use within Old Bethpage. Broad Hollow Estates had applied for a "temporary" variance of ten years.

## Plainview to Vote On Union Free Plan

PLAINVIEW — Election of school district officials has been delayed until Friday night, May 26, when a decision will be made to establish a Union Free School District. About 125 persons attended the annual meeting last week on Tuesday when the budget was approved. Thirty-four voted on the budget.

This community is now a Common School District with three trustees. The present incumbent, William Schwartz, would normally serve until July 1 along with the district clerk and district treasurer. If a Union Free School District is created, then the position of clerk and treasurer will be filled by appointment of the board. The membership of the Board would increase to five or more members.

Depending upon enrollment during the coming months, it was indicated that the school may go on part time basis in the fall.

**SHOULD WE INCORPORATE?**

**Six Residents Debate 'Local' Govt**

HICKSVILLE — Six residents divided into two opposing teams debated the question of incorporation for this community at the Civic Association meeting, Apr. 27. "A distant government" and "lack of planning to meet local needs and problems" were strong points of those in favor of incorporation. Those opposed argued that "higher taxes" and "duplication of services" would result.

It was one of the best attended meetings of the Association for the year with more than 150 present. The participants in the debate were members of the Adult Education Program public speaking class directed by Miss Viola Wood. Stephen Smatlik, civic's program chairman, was moderator.

In summary, the arguments were:

**MRS. JANET SCHUMACHER** (for) — It is now time for a change, to get back to Democratic ideals. Township government was adequate years ago, but is no longer satisfactory for today's needs. Today a distant government tells us what to do.

**Mrs. ELEANOR SCHNEIDER** (against) — This question affects all property owners in Hicksville and is a matter for all to consider carefully. No Nassau village has incorporated since 1938 while South Floral Park and Sea Cliff are considering the possibility of becoming unincorporated again. We have local representation in government and our officials are easily approached. Incorporated government is antiquated and old-fashioned. It would require a bond issue of at least \$500,000 to set up a village with its municipal building, highway and road machinery, etc.

**MRS. LAWRENCE WEBER** (for) — Correct planning would give insurance for tomorrow. We could plan for our own community as to zoning and parking. We could correct overcrowding and protect local residential areas. We now have a distant government while tremendous growth here requires concentrated planning. Local problems which could be checked by adequate local government include inadequate parking, topsoil removal by unscrupulous developers, sandpits and RR grade crossings. Incorporation would promise a better future for the community.

**CHARLES KRUMENACHER** (against) — What caused this demand for incorporation? Are we prepared to pay more taxes? Low priced homes cannot carry the burden. More business areas must be allowed to expand in surrounding villages and thus lower taxes.

**STANLEY MEDE** (for) — On

**Incorporation Starts with Petition**

The procedure for incorporating was outlined at the Civic meeting last month by Stanley Mrsus, one of the participants in the debate. A petition must be signed by either (a) 51 per cent of the residents, or (b) 51 per cent of the owners of assessed valuation in the area. This petition is presented to the Town Board and after a public hearing of the board, a referendum vote may be held.

While incorporation for Hicksville has been one of the basic platforms of the Civic group since it was organized about three years ago, the Association has attempted to examine the question impartially. At the February meeting, town government was discussed by Supervisor Walter Fassbender of Huntington and in March Village government was the subject of Mayor Joseph Nohowec of Mineola.

question of costs, he had checked with 12 incorporated villages for data. Comparison of tax rates prove that many incorporated villages pay less than Hicksville, get better officials and more recognition from the state. Hicksville has a rate of \$1.80 per \$100 while taxes for the same services in incorporated villages show: Westbury \$1.20, Mineola \$1.42, Garden City \$1.34, Hempstead \$1.82, Freeport \$1.52, Rockville Centre \$1.46; Lynbrook \$1.42, Massapequa Park \$1.38, Valley Stream \$1.38, Floral Park \$1.42, Stewart Manor \$1.08, Malverne \$1.65. Further, an over-worked Town Board now must work on plans for the entire town and cannot concentrate on local problems. More important than cost is the fact that most get government closer to the people.

MRS. ALICE LEHMANN (against)—Incorporation is more expensive and taxes would increase. Since many local roads are town highways and would have to be taken over by the village, the cost of snow removal would be high. Hicksville has too many sideroads. Many town meetings are held at night. Incorporation is really just a "neighborhood fight." What is needed is more centralization in the county of schools and highway systems.

During the question period which followed, the audience took an active part. It was shown that no town officials are "elected locally," but rather that they are voted upon town-wide. Town Board meetings are most always held on weekday mornings.

# American Legionnaire

Lightning with this week's column, I hope I will be able to bring to all local veterans the latest news from Washington, which may concern some of you from time to time.

For the first time since the GI Bill of Rights was enacted in 1944, unmarried widows of World War II veterans are now eligible to use a deceased husband's GI loan privilege. Approximately 76,000 unmarried widows are made eligible to obtain GI loans for home or farm buying purposes or to set themselves up in business on the same basis, on which the husband would have been eligible in the event he had lived. Nothing in the law prohibits widow remarrying after obtaining a GI loan.

An important change in the new housing bill liberalizes the GI bill to permit some veterans—who have already used their GI home loan entitlement, but who have lost or otherwise disposed of the home for "compelling reasons devoid of fault on the part of the veteran"—to obtain a second guaranteed loan, if the Veterans Administration approves.

The present VA loan guarantee coverage has been raised from 50 to 60 per cent of the total loans. This means that in many cases it will be possible for veterans to buy or build homes costing as much as \$12,500 without being required to make any cash down payment. In addition to this, the amortization period for GI loans has been increased from 25 to 30 years, bringing GI housing into range for more and more veterans.

GI INSURANCE—VA expects to clear decks of entire job by June 30. After that date, but not before, VA will begin handling inquiries from veterans who failed to receive checks. Complaints from those who have received checks—but are not satisfied with amount—should be made now—and sent to District Office designated by code number on check—DO NOT send to Washington VA office.

The American Medical Association has announced that it will—for all practical purposes—join the American Legion in opposing enactment of pending legislation to merge VA hospitals into United Medical Administration—as proposed by Hoover Commission.

# Comets, Dalers Co-Champions; Elder and DeSerre Lead Hicksville

PORT WASHINGTON — The banners of Hicksville and Farmingdale were run to the top of the flagpole when the Junior Division events were concluded at the 32nd renewal of the historic Invitation, here, Saturday, as both schools scored 24 points to tie for the championship.

Charlie Elder, with a new record in the high jump, a victory by Charlie DeSerre in the 100-yard dash and the triumph of the relay team consisting of Ed Longo, Jim Sawyer, Ron Williams and DeSerre were responsible for the hauling of the Orange and Black standard up even with the Green and White.

It was a refreshing afternoon for coach Lou McHevite, who missed this title two years ago by 1-5th of a point and in part atoned for Farmingdale's triumph in the traditional triangular meet three days before.

Hicksville, without a cinder victory in five years, was leading

Westbury by half a point and the Dalers by 1½ going into the relay in the annual three-way struggle, but the Green won the last event and the meet with 43½ points. Westbury was second with 42½ and Hicksville third with 41.

Elder Replaces Byrnes  
 Elder with a fine jump of five feet eight and three-quarter inches replaced the old record of five feet seven inches set by Hicksville's Billy Byrnes in 1946.

DeSerre's triumph in the 100 was a notable one for the Comets. His win in 0:11.3 retired the Sag Arlington Memorial Trophy and it will remain permanently in the Hicksville showcase.

The Comets actually took the trophy right from under the nose of Farmingdale, which gained the first two legs on it when Ronnie Schaller won the event two years in a row. Bobby Thomas then came along to win twice for the Orange, and DeSerre's win was

the one needed to retire the golden shoe.

Jim Maher carried Farmingdale's hopes for its retirement, but he finished second to DeSerre's bid.

Hicksville scored in every event to get the tie. The relay team beat Farmingdale in the time of 1:47.5 to knot the count 24-24, following an afternoon dominated by the two schools in the junior events.

Longo was third in the broad jump, Elder got a second in the shot put, Sawyer was third in the 220-yard dash and Williams was third in the high jump.

Oddly enough both schools did not score a single point in senior competition which saw the laurels go to Great Neck.

Of interest to Hicksville fans was the erasing of Ed Coleman's shot and discus marks in the senior event's by Port's Don Bell and Garden City's Bob Buschman respectively.

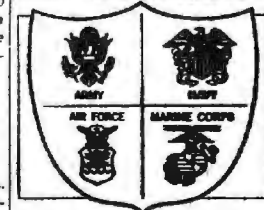

Roman cited the case of Fred C. Trump, builder of two apartment developments in Brooklyn, who has provided space in his projects to conduct elementary school classes and has rented the quarters to the School Board at \$1 a year.

Local carriers, members of the National Assoc. of Letter Carriers and the National Federation of Postal Clerks, today asked Hicksville post office users to write Congressman W. Kingsland Macy at Washington and protest the cut in service.

The carriers, following a meeting Monday night at the Legion Hall, also urged all to have their friends write letters and to write also to Senators Herbert H. Lehman and Irving M. Ives at the Senate Office Building, Washington. The carriers point out that most people will only get their mail in the afternoons, that mail left in boxes may be delayed as much as two days and directory service will be discontinued.
