And You Thought It Was Cold

NEW YORK — "B-r-r-r-r" was the comment by Michael T. Balus of 1 Walnut Lane, Hicksville, when he emerged from the icy Hudson River after diving in at 43rd St. here to retrieve a gold-painted wooden cross as part of a religious ceremony on Sunday, Jan. 10.

The 200 shivering spectators were members of the Hellenic Orthodox Church taking part in the annual observance of the Feast of the Epiphany. The ceremony was conducted by Magr. David Leonardis of the church, who released a dove into the air as Balus dove into the water.

In other years as many as 20 divers have taken the annual cold plunge into the river for the honor of recovering the cross which symbolizes the washing away of humanity's sins. This traditional ceremony has been observed locally for 34 years and dates back centuries.

The hardy Hicksville resident who is 26 years old brought the cross ashore on his first try. The event was recorded on news television programs.

\$190,000 PROPOSITION

Township Pushes Purchase Of Property For 2 Car Parks

OYSTER BAY — Acquisition of Griffin and Rushmore properties for new public parking fields in Hicksville is being pushed thru by the Town Board following a public hearing held Tuesday morning, here, upon appropriation of \$190,000 for such improvements.

Speaking in favor of the projects were Al Schackner, president of Hicksville Chamber of Commerce, and Henry G. Eisemann, president of Bank of Hicksville and member of the chamber board of directors. The properties

are on both sides of Heitz Pl. and are expected to accommodate upwards of 200 cars.

Efforts to acquire additional carpark sites were outlined at the Chamber Directors meeting on Jan. 8 at the Milleridge Inn, Jericho. There was also a report on efforts to obtain R11 grade crossing elimination.

A nominating committee was designated including Mal Pierce, chairman; Michael Sullivan, Patrick Buffalino, Francis Anderson and Patrick Caputo.

Reports Growth Of LI National

HICKSVILLE—Assets of the Long Island National Bank, here, increased to \$19,314,417.26 which was a gain of over three million dollars during 1953, it was reported to stockholders at the reorganization meeting of the Board of Directors, Tuesday, by William E. Koutensky, president. He was re-elected to head the bank. Loans and mortgages increased to \$2,011,490.58, showing a year end figure of \$8,885,994.49.

President Koutensky expressed "sincere regret upon the loss through death in 1953 of Vice President Henry J. Weickmann, Assistant Cashier Lawrence M. McGunnigle and Custodian Aaron Luhnmann. The Bank suffered a great loss upon the death of these fine men," he said.

He also expressed thanks and appreciation for "the fine spirit of cooperation that was shown by his fellow directors, officers and personnel." Personnel at the end of 1953 numbered 70 serving 30,000 accounts in the deposit and loan departments.

Forecasts Democratic Victory In November

HICKSVILLE—Victory for the Democrats in the state of New York was forecast here Wednesday night by Lawrence McKeown, county party chairman, at the installation of officers of the Democratic Club in the Legion Hall. He cited the progress made by his party in the election last November in Nassau County and noted the significance of the Nassau GOP pluralities, now under attack, which in the past have "carried the state".

McKeown claimed that a study of the last election results in Nassau showed that 102 per cent of the Democratic enrollment voted, a record high for the nation. At the same time, 38 per cent of the enrolled Republicans voted. He also predicted that a Nassau resident will be on the State Democratic ticket this fall.

Town Receives Garbage Bids

OYSTER BAY — Councilman Frank Chlumsky is studying bids for Hicksville garbage removal service, received here Tuesday morning, before making his recommendations.

James H. Allen of Hicksville bid on three contracts. On the one year contract to run from Feb. 28, 1954 to March 1st, 1955, he bid \$86,666, 85 cents for each new dwelling per month and \$5 per month for each new store.

He also bid \$173,323, 85 cents per house and five dollars for each new business on the contract which would run from 1954 to 1956. On the three year contract to run from 1954 to 1957 he bid \$260,000 and one cent.

The other bidder was Nassau Sanitation which only bid on the one year contract because its contract with the union expires this year. The bid was \$111,000 \$1.50 for each new house and \$6 for each new business.

On garbage collection in Ext. 3 there was one bidder, Nassau Sanitation. The bid for one year was \$4,000, \$1.50 per house per month, and \$6 for each new store. Also because of the union contract expires (Continued on Page 4)

AN ORDINANCE regulating the control and seizure of dogs in the Town of Oyster Bay, Nassau County, New York, pursuant to Article IX, Section 130 of the Town Law of the State of New York.

Section 1. It shall be and hereby declared unlawful for any person owning, possessing or harboring any dog to allow same to run loose or be at large upon any public highway, street, sidewalk or other public place in the Town of Oyster Bay unless such dog is under the immediate and full control of the owner or person in charge thereof and while said dog is on leash.

Section 2. Any person or persons violating the provisions of this ordinance shall be liable for and forfeit and pay a penalty of not more than Twenty-five dollars (\$25.00) for each offense. Any violation of this ordinance or any part thereof shall constitute a disorderly conduct and the person so violating any of the provisions thereof shall be and is hereby declared a disorderly person.

Section 3. A dog warden shall seize any dog found at large or not under the immediate control of the owner or person in charge thereof. Every dog seized shall be properly fed and cared for at the expense of the municipality until disposed of. The owner of a dog seized may redeem the dog within five days of the seizure upon payment to the Town Clerk of a fee in the amount of Two dollars and produce a license for said dog. Any dog not so redeemed within such period of five days shall be sold or killed by the warden. In case of a sale, the purchaser must pay a purchase price of Two dollars (\$2.00) to the Town Clerk and also obtain a license for the dog. All proceedings by the Town warden for seizure and impounding a dog, the redemption, killing or sale thereof, and the fees of such dog warden shall be conducted pursuant to the provisions of the Agriculture and Markets Law of the State of New York.



WHEREAS, the Commissioner of Public Works has recommended that said Oceanside Road from Foxhurst Road, Oceanside, northerly to Merrick Road, Rockville Centre, a distance of .616 miles and from Sunrise Highway, northerly to Long Beach Road, Rockville Centre, a distance of .152 miles, Town of Hempstead, be incorporated into and made part of the county road system and has caused to be prepared a map entitled "Map showing Oceanside Road for Incorporation into the County Road System, Nassau County, New York, from Foxhurst Road, Oceanside, northerly to Merrick Road, Rockville Centre, a distance of .616 miles and from Sunrise Highway, northerly to Long Beach Road, Rockville Centre, a distance of .152 miles, Town of Hempstead, New York" date January 1954, and

WHEREAS, the Board of Supervisors is of the opinion that said road to be made part of the county road system of said County.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF SUPERVISORS OF THE COUNTY OF NASSAU AS FOLLOWS:


