## Board Denies Change In Zone

A large delegation of residents from Woodbury Gardens, Miller Rd., Twin Lanes Ave and vicinity appeared at the public hearing on the application, Tuesday morning, to register opposition to the proposal which included a request for a permit to store, park and house school buses.

## NASSAU COMMERCIAL LEADERS:

# Hicksville Among Top Ten With 426 Business Firms; 78 Percent Rise in 5 Years

NEW YORK — The community of Hicksville today ranks among the "Big Ten" communities of Nassau County as far as commercial business is concerned, according to a survey by Dun and Bradstreet released here. Hicksville has 426 rated businesses listed for 1954 which is an increase of 78.2 per cent over the 239 listed here five years ago.

HICKSVILLE — Approximately 200 business and civic leaders of the Hicksville-Levittown area were guests of The Prudential Insurance Co. here last Friday at a reception to mark the elevation of its Hicksville office to the status of a full scale District Agency.

Hicksville is given an 8th position on the new ranking for 1954 in the entire county, going ahead of Lynbrook with 418 and Elmont with 381. At the top of the list is Hempstead with an even 1600, followed by Freeport with 689 and Valley Stream's 557.

Fourth on the list is Great Neck with 536, Mineola is fifth with 506, Rockville Centre follows with 504, New Hyde Park has 502 and then comes Hicksville.

Levittown appears on the listing for the first time with 171 business concerns.

Other mid-Island communities are listed as follows: Bethpage has 143 businesses, a gain of 120 per cent in five years, Farmingdale has 280 today, an increase of 48.1 per cent; and Jericho has 18 businesses, two more than five years ago in 1949.

Oyster Bay has shown a decline from 137 to 134 in the five-year span. Also down in Sea Cliff from 85 to 59 and Woodbury is one less today with eight.

Westbury has 350 businesses, showing a gain of 70.7 per cent since the 205 listing in 1949.

Hicksville with 426 business concerns in 1954 is ahead of the two cities in Nassau, Long Beach, according to the Dun & Bradstreet, has 332 businesses and Glen Cove, the other city, 368.

Massapequa is credited with the most remarkable business growth in the county, a jump of 300 per cent in five years to a total of 257. Baldwin, on the other hand, lost the most listings, and went down better than 35 per cent in the same period. Baldwin has 226 businesses today compared with 350 in 1949.

# Set Boundaries For St. Ignatius

HICKSVILLE — The establishment of new Roman Catholic parishes in this area has reduced the land area of St. Ignatius Loyola Church parish, although the number of members in the congregation continues to grow with the population.

The westerly boundary between St. Ignatius and Holy Family, also in Hicksville, is (from the west) along Old Country Rd. to Clarissa Lane, south on Clarissa into Blue

berry Lane to Malone St., east on Malone and Pine St. to Newbridge Rd., across Newbridge along Glenbrook Rd., Boulevard Dr. to Division Ave., south on Division to Tenth St., east on Tenth to Jerusalem Ave.

South on Jerusalem to Constellation Rd., east on Constellation and Farmedge Rd. to Bloomingdale Rd. and north on Bloomingdale running into New South Rd.

On the east-the boundary between St. Ignatius and Our Lady of Mercy is along New South Rd., north across Plainview Rd. into Cliff Dr., north across Woodbury Rd. along Ketcham E. and then cross country to the intersection of Miller Rd. and Robbins Lane.

On the North, the boundary between St. Ignatius and St. Edward R. C. Parish of Syosset, is north west along Robbins Lane to Jericho Tpke., west on Tpke. to Jericho-East Norwich Rd., north to Cedar Swamp Road and northwest along Cedar Swamp to the continuation of the Oyster Bay - North Hempstead Township boundary line.

# Fork Lane P-TA Hears About School Expansion

HICKSVILLE — The Fork Lane PTA membership was well represented at the meeting held Tuesday, Feb. 2.

Vice President Dexter Coney, who presided in the absence of the president Joseph Parnicky introduced Emily Joyce Eisaner, president of the Ladies Auxiliary of the Jewish War Veterans who gave her personal experiences in the meaning of brotherhood for the observance of February as Brotherhood Month.

The report of Chester Hummel, Fork Lane School representative to the Hicksville PTA Council, was read. The announcement that Grace Dondare, reading consultant, had been added to the staff of the school system, was made.

Parents Education Committee made known that another showing of the film, "Preface to Life" will be presented exclusively for fathers. Joseph Reid will preside as moderator if his schedule permits. The date and time will be announced at a later date by the committee.

**DISCUSS NEW PROJECTS**  
Sidney Kosby, chairman of the

legislative committee, introduced Milton Leavitt of the Dutch Lane PTA group, who urged the entire membership to be sure to register and vote, elections to be held Saturday, Mar. 6. He concluded by saying that elections were lost at registration by lack of interest rather than at the polls.

School psychologist William Glaser discussed the purpose of his job. Summing it up he said the primary purpose was to help the parents and teachers understand the child better and to help the school understand the child better. He also stressed the need for more child guidance clinics in Nassau County. Mr. Glaser also showed the film "He Acts His Age," which depicted the various stages a child passes through at various age levels. This is the first of a series of films, made to acquaint parents with the child's development.

When the business meeting was adjourned, the Hospitality Committee brought forth a variety of sandwiches and coffee, supplied by the mothers of the fourth grade classes.

## LI National To Exhibit Money

HICKSVILLE — Specimens of United States money minted from Colonial times to the present day will be on display at the Long Island National Bank here for one week, beginning Feb. 23, it was made known by William E. Koutensky, president.

The exhibit is to be made up of eight frames of currency and three frames of coin.

Recalling the nation's financial and economic struggles will be specimens of currency issued by the Continental Congress to help finance the Revolution. Overproduction of this currency and counterfeiting, however, caused it to become practically worthless and resulted in the phrase "not worth a continental." Struggles of the Civil War period are reflected in fractional currency called "shipplasters," issued by the North to replace coin which had become scarce. Confederate currency issued in the South to finance the War will also be in the display.

Of unusual interest will be the collection of Federal Reserve notes — of which almost \$25 billion are outstanding — including the seldom-seen \$10,000 denomination. The set of notes was printed especially by the Bureau of Printing and Engraving, in Washington, D. C., for the Federal Reserve Bank of New York, through whose cooperation the collection is being placed on display here. Each note in the series, although a genuine reproduction, is engraved on one side

only. Included among the early coins will be Wood's penny, made in England and shipped to the colonies in an attempt to ease the coin shortage. Also of interest are the one-half cent piece, the first coin to be minted by the United States; the two-cent piece of 1864, the first U. S. coin to bear the inscription "In God We Trust"; and the trade dollar, issued from 1873 to 1883, the only coin ever demonetized by the United States. Gold coins, withdrawn from circulation in 1933, will be in the exhibit, too.

The making of a quarter, illustrating each step in the process from a silver bar to a finished coin, will be shown in one of the frames. Another has specimens of counterfeit notes, paired with genuine, and samples of raised notes.

# NEIGHBOR DOWLING VIEWS NEWS: Seniors May Go To Levittown HS

By JOHN DOWLING

Last Monday, Oyster Bay High School accepted the final tuition resolution from the Plainview School District. This is in keeping with a resolution passed some months ago by the Oyster Bay Board of Education limiting the number of tuition students because of a rapid increase in the district's home enrollment.



Forwarded of this quota system, the Plainview School Board and the district's principal, Robert Tuttle, have been in constant touch with other districts contiguous to Plainview in order to make provisions for any new senior high school students that may move into the district between now and June.

Since Hicksville School of-

icials have already indicated their inability to absorb further or any outside students because of their own high enrollment problem. Arrangements are being made to send all new Plainview senior high students (grades 11th through 12th) to Levittown High.

In addition, Bethpage school authorities have indicated they will assist Plainview with its 9th and 10th grade problem.

By next September, Plainview will be in a position to take care of its students through the eighth grade. This will be made possible by the opening of the new Plainview-Jamaica Ave. School and the new 10-room building on Central Park Road south of the Plainview Fire headquarters.

At the present time, the district's enrollment from kindergarten through grade seven totals one thousand one hundred and seventy-five students. In addition, there are

200 students in grades eight through twelve who are being transported to high schools outside Plainview.

Although the present situation is far from ideal, the availability of two new schools in September will give Plainview 38 class rooms within the district compared to the existing seven rooms. This should enable the Board to eliminate transportation outside the district for all grades excepting grades nine through twelve.

Since the department of Education recommends that a district must have an enrollment of approximately seven hundred and fifty students eligible for high school before any senior school building plans can be submitted, it will be some time before Plainview can go ahead with any high school plans of its own. Another factor which vitally affects a plan of this nature is the matter of centralization.

All in all the Plainview educational picture looks much brighter than it has for a long time and this has been made possible by the high level of cooperation between the residents, the principal and his staff and the Board of Education.

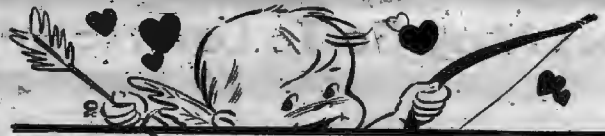

# Can We Hold Business Gains?

By Fred J. Noeth

WE BELIEVE the report featured on our front page in today's issue is the most significant story to be published in the history of the Herald.

Included in this count of commercial enterprises are manufacturers, wholesalers, retailers and other businesses, generally those buying regularly on credit. Dun & Bradstreet explains that the count does not include establishments of a service or professional nature, such as real estate, brokers, barber and beauty shops, professional men, stock brokers, etc.

Hicksville thus has 426 commercial enterprises and—anticipating your question—it does include gas stations and bars.

The position of Hicksville is most significant. It is the only community in the Township of Oyster Bay to rate "the first ten towns" position. Every village ahead of it is incorporated. Six on the list are in the Town of Hempstead and three are in the Town of North Hempstead.

We also believe that the experience of Baldwin is of significance for Hicksville. Baldwin, which at one time was proudly advertised as "the largest-unincorporated community in the country", has slipped down the scale. It had 351 businesses five years ago, it has 226 today.

Those who have been reading the newspapers have read from time to time about the continuous but fruitless efforts of unincorporated Baldwin to do something substantial about parking conditions and grade crossing elimination over there. Without attempting to assume the role of a prophet of doom, we find reason for concern in this experience.

Unless Hicksville can solve its complex multi-layer local governmental problems, it may find itself slipping down after a certain peak has been reached. The peak is still ahead however, because the experts at Dun & Bradstreet predict we will top the 500-mark before the end of 1954.

This becomes more significant when we consider the fact that "heavy building" in the Hicksville area is credited by D & B with the gains in our section. We are fast approaching the point where home building in Hicksville's proper will move forward at a slower pace—we are just going to run out of land space.

# Chamber Suggests Town Board Act To Restrict Farmers' Markets

HICKSVILLE—The increase in the number of so-called farmers' markets in this area is detrimental to established businesses and Jyster Bay Town Board is being asked to consider legislation to limit their number, according to a decision reached at a special meeting of the Chamber of Commerce directors, Monday morning, Feb. 1.

Vice President Maj. Pierce presided at the special session with a number of local retailers also present. It was decided to send a telegram to the town officials stating "that it is the consensus of the businessmen of the area that it is detrimental to business in general to countenance the increase of Farmers' Markets and therefore some legislation should be enacted or considered by the Town

Board whereby the number of Farmers' Markets should be limited and their proximity to business areas should be regulated."

Plans for the creation of another farmers' market off South Broadway, opposite the entrance to Grumman's, has poused widespread interest and concern among retailers of the community, the Chamber Directors were informed.

The Town Board received the telegram at its meeting on Tuesday and referred the proposal to its legal department for consideration and recommendation. Meanwhile it was learned that the Board has given its approval to the operation of the market off South Broadway, opposite Grumman's.

### Support For Home Rule

Support for home rule government very often comes from the most respected of people. In one of his recent columns in the daily press, George Sokolsky quotes one of the nation's outstanding industrial leaders on the subject of governmental decentralization. Mr. P. W. Litchfield, chairman of the board of Goodyear Tire and Rubber Co. says that we need to organize at the local level. And, we might add, the local level in Hicksville means Eckville.

### Decentralization Needed

Sokolsky points out that many of our great efforts need decentralization. People have become so accustomed to expecting the Federal government to do everything on a vast scale that they forget the old Chinese saying that the place to start cleaning up is on one's own doorstep. In line with this, we certainly must not expect that the Oyster Bay township government should do the things for us that we should be doing for ourselves. Hicksville is one of the very few, if not the only community of over 30,000 people in the entire nation not having a gumption and ability, locally, to handle its own local affairs like parking, traffic, parks, zoning, and the like.

### Solution For LIRR?

Only a few short years ago Hicksville was a relatively small community of about 8000 people. It suffered then because of the lack of local government. With the population quadrupled, it suffers even more. It is a new population that, to a very large extent, hasn't yet had its chance to settle down and survey its community affairs. It won't be very long in settling down and when it does the local problems will be recognized and appreciated. The campaign for local home rule government will then probably be a landslide, the dictates of a political boss notwithstanding.

### Incorporation Must Come

We are indebted to the following little gem. It seems that the Pennsylvania Railroad was providing the same general quality of service that its stepchild, the Long Island Railroad provides here. Our commuter friend pointed out that if the railroad was asked to move 6000 packages, each weighing 150 pounds, 30 miles into town and back each day, it would fall all over itself trying to get the business. But if the packages are people, the railroad cries great big tears. And people get themselves on and off the trains without assistance. Freight packages can't do that. We don't know how to run a railroad, and it sure seems like the LIRR doesn't either.

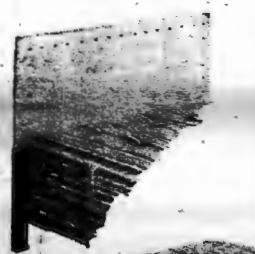

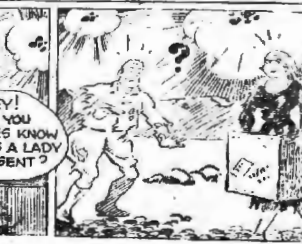
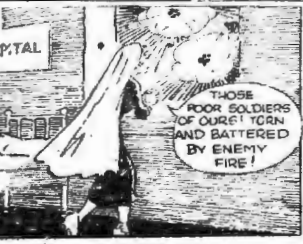

**'Doctor Jones' Says**  
 By PAUL B. BROOKS, M.D.  
 Have you heard they've started, now, making blood pressure tests on chickens? Yes, that's right. So I read in Science News Letter. Adult "chickens", that is: the feathered kind. It's research work Dr. Sturkie's been doing—the poultry physiologist at Rutgers Agricultural Experiment Station.  
 They knew that about half of the adult birds that die "natural" deaths die from non-infectious diseases and old age. Their studies have shown that one cause of such deaths, apparently, is high blood pressure.  
 The doctor devised an instrument for making tests. They've brought out some things that're interesting, in the light of what we know of blood pressure in humans. The blood pressure increases with age, in these birds, just as it does in humans. The percentage of increase in chickens from ten months to three and a half years old, they find, runs about the same as for humans from 20 to 65 years.  
 The same as in humans, the blood pressure of males averages higher than in the females. "Why?" Well, that's a question. Maybe it's greater responsibility—more to worry about: the roosters, I mean. Anyway, they seem to see possibilities of getting more eggs in coming years. That'd be by picking out, for breeding purposes, hens whose blood pressure is less affected by age. The roosters—maybe they don't want them to live too long. It'd take longer to cook 'em.  
 But, you know, it wasn't till about the time I started in medical college we began hearing about blood pressure. The doctors, in the old days—they spoke of "pulse pressure." They recognized its significance. From feeling the pulse they could tell something about what, now, we call blood pressure. The first instruments for measuring it were just beginning to appear.  
 Well, nowadays a lot of people are worrying about their "high blood pressure." Many of 'em, of course, need treatment. But one of the sensible conditions, in recent years: for elderly people relatively high blood pressure is "normal." If they're otherwise well, their doctors are advising a lot of 'em, in words or effect, to "just take it easy and forget it."

## Elementary Enrollment Peak At 8,000 Within Next 3 Years

HICKSVILLE—Enrollment in local public schools, kindergarten thru 6th grade, will exceed 8,000 students by Sept. 1957, it was noted today as support for the proposed expansion of district schools was being marshaled. Peak capacity of the schools today, including the new Woodland Ave. building which is due to open shortly, is given as 4,610 with 85 pupils in a class.

According to the report on the building requirements of the district, prepared by the Institute of Field Studies, Teachers College, Columbia University, additions now proposed for four of the schools and scheduled for voter consideration on Mar. 6 would increase the capacity of the system to 4,225 with 25 in a class, to 5,675 with 35 in a class.

The Columbia Report (Supplement no. 2) projects the kindergarten thru 6th grade enrollment as follows:

Sept. 1953	5,227
Sept. 1954	6,950
Sept. 1955	6,950
Sept. 1956	7,620
Sept. 1957	8,015

It notes thereafter a gradual decline to 7,935 in 1958 and 5,660 in 1965 (eleven years hence). It also provides the comment that the long term projected enrollment, after "peaks", will be 4,800.

Capacity of the various schools today, 25 in a class, is given as follows: Bayas Ave. 290, Dutch Lake 290, Fork Lane 290, Old Country 290. These four after the additions are completed would be

increased to a capacity of 530 each.

The list continues with present capacities: East St. 630, Lee Ave. 530, Nicholai St. 415 and the new Woodland Ave. building 530.

### VOTE ON MARCH 6

Registered voters of the district will cast their ballots at the high school, Jerusalem Ave. and Second St., on Saturday, Mar. 6, between the hours of 10 A.M. and 8 P.M. on six questions. The first four provide for appropriation of \$500,000 for the additions to each of four schools which were opened a year ago.

Those who have not previously registered for school voting will have their opportunity to do so on at the high school on Tuesday, Feb. 23, from 4 to 9 P.M. and on Saturday, Feb. 27 from 10 A.M. to 8 P.M.

The statistics in this report were made available to members of the Citizens Advisory Committee on Education in the local district at a special meeting Monday night at East St. School cafeteria by Richard Schoel, member of the

board, who has been delegated to direct a "referendum committee" of the board.

Joseph Cawley of 2 Glow Lane is in charge of a committee of the Advisory Group scheduling organization meetings where speakers for the project will be invited.

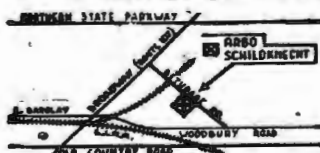

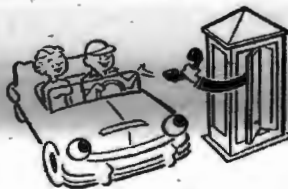
