# 528 Girl Scouts Celebrate

**HICKSVILLE**—Five hundred and twenty-eight local girls are celebrating a birthday on Mar. 12, according to Mrs. Merton Wilbur, Girl Scout Town Committee Chairman. That day is the 42nd birthday of Girl Scouting, and the theme of the entire week is "Know your Neighbor—Know your Nation".

The history of Girl Scouting here, Girl Scout Laws and Promises will be demonstrated by window displays throughout the town during the coming week, Mar. 7 to 13. There will be visual displays in Eisemann Buick, Braun's Market, Stop 'N' Shop, Sunrise Food Market, George and Cliff's Market, the Herald and the Free Public Library.


Girl Scouting was organized here by Mrs. Joannia Tallafiero in 1917. This was just five years after Juliette Low organized the first troop of Girl Scouts in Savannah, Ga. In 1923 the first town council was organized here and its members who assisted Mrs. Tallafiero were Miss Louise Augustin, Mrs. E. A. Van Slyke, Mrs. Charles Voigt and Miss Mabel R. Farley. There was one troop with a registration of about 20 girls.

Hicksville has played an important part in the development of Scouting in Nassau. In 1939 Hicksville joined with Bethpage, Farmingdale, Jericho, and Westbury to form Mid Island Council. The council membership is now 14 towns, of which Hicksville is the second largest.

In contrast with one troop in 1923, there are now 24 troops meeting in the schools and churches in town with an enrollment of 528 Brownies and Scouts, and over 110 registered adult workers. The scouts are in every section of the community and the affairs of the local organization are directed by the town committee, which meets once each month and comprises the leaders of each troop, the elected town officers and the chairmen and members of the committees.

## Tragic School Bus Accident Shocks Entire Community

**HICKSVILLE**—Religious funeral services will be held at 1 o'clock Friday afternoon, Mar. 5, for eight-year-old Paul A. Jud in Trinity Evangelical Lutheran Church on W. Nicholas St. with the Rev. Edward H. Stammel officiating. Paul, a first grade student at the Lutheran Parochial School, lost his life in a tragic accident in front of the Church on Tuesday morning.

The children of the school will attend the services in a group. They will join in the singing of "Beautiful Saviour".

### STRUCK BY BUS

Paul, the son of Mr. and Mrs. August Jud of 74 East St., was struck down by a school bus on W. Nicholas St. at about 8:30 Tuesday morning, Mar. 2. Police reported the child was crossing from the south to the north side of the street when bus No. 19, owned by Bonkert and operating under contract with the school

district, passed over him. Driver of the bus was Ralph J. Fox, 58 of 4843 Ava Rd., Bethpage. After an investigation by police and detectives of the second precinct under Capt. Vincent Chimenti, no police action was taken. Fox was visibly shaken by the unfortunate accident. He is widely admired by the parents of his regular youthful passengers on the route of bus 19.

## Vote This Saturday On More Schools

**HICKSVILLE**—Nearly 3,500 local adults are registered for the special referendum of the school district this Saturday, Mar. 6, at the high school on Jerusalem Ave. Polling hours are from 10 AM to 8 PM on four propositions for expansion of elementary school buildings at a cost of \$600,000 each. Also purchase of five acres of property for another school off Newbridge Rd. near the Holy Family R. C. Church for \$42,000 out of surplus funds, and a question on division of the school district into voting areas. A two-third favorable vote is necessary on the first four questions, school authorities warn, urging a large vote.

Karran of 39 Grove St., here, who was injured when a pumping station exploded at Centereach, on Feb. 24, returned home Wednesday, Mar. 3 from the Mather Memorial Hospital, Port Jefferson, where he had been a patient since the accident. His condition was described as "much improved."

Karran, well-known here, foreman on a job for C. W. Lauman Co. of Bethpage, at the time of the accident escaped with injuries described as "serious." A fellow worker, Leonard Cocker, was killed at the time when he was buried in the rubble of the blasted pumping station.

## In People's Corner

Written in the Interest of  
Better Local Government . . .

Political parties spend a great deal of their time and energy trying to sell to the public the idea that their candidates, and their elected officials, are not only the best—but the only good men.

If anyone seriously tried to convince us that all good men were tall, dark and handsome, we would merely laugh. Such a statement is so obviously false, and since only fools could believe it, we would laugh in his face.

Anyone who relies solely upon political parties to provide him with all his information about candidates, issues, etc., must do so at his own risk. We must never fail to realize that the party's point of view will always be presented in a light most favorable to the promotion of its cause.

Since we voters, cannot possibly come to know all the candidates, we must to some extent rely upon a party label. There is nothing wrong with this practice as long as we realize that it is not entirely reliable. But when a party does its utmost to keep its candidates, and its officials, under cover, when it avoids all open and public discussion at election time, they are depending entirely upon the party label to elect their men. When this happens, as it has happened here, the public should beware. The public should demand to know more than that he's a Republican.

Men are never so likely to settle a question rightly as when they can discuss the matter freely and openly with all parties concerned.

When the interchange of information is free, the expression of individual or group opinion is sometimes gently but always firmly discouraged, by our public officials, or by any powerful political group, we are having our freedom of choice, our rights and privileges openly challenged.

## Kiwanis Club Reports Active Year

The club celebrated National Kids Day in September by holding a Hobby Show at the High School Athletic Field, entertaining approximately 175 children and presenting prizes for their hobbies.

The club also sponsored and ran a Teen Canteen Dance, held a Father and Son Dinner entertaining 35 children, gave a Halloween Party for the Junior High School Students in conjunction with the PTA. This event entertained 300 children with prizes and refreshments. The following week a Halloween party with prizes and refreshments was given to the first six grades of the elementary schools, 400 children participated.

# Rumors Become Sordid Story

Well neighbors, I guess you now must of you have read the sicken- ing and sordid story currently being featured in the New York Daily News—"From the Public Schools to Public Enemies."

That newspaper, which has the largest circulation in America, recently assigned several of its top news reporters to the task of unearthing the truth about the long-existing, ugly rumors concerning the New York City school system.



What they found and what they are still writing about has shocked everyone except the New York City officials who have known the truth and have deliberately suppressed it for many months.

It is these same individuals who have been devoting all of their energies toward convincing Nassau residents how wonderful it would be for all if the county was annexed and integrated into the city scheme of things. You're all familiar with the high-sounding drivel about one Board of Education, one Mayor and one this and that. Apparently the city scheme of things isn't working so well except to further enlighten county residents of the foolhardiness of such a move.

When the schools fall apart—and that's what has happened in New York City—then the rest of the city is tottering in the edge of moral and economic disaster.

# Our Children Needs Schools

**YOUR FAVORABLE VOTE** for the bond issue to cover the cost of increasing facilities to provide education for the children of Hicksville is urgently requested. The need for the construction of 36 more classrooms at this time is readily apparent. There are today thousands of boys and girls just under school entrance age who will require these classrooms in the very immediate future.

The statistics speak for themselves. The School Board can plot with some accuracy the number of classrooms needed as of today, next September and succeeding years. Each year about 1,000 children are reaching school entrance age. A leveling off period is also forecast, but we are assured that the proposed additions to four schools will not exceed our minimum requirements. In other words, there does not at this time appear to be even a remote possibility of "overbuilding."

**The need is definite and urgent. We urge your vote in favor of the propositions.**

However, at the risk of criticism for daring to raise the question, we must take exception to the technique used in selling these proposals to the community. Our complaint is with some "official" statements made in regard to the cost of the program. The careless reader would get the impression that these schools will be built at practically no cost to the property owner.

Herald readers were given the full text of the material supplied speakers of the "Referendum Committee" on the "effect of proposed additions on taxes and tax rates". It was all there, but a hurried reading could leave only one impression: We are going to build two million dollars worth of more schools and the tax rate will not change—in fact, it may go down.

True enough, there were plenty of qualifying expressions to be found in the text: "impossible for Board to forecast with certainty", "too many factors which influence the tax rate", "variable influences which cannot be foreseen", etc.

But, what has not, in our opinion, been made plain in data fed the public in recent weeks about the cost to the taxpayers is that the "experts" are now talking about school taxes as a double-decker proposition. There is the generally understood "school tax rate", which is today \$3.14 per \$100, and there is a new line of thought which divides this total tax into "operational" and "debt service" costs.

We make a point of this because while we are told there is a ceiling, under existing State Laws, on the "debt service" part of the tax rate, there is no ceiling on the "operational" part of the tax and that this portion of the cost is likely to keep rising. For example, we are told the presently committed (1955-6) debt service rate is \$1.13 per \$100 of assessed value or \$45.20 on a house assessed at \$4,000. But the actual tax rate for schools on a \$4,000 house right now is \$125.60 with our rate \$3.14. The \$30.40 portion of the tax bite is not even mentioned.

**The need for these additional facilities is staring us in the face. We think the people of Hicksville recognize this need and will vote for these proposals on Saturday. We don't think it is necessary to paint a "pie in the sky" picture and lead taxpayers to think they are going to get all this while taxes hold firm or decline.**

Mrs. Reynolds, who described her feeling about Donald's homecoming as "I'm just too thrilled to say anything," is busy seeing to it that his room is fixed the way he liked it before he left and is planning many surprises for the returning hero. Another member of the family who is overjoyed at the news is Donald's 13-year old sister, Arlene, who has been waiting a long time to see her big brother.

Mr. Reynolds, who served with the U. S. Navy in the south Pacific during World War II, expressed his feelings by saying: "We overjoyed beyond words and we hope that all of the young men in our armed forces will eventually be able to return home to their loved ones."

The Reynolds family reside at 27 Blanche St., Plainview. Cardinal Spellman's letter to the family follows:

Among those I visited was one very dear to you from whom I received a commission to bring you affectionate greetings which I am happy to do with this letter.


