### 379 Fire Call Set Record

HICKSVILLE—The fire dept during 1953 answered a total of 379 alarms, an all-time record for the community and an increase of 28 over the previous record year of 1952, it was noted today as the term of office of Chief Edward E. Schuiter, Jr., concludes. The department has answered more than 135 calls for assistance during the first three months of this year. The new chief will be installed at the department meeting next Monday night.

During the past week, ten calls were received, three for grass fires and four for oil burner alarms. A box alarm shortly after midnight, Tuesday, called the vamps to the McKeran home at 78 Cliff Dr. where flames damaged the attic.

## Mrs Sutton To Seek Re-Election

HICKSVILLE—Edna Kuhne Sutton of Lee Ave., vice president of the Board of Education, will be a candidate to succeed herself as a trustee of the school district in the May 5 election, it was learned today. Mrs. Sutton's decision to be a candidate for a third term was generally anticipated.

While personal considerations had made it difficult for Mrs. Sutton to make an earlier announcement, she has been besieged with appeals by her many friends in the district to agree to the circulation of a nominating petition in her behalf, the Herald learned. Friends noted that her personal popularity has resulted in the absence of any other candidates for her position on the board.

Mrs. Sutton is concluding six years as a member of the

Board. She was largely responsible, during her early tenure, for the Columbia Survey of the school district needs and requirements at a time when the community was first beginning to feel the impact of post-war new home building.

The mother of two children and a former teacher, Mrs. Sutton has been active in Parent-Teacher and other community affairs.

Larry Roman and Joseph Cawley are candidates to fill the vacancy caused by the expiration of the term of Henry C. Bregel, who is not running after serving for 20 years.

All voters must register personally on either Apr. 24 or 27 to be eligible to vote for board candidates on May 5.

## Town Decides Lebkuecher Gas Station Plea On Apr 20

OYSTER BAY—The decision of the Town Board upon a plea to permit another gasoline station in Hicksville, strongly opposed at a public hearing on Tuesday by residents, is anticipated following the Board meeting on Apr. 20, according to Councilman Frank Chlumsky.

The application of Anna Lebkuecher for permission to build a gasoline station on Old Country Rd. at Lee Pl. was heard Tuesday. Judge Joseph P. Lebkuecher appeared at the hearing to represent his mother's application.

Opposing the application were residents in the vicinity, including the Southern Homes and the Duffy Park Area. George O'Brien of 26 Burkland Ave. appeared to speak in opposition for the Duffy Park Civic Assoc. and present a petition with 200 signatures.

**SCHOOL DISTRICT OBJECTS**  
Mrs. Robert Best of 32 Washington St. also spoke and presented the petition of residents of the Southern Homes. It was also reported that the school district objects since the site is almost opposite the Old Country Rd. Elementary School.

Objectors cited the hazards to children of the area which would develop, depreciation of property values and pointed to the fact that there are no gasoline service stations in the Hicksville area of 6 square miles.

The hearing was closed and the Town Board reserved decision. Action is anticipated at the Apr. 20 session.

## New School Budget Indicates Tax Rise

HICKSVILLE—While the official school district tax rate for 1954-55 will not be established until after Aug. 1, informed sources indicated today that the rate may rise to about \$3.65 per \$100 upon the basis of a net budget of two million dollars. The gross budget of the district coming before the voters at the annual meeting on May 4 will exceed three million dollars with estimated revenues, including state aid, above a million.

### School Board Goes on Record

HICKSVILLE — Responding to a plea from Walter Scheiber, president of the Duffy Park Civic Assoc. who appeared with three other residents of the area, the School Board on Wednesday night went on record as opposed to the construction of a new gasoline station on Old Country Rd. at Lee Pl. The potential hazards for children of Old Country Rd. school who cross the busy highway at the same point was stressed.

School Board members are unwilling to be quoted on the anticipated tax rate. The present rate is \$3.14 per \$100 of assessed valuation and if it rises to \$3.65, it would add about \$25 to the tax bill on a home assessed for \$5,000.

The cost of instructional service continues as the largest single category of the proposed budget and is expected to top \$1,700,000. Debt service, which provides for the payment of bonds and interest due on new buildings in the district, will run better than a half million dollars.

The Board of Education continued its work on the proposed budget at a special meeting, Wednesday night.

## Dedicate New Church This Sunday

PLAINVIEW—The Church of the Good Shepherd, Lutheran, Central Park Road, just north of Old Country Road, here, will dedicate its new \$65,000 Church building and Parish House this Sunday, Palm Sunday, at 3:30 p.m. The ceremonies will climax an exceptionally rapid growth for the Congregation which was first organized as a mission in early 1952 by Trinity Evangelical Lutheran Church of Hicksville.

The new Congregation which now numbers almost 500 souls, has invited the Rev. Edward H. Stammel, pastor of the "mother" church to give the dedication sermon. The Rev. John Hirsch, pastor of the Church of the Good Shepherd-Lutheran, will officiate at the ceremonies.

Birth of the Church of the Good Shepherd-Lutheran took place just about three years ago. In the Fall of 1951, Pastor Stammel of Trinity was surveying the growth of the Plainview area with the thought in mind of establishing a mission here when he heard that "the Forsythe" property of 10 plus acres and residence was available for purchase.

This was one of the last pieces of desirable property not already sold to building development companies. Numerous buyers were interested in purchasing this property which had a price of \$42,000. The Rev. Stammel realized this.

# Parents Responsible For Children

An interesting situation developed last week when two responsible officials publicly presented opposite views on delinquency. The first came to the public's attention when Children's Court Judge James Gehrig in an annual report to County Executive Patterson blamed school boards for delinquency because they are not paying enough attention to reading disabilities.



The second, and by far the more objective because it went to the heart of the matter, was the speech made by District Judge Paul Widlitz who told the members of the Lewittown Memorial High School P.T.A. that irresponsible and unthinking parents are primarily responsible for delinquency. Judge Gehrig's attempt to lay the cause for delinquency on school boards is ridiculous, and his charge that lack of remedial reading programs is a principal factor in the

anti-social behavior of problem children has some merit but by no means can it be singled out as the major cause for delinquency.

His statement, to say the least, is a weak one because it overlooks the real reason for delinquent children—the lack of parental interest and example.

On the other hand, Judge Widlitz, who, probably is not a very popular person with some groups because of his pointed remarks brought the delinquency problem right out in the open.

He said that institutions of all sorts of recreational and planned programs are good things to have but if children lack self discipline to do something worthwhile you can't make them do it.

Self discipline and responsibility comes only from parental interest in children's activities and studies and not from remedial reading classes as Judge Gehrig says.

All the remedial reading classes in the world cannot take the place of parental love, guidance and help.

The school boards and their administrators do everything possible to institute proper programs

for children but its not within their province to pry into the home affairs of the students to determine the kind of training or example parents set for the children.

You've probably all heard of the case of the irate parent who complained to the teacher "you're giving my child too much homework and I don't have the time to help." Well if the parents don't have the time to help after the child leaves the schoolroom, we wonder who has? The school boards? The school administrators?

They've families of their own to take care of after school hours.

No matter how you look at it, the primary responsibility lies with the parents and no one else. Any attempts to place the blame on others is completely unrealistic.

The school boards, school administrators and teachers can never supplant home training. And, of course, that's not their job.



was no time to lose if this was to be placed in the service of the Lord.

Without seeing the property, he immediately placed a \$100.00 personal check with the seller as a binder, he then called together about 60 members of his congregation, explained the proposition to them and asked their support. Even though the Hicksville congregation was seeking to raise sufficient money for a school building at the time, it voted to purchase the Forsythe property in order to establish the mission in Plainview. This took place in Nov., 1951.

In February of the next year, the first dedication ceremonies took place. Pastor Stamm served as minister to the mission, then known as the "Plainview Chapel" until a year later when the new congregation was able to call the Rev. John Hirsch as its pastor on Feb. 1st, 1953.

Until the present time, the former Forsythe residence has served as a Chapel, after the dedication it will become the Parsonage.

### PLAN HIGH SCHOOL

Although only a small portion of the ten acre plot of land is now being used, the thought of the local Church leaders is that an elementary school, serving Plainview, and later a High School serving all of Nassau, will be built there.

The modern styled church building was designed by Robert A. Green of Tarrytown, N. Y., designer of the parochial school building of Trinity, Hicksville, and the Walt Whitman elementary school of Woodbury. The building was constructed by the firm of Arthur Funfgeld, Hicksville.

Green recently was awarded first prize for his design of this school in national competition for better school buildings.

# CURRENT COMMENT: Schools Take Spotlight Now

By Fred J. Noeth

THIS IS THE TIME of year when interest is sharply focused upon the affairs of our school districts. Besides the fact that budgets are being prepared for a new fiscal year, starting July 1, there are also varying degrees of interest in the election of board members.

Because there are so many new homeowners in the mid-island area who are having their first contact with this phase of real home rule government, a few comments might be of interest.

School Board members receive no compensation for their services. They are usually elected for three-year terms of office, the exception being when an unexpired term is to be filled as in the case of Plainview where Leland Baker has resigned because he is moving out of the district.

The naming of candidates is a fairly simple matter. Just draw up a petition containing signatures of 25 people who are qualified to vote in the district. The candidate must of course be a qualified voter, also. There is a slight change in the law this year requiring that the petition state the name of the last incumbent. In other words, petitions must now nominate candidates for a specific vacancy.

Hicksville and Bethpage school districts require advance personal registration of voters. On the dates set by the Boards of Education, within a span of time fixed by the State Education Law, all persons who wish to vote on the budget on May 4 and vote for candidates to the Board on May 5 must in these districts present themselves personally at the voting places and be registered.

Those failing to register at this time will not be allowed to vote. Personal registration is not established as yet in Jericho and Plainview.

The annual school meeting on Tuesday night, May 4, on occasion becomes an exciting evening. At this time the budget for the coming year's operation of the entire school system, as prepared by the School Board, is offered for your consideration. It may be voted upon as a single question, or it may, as sometimes happens, be voted upon item by item.

Annual meetings sometimes become long drawn-out propositions and—sad to relate—the number of persons voting upon the budget at the end of a long evening is seldom more than a handful compared with the vast numbers who line up to vote for board candidates.

The budget vote and the annual meeting is the one statewide occasion when every taxpayer can exercise a great American privilege. He can question in detail the various items and sums which make up the budget and eventually becomes a tax rate. This rate determines the cost to the individual homeowner, conditioned by the amount for which his property is assessed.

The Education Law requires that a summary of the proposed budget must be available for inspection by all qualified voters at least seven days prior to May 4. Usually you can get a copy at the office of the school principal during regular business hours.

The things you approve—or disapprove—at the annual meeting on May 4 will determine the kind of educational program you get, and its cost, for the year 1954-55. Plan to be present at the annual meeting this year—you'll find it an informative, interesting and perhaps rewarding experience.



# Our Neighbor Finds Missing Boy

Martin Schlueter of 40 Woodbine Dr. said, "the biggest reward he could have received was the satisfaction that he got when he saw the boy in his father's arms."

After a search of 3 days by the state police, Nassau police, Coast Guard by air and sea, local residents and fellow workers at Grumman Aircraft Co. where Doukas is a foreman, had failed, an ex-marine followed a hunch of his own and found 10 year old William Doukas of Massapequa Park.

Little William was found at 6:15 P.M. Saturday on Main St., Farmingdale, with two empty milk bottles in his hands. He had spent his days hunting empty bottles to collect the deposit money for food. Since his disappearance, he had slept in an excavation near St. Raphael's Catholic Church at night.

A confused William ran away cause everything he did seemed to be wrong and he didn't want his parents sick worrying over him. Felt that he would not be missed. As a result of his disappearance his mother was taken to Brunswick General Hospital, Amityville suffering a shock.

Mr. Schlueter, having two children, a girl 12 and a boy 7, and knowing how much the boy was doing shopping etc. decided that the others had been using the wrong technique. He told his wife "that he was going to look in the stores and doorways for him."

Mr. Schlueter went through some Hicksville stores and then drove through another town before he arrived in Farmingdale. After parking his car, he saw this boy with a blue jacket and cap on. Feeling that he wasn't the one to find William, he hesitated and followed the boy a ways before asking him his name. When asked, he gave his first name as Jackie, but seemed confused when asked his last name and ended by saying "Doukas". Asked if he knew his mother was in the hospital, William said, "that was why he had run away, as he did not want his mother to get sick."

Mr. Schlueter took William home. When his father saw him he cried, "My boy! My Boy! and ran and put his arm around William.




