**AN URGENT APPEAL:**

**Plea To Save Girl From Rabies Shots**

HICKSVILLE—Two-year-old Maureen Lane of 6 Elwood Ave., here, will be forced to undergo a series of painful anti-rabies injections unless the small white and tan dog who bit her in the ankle is found by tonight (Tuesday). A week-long search for the animal has been unsuccessful and Mr. and Mrs. Dennie Lane are pleading for the cooperation of the community in an effort to find the dog to test it for rabies.

Little Maureen was bitten in the right calf a week ago Sunday. It's a neighbor's dog and the day after the accident, the animal ran away and has not been seen since. Press and radio appeals have been made. The announcement was made at Sunday masses at Holy Family Church.

The dog is described as part Spitz and part Pomeranian. It is a small white animal with tan spots and a white bushy tail. It answers to the name of "Whitey."

If you have seen "Whitey" or know where the dog is, please call Mrs. Lane at Hicksville 4-3613 immediately and protect little Maureen from those painful anti-rabies shots.

**Opposition To Apartments**

OYSTER BAY—Residents of Princess Ave., Hicksville, are planning to present a petition of opposition to the Town Board here, this morning (Tuesday) when a public hearing is held upon a permit for garden apartments at North Broadway and Princess Ave.

The petition states the property owners register "vigorous opposition and protest the granting of this permit. Residents of the immediate vicinity, especially resent the possibility of this type of dwelling's intrusion into a community of small homes which were purchased to provide quiet, private suburban living for themselves and their families and as an escape from any association with apartments and their accompanying adult-social and child-play problems.

**PSC To Set Another Date On Grade Crossing Plans**

ALBANY—The ink on weekend edition of the Herald was hardly dry when the scheduled hearing by the Public Service Commission on preparation of plans for Hicksville's Rail Road grade crossings was cancelled.

Alton G. Marshall, PSC Secretary, gave notice on Friday that the hearing has "been rescinded and a later date set. You will be advised in due course of the new hearing date," he advised.

The first order had set the hearing for June 24 at 233 Broadway, New York, before Examiner Sanders Schwartz. The order lists "case 10324—in the matter of the proceeding, under the Grade Crossing Elimination Act, as supplemented by the Grade Crossing Elimination Act of 1939, for the elimination of the existing highway-railroad crossings at grade of the railroad operated by the Long Island Rail Road Co. and Jerusalem Ave., Broadway, Marie St., Nicholas St., Old Country Rd. and Barclay St. in the town of Oyster Bay, Nassau County. **Clothing Drive Swamps Volunteers**

By this Friday, the committee hopes to be able to announce a central location where parcels can be left this coming weekend. The items collected last Saturday far exceeds the 10,000 lbs. gathered here for Korean Relief a year ago.

**Praises Public Cooperation In Civil Defense Test Alert**

HICKSVILLE—Public cooperation with the Civil Defense test alert here yesterday (Monday) as part of a nationwide CD drill was described as "excellent" by Col. William Godfrey, local CD director, last night.

The control centre in the firehouse was manned, auxiliary police patrolled the street and more than 30 volunteer firemen were on hand for emergencies.

Areas in the district where the alarm signals could not be heard were recorded.

There were more than 75 volunteers on duty during the alert. The public schools cooperated by conducting air raid drills, under the supervision of Dr. E. H. LaBaron, superintendent of schools. St. Ignatius Parochial School also also conducted a drill during the 15-minute period between the "red" and "all clear".

At the firehouse control centre, Deputy Director Fred J. Noth was in charge in the absence of Col. Godfrey. Telephonic, radio and messenger communications were manned and available. Auxiliary police in uniform, under Sgt. William F. Perdue were on duty and cooperated on traffic control with the county police.

## Amperex Still Out On Strike

HICKSVILLE — A meeting between the management of Amperex Electronic Corp and the union, out on strike for three weeks, was held with a conciliator in New York City last Thursday and ended almost immediately.

Union spokesmen said that negotiations are still "deadlocked", insisting that the union "is willing to bargain at all times."

A spokesman for the 220 striking employees told the Herald, "if the management has any real interest in bargaining in good faith, it should send someone with enough authority to bargain in good faith. We are not interested in a lot of name calling."

Regarding Amperex charges, published in the weekend Herald, that nails had been spread in the path of non-striking workers' cars, the union spokesman described statements on alleged violence as "unfounded".

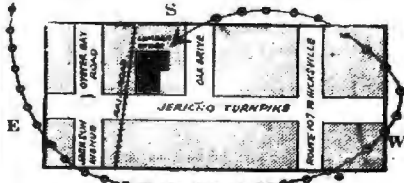

# In People's Corner

Written in the Interest of  
Better Local Government . . .

Our local problems, which in varying degrees are common to all the hamlets of our township, will not be solved in our lifetime. And unless we hear ourselves even our children will remain without the legal authority, to attempt a solution for themselves.

With village government, in place of special district town government, the people of each developed area would have for the first time, at least an opportunity, to try to solve their own problems.

Village government in itself will not solve all our problems. But village government will shift the responsibility, for their solution, to the shoulders of the people of each village concerned.

Local people would then, for the first time, have the legal right to attempt to work together towards an acceptable solution. The special district absentee form of government would then be a thing of the past.

With village government, our mayor and our village trustees, would all be residents acquainted with the local problems.

With village government our mayor and our Village Trustees, would all be known by us, ac-

quainted with us, living with us.  
With Village Government, our officials would be accountable to us. People in Massapequa would elect their own officials, and we would elect ours. When an official was a poor public servant, we could vote him out of office.

We do not claim that Village Government will be a "cure-all", everybody won't always be happy! But it will return local government to local people. It will take local government from the town and county politicians, and return it to the people where it belongs.

Village Government can cost us more, cost us less, or cost us the same as town government. Its cost depends upon us, the people, and upon those people whom we elect to perform the services we desire.

Under town government the people in one locality cannot control the amount of their taxes or the number of their services. Under Village Government the people in each village can control their taxes, can decide on the number and nature of the local services they want their village to provide.

The democratic process is simple, you must think and act for yourself. When you do—democracy works . . . autocracy falls.
