Two More False Fire Calls At Schools

HICKSVILLE—Three more false alarms of fire, two of them at local school areas, were received by the volunteer fire dept. during the week to make the staggering and alarming total 38 for the year.

Vamps answered a false alarm from the call box at the Lee Ave. School at 11:40 AM on Wednesday, July 28, and another on Monday, Aug. 2 at 3:55 PM from the call box at the Woodland Ave. School in the opposite end of the district.

There also was a false alarm from the automatic alarm device at the Metabab plant on Duffy Ave. at 8:20 AM on Friday, July 30.

Rubbish fires called out firemen to 502 Old Country Rd. on July 29 at 5:02 PM and at W. John St. and Burns Ave. on Sunday afternoon at 1:52.

The volunteers also went to Wm. Carlucci home at 49 Grape Lane on Saturday morning, July 31, at 10:34 for an oil burner and to the Bauchsbaum residence at 35 Basket Lane on Friday morning, July 30 at 10:13 for a washing machine alarm.

School Tax Rate Climbs

HICKSVILLE—The new school district tax rate will be 42 cents higher, an increase of \$16.80 for a home owner with property valued at \$4,000, it was learned today. The Board of Education set the rate at \$3.56 per \$100, Wednesday night, for 1954-55, compared with the current rate of \$3.14. Earlier estimates had predicted a rate of \$3.65. Total valuation of the school district area is now \$59,603,818.

Mailmen Set County Record

Mailmen of the Hicksville Post Office and cooperative community residents set a record for the entire county in the muscular dystrophy collection a few months ago, it was learned this week. Bethpage, for its size, was high in Nassau also.

Hicksville carriers collected \$4,862.08 which was the best for Nassau. By comparison, the City of Albany only reported \$10,708.

Amounts for some Nassau communities in the drive were: Hempstead \$2,404.68, Garden City \$2,038.23, Rockville Centre \$1,790, Bethpage \$1,540.11, Westbury \$2,564, West Hempstead \$1,031, Port Washington \$30.77, Wantagh \$9.26, Bellmore \$5.13, Floral Park \$6.15.

Kids' Play Aids Polio Fund

HICKSVILLE—Nine children from Hillside Terrace section presented a play titled "Alice at the Circus" on Friday, July 30. Admission was six cents and proceeds will go to the polio fund. Money they raised a few weeks ago at a Bazaar they sponsored went to the same cause. The children ranged in age from seven to eleven years. The members of the cast were: Virginia Strickroth, Joan Rodecker, John Archer, Jeanne Archer, Margaret Giles, Clifford Giles, Penny Sinasi, Pam Sinasi, Larry Calucci and Patricia Mirabella. All costumes used in the play were made by the children. Proceeds from both projects were \$4.39.

Use Over 8 Million Gals. Water Daily

HICKSVILLE—The water district, pumping eight to nine million gallons of water daily, is barely managing to keep sufficient supply in the mains for the daily demands plus a "fire flow"; i. e., a supply for fire fighting emergencies.

Residents are again reminded to restrict their watering and lawn sprinkling to odd-numbered days south of Old Country Rd. and to even-numbered days north of Old Country Rd.

HEARING ON BEAN BAG LAW:

Ball Playing In Park Area Divides Hillside Terrace

OYSTER BAY—The public hearing on proposed "anti bean-bag and Sunday ball playing" regulations for park and parking district properties in the Township, here, Tuesday featured an exchange of viewpoints between two factions in Hillside Terrace section of Hicksville.

While there were objections voiced by residents of Locust Valley and Syonset to the general terms of the ordinance, particularly the portion which forbids any type of ball games in park or recreation areas on Sundays, major comments centered about the general use of the playground in Hillside Terrace.

Supervisor Lewis Waters at the opening of the hearing in the packed courtroom of the Town Hall pointed out that the proposed ordinance "has nothing to do with school district properties, or with private or public fields outside of play or park areas in park districts."

A petition of protest against all ball playing at the Hillside playground signed by 28 residents "who live on the perimeter of the field" was presented by Mrs. Yasen of 77 Haverford Rd. She said residents lost the enjoyment of their back yards, have been

Two More Gas Stations Okayed

OYSTER BAY — Approval for two more gasoline service stations in Hicksville was granted by the Town Board this week. Both had been strongly opposed by area residents. Both approvals are subject to the creation of "site-wide zoning" on rear property lines before construction starts, an official said.

The subject of strenuous opposition from the residents of Dove St and vicinity when the public hearing was held, May 18, the Board has approved a new station for the south east corner of Old Country Rd and South Oyster Bay Rd., next to the Jeri-O Diner. The fence is to be erected along the line of Dove St and next to the Diner.

Also granted was the request for the opening of a station on W. John St at the corner of Burns Ave., which had been opposed by the North West Civic Assoc. at a hearing on June 15.

9 Bid On Duffy Ave. Drainage

HICKSVILLE—Work on the installation of drainage on Duffy Ave., here, preparatory to a general improvement of the street, is scheduled to start by mid-August and be completed in 175 calendar days.

Bids on the project were opened by the Town Board, Tuesday morning, and referred to the engineer for study and recommendation. Zara Contracting Co. of Hicksville was the lowest bidder at \$109,840, Lizza and Sons, Inc. of Oyster Bay was second with \$122,734, and Switzer Construction Co. of Glen Cove third at \$123,804. There were a total of nine bids. The engineer's estimate was \$166,580.

The street will be passable to a limited degree during construction.

11,524 At Playground In Week

HICKSVILLE — The Summer Playgrounds, under the supervision of the Board of Education had 11,524 youngsters attend the playgrounds last week. The attendance by days was Monday 2,314, Tuesday 2,188, Wednesday 2,314, Thursday 2,572 and Friday 2,296. Registration continued to go up with a total registration of 4,760. Thursday's attendance of 2,572 was the

highest single day's attendance since the start of the playground six years ago.

This year's attendance exceeded all expectations as the average attendance the year is running about 2,278 while last year the average attendance was 1,275, according to Director Chester Jaworski. The popularity of the playground can be very well indicated by the at-

tendance figures. Woodliss Avenue broke all records for a single playground when 520 youngsters showed up to see the movies last Thursday.

An excellent turnout is expected for this Friday's show. An evening program may be conducted some time during the year.

East St. School—The Playground continues to attract large numbers of children. Arts and Crafts are proving very popular. In baseball, the major leagues are having very interesting games while the minor league is proving so popular that a new team is being added to the league.

Fork Lane School—The Junior group 5-7 years old, worked very hard and produced a half hour variety show. There were four shows which were thoroughly enjoyed by the hundreds of children who saw them. Following the movies on Friday of every week, an amateur show is held. The youngsters are looking forward to these shows and much creditable talents have been uncovered.

Dear Jean:

A Jericho resident has obtained a Supreme Court injunction against "allegedly widespread and unsafe building practice" in the town of Oyster Bay. A temporary order, pending a trial in the Fall, has been signed by Justice HUNTINGTON after ALBERT MECHTOLD of Bulwer Ave., Jericho, brought a taxpayer's action against builders of Roanne Gardens development. Injunction seeks to keep the town building inspector from issuing certificates of occupancy to the builders on claim: they are using "bank run" material in foundations of first home completed, resulting in foundations footings which are claimed to be "unsafe".

While no official decision has been made as yet, there are strong indications the Town Board may approve that Garden Apartment zone change for the north side of Hicksville, adjacent to Princess Ave. . . . Reports of a proposed parking field of some kind on Notre Dame Ave., said to be planned by a private resident, appear unconfirmed. Town officials say there is nothing before them on this. . . . Bank of Hicksville provides its business firm patrons with a unique service. Weekly a copy of "Trends", a business newsletter, is mailed to such depositors.

Section 1. The County of Nassau shall issue its Bond Anticipation Notes of the aggregate principal amount of \$3,575,000, pursuant to the Local Finance Law of New York, in anticipation of the sale of \$3,575,000 Serial Bonds authorized by the Bond Ordinance entitled "Bond Ordinance, dated August 9, 1954, authorizing \$3,575,000 Serial Bonds of the County of Nassau to finance the construction of sewer facilities in Sewage Collection District No. 2-NHP of Nassau County, pursuant to the Local Finance Law and the County Government Law of Nassau County," adopted by the Board of Supervisors on August 9, 1954.

Section 4. The power to prescribe the terms, form and contents of said Bond Anticipation Notes, subject to the provisions of this ordinance, and all powers and duties pertaining or incidental to the sale and issuance of said Bond Anticipation Notes, are hereby delegated to the County Treasurer. The County Executive and the County Treasurer are hereby directed to sign any Bond Anticipation Notes issued pursuant to this ordinance and the County Clerk is hereby directed to affix to such notes the corporate seal of the County of Nassau and to attest such seal.

Section 5. The Clerk of the Board of Supervisors is hereby directed to publish this ordinance in full together with a notice in substantially the form prescribed by Section 1180 of the Local Finance Law. The validity of said Bond Anticipation Notes may be questioned only if such obligations are authorized for an object or purpose for which said County is not authorized to expend money, or the provisions of law which should be complied with at the date of the publication of this ordinance, are not substantially complied with, and an action, suit or proceeding contesting such validity, is commenced within twenty days after the date of such publication; or if said obligations are authorized in violation of the provisions of the Constitution of New York.

Section 6. This ordinance shall take effect immediately upon its adoption.

threatened with bodily injury and property damage, and that only "a select few" get to play baseball while other children are forced to play in the streets.

Objections to the ban on ball playing were also registered by Charles DeShaw of the Hicksville Youth Coordinating Council.

As the hearing closed on motion by Councilman Chlumsky, Waters commented "this is the second time we had a hearing on this. This ordinance gives us authority to regulate these areas and games... gives us the power to carry thru. We will do whatever we feel is best for the town here."

It was learned following the hearing that the Board will probably adopt the ordinance but is considering deletion of the reference to Sunday play.

When the proposed regulation was read, the specific mention of "bean bags" was greeted with a loud gawk from the audience while several board members frowned.

The class of objects or purposes (hereinafter referred to as "purpose"), to be financed by the issuance of such Serial Bonds includes and is limited to the following objects or purposes to be undertaken or completed during or after the year 1954: (1) the construction or reconstruction or widening or resurfacing of public highways designated as county roads of the County of Nassau, whether including or not including the construction or reconstruction of sidewalks, curbs, gutters or drainage, or landscaping or grading, where the pavement thereof is to be of more durable construction than pavement of sand or gravel or water bound macadam or penetration process, and (2) the acquisition of such land as may be required for such purpose.

Section 3. The Board of Supervisors has determined and hereby states that the estimated maximum cost of such purpose is \$2,500,000 and that the Board of Supervisors plans to finance such cost by the use of (1) \$1,172,000 heretofore provided for such purpose either by bond ordinance or by budgetary appropriation, and (2) \$98,000 representing current funds heretofore provided for such purpose by a budgetary appropriation which has not lapsed, and (3) \$1,260,000 to be raised by the issuance of the Serial Bonds hereby authorized. Except as hereinbefore stated no moneys have been authorized to be applied to the payment of the cost of such purpose. Not less than \$125,000 of such maximum cost has been provided by budgetary appropriations which have not elapsed.

Section 4. The Board of Supervisors hereby determines that the purpose for which said bonds are to be issued is described in Subdivision 20 of Paragraph 4 of Section 11.00 of said Local Finance Law and that the period of probable usefulness of said purpose is ten years.

Section 5. PROPOSED ORDINANCE NO. 128, 1954
BOND ORDINANCE, DATED AUGUST 9, 1954 AUTHORIZING \$9,575,000 SERIAL BONDS OF THE COUNTY OF NASSAU TO FINANCE THE CONSTRUCTION OF SEWER FACILITIES IN SEWAGE COLLECTION DISTRICT NO. 2-NHP OF NASSAU COUNTY, VIRGINIA TO THE LOCAL FINANCE LAW AND THE COUNTY GOVERNMENT LAW OF NASSAU COUNTY.

WHEREAS, the Board of Supervisors of the County of Nassau, acting pursuant to and in accordance with Section 1222 of the County Government Law of Nassau County, as amended, has, by ordinance duly adopted on June 2, 1954, established the sewage collection district known as "Sewage Collection District No. 2-NHP of Nassau County" and has, by said ordinance, directed that the sewer facilities described in the general plan referred to in said ordinance shall be constructed in said District, and such sewer facilities are those which are described in Section 2 of this ordinance; and

WHEREAS, the Board of Supervisors desires to provide for the financing of the cost of constructing such sewer facilities; and

WHEREAS, the entire cost of constructing such facilities is to be paid by assessments upon benefited real property in such District and such District has an area less than the area of the County; NOW, THEREFORE,

BE IT OBTAINED by the Board of Supervisors of the County of Nassau, as follows:

Section 1. The County of Nassau shall issue its Serial Bonds of the aggregate principal amount of \$9,575,000, pursuant to the Local Finance Law of New York, in order to finance the specific object or purpose hereinafter described.

Section 2. The specific object or purpose (hereinafter referred to as "purpose") to be financed by the issuance of said bonds shall be the construction of a sanitary sewer system in said Sewage Collection District No. 2-NHP of Nassau County, in accordance with said general plan described in said ordinance adopted on June 2, 1954, including the acquisition of such land or rights in land and the acquisition and installation of such original furnishings, machinery and apparatus as may be required for such sanitary sewer system.

Section 3. It is hereby determined that the maximum cost of such purpose as estimated by the Board of Supervisors, is \$9,575,000, and that the Board of Supervisors plans to finance the cost of such purpose entirely from funds rais-

ed by the issuance of the Serial Bonds authorized by this ordinance, and that no moneys have been previously authorized to be applied to the payment of the cost of such purpose.

Section 4. It is hereby determined that the purpose is one of the objects or purposes described in Subdivision 4 of Paragraph (a) of Section 11.04 of said Local Finance Law and that the period of probable usefulness of such purpose is thirty years.

Section 5. The power to prescribe the terms, form and contents of said Serial Bonds, subject to the provisions of this ordinance and of any other ordinance or resolution hereafter adopted, and all powers and duties pertaining or incidental to the sale and issuance of said Serial Bonds, are hereby delegated to the County Treasurer. The County Executive and the County Treasurer are hereby directed to sign any Serial Bonds issued pursuant to this ordinance and the County Clerk is hereby directed to affix to such bonds the corporate seal of the County of Nassau and to attest such seal. Each interest coupon representing interest payable on such Serial Bonds shall be authenticated by the facsimile signature of the County Treasurer.

Section 6. The Clerk of the Board of Supervisors is hereby directed to publish this ordinance in full together with a notice in substantially the form prescribed by Section 81.00 of the Local Finance Law. The validity of said Serial Bonds or of any bond anticipation notes issued in anticipation of the sale of said Serial Bonds may be contested only if such obligations are authorized for an object or purpose for which said County is not authorized to expend money, or the provisions of law which should be complied with at the date of the publication of this ordinance are not substantially complied with, and an action, suit or proceeding contesting such validity, is commenced within twenty days after the date of such publication; or if said obligations are authorized in violation of the provisions of the Constitution of New York.

Section 7. The County Treasurer is hereby authorized to cause such bonds to be printed and to do such things as may be necessary to advertise the sale of the bonds and to employ Messrs. Reed, Hoyt, Taylor & Washburn, Attorneys of New York City, to furnish to the purchaser or purchasers of such bonds an opinion as to their legality.

Section 8. This ordinance shall take effect immediately upon its adoption.



PROPOSED ORDINANCE NO. 132, 1954 BOND ANTICIPATION NOTE ORDINANCE AUTHORIZING THE ISSUANCE OF \$2,114,000 BOND ANTICIPATION NOTES OF THE COUNTY OF NASSAU IN ANTICIPATION OF THE SALE OF SERIAL BONDS AUTHORIZED TO FINANCE THE CONSTRUCTION OF SURFACE DRAINAGE SEWER SYSTEMS, PURSUANT TO THE LOCAL FINANCE LAW AND THE COUNTY GOVERNMENT LAW OF NASSAU COUNTY.

Be It Ordained by the Board of Supervisors of the County of Nassau, as follows:

Section 1. The County of Nassau shall issue its Bond Anticipation Notes of the aggregate principal amount of \$2,114,000, pursuant to the Local Finance Law of the State of New York, in anticipation of the sale of \$2,114,000 Serial Bonds authorized by the Bond Ordinance...

Section 2. The class of objects or purposes to be financed by the issuance of said Bond Anticipation Notes includes and is limited to the following objects or purposes to be undertaken or completed during or after the year 1954: (1) the construction or reconstruction of, or the construction of additions to, surface drainage sewers established by the County for the purpose of drainage and to protect the property and the public health within the County from floods, freshets and high waters, including dams, culverts, ditches, sluices, and other channels for the passage of water and the deepening, straightening, altering, piping or otherwise improving of streams, ditches, drains, or water courses in order to prevent the overflow of water and so as to provide that they shall carry off such additional water as may be brought to them by other public improvements in the County, and (2) the cost of the acquisition of such land as may be necessary for the acquisition and installation of such machinery, equipment or apparatus as may be required for such purpose.

Section 3. As required by said Local Finance Law, it is hereby stated that (a) there are no outstanding Bond Anticipation Notes issued in anticipation of the sale of said Serial Bonds and (b) the notes authorized by this ordinance are not renewal notes and (c) the notes authorized by this ordinance shall mature within one year from the date of their issue and (d) such notes are not issued in anticipation of bonds for an assessable improvement.

Section 4. The power to prescribe the terms, form and contents of said Bond Anticipation Notes, subject to the provisions of this ordinance, and all powers and duties pertaining incidental to the sale and issuance of said Bond Anticipation Notes, are hereby delegated to the County Treasurer. The County Executive and the County Treasurer are hereby directed to sign any Bond Anticipation Notes issued pursuant to this ordinance and the County Clerk is hereby directed to affix to such notes the corporate seal of the County of Nassau and to attest such seals.

Section 5. The Clerk of the Board of Supervisors is hereby directed to publish this ordinance in full together with a notice in substantially the form prescribed by Section 81.00 of the Local Finance Law. The validity of said Bond Anticipation Notes may be contested only if such obligations are authorized for an object or purpose for which said County is not authorized to expend money, or the provisions of law which should be complied with at the date of the publication of this ordinance, are not substantially complied with, and an action, suit or proceeding contesting such validity, commenced within twenty days after the date of such publication; or if said obligations are authorized in violation of the provisions of the Constitution of New York.

Section 6. This ordinance shall take effect immediately upon its adoption. D667-es8/5

Be It Ordained by the Board of Supervisors of the County of Nassau, as follows:

Section 1. The County of Nassau shall issue its Serial Bonds of the aggregate principal amount of \$2,114,000, pursuant to the Local Finance Law of New York in order to finance the class of objects or purposes hereinafter described.

Section 2. The class of objects or purposes (hereinafter referred to as "purpose"), to be financed by the issuance of such Serial Bonds includes and is limited to the following objects or purposes to be undertaken or completed during or after the year 1954: (1) the construction or reconstruction of, or the construction of additions to, surface drainage sewer systems established by the County for the purpose of drainage and to protect the property and the

The County Executive and the County Treasurer are hereby directed to sign any Serial Bonds issued pursuant to this ordinance and the County Clerk is hereby directed to affix to such bonds the corporate seal of the County of Nassau and to attest the same. Each bond shall represent interest payable on such Serial Bonds shall be authenticated by the facsimile signature of the County Treasurer.

Good News For Coffee Drinkers

A Bethpage resident who drives for Krug Baking Co. miraculously survived the crash of a Thunderjet airplane at Wantagh, Tuesday, and was able to give one of the best eye-witness accounts of the crash.

He is Frank Curley, 26, of 216 Second St., Bethpage, and was standing on the lawn of a home on Denver Rd. within feet of where the plane crashed to earth and burst into flames. He participated in the first rescue efforts.

He told the Herald-Tribune: "I was standing on the lawn at 1861 Denver Road, with a delivery basket on my arm, talking to Mr. Harry Loester. Three of his children were there. I heard the plane high in the air and looked up. I couldn't see it at first but I could see its track. It seemed about 10,000 feet up.

"We went on talking for perhaps two seconds when I heard it make a noise as if it were crashing through the sound barrier. At the same time I looked up. It was coming straight down and I estimate it was going 800 miles an hour. Before I could move, it was right on top of us.

"I sprinted for the rear of the house. Mr. Loester and his children threw themselves on the ground. While I was trying to get away it hit the road and exploded, and a ball of fire rose in the air

and the next thing I knew the flames were scorching my neck and scalp.

"Then I saw that the Loesters were burned and I came back and began helping them and other people who were coming out of the houses after getting knocked around. The doctors treated my burns at the scene. Mr. Joseph, belonging to the Krug Baking Co., was parked eight feet from the crater that stretched across the street. All that happened to the truck was that it had a hole in the roof."

Teen Canteen Wants Vote On Paid Recreation Director

HICKSVILLE—The action of the Board of Education in delaying the school recreation program met with severe criticism from the Teen Canteen executives this week.

Pointing out that the Hutchinson survey on recreation (now being published serially in the Herald) emphasized the need for a school program now, the Canteen board listed six reasons for its stand:

"1. It is necessary to start a recreation program now while our teen population is comparatively small.

"2. Although volunteer groups are to be commended, the lack of a full time professional director is a fatal handicap. The history of

the eight previous groups in Hicksville proves that volunteers cannot operate successfully for any important length of time.

"3. Most volunteers are not adequately trained to work with large groups of teenagers. Because of personality differences there is no consistent pattern of approach.

"4. Very few adults will risk taking part in a program where they can be held financially responsible in case of accident.

"5. A properly run program demands many hours of work and planning, even by professionals. Most volunteers with prior personal obligations cannot devote as much time as the job requires.

"6. Teen Canteen feels that youth centers may be desirable but they are not economically practical. The available neighborhood schools furnish the best facilities for a youth program. Furthermore, the schools are already covered by insurance and a school run program aided by volunteers would not leave any individual open to personal lawsuit in case of mishap.

"For these reasons, Teen Canteen finds itself unable to continue an active program of recreation for the youth of Hicksville.

"However, adult Canteen members have all indicated their complete willingness to cooperate with a school program as soon as it is established."

The Canteen group further urged the School Board to give the citizens an opportunity to vote for a school recreation program.

Canteen And Club Split

The Hicksville Teen Canteen and the Hicksville Teen Club have been two separate organizations since last May. Mrs. William Orton of 24 Acre Lane is head of the Teen Canteen, which has held most of its affairs at Dutch Lane School and Levittown Hall, and Mrs. Edward Kist of 6 Milton St. is head of the Teen Club sponsoring group which holds affairs at Burns Ave. School and the high school, including a dance at the latter place this Saturday night.

The split came regarding the employment of a recreation director. At the time of the separation, Mr. and Mrs. Kist wrote Mrs. Orton: "The majority (of the executive board of the Teen Canteen) publicly favors the appointment of a professional recreation director while we are publicly opposed to such action. The public expression of two opposite ideas from one organization does make for a confusing situation. The only way to clarify the matter is for us to withdraw from the organization of Teen Canteen."

A third youth organization sponsoring events for teens is the Hicksville Social and Athletic Club which includes Irving Mallon and Joseph Byrne as principal adult sponsors. The HSAC has been holding Tuesday night dances at the parking field in cooperation with the Legion Post and splash dances at Levittown Pkway Pool and Hall last Friday night and again this Friday evening.
