Edward Schulter, Long Active Firemen, Dies

HICKSVILLE—Edward R. Schulter, Sr., of 20 Raymond St., former chief of the Hicksville Fire Dept. and long-time member and former captain of Chemical Co. No. 3, died on Saturday at the age of 67. He will be buried this morning (Tuesday) at Plainlawn Cemetery, here, following religious services at Mowen's Funeral Home, E. Barclay St., at 10 o'clock by the Rev. Edward Stammel, pastor of Trinity Lutheran Church.

Ex-chief Schulter was a resident here for 50 years. He is being buried in his uniform as a member of the volunteer fire dept. He was the oldest living ex-chief, serving in 1913 and 1914. He was the 8th chief of the department and his son, Edward R. Schulter, Jr., who is among the survivors, was chief last year. Members of the Fire Dept. and Exempt Fireman's Assoc. attended services in uniform last night (Monday). Masonic services were also held last night.

He is survived by his daughter, Edith Proctor of Huntington; three sons, Edward, Harvey and Henry; two sisters, Mrs. Emma Mack and Mrs. Minnie Sturm, and seven grandchildren. His wife was the late Lillian Puvogel.

OBJECTS TO PRESS RELEASE:

Eirich Supports One-Mile Junior High Bus Proposal

HICKSVILLE—Arthur L. Eirich, member of the Board of Education, today publicly recorded his support of proposition no. 1 in the referendum this Saturday to reduce the distance limitation for transportation of junior high school students to one mile. He also took exception to a publicity release made by President Edna Kuhne Sutton, in the name of the Board of Education, which claims to be neutral but actually, according to Eirich, aims to discourage a favorable vote by alleging higher costs.

The publicity release which was published in the HERALD on Aug. 16, was never submitted to the Board of Education for approval, Eirich asserted.

Emil J. Szendy, another board member, has already taken issue with Mrs. Sutton on the publicity release. He has publicly recorded his support of the Junior High Bus proposition.

Szendy and Eirich on May 20 at a special meeting of the Board of Education which was attended by more than 100 spectators when the entire bus question was studied attempted to have the limitation for junior high bus service reduced to one mile. Their motion at that time was defeated by a 3-2 vote.

"The safety of the children must be a primary consideration rather than feeling against any individual or group of individuals, particularly in our growing community with its vastly increased highway traffic," Eirich told the Herald. "The so-called two-mile limit on Junior High transportation has been a farce since there are those who live less than that distance provided with bus service during the past term.

"If a vote of the district is required to accomplish a more realistic approach to the problem of providing for the safety of small children attending classes, then I am in favor of such proposition. I urge a vote of YES on proposition no. 1 this Saturday, Aug. 21, when the polls are open from 2 to 10 P.M."

583 More

An additional 583 voters registered in Hicksville School District, Saturday, to make the total eligible to cast ballots on five questions next Saturday, 3,952. There were 2,469 previously registered for the annual meeting and election in May.

The ceremony of investiture was held Sunday afternoon at the church. Some of the audience which exceeded the capacity of the church were seated in the church yard and heard the ceremonies over loudspeakers. Msgr. Bittermann, as dean of Central Nassau, has limited jurisdiction over 23 Catholic parishes. This is the first picture of the new monsignor in his robes. Bishop Thomas E. Molloy of Brooklyn, informing Msgr. Bittermann of his official designation by the Pope, wrote: "This ecclesiastical honor is bestowed in recognition of your notable priestly zeal in promoting the sanctification of souls and of your very faithful devotion to the advancement of works of religion, education and charity."

Plainview Couple Hurt In Upstate Collision



757 Students From 49 Schools Go To Classes Here During Summer

HICKSVILLE — The fifth year of the Summer High School here will close the fourth week in August. The final examinations and the August Regents examinations will be held Aug. 23rd, 24th and 25th.

The first summer session had over 800 students registered. The second summer session had over 400 registered. The third session had approximately five hundred registered. The fourth session had five hundred and forty-five registered.

The registration this summer exceeded all expectations. Seven hundred and fifty-seven students have registered from 49 different schools. The growth has been most gratifying. A number of the stu-

dents are taking subjects in which unsatisfactory work was done during the past school year. A surprisingly large number of students are taking accelerated courses, according to Mabel R. Parley, principal.

Three hundred and thirty-three of the students are from Hicksville, many of whom are taking accelerated courses. Fifty-five of the students come from Robert L. Simpson High School, Huntington. Fifty-two students are from Levittown Memorial High School. Forty-eight of the number registered come from Weldon E. Howitt High School, Farmingdale. Thirty-six students come from South Huntington High School. Thirty students come from St. Dominic's High School.

Also twenty eight students come from Westbury High School. Nineteen students come from Bethpage. Thirteen students come from Oyster Bay High School. Hempstead High School has ten students. We have eight from Glen Cove High School and seven from Northport High School.

What Happened To Fluoridation

To the Editor:

I am wondering what has happened to the proposed suggestion that fluorine be added to the drinking water of Hicksville.

Last year at one of the PTA meetings at East St. School the subject was presented and thoroughly discussed. I was under the impression all the other PTA meetings were discussing this subject also. I also seem to remember reading something about it in your paper afterward. But to my knowledge we still do NOT have fluorine in the water. Why?

I've just been taking our five children to the dentist. They have inherited "soft" teeth and the dentist has suggested fluorine treatments. At \$12 a treatment, that is \$60 for five children for fluorine

treatments without having any of the many cavities each has filled.

No one needs to tell any parent how difficult it is to make ends meet nowadays. Yet, if we had fluorine in the water, these treatments would be unnecessary and the \$60 could go toward the payment of having the existing cavities filled.

Are there not many other parents who are concerned enough about their children's teeth and about saving money to urge the town officials to take the steps necessary to get fluorine into Hicksville's Water Supply?

I shall be looking forward to more articles on this subject in the next publications of the Mid-Island Herald.

THE MANY FRIENDS of the Rt Rev Msgr George M. Bittermann, VF, pastor of St. Ignatius Loyola R C Church of Hicksville for nearly a quarter century, will join tonight (Tuesday) in honoring him at a reception and dance at the St. Ignatius School marking his elevation to the dignity of Domestic Prelate.

The friends of Father Bittermann, both members and non-members of his vast congregation, recognize that a high honor has been bestowed upon him and indirectly upon the community of which he has been an outstanding citizen for so many years.

The explanation of the Domestic Prelacy conferred upon Rt Rev Msgr Bittermann is worthy of detailed mention.

"The Domestic Prelacy", we are informed, "belongs officially to all Archbishops and to Bishops Assistant at the Papal Throne, as well as to a number of Vatican officials. By special letter of the Sovereign Pontiff, issued by his Secretary of State, it is also bestowed upon individual clergy who have rendered distinguished service. Clerics so honored are given the title 'Illustrious and Right Reverend', to which 'Monsignor' is usually added.

"The origin of this Prelacy is lost in the past. During the 14th century, when the Popes resided at Avignon, certain officials residing in their palace were known as 'Praelati Domus'. A document dated Feb. 13, 1554, during the Pontificate of Pope Julius III, indicates that in those days certain other clerics, in addition to those actually residing in his palace, were numbered among his Domestic Prelates. It is this group which must be regarded as comparable to our present dignitaries", we are told.

"Today there are over 4,000 Domestic Prelates in the various diocese of the Catholic Church. Created for the duration of their lives, their privileges were listed by Pope Pius X on Feb. 21, 1905, outstanding of which is the right to wear the violet garb distinctive of prelate and the use of a special candle called 'Palmatoria', when they celebrate Mass with solemnity.

"For Domestic Prelates not actually serving at the Vatican, their Prelacy is a sign of the Holy See's favor rather than an assigned office with concomitant obligations. It makes them honorary members of the Pope's household and entitles them to have their names listed individually in the official 'Annuario Pontificio' which is issued yearly by the vatican".

We feel certain the entire community joins in this prayerful salutation to Rt Rev Bittermann, written by Bishop Thomas E. Molloy of Brooklyn on June 1 of this year when his designation as a Domestic Prelate was announced:

"Permit me to extend to you most cordial felicitations in recognition of this well merited distinction which you have received from the Supreme Pastor of Christendom. I desire also to express the prayerful hope that you will be favored with future years of divine blessings and aid in your priestly labors so as to realize a rich spiritual fruitage in your holy ministry and merit divine approval and reward in time and eternity".

Q. How much of the taxpayer's share of entertainment expenses is deductible?

A. In a recent decision the Tax Court unanimously held that only that portion of the entertainment outlay for yourself which is different from or in excess of the amount you would ordinarily spend on yourself or your family is deductible. Now, in order to have a right to establish the expense so as to have been helpful, usual, or necessary, you must also show how much of your share is in excess of any nondeductible personal expenditure.

For example: Suppose that you take a customer to lunch and the bill is \$9.00 or about \$4.50 each. How much of the \$9.00, if any, is

deductible? Well, according to the decision a part is deductible. The Tax Court agrees that a restaurant or similar establishment is a usual place for business men to meet for congenial discussion. Now, then, how much should you deduct? If you can prove that you usually spend about \$2.00 for lunch you would probably be entitled to a deduction of \$7.00. Formerly, you undoubtedly deducted the \$9.00.

Gov't. 'Lukewarm' To School Aid

WASHINGTON—The administration is "lukewarm" to two principal proposals before Congress on further direct Federal Aid to school construction it was reported this week by Congressman Stuyvesant Wainwright, U. S. representative for the mid-Island area of Nassau and Suffolk County.

The progress of pending legislation on Federal school construction aid is of keen interest to mid-Island school districts.

Congressman Wainwright reported on Monday:

"The President of the United States was asked at his last week's press conference to state his position on direct Federal Aid to school construction. He referred the matter to his Secretary of Health, Education and Welfare, Mrs. Hobby. She, in turn, was lukewarm to the two principle proposals before the Congress. One proposal would cost five billion dollars, (the Kearns bill) while, the other, a temporary measure, would cost two hundred and fifty million (the Frelinghuysen-Cooper bill).

Here is the problem: Somewhere in the neighborhood of 340,000-305,000 classrooms are needed in the United States. The construction cost would be between ten and twelve billion dollars. Nobody familiar with the situation in Nassau and the eastern end of Suffolk County can deny the tragedy of our own situation. There just are not enough school rooms, to cover the needs. The school district, even with increased state assistance, have been unable to fill the requirements caused by the tremendous inwell of population in specific areas.

"Here is the dilemma: The local school districts, with state aid, raise the money, build the schools, and hire the teachers. Most school boards are, basically, opposed to state interference much less intervention by the Federal government. Yet if a local school district in these needy areas fulfill the money raising requirements within the district, or even the towns, the tax rate would at once jump to an intolerable level. In fact, the local citizenry just could not support the additional taxation. It was this that forced school districts to go to the states for aid. Must they now go to the Federal government?

"The grave danger, of bringing the Federal government into the picture is the ultimate possibility of Federal control of education at the pre-college level," Wainwright said. "For example, in Hitlerite Germany youth was moulded into the proper frame through the Third Reich's control of the schools. Today in Soviet Russia the evil of Communism is perpetuated in that all schooling, all teaching is centrally controlled not only from Moscow, but by the Communist Party itself.

The tract extends from South Broadway, Hicksville, to Bloomingdale Road, Levittown, and is opposite Grumman Aircraft Corp. plant. The road frontage is part of the new North-South Expressway which will connect with the Long Island Expressway.

Lauman states that due to the tremendous influx of new residents there is a labor market in the vicinity unequalled anywhere in the East. In the last five years the population within a radius of ten miles of the tract has increased from 300,000 to 1,200,000—an increase of 300%. Lauman proposes to have on the site a day nursery to take care of children for working mothers.

Fewer Polio Cases This Year

MINEOLA—Basing estimates on conditions at this particular date, it appears possible that Nassau County will have one of the lightest poliomyelitis case loads since 1947 when the total was 27, according to predictions of Dr. Joseph H. Kinnaman, acting health commissioner.

"How many new cases of poliomyelitis will be reported in Nassau during the coming months can not be predicted with mathematical precision, because this disease is tricky and baffling in its rise and fall," said Dr. Kinnaman.

"However, conditions at the present date are encouraging. For instance, cases have been reported thus far this year in 17 communities while 26 was the average low during the past five year period. Also, our case load of 26 on this date is only about 44 percent of the average total on this date over the past five years."

There have been 26 cases reported this year against 44 on Aug. 11 last year. Levittown leads all other communities with 4 reported cases. Plainview has two and Bethpage one. There have been none in Hicksville.
