Plans Raising Or Lower Track Level Subject Of Next Hearing On Feb. 14; Chamber Elated With Progress Made

NEW YORK CITY—The elimination of six and possibly seven rail road grade crossings in Hicksville, which have been the object of concentrated civics' effort and motorists' anger for nearly 20 years, today appeared destined for accomplishment within a reasonable period of time. Chamber of Commerce leaders and other interested Hicksville citizens were elated with the outcome of a public hearing before Examiner Sanders Schwartz of the Public Service Commission, here Wednesday.

While it was realized that a great deal must still be done by various branches of state and local government before the eliminations will become a reality, all concerned expressed themselves as well-pleased with the initial stage of the proceedings.

Examiner Schwartz, at the conclusion of the four-hour hearing confided that there appeared to be little question that the requirements of "public safety and convenience" had been conclusively established.

He set Monday, Feb. 14, as the date for a continuation of the hearing. At that session, study plans will be submitted. The township, county, state dept of public works and Long Island Rail Road will work together in the development of the study plans and surveys.

The February hearing will be the final stage before the drafting of contract drawings and specifications. At that session, the questions of whether the crossings will be raised above the highway or lowered is to be determined.

A vast amount of statistical data on the Hicksville grade crossings was submitted and entered into the record.

Ralph Holloway, bridge engineer for Dist 10, New York State Dept of Public Works at Babylon, submitted a memorandum of more than 100 pages covering the six crossings: Jerusalem Ave., Broadway, Marie St., Nicholas St., Old Country Rd and Barclay St., Hicksville.

Under examination by Edward J. Ramer, engineer of the State Dept of Public Works representing E. W. Wendell, deputy chief engineer of the Dept of Public Works in charge of grade crossings, the state also submitted data on Bethpage Rd crossing as a possible seventh, crossing to be eliminated.

During the hearing, Assemblyman John J. Burns in addressing Examiner Schwartz complimented the Dept of Public Works for its foresight in submitting the additional data.

Crossing Delays Wastes \$260,000 In Gas Annually

NEW YORK CITY—An estimated \$260,000 worth of gasoline is consumed and wasted by motor vehicles impatiently waiting at six LIRR grade crossings in Hicksville during the year, it was brought out at the PSC hearing, here, Tuesday.

A survey of traffic conditions, prepared by Briganti and Crachi in the direction of the Oyster Bay Town Board and introduced in evidence, reported that during a 16-hour period in July from 7 AM to 11 PM, it was found traffic flow was interrupted and delayed for a total period of 8.6 hours. The delay was caused by the passage thru Hicksville of about 80 trains per day on the LIRR. Estimating that about 7,000 vehicles are interrupted at the six crossings for periods from a half minute to seven minutes, the report states this represents "approximately \$260,000 a year in gasoline consumption.

During the 16-hour period, it was found that 49,600 vehicles passed over the six Hicksville grade crossings.

FOCUS ON JR HS BUS:

District Votes On 5 Questions, Saturday

HICKSVILLE—With over 3,000 adults eligible and registered to vote this Saturday, Aug. 21, at four schools in the district between 2 and 10 P.M. on five questions, Community interest is focused upon Proposition No. 1 which involves the transportation of junior high school students living a mile or more from the Jerusalem Ave. building. It is anticipated, under the law, that 7th and 8th parochial students living a mile or more from St. Ignatius School will also receive bus service.

Voting will take place at Burns Ave., East St., Old Country Rd. Schools and the High School. Official results will be announced by the Board of Education at the high school after the polls close at 10 o'clock. Results may be obtained by phoning the special Herald phone at Hicksville 3-0348 after 10:30 P.M.

While there has been apparent differences of opinion among Board of Education members on the manner in which the bus question was presented to the community, the Board acted at a special

meeting, Tuesday night, as if the results of the referendum are a foregone conclusion.

Board members met for the first time with Max Wilton Cheney, newly appointed transportation administrator of the district, and discussed fine points of the one-mile service.

Cheney presented a map indicating the exact one-mile distance from Junior (and Senior) High School. Since the mileage in some cases came to a point in the middle of a block, a motion was made by Richard Schoel and unanimously (Continued on Page 6)

HOLD OUT OLD COUNTRY ROAD SCHOOL:

Open Bids For 3 School Additions

HICKSVILLE — Bids received for the construction of additions to three 10-room elementary schools of the district—with the fourth school, Old Country Rd., withheld from bidding—appear to be well within the architect's budget for the work, today.

Bids were opened during a two-hour session on Tuesday night for the additions to the Burns Ave., Dutch Lane and Fork Lane Schools. Old Country Rd. was withheld so that it can be made the subject of a special application for Federal construction aid.

School Architects Knappe & Johnson are now studying the bids and are expected to make their recommendations to the Board at a special meeting next Monday night. It was tentatively indicated that bids, including desirable alternates, upon general construction, heating, ventilating, plumbing and electrical work may be about \$50,000 under the architect's budget or about \$1,600,000 for the three buildings.

There were 13 general contracting bidders with Arthur Koch of Huntington apparently the low bid-

der. It was a long six-hour session for the Board of Education, Tuesday night. After more than two hours devoted to opening and reading the bids in the East St. School cafeteria for with an audience of more than 100 representatives of bidding concerns, the Board went into other business of the district after 11 o'clock at night and finally adjourned at 2 A.M.

LEGAL NOTICE

PROPOSED ORDINANCE

BOND ORDINANCE, DATED AUGUST 23, 1954, AUTHORIZING \$120,000 SERIAL BONDS OF THE COUNTY OF NASSAU TO FINANCE THE IMPROVEMENTS REQUIRED FOR THE ELIMINATION OF GRADE CROSSINGS, PURSUANT TO THE LOCAL FINANCE LAW AND THE COUNTY GOVERNMENT LAW OF NASSAU COUNTY.

Be It Ordained by the Board of Supervisors of the County of Nassau, as follows:

Section 1. The County of Nassau shall issue its Serial Bonds of the aggregate principal amount of \$120,000, pursuant to the Local Finance Law of New York, in order to finance the class of objects or purposes hereinafter described.

Section 2. The class of objects or purposes (hereinafter referred to as "purpose"), to be financed by the issuance of such Serial Bonds includes and is limited to the following objects or purposes to be undertaken or completed during or after the year 1954: the acquisition, construction or reconstruction of or addition to bridges or underpasses necessary to permit streets, avenues, highways or roads to pass over or under railroads, whether or not including the acquisition of land or rights in land and whether or not including retaining walls or approaches to such bridges or underpasses, where the material to be used in making said improvements is stone, concrete or steel or a combination of two or more such materials. The funds raised by the issuance of said bonds shall be used solely to finance the portion of the cost of such purpose which is required to be borne by the County under the provisions of Section 94 of the Railroad Law.

Section 3. The Board of Supervisors has determined and hereby states that the estimated maximum cost of such purpose is \$663,000 and that the Board of Supervisors plans to finance such cost by the use of (1) \$535,000 heretofore provided for such purpose either by bond ordinance or by budgetary appropriation, and (2) \$7,000 representing current funds heretofore provided for such purpose by a budgetary appropriation which has not lapsed, and (3) \$120,000 to be raised by the issuance of the Serial Bonds hereby authorized, and (4) not less than \$33,150 of such maximum cost has been provided by budgetary appropriations which have not lapsed. Except as hereinbefore stated no moneys have been au-

thorized to be applied to the payment of the cost of such purpose.

Section 4. The Board of Supervisors hereby determines that the purpose for which said bonds are to be issued is described in Subdivision 10 of Paragraph a of Section 11.00 of said Local Finance Law and the period of probable usefulness of said purpose is twenty years.

Section 5. The power to prescribe the terms, form and contents of said Serial Bonds, subject to the provisions of this ordinance and of any other ordinance or resolution hereafter adopted, and all powers and duties pertaining or incidental to the sale and issuance of said Serial Bonds, are hereby delegated to the County Treasurer. The County Executive and the County Treasurer are hereby directed to sign any Serial Bonds issued pursuant to this ordinance and the County Clerk is hereby directed to affix to such bonds the corporate seal of the County of Nassau and to attest such seal. Each interest coupon representing interest payable on such Serial Bonds shall be authenticated by the facsimile signature of the County Treasurer.

Section 6. The Clerk of the Board of Supervisors is hereby directed to publish this ordinance in full together with a notice in substantially the form prescribed by Section 81.00 of the Local Finance Law. The validity of said Serial Bonds or of any bond anticipation notes issued in anticipation of the sale of said Serial Bonds may be contested only if such obligations are authorized for which said County is not authorized to expend money, or the provision of law which should be complied with at the date of the publication of this ordinance are not substantially complied with, and an action, suit or proceeding contesting such validity, is commenced within twenty days after the date of such publication; or if said obligations are authorized in violation of the provisions of the Constitution of New York.

Section 7. The County Treasurer is hereby authorized to cause such bonds to be printed and to do such things as may be necessary to advertise the sale of the bonds and to employ Messrs. Reed, Hoyt, Taylor & Washburn, Attorneys of New York City, to furnish to the purchaser or purchasers of such bonds an opinion as to their legality.

Section 8. This ordinance shall take effect immediately upon its adoption.

School Tax Rate Goes Down For Second Year

PLAINVIEW—The Board of Education today announced the tax rate for 1954-55 as \$2.77 per \$100 of assessed valuation, a reduction of 75 cents per \$100 from the all-time high of two years ago. The reduction is the result of a sharp increase in assessed valuation of the district which rose in one year from \$9,200,000 to \$16,000,000, according to John Dowling, School Board president.

The new rate marks the second reduction in the school tax in the past two years. It was 2.62 per \$100 two years ago and \$3.165 last year.

It is also one of the lowest rates in the mid-Island area. The Herald reported on Tuesday that rates in Hicksville, Island Trees and Bethpage will all exceed \$3.00 per \$100 next year.

"The reduction is also due to the institution of budgetary planning some time ago," Dowling added. The Board of Education announced

the appointment of three people to its administrative staff. Arthur Bunce, formerly of Bethpage, will be principal of the Plainview-Jamaica Ave. Elementary School when it opens next month; Mrs. Irma Miller, has been named principal of Mannetto Hill School; and Fred Karpman, assistant to the principal at Mannetto Hill School. He has been a teacher in the system for the past two and a half years.

John Brooks continues as principal of the Central Park Rd. School. Robert Tuttle is district principal.

The district office is now located in the Plainview-Jamaica Ave. School which will have its dedication on Aug. 29.

I have been spending a great deal of time at Asbury Park, New Jersey, lately, since my wife was vacationing there; and I must relate an experience I had a week ago. It is interesting to note that while all of this is going on everyone claps in rhythm to the music.

One of the unusual customs I noticed is that when someone is dancing they approach someone sitting at a table and dances to them, at which that person rises and dances with the group. Since most of the dancing is done by the audience, my wife, May, got up on the floor, too, and I danced with my mother-in-law, Malakie, in my best anglo-Lebanese manner. The entire affair was so complete that they even served mazah, which is traditional with good times. Mazah

is the food that is served when good friends get together—such as kibbi (lamb and wheat), baba kannah, (egg plant salad), homus, (chick peas with sauce, salads, olives, cheese, etc.) At the affair we met several teen agers from Palestine who were pleased to see the near East customs right here in our country.

 was John Solarzski of Rockville Centre engineer for the L.I.R.R. who gave data on crossing accidents in Hicksville from 1938 to 1954.

Witness for the Town of Oyster Bay was Theodore Briganti of the consulting engineering firm of Briganti and Crachi of Westbury which had prepared a special grade crossing traffic survey in the Hicksville area for the Township this month.

Briganti was examined by Robert Glasser, deputy town attorney, and a great deal of data on blockading of crossings by the present arrangement was entered into the record.

SPEAKS FOR PEOPLE

Also commenting for the record at the hearing were Councilman Frank Chlunsky of Hicksville who said he was speaking "for the people" as their elected representative. He said that for ten years the grade crossing situation in Hicksville has been recognized by him as "critical".

Walter G. Staackler of Staackler & Frank who are building the Mid-Island Shopping Plaza on North Broadway spoke and submitted plans for their huge shopping centre. With 900,000 square feet of selling space scheduled in the Plaza, he said a lease for 200,000 sq ft is now awaiting attorney action on the leasing and an opening for this big store is anticipated for the spring of 1956.

The Shopping Plaza, he estimated, will daily put 12,000 cars of shoppers across the Hicksville crossings.

CHAMBER ON RECORD

Attorney Michael Sullivan appeared for the Chamber of Commerce and submitted a written memorandum. Albert Schachner, Chamber president, spoke for the record as well as Attorney Aaron L. Rochman, appearing in behalf of several business clients in

Hicksville. No objections to the proposed eliminations were voiced at the hearing.

At its conclusion Examiner Schwartz said "it can be safely assumed that this matter will be favorably received" by the State Public Service Commission.

The importance of community agreement on raising or lowering the tracks was stressed at the end of the hearing. A spokesman for the county said that disagreement

on such details had probably delayed the progress of elimination for Freeport-Baldwin area.

There were a number of letters and communications from civic groups and individuals on the record of the hearing, Schwartz announced.

About 60 persons were present for the hearing held in the Woolworth Building at 233 Broadway, here. The hearing opened at 10 o'clock in the morning and concluded after 1 P.M.

 line carried that the transportation on his map for the one-mile limit be "strengthened to include areas well defined by street intersections" or corners.

The board was in complete agreement that the one-mile measure should be made "liberally" so that at some points school bus stops may be "a little less than a mile from junior or senior high."

Cheney was directed to prepare a new map, based upon the newly adopted policy.

OFFICIAL MEASURE

There was considerable discussion about the accuracy of the "measuring device" used to calculate the mileage. It was finally decided, upon motion by Joseph Cawley, that Cheney's 1950 Dodge be used "as the official measuring instrument of the district for the year 1954-55". When it developed that Cheney's speedometer, which he had had checked by Omar Bros. of Hempstead on Aug. 14, is running 158 feet long on a mile (ie, reaching a mile 158 feet further than an official mile), the board authorized Cheney to have a special meter put in his car.

The meter, Cheney said, will cost \$44. The vote of approval was unanimous and Cheney commented: "This takes a big burden off my shoulders."

Questions before voters on Saturday are (1) One mile limit for junior high transportation—it is now two miles, (2) one mile transportation for senior high—now two miles, (3) renovations in Nicholas St. School building, (4) installation of a folding partition in the high school gymnasium, and (5) authority to dispose of 300 unwanted students' desks.

Sharpening interest in question No. 1 is the case of Robert Conlin of 29 Lehigh Lane who last term kept his children home from Junior high school when they were refused transportation. He claimed his home is 1.8 miles from the school and that students living 1.5 and 1.3 miles from the building were being transported.

More than 300 of the additional 583 voters registered last Saturday reported at East St. School indicating the interest in the proposed questions in that voting area which includes Hillside Terrace, Conlon's neighborhood.

Doctor Jones Says

By PAUL R. BROOKS, M.D.

Did you ever stop to think how ideas about hearts have changed, over the years? From Bible time: "... the modifications of my heart... a clean heart." It was the seat of thought and conscience. That's about the way it was 'til the English doctor, William Harvey, in the early sixteen hundreds, produced some "inside information" on the circulation. The heart; that indicated, was a pump, not a thinking organ.

A pump so efficient that no pump manufacturer has yet been able to equal it. Something I was reading (Yes, Science News Letter. You're right): a normal adult heart, each day, pumps nine to ten tons of blood through miles of blood vessels. It doesn't do it without rest. Someone's figured, they said, that it's normally pumping only eight hours out of each twenty-four.

In spite of its wonderful efficiency it does, sometimes, get out of order. Occasionally one is defective from the start. There're many kinds of heart disorders. But three, they've determined, account for around 90 per cent of the cases. One, coronary heart disease, comes from trouble with the coronary arteries. They supply blood to the heart muscle. Another is connected with long-continued, excessively high blood pressure.

The third is rheumatic heart disease. That's a leading cause of death between the ages of five or nineteen. It follows rheumatic fever, and that usually follows attacks of streptococcus sore throat. Rheumatic heart disease is a good example of one that may be prevented. Modern, effective treatment of streptococcus infections surely is preventing a lot of 'em. Most heart conditions can be helped by proper attention. Incidentally, not everyone that thinks he has heart disease really has.

One comforting thing about heart disease: Most heart patients, under competent supervision, can continue working. As a heart specialist told an industrial medical group, work doesn't cause heart disease. If it's work they're accustomed to, it usually isn't detrimental.

Finally (This is slightly corny—but it's true) few people're indispensable; hearts aren't trumps; but, to keep folks living, hearts are indispensable pumps.

County To Get Bids On Jail

MINEOLA—The County Board of Supervisors here will receive bids on Sept. 28 upon the new Nassau County Jail to be built in the rear of Meadowbrook Hospital, East Meadow, at a cost of about four million dollars. The new jail will be erected on the jail-farm site north of Hempstead, adjacent to Carmen Ave.

The Supervisors will set a public hearing on Sept. 27 on land acquisitions for improvement of South Oyster Bay Rd from Plainview Rd to Woodbury Rd., Hicksville, and from Woodbury Rd to Northern State Parkway, also Hicksville. On the average it is proposed to slice about four feet from front yards along the highway, a spokesman said yesterday.

Best Time Of The Year

For a great many of us summer is the best time of the year. Except for the few dog days such as we have had during the last week, the warm weather is very easy to take. But there is such a thing as carrying this temperature business too far. For instance, the temperature on the Mid-Island Railroad cars during the evening is more than people should be asked to take. We haven't any measurements on it, but it sure seems to be way above 100 degrees.

What Can Be Done?

It seems that the cars sit in the yards in the glaring sun all day long with the windows shut tight. No wonder they feel like furnaces at 5 o'clock! The windows are closed as a matter of policy, we suppose, in case it rains. Of course, it hasn't rained hardly at all this summer, but that doesn't seem to make much difference. The windows still stay shut and the cars become furnaces. Several things can be done to alleviate this aggravating condition. First, the railroad officials might check the weather bureau each day for possibilities of rain just as many other commercial enterprises do. Or they might hire their own private weather prognosticator. Second, they would do well to paint the cars a light color to reflect the sun's rays and prevent the temperature from building up inside.

Raceway Sets The Pace

The L.I.R.R. would do well to emulate the Roosevelt Raceway in so far as their operations depend on the weather. Whatever else may be said about the Raceway, they have shown that it is practical and reasonable to maintain a private weather station to work in conjunction with the government weather bureau. Our neighbor, Frank Curran of Abbot Lane and woolly bear caterpillar fame, has been predicting the weather at the raceway for a long time now and hitting it on the nose every time. We would venture to suggest that the L.I.R.R. and Mr. Curran get together and make a deal. Then all the car windows could be left open most of the time and they would be comfortable when the commuters pile in.

Light Color Would Help

Those of us who have light colored cars know how cool the trunk is even after many hours in the sun. It is little short of amazing how much good a light color does. The same principle applies to railroad cars. Besides making the cars more comfortable, the light colors might even be more attractive to the eye. It would be a big help in its rehabilitation program, the L.I.R.R. applies light colored paint to all of its passenger cars. And also, we hope that the new cars that they are planning to order just as soon as the bankruptcy proceedings are vacated, will be either stainless steel or painted a light color.

"Dog Days" Are Here - Authorities Give List Of Precautions To Be Taken

County Health Dept. reports step on paws, pull tails or other bite cases have increased by wise abuse dogs. Don't interrupt dogs when they are eating. Don't snatch bones away. If you have two dogs, pet both equally. Dogs are jealous, too. Don't stop dog fights with bare hands. Water is better, if available. Be careful of an injured dog. Pain makes them snarl.

The Health Authorities have stressed the urgency of getting a description of the offending dog so that it may be picked up, and they have also emphasized the necessity for obtaining prompt medical attention for face and head bites, as well as for any dog bite where the skin has been broken. However, a few words on how not to get bitten should be useful, and here's what breeders and kennelmen say in part:

DOG—DON'T'S

Don't pet strange dogs. If you must, extend your closed fist slowly—not your open hand—and let the dog sniff. "Dog days" are in August. Be cautious this month. Don't let children maul, kick, or ring more than he does on eyes.

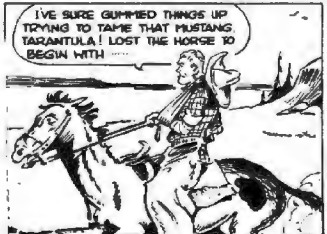

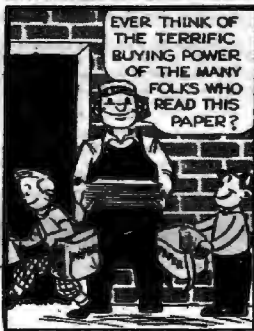

Suggestions For Dog Motoring

In the earlier days when motoring was a daring adventure, the problem of dogs and automobiles was pretty much one sided. Dogs regarded the sputtering, noisy vehicle as a kind of canine public enemy number one. But today millions of dogs enjoy this means of transportation. And this change has wrought serious problems for the dog-owner, especially if his dog does not have proper motor manner, warns Raymond J. Hanfield, executive secretary of the National Dog Welfare Guild.

To be sure that your dog will be a pleasure to have along on your vacation and not a nuisance, Hanfield sets forth several rules for dog-owners.

When preparing for the trip, be sure to pack your dog's collar and leash, his brush and comb, and most important, his feeding dish. His favorite toy will help relieve the tedium of the drive.

The dog-owner's first problem is apt to be his dog's car sickness. Unless the dog is an experienced traveler, withhold food and water for at least several hours before starting out. Should your dog be prone to car sickness, a veterinarian can provide any one of several good preparations.

Don't let your dog move from one seat to another, but train him to ride in one place. If you aren't sure he will be quiet, it will be

safest to fasten him securely on a leash to prevent him from leaping out the window.

Don't let him bark out of car windows. And although it looks very sporting, don't let him stick his head out the window. It is a dangerous practice. The dog may easily get something in his eye and the wind is bad for both his eyes and ears.

If he must be left alone in the car, be sure it is in the shade with one or two windows partly open. And remember that although the car may be in the shade when you park it, it may be exposed to the sun an hour later.

If you observe these rules, your dog will enjoy his trip . . . and so will you.

Three Other Recommendations

(Sixth of a Series)
The three remaining recommendations of the Hicksville School District Recreation Survey prepared by Dr. John Hutchinson of Columbia at the direction of the school board covers development of recreational use, adoption of a policy by the School Board to allocate facilities and areas, and formation of a citizen recreation council.

Six recommendations, starting with employment of a professional director of recreation, have been published in preceding articles of the series.—Editor.

The recommendations continue:

Recommendation VII: The areas surrounding the new schools should be developed for recreational use.

School District #17 has shown great foresight in purchasing excellent areas for the schools. Although some very fine improvements have been made, this project should continue until all areas are suitable for varied recreational use.

Areas for softball, volleyball, basketball, tether ball, circle games, soccer, field hockey, shuffleboard, horseshoes, handball, and other outdoor games should be designed. Once the grass turf attains maturity the problem of maintenance should be rather

small. To have an appreciable amount of these areas developed would mean a waste of resources and actually short-sighted planning.

These areas will prove most valuable for the regular school program, the after school recreation program, and the summer recreation program. Further, adult groups and post school youth could use these areas for their league games and informal recreation activities.

Recommendation VIII: A policy or policies should be adopted by the School Board of School District #17 for allocating facilities and areas.

With the additional new gymnasiums, improved areas, and an expanded program the equitable allocation of space to groups will become a rather large task. Unless the recreation director can schedule these facilities and areas with regard to the total community program, he will be unable to coordinate the activities to the advantage of all concerned.

Any policy adopted should be developed with the concept that regularly scheduled educational functions receive priority. Also, it follows that school personnel should plan for the use of areas and facilities early enough each year to give the recreation director freedom to meet the requests of the groups who also need school facilities and areas for recreation purposes.

Recommendation IX: A citizen recreation council should be formed in School District #17.

The school board should sponsor a voluntary recreation council which would be formed of representatives from various organized groups in the community as well as interested lay citizens. Such a council would have no legal authority.

This council could accomplish some of the following purposes for recreation:

1. Interpret the recreation program to the rest of the citizenry.
2. Keep abreast of the changing recreation needs and conditions of School District #17.
3. Experiment with and sponsor recreation activities for the District to either prove or disprove their value as necessary additions to the overall program.
4. Serve in an advisory capacity to the recreation director and the school board.
5. Insure that recreation continues as a community recreation venture which is aimed to meet the needs of all groups.
