# School Days Resume For 14,000 Sept. 8

Mid-Island schools will open their doors for the fall term on Wednesday morning, Sept. 8. More than 14,000 boys and girls will be reporting for classes in Hicksville, Bethpage, Plainview and Jericho. Three new school buildings will be in operation for the first time. A fourth building—Woodland Ave. School in Hicksville—opened at the end of the term, last Spring.

The new schools are Pine Ave in Bethpage for elementary pupils, Trinity Lutheran School in Hicksville housing the kindergarten thru the 8th grade, and Plainview-Jamaica Ave. School in Plainview where the first junior high program in the history of the community will be offered.

Dedication of the Plainview-Jamaica Ave. building is set for this Sunday, Aug. 29, with exercises starting at 3 o'clock, followed by inspection. All community residents are cordially invited. Dr. Edward J. McCleary, superintendent of East Meadow Schools, will be dedication speaker.

An open house and registration of new students will take place at the Trinity Lutheran School in Hicksville on Tuesday, Sept. 7, from 9 A.M. to 4 P.M. and from 7 to 9 P.M. Richard Engbrecht is principal of the school which taught 168 pupils in the kindergarten to 4th grade last term.

The new Lutheran Church has 256 students enrolled in the kindergarten thru 8th grade. All classes will be on full-time sessions except the morning and afternoon kindergartens. A lunch program will start on the first day of the new term in the brand new building on Nicholas St.

**7500 IN HICKSVILLE**  
Ten Hicksville Public Schools in nine buildings are expected to start with an enrollment of 7,500, an increase of about 500 over the registration last term, according to Dr. E. H. LeBaron, superintendent of schools.

There are more than 300 teachers on the faculty including 77 additions and replacement in the staff. Added to the staff during the summer was Dr. Wallace E. Lamb as assistant superintendent of schools.

In the Hicksville High School building three new classrooms and a teacher's conference room have

District Principal Robert Tuttle at Plainview says an enrollment of 2,040 is anticipated, compared with 1,850 last term. There were 200 additional registered last Friday, Aug. 20.

### START JUNIOR HIGH

Kindergarten thru third grade will be on double sessions and the

4th grade up on single. All 6th, 7th and 8th graders will attend the new Plainview-Jamaica Ave School where a junior high school program is being offered for the first time in the history of the district. The new school is being used for the junior high because of its added facilities, such as auditorium, cafeteria, gym, etc.

Senior high pupils of Plainview are at Hicksville High while 9th thru 12th graders are also attending classes in Bethpage and Oyster Bay this term.

Plainview has 50 classroom teachers plus 24 special teachers, custodians and clerical workers.

# Plainview Chamber Supports Elimination of RR Crossings

PLAINVIEW — The Chamber of Commerce here is on record with the Public Service Commission in support of the proposed elimination of L.I.R.R. grade crossings in Hicksville.

"Many Plainviewites must necessarily depend on the shopping and entertainment facilities offered in Hicksville as part of their daily existence and therefore must cross these railroad intersections many times daily," according to Michael M. D'Auria, attorney for the chamber. "We fully believe these crossings to be a hazard to life and limb," he advised the P.S.C.

"The great influx of residents to this area has also overburdened the local traffic situation. Further delays caused by these crossings have made it almost impossible to enter or leave Hicksville during the rush hours. This is now causing a hardship on local retail mer-

chants as well as operating a danger to pedestrians and drivers alike" he added.

"We therefore join the other local groups of this area in voicing a strong appeal in favor of eliminating these R.R. crossings."

Joseph E. Dockow, secretary-manager of the Chamber, said today that the hearing on Aug. 18 indicated that "elimination of the six Hicksville crossings became a virtual certainty as state, county and town officials gave their support to the project at the hearing. The crossings were blamed for numerous accidents, traffic tie-ups and loss of business. It is safe to go on the assumption that the commission will approve the eliminations."

D'Auria was appointed to look into the proposal in the interest of

this company by Mr. Edgar A. Tracy, Chamber president.

# Democrats To Honor McGaffrey Sunday

More than 100 prominent Democratic leaders of Nassau County will attend a testimonial dinner this Sunday evening, Aug. 29, in honor of School Board Trustee William H. McGaffrey of 19 Hope Drive, Plainview, the Democratic Party candidate for State Assembly, it was announced today.

The dinner, which will herald the formal opening of McGaffrey's Campaign for State Assemblyman for the Township of Oyster Bay (4th A.D.) will be held at Anselmi's Restaurant, Bethpage.

**MERCADANTE MC**

Lawrence W. McKeown, Nassau County Democratic leader, will deliver a guest address and Luke Mercadante, former Mayor of Glen Cove City and member of the Nassau Board of Supervisors, will act as Master of Ceremonies. Judge Joseph Suozzi of Glen Cove, Charles Kerrigan, Eastern Regional Director of the UAW-CIO; Thomas Abbott of Massapequa, long-time Democratic leader of Oyster Bay Town and William A. Cicer of Hicksville, State Assembly leader, will also speak.

Bill McGaffrey received county-wide notice recently for his fight against the Long Island Lighting Co. for what he called "outrageously high gas bills in Eastern Nassau, very often as high as \$40 and \$50 per bill—excluding heating." The Lighting Co., he claimed charges gas consumers approximately 40 per cent more than the neighboring Consolidated Edison.

This past Spring, along with Civic Associations in Hicksville, Plainview, Plainedge, Syosset, Massapequa, Jericho, Bethpage and Farmingdale, McGaffrey organized a 1960 signature petition of protest to the Public Service Commission to lower the rates.

Last week, however, McGaffrey stated that he had unearthed new information about what he called L. I. Lighting Co. "monstrous waste and nationally unprecedented mismanagement," specifically that the L. I. Lighting, according to its own admission, cannot find or account for 12.9% of all its gas, waste that McGaffrey charged "costs the Long Island homeowner about \$6,000,000 in the past three years alone." The cost of this inefficiency, he stated "comes right out of our pockets, not out of the profits of the L. I. Lighting

Co. as it should."

In comparison, McGaffrey pointed out, the American Gas Assoc. specifically states that the average utility throughout the country wastes only 3% of its gas through leakage and other reasons.

**'POLITICAL HACKS'**

In a sharply worded letter to the P.S.C., which McGaffrey claims is run by "four political hacks, hand-picked by Governor Dewey for this \$16,500 per year patronage plum because of services rendered to the Republican Party machine," McGaffrey demanded a reopening of the hearings based on this new information about alleged waste and mismanagement. This past Tuesday the P.S.C. replied that McGaffrey's demand for a new hearing was "under consideration."

During August, McGaffrey also attacked the L. I. Lighting's application for a 3.5% increase in electricity rates, pointing out that they already earn a greater percentage profit on electricity than Con Edison, and seven other utilities chosen at random throughout the country.

McGaffrey is a senior trial counsel for a Long Island insurance firm; a member of the Board of Directors of the Plainview Civic Association; former Historian of the Catholic War Veterans; and a member of the Queens and Nassau Bar Associations. A veteran of World War II, he served in the Combat Air Crew of the U. S. Navy. He is a graduate of St. John's College and Law School.

# Nice To Find Others Agree

THERE IS PROBABLY nothing as satisfying to an old crab such as the writer, than to find that other people and official agencies and authorities have come to precisely the same conclusion as you have—especially after the passage of an interval during which you felt you were a voice croaking in the wilderness.

A good number of assorted items which we have been bellyaching about for some months (and even years) seemed to crop up in the news during the past few days.

For example, solving local traffic bottlenecks. The Public Service Commission, according to our one-time boss, John M. Greene of the LI Daily Press, finds that too many communities have "taken little or no action to uncork traffic bottlenecks which are threatening their economical well-being and their public transportation system."

We were a member of a Citizens' Advisory Committee on Parking for Hicksville which on Oct. 13, 1949—just a few weeks short of five years ago—made recommendations to the Oyster Bay Town Board on many phases of local traffic conditions and bottlenecks which are only today getting some attention.

Among the urgent recommendations were improvement of the RR plaza area, between Broadway and Jerusalem Ave. at the station with paving and lights, for commuter parking use; purchase of property east of LIRR between Nicholas and Marie St. for parking field which has just been acquired in recent weeks by the district; acquire property in back of the Professional Bldg. for a parking field, which was done during this year, four years later; regulate the operation of taxi cabs, get the State to widen Newbridge Rd., and prohibit U-turns on Broadway, posting signs to that effect.

Regarding taxi cab control, the Chamber of Commerce directors on Monday, decided to write again to the Township asking about their 6-month old request for such an ordinance. Nothing had been heard in the interval.

On another part of the traffic bottleneck question, we found during the week that the PSC Examiner conducting the hearing in New York City stressed the importance of community-wide agreement on the type of elimination if we hope to speed up the project.

We had commented at length on the subject of agreeing to "Raising or Lowering" the tracks just the week before the hearing. It now appears, after conversation during a recess at the PSC hearing with an engineer of the State Dept. of Public Works, that raising the tracks is less expensive than lowering the track level and therefore stands the best chance of approval if we hope to get speedy action and the appropriation of state funds.

In another field, we found the right-to-vote issue irritating to many north shore and mid-Island Republicans in the past few weeks. Harold Glasser of Saddle Rock is seeking the right to run in the Sept. 14 primaries against William S. Hults of Fort Washington for the Republican nomination in the State Senatorial District which includes the Townships of North Hempstead and Oyster Bay.

Glasser's petition for a place on the GOP primary ballot has been tossed out as being "inadequate". While we do not wish to discuss the pros and cons of the particular petition (the issue is headed for a showdown in Supreme Court), there is an uncomfortably familiar ring to tactics of the Machine, apparently afraid to let the voting public decide an issue at the ballot box.

What really put the finishing on our cake, however, was the comment attributed to Township Republican Leader Howard T. Hogan, speaking at a meeting of the North Massapequa Republican Club which was described as a "kickoff" for the GOP campaign in the county.

"He (Hogan) urged the 200 people present to let their voices be heard in the Town Hall", according to the report in the Massapequa Post.

Letting voices be heard in Oyster Bay Town Hall has been a policy we have repeatedly advocated when residents find certain particular local situations irritating.

And yet, this same week we were told by a couple of residents who voiced their gripes concerning a local problem in the town hall that they were sharply questioned by an official: "What paper do you read? Does the Mid Island Herald influence your thinking? Did that fellow Noeth send you over here?"

Really, boys!

# The Question Box

The following are representative of the questions asked at the Public Library. If you need help in obtaining answers to your questions, or desire to do research in certain fields, call Mr. Eisner at the Library, Hl 3-1417. However, the privilege of borrowing books is extended only to residents of School District 17; non-residents must pay a 5 dollar annual fee to borrow books, although the library will extend its reference services to non-residents without charge.

Q. How many cubic feet of concrete will be produced by mixing one bag of cement?

A. Assuming you are not using the prepared mix, but plan to mix cement, sand and gravel or stone, one bag of cement mixed with 1½ cubic feet of sand and 3 cubic feet of gravel or stone, and about 5 to 5½ gallons of water will produce 3½ cubic feet of concrete.

Q. Are there any legal holidays in the month of August?

A. There are no legal holidays in New York State in August. However, Aug. 16 is a legal holiday in Vermont. This day commemorates the anniversary of the Battle of Bennington, fought on Aug. 16, 1778. The battle was won by the American forces under command of Col. John Stark, and was influential in frustrating the British attempt to separate New England from the rest of the colonies.

# Ask the CPA

Q. Can a husband and wife establish a business partnership and then at age 65 both collect retirement benefits?

A. Yes. As far as any benefits income tax-wise there is very little that a partnership return accomplishes that cannot be accomplished by a joint return. The establishment of a husband and wife partnership contains another important advantage—it makes the wife eligible for retirement income under the self-employment income tax section of the Code. As long as a legal gift of a partnership interest has been made to the wife and profits are shared in accordance with capital and services performed by each partner then the partnership is a valid partnership and recognized as such. According to the Internal Revenue Service the propriety of the partnership will be based on income tax law notwithstanding any local laws to the contrary. The importance of this fact can hardly be overestimated. Another way of providing retirement benefits for a wife would be to conduct business under the corporate form. In this manner the wife can be placed on the payroll and "social security deductions" made from her pay. Needless to say the wife must perform bona fide services for the corporation to warrant a pay-check.

# THE SCHOOL ARE YOURS: Grass Roots Democracy In Action

"How many different types of school district meetings are there?" asked John.  
"Before I answer your question let me say this. School district meetings are excellent examples of grassroots democracy in action. In district meetings all qualified voters of the school district have an opportunity to decide the vital issues regarding the educational program in the community."  
"You stated before, I believe, that any voters qualified to participate in municipal or state elections can usually vote in school district meetings provided they own or lease property in the school district or have a child attending the local school."

"That is true. School districts having a population of 3,000 or more may require voters to register before voting in district meetings. Now, essentially there are two types of district meetings. One is the annual meeting and the other is an special meeting called by the Board of Education."  
"Notice of these meetings must be published in the paper."  
"Yes, legal notices must be printed twice in a newspaper having general circulation throughout the district. The first notice must be published at least 22 days prior to the date set for the annual meeting or special meeting. The notice must specifically state the business to be transacted unless otherwise provided by Education Law and is dated and signed by the District Clerk, acting as an agent of the Board of Education."

"You said there were two kinds of district meetings—annual and special. That's not hard to remember."  
"Let's consider the annual meeting first. As the name implies it is held once each year on the first weekday in May. This applies to all districts in Nassau County except those of an incorporated city or village."  
"What is the usual agenda of the annual meeting?"  
"The typical agenda is something like this. The District Clerk reads the call of the meeting. A chairman is elected by those present and qualified to vote. The District Clerk usually acts as the clerk of the meeting. Next, the budget for the coming school year July 1 to June 30 is presented by the Board of Education. Generally the budget is discussed at considerable length. Voters present are at liberty to discuss any item asking any questions and may request an item by item vote. If this happens a vote is taken on each item or each category of the budget."  
"What does category mean?"  
"The budget is divided into several categories or sections such as Instructional Services, Maintenance of Plant, Capital Outlay and Debt Service. In the Instructional Service category are salaries of principals and teachers, supplies and textbooks, etc. In Maintenance of Plant are the salaries of custodians, cleaning and maintenance supplies etc."

When the budget has been approved (by item or category) a motion is made and seconded that the district shall raise dollars—the total amount of the budget minus anticipated receipts—for the coming year. Then a secret ballot or a recorded 'aye' and 'nay' vote is held upon the question. A roll is kept of the names and addresses of each person voting following the appointment of tellers. With the announcement of the vote the next usual order of business is the election of members of the Board of Education to replace those whose terms expire on June 30th."

"Didn't we discuss something about nominating petitions sometime ago?" asked John.  
"That's right. Nominating petitions for a candidate for election to Board of Education must be signed by at least 25 qualified voters of the district and submitted to the District Clerk 10 days prior to the annual meeting."

"Can nominations be made from the floor at the annual meeting?"  
"No, beginning in 1952 nominations must be made by petition. Of course there can always be a write in vote and space must be provided."

ed on the ballot for such a vote. Again tellers are appointed and a secret ballot taken for election of members of the Board of Education. A roll is again kept of the names and addresses of each voter. After the results are announced any other business which may legally come before the meeting is transacted and the meeting adjourned."  
"That appears to be a very lengthy agenda."  
"Very true. Perhaps that is the reason many districts today are holding the annual meeting on two consecutive nights as provided for in the law, the first night for the budget and the second for the election of members of the Board of Education."

"What about special meetings?"  
"Special meetings may be called by the Board of Education for several purposes as stated in the legal notice of the meeting. These meetings can be called to elect a board member to fill a vacancy, to secure approval of funds to purchase a school site, or to build a new school or to purchase school buses. A special meeting can be held to appropriate monies for additional transportation or for any necessary expenditures not covered by the budget."  
"How is the vote taken at these meetings?"  
"By the secret ballot as at the annual meeting."

## Back Yards And Fences

There is one fact about American yards that always brings comment from visitors from other countries. The lack of fences to mark property lines seems to amaze them.

Perhaps the happy-go lucky, trusting nature of most Americans accounts for this: whatever the

cause, most landscape designers agree that one of the basic requirements of an attractive yard is a border of some kind—be it an evergreen hedge or a brick, stone or wooden fence.

This border is compared to the frame for a picture. The choice of a border is endless. The major consideration is the architectural design of your home. A house of formal, imposing design should not be bordered by a picket fence. A Cape Cod type home, on the other hand, makes a lovely picture when bordered with a picket fence.


Many new designs in fence construction have come into use with the modern house. Woven wooden fences and louvered fences are good examples.

Often a fence or border of evergreen is important to insure privacy. An evergreen border is beautiful but requires more attention and space than a fence.

Every yard needs a service area in which to hang clothes to dry, rugs to sun and keep garbage cans and other, such eyesores from view. This is particularly important for the new homes being built with large windows.

Good advice is not to try to economize too much on the construction of a fence if it affects the quality of the materials used. Any kind of fence will be fairly expensive.

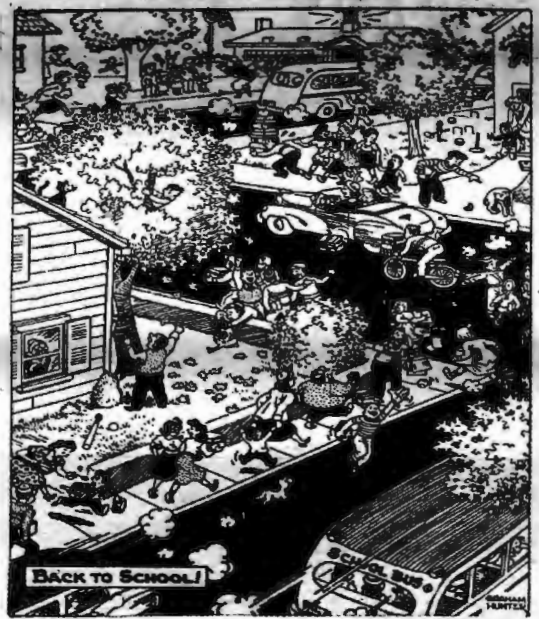

## Aviation Firm Lays Off 3,000

FARMINGDALE — Republic Aviation Corp. here announces that approximately 3,000 employees were laid off or will be laid off in the "near future".

The company stated that the reasons for the lay-off were the Republic "has been building up an inventory of assembled planes while at the same time intensifying its efforts to deliver completed ships which have been stored on the field awaiting delayed equipment and modification work."

The company stressed that this lay-off is not caused by any reduction in orders. Republic still has a backlog approaching \$1,000,000,000 in orders for fighter planes for the Air Force, including the F-84F Thunderstreak and the RF-84F Thunderflash. Additional orders have been placed for the XF-108 and the F-106—the former being an experimental interceptor while the F-105 is scheduled for production as follow-on successor to the F-84F. It will not be in production until late 1965, but the company states that its present production and subcontracting program is now geared to "release some space for the beginning of the pre-production tooling and planning for the F-105."

Republic has been employing approximately 29,000 people.

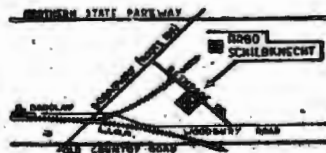

# The Herald's Spotlight

The Herald Spotlight warned just two issues ago that the Hicksville Field Club would not make a timid move in its efforts to keep semi-pro football alive on Long Island.

Manager E. Irving Jessor, upon consulting head coach Dom Sabatella, officially placed the Black and White in the New York-New Jersey football conference fold, early this week.

This move poses many problems for the management but the initial flurry in that respect is very slight to the interest in the team that the announcement produced.

It is an ambitious step. So much so that it may prove very successful. The league is strong and not slip shod and if the B&W fields a respectable team, the turnstiles might hum again.

What with travel now a major factor along with the many other bill producing aspects of conducting the sport the early figures indicate that eight thousand paying customers will have to see the club if it is to meet its breaking point in the enterprise.

Leaders of the York-Jersey loop aren't interested in weak sister members and the fact that there is no gate splitting underscores the feeling.

Each club takes everything it gets at home and receives not a red cent for its road gates. The revenue from home contests must cover expenses for away games.

The league is comprised of four Jersey teams—Jersey City, Linden, West New York and Plainfield—and four New York eleveens—Hicksville, Middletown, Ossining and Yonkers.

The schedule printed in this issue calls for home and home affairs with own state teams and one game with each club from the opposite state.

Hicksville replaces Peekskill, N. Y., in the league and with the exception of an opening Saturday night date at defending champion Middletown fared very well in the scheduling.

That opening date has upset the organizational plans just a bit and a switch would be appreciated but not expected.

With the Black and White taking the biggest step on the grid, players from other folded Nassau eleveens are expected to bolster the team.

Vince Alexander, Bill Glynn, Tom Silk, Tom White and the Kessler Brothers from Mineola are all but signed. That group performed for the Westbury Vamps in the last two campaigns.

Past season high school stars from Nassau will be rounded up and already Hicksville High is represented by Joe Pepe, Joe De Vaul, Stan Surchanski, Howard Speeding and Al Knipping.

A big roster is required since at least 25 uniformed players must be ready by game time or the official must declare a forfeit. Limited to a top of 35 men the roster may not be changed after Oct. 1st.

Rigid rules may attract the interest of the fans since the game has suffered in the post-war era due to independent and loose leagues.

A photograph of each player must be submitted to the roster committee so that there will be no "loading up" for a specific contest which has been a prime complaint of the admission paying customer on Long Island in recent years.

It is reported as the cradle of semi-pro football on Long Island, Hicksville is really going to give it a rocking in 1954 to see if it has possibilities of growing again.

It was the sixth inning of a tie ball game when a punt down the third base line caused the downfall.

Jim Barone lost for the locals despite a repeated ability to summon strength from the strikeout districts. He called up eight of them at crucial moments but the host team won under the arcs of Municipal stadium.

Many prizes have come to our friend Steve Ruggiero in his athletic efforts in this community both from the player and coaching sides but we believe his annexation of the 1954 Hicksville Community Softball League championship, Tuesday, must be the sweetest.

The three straight wins overcame a crushing loss to Breen's in the opening playoff game.
