School Board Engages Stoll to Answer Critic

HICKSVILLE—Attorney Charles H. Stoll has been engaged by the Board of Education to assist in the preparation of the Board's answer to the State Commissioner of Education on the request of a taxpayer for review of the school district's attorney fee arrangement, it was learned Wednesday. The Board has been directed to file its reply to the complaint of Lawrence A. Roman that the fees being paid the school attorney are "unreasonable" by today, Aug. 7.

The School Board on April 29 entered into a contract with Michael Sullivan as the attorney for the school district arranging to pay him a one-percent of bond issues fee, sliding downward to a half-percent on \$2 millions and more, which Roman believes is "unreasonable". He has charged that Sullivan has already received more than \$38,000 in fees from the district on new school construction and questions "whether another \$50,000 plus an annual retainer of \$1200 isn't a little bit too much to pay for part-time services of an attorney for a school district this size."

Truck Strike Delays New Church

HICKSVILLE—Construction of the new buildings for Holy Family Parish R. C. has been delayed because of the trucking strike according to Rev. Martin O'Dea, pastor of the parish. No date has been set for the official dedication, as yet. The buildings are located on Fordham Avenue and Newbridge Rd. and include a rectory, church, parish center and a convent.

Plainview Valuation Zooms Up

MINEOLA—The total assessable property valuation of mid-Island school districts increased this week as new values became effective on Aug. 1. Plainview School District showed the highest percentage gain in the county, a leap of 74 per cent, reflecting recent home building activity there and the new total is \$9,891,700.

Popular Teen Canteen Needs Adult Support

HICKSVILLE — Community-wide adult participation in a planned recreational program for teen-agers is the objective of the Teen Canteen which will meet again in two weeks to round out its organizational set-up, it was learned today. An enthusiastic group met Tuesday night in Levittown Hall at the call of Mrs. Marie Levy, officer of the Teen Canteen executive board.

A series of seven dances held at Levittown Hall has met with enthusiastic interest of teens, the group was told, and broadening of the program is planned with a dance scheduled later this month at the VFW-Hall on Grand Ave.

Mrs. Edward Kist of Milton Ave., who recently addressed an open letter to community groups suggesting establishment of a local youth program, is a newly-elected director of the Teen Canteen. She told the Herald yesterday the program planned will apparently serve the purpose she had suggested.

Marvin Sultan is executive chairman of the organization with Mrs. William Orton as community coordinator and Mrs. Levy activities director. Committees on liaison, publicity, ways and means, hospitality, teen council, refreshments, program, house, transportation and service are being developed.

"We have met with continued success in one area of Hicksville and feel confident that with the added advice and participation of the entire community, we can inaugurate a youth program that will satisfactorily fill a pressing need that we have all recognized," the Teen Canteen Board announced in a letter to adults interested in community youth recreation.

Garden Civics Urge Learners Steer Clear of Built-up Areas

HICKSVILLE—A near tragedy in the Woodbury Gardens section today prompted the civic association to ask the help of Herald readers in locating and suggesting non-congested areas where people learning to drive automobiles can practice.

Describing the problem as "acute and hazardous", Edward Mastrella as chairman of the Woodbury Gardens Civic Improvement Committee wrote "perhaps some of your readers could suggest areas for the many people who wish to learn to drive. We want to encourage them in their efforts, and we feel sure that they, in turn, would welcome suggestions.

MANY SMALL CHILDREN

"In our neighborhood of 300 homes", he stated, "we have more than 600 children; 500 of them under seven years of age. We are deeply and rightly concerned with their safety. We are painfully aware that a conflict exists between the worried parents and the anxious learner. Both want streets with little traffic. It seems sensible to request that in residential areas the learner defer to the parent.

"We realize that this problem is only a small part of the traffic hazard that is ever increasing with the growing population and

its concomitant, greater traffic. We are also aware of the responsibility of the parent.

"However," Mastrella continued, "we do want to place a special emphasis on the importance of learners avoiding, wherever possible, residential areas where children play. It is imperative that the learners use extreme caution in choosing practice areas. Except where dual-controlled cars are used, the car is almost in complete mechanical control of the operator. A competent experienced driver alongside the learner is merely instructional help. We therefore appeal to all those who are practicing driving to search carefully for safe practice areas," he stated.

Board Requests Help on Census

HICKSVILLE—The cooperation of all residents was asked by the Board of Education as the annual school census is being made as required by law. Enumerators will identify themselves and their questions only take a few minutes to answer, the Board spokesman said. The census touches every household and questions "should be answered by an adult in order to assure reasonable accuracy of data." An early conclusion of the census "and at a minimum expense" is the board's objective in asking cooperation.

Bids for transportation of students in the fall as well as for coal and oil and purchase of a station wagon were advertised by the School Board today.

In a separate bowl, beat 1 egg, add 1/3 c milk. Add egg mixture to dry mixture. Mix batter thoroughly. Pour into 9" pan—greased. Brush top with melted butter. Crumb mixture: 1/2 c flour, 4 t sugar, 3/4 t cinnamon. 4 t shortening. Mix thoroughly. Place on top of batter. Bake in moderate oven 400 degrees F. for 25 to 30 minutes.

Ready to Deliver Home Rule Petition

Forthcoming Church Merger Recalls 1921 Easter Eve Fire

The merger of the First Reformed Church with the Parkway Community Church on Hempstead Ave. in October will mark the passing of one of Hicksville's old landmarks as the edifice at the corner of Jerusalem Ave. and Newbridge Rd. (near the railroad depot) will probably be torn down after it is sold this fall.

The First Reformed Church came into being shortly after a small group of people met in a carpenter's shop on Broadway in 1883 to form a regularly organized Protestant church where English services might be conducted. In 1888 Hicksville had a population of 1,000 and there were two churches in town, a Roman Catholic and a German Lutheran Church. In February 1885 the Rev. Ernest Gutweiler was called from Long Island City and on March 4 was duly installed as the first pastor.

BOUGHT SITE IN 1889
It was decided at a meeting of the new congregation in Feb. 1889 to buy the William Sevin lots at the corner of Newbridge Rd. and Jerusalem Ave. The church was soon under construction and the cornerstone was laid with appropriate ceremonies on Dec. 3, 1890. By the time the church was ready for dedication in February 1891, there were four societies active in the congregation. These were a Ladies' Aid Society, Christian Endeavor Society, Kings Daughters and the Busy Bees. When the Sabbath School was organized George Luth was the first superintendent.

Furnishings for the church including the elegantly carved pulpit and communion table were obtained as gifts from the church members and the church organizations.

After 25 years of ministering to his people, the Rev. Gutweiler, upon the advice of his physician, presented his resignation on April 24, 1910. He was succeeded by the Rev. J. O. Ottinger from the Presbytery of Brooklyn in 1912, the Rev. F. P. Emerich in 1918 and the Rev. William P. Dailey in 1920.

Fire broke out in the church the night before Easter Sunday in 1921 and caused considerable damage to the structure. The insurance was not sufficient to make the needed repairs so the

balance was raised by popular subscription. At the same time the debt on the church was cleared up and henceforth remained free and clear.

Teen Canteen Should Go Far

By Fred J. Noeth

WE WERE IMPRESSED with the program for planned recreational activity for the teens of our community which was outlined in some detail at a meeting for adults at Levittown Hall, Tuesday night. With the right kind of sympathetic interest and cooperation from the community—which is the main thing the Teen Canteen is seeking at this time—the program should go far.

The beginnings of this program, consisting of a series of 25-cent dances for teens held at Levittown Hall in recent weeks, have proven that this can be the answer to the constant but never satisfied dream of many of our teens. Some 1500 youngsters, from 13 to 18 years of age, have enjoyed the seven dances to date.

Dances are not the entire answer, and the organizers of Teen Canteen are well aware of that fact. However, dances do go a long way toward meeting the immediate need for organized social activity and more will be held. While the first seven were held in Levittown Hall, open to all teens of Hicksville School District, future affairs will be held at the Hall and other structures in the community. The VFW Hall on Grand Ave. will be the scene of a dance the third week in August.

Marvin Sultan who has perhaps not always enjoyed the most enthusiastic coverage of his pro-Levittown civic activities, did an admirable job in conducting the meeting Tuesday night. Plans are being made for another adult meeting in a couple of weeks and any adult sincerely interested in our teens should be present. The group has named several committees, including a liaison unit which will solicit your support and cooperation.

If we may be permitted an aside at this point, one of the reasons for strong interest in incorporation of Hicksville as a municipality is that it would make our community eligible for special state financial assistance, under the State Youth Commission formula, for a local youth program. Application for such funds must be made by a municipality. Villages which we know now enjoy this type of assistance, because they are villages with home rule, including Hempstead, Sea Cliff and Floral Park.

The Teen Canteen is not looking for financial aid at this point but as its program develops there will be need for experienced, trained, paid personnel to keep the many phases of the work rolling. Actually, it was reported at the meeting, the Canteen has a balance of \$118.68 in the bank after its series of seven dances. It started with a loan of \$35 from a civic association and shortly after acquired \$100 in a division of funds from last year's pool tag registration in the Levitt section.

The importance of an adequate and effective youth program was expensively demonstrated again this week as the Hicksville Board of Education reported further damage and vandalism after dark at the various local public schools. A formal complaint has been made to the police who are now patrolling school areas. Two nights "fun", for example, produced a bill of \$87 for new window glass.

Parental responsibility is definitely a key in the solution of this situation and probably the very people to whom this applies will not read this or any newspaper. As it was brought out by one gentleman at the Teen Canteen meeting, a fundamental job is that of educating the parents—if we are to develop a useful and practical youth program. It can be done.

Where Do We Belong?

Much discussion among residents and owners of Levitt houses in South Hicksville area has always centered about the relative merits of "belonging" to Hicksville or to Levittown. Many of us—and we believe it is the majority—see the preponderance of benefits in being part of Hicksville. Some prefer Levittown. Now, nobody can argue with his neighbor's choice of personal friends and associates, his church, his politics, or his women. We are all free to choose as we individually see fit.

What Are The Merits?

Even though some people living in this area prefer to be associated with Levittown, the practical facts are that they should have a strong interest in some of the affairs of Hicksville. After all, about 70 percent of our tax money is collected for administering Hicksville affairs. It stands to reason that they should take an active interest in how their money is spent.

They will benefit from taking an active part in Hicksville civic and school affairs. Nothing is gained from a dollars and cents viewpoint to improve conditions in Levittown. Only by working in Hicksville, where their tax money is spent, can they get better value for their tax dollar.

Lower Taxes in Hicksville

For identical houses separated by only a few feet over the Township Line, owners in Hicksville pay approximately \$75 per year less than those owners in Levittown pay. This is because Hicksville has more industrial and commercial properties to share the tax load. It is well known that the factory owner contributes to the school tax just as much per \$100 of valuation as the home owner. And they don't send children to school from the factories. Also, Hicksville already had many facilities established when we arrived, whereas Levittown had to start pretty much from scratch.

Children Attend School in Hicksville

Our children necessarily attend Hicksville schools. It is very obvious that if we are interested in any school system it must be the Hicksville system. Out of every tax dollar, 47 cents is spent by the school board. We are of necessity very much interested in the activities of Hicksville School Board. Children spend many hours in the school buildings with the teachers. We are of necessity very much interested in the physical facilities and the teachers themselves. How else could we be?

Hicksville Fire Department Protects

If we should ever have the misfortune to be the victim of a serious fire, it will be the Hicksville Fire Department that will come in a big hurry. If any of our men want to join a fire department, they join the one that protects their homes—the Hicksville department.

Garbage Collection

Our garbage is collected by the Hicksville Garbage District. An appreciable part of our taxes is used for this purpose and if we want better service, we must look to Hicksville (actually Oyster Bay, until we are incorporated) for help.

Streets and Highways

If our streets need repairing or cleaning we naturally look, not to Levittown, but to Oyster Bay (for the present) for service.

Swimming Pools and Levittown Hall

The only facilities in which Levittown authorities have a prospective operating interest are the swimming pools and Levittown Hall. And that arrangement is only a possibility for the future. If it should ever come about, it will be Oyster Bay members of the joint district board who will have the responsibility of looking out for our interests.

Postal Service

We are in the service area of the Hicksville Post Office and if we have our mail addressed to "Levittown", a full day or more is lost in transit. Such mail is first sent to the Levittown Post Office on Hempstead Turnpike. It must be sorted and laid aside for shipment to the Hicksville Post Office. All this is a waste of time, effort, and tax money. Common sense tells us to have our mail addressed correctly to Hicksville.

Final Analysis

In the final analysis it can only be that all residents of the Levitt houses in South Hicksville, in their own enlightened self interest, should take an active interest in Hicksville civic affairs. While they may prefer to take part in Levittown social and cultural activities, that is no reason to throw over their privileges and responsibilities in the field of government activities in Hicksville. All of us should choose our own friends and associates freely. But when it comes to community affairs, there should be but one answer.

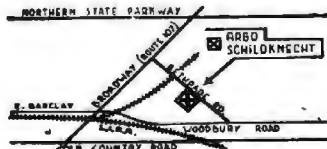

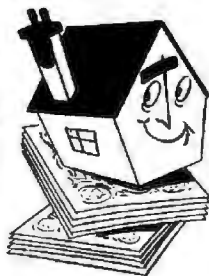

Home Rule Vote Coming Along

The long awaited vote on the question of the Incorporation became a reality last Friday morning, July 31, when the committee including Kurt Maler, John Larkin and your reporter presented the 700 page petition to Deputy Supervisor Lewis N. Waters at Oyster Bay Town Hall. John Finnegan, Captain of 15th Election District workers for the drive when informed of this good news stated, "This is indeed a day long to be remembered by the people of Hicksville. Our work has just begun, the question of the vote ahead will require the continued effort of our many volunteers to get the people out to vote. I wish to thank all the workers who did such a terrific job in obtaining the hundreds of petitions from the NW section".

After review by the Supervisor a hearing will be held some place in Hicksville to see if proposition and petition are in order. Within five days after the hearing notice will be given of the election, then the question of whether we become a village or remain under "remote control" is up to YOU the voter.

At the monthly meeting of the Civic Association this past Tuesday evening a motion was made to hold

a Special Meeting for the purpose of hearing the proponents and opponents on the question of Home Rule for Hicksville sometime next month at a place to be designated after review by the Executive Board of the Association.

DRAINAGE QUESTION
Since late 1952 after a meeting with Town Board over in Oyster Bay we were told of impending surveys by engineers on our serious drainage problem. Work was to get underway in March of 1953, but as late as this week we finally hear that 90 per cent of the survey has been completed.

Over 8 months to make a survey in this area—why so long? In the meantime each rainfall makes conditions worse, streets are flooded, sidewalks badly need repairs and all we get is promises. Highway Department has now used excuse of strike for delays in finishing several of our roads, what was the delay before the strike—the answer most likely would be bad weather—budget problems and equipment needed elsewhere. If they started on the job why didn't they finish it as Jack Brandt, Supt. of Highways promised. If you have been reading the daily papers lately they will hear out my many re-

marks on the Highway question and promises by Jack Brandt. The politicians are having their own troubles with nominations for the post of Highway Supt., several local candidates from Bethpage and Massapequa feel that its time for a change.

In the meantime our roads continue to take a beating from heavy trucking in our section and flood caused after each rain. TOB Highway Equipment has been laying idle on corner of West John and Burns Avenue for many weeks. We want the drainage promised and roads completed without any further delay—or these elected officials will know the feelings of the taxpayers come November!
