## Young Democrats Claim Few Voters Know Score

HICKSVILLE—Ninety per cent of the residents of Oyster Bay Township "do not know the basic political facts of their lives," it was claimed today by the Young Democratic Club as the preliminary result of a survey now underway. James Munver of 2 Cloister Lane is canvassing chairman. The club found "less than one person in 10 questioned knows, for instance, how many persons sit on the Board of Supervisors and well over 60 percent are not even sure what the Board of Supervisors is."

"The circumstances that many persons interviewed have lived in the township less than four years is doubtless one of the reasons they know so little about the manner in which Nassau County operates", the Young Democrats conclude.

# GOP Contests Loom For Committeemen

M NEOLA—Contests for Republican committee-man positions in at least four of Hicksville's 14 election districts on Primary Day, September 15, appeared certain today. This is the final day for the filing of designating petitions by party members with the Board of Elections, here. There have been no GOP committeeman contests in Hicksville in over a decade, according to political observers at the county seat.

The reported competition facing incumbents in the bi-annual primary is being taken here as a positive demonstration, challenging the Republican leadership in Hicksville by County Clerk Ernest F. Francke. At least two of those expected to make a bid for committeeman election are women.

If the contests materialize, they will attract interest in party ranks throughout Nassau County where GOP committeemen contests are so few, some observers note, as to be almost unheard of.

Focal points, according to information available last night, may include the 3rd Election District where Michael Sullivan is a GOP committeeman with John Herzog, 16th district with incumbents Clifford Place and Leroy Wells, 29th district where the present GOP Committeemen are Francis Anderson and Henry Schneppf.

Also mentioned as possible disputed districts are 41st where William Reichert and Andrew Heberer are incumbents; 42nd, Ernest Francke and Harvey Selunter now in office; 44th, John Jeanson and Stanford Weiss, and 47th where Louis Kappstatter and Nelson Baldwin are incumbents.

Duly enrolled party members will vote for two committeemen in each Election District on Primary Day, Sept. 16, when polls are open from 12 noon to 9 P.M. Primary elections normally attract little interest with less than 50 votes recorded in many districts where GOP registration frequently exceeds 700.

Snap judgement may be fine in an emergency but it's foolhardy to rely on such quick decisions when it comes to choosing leaders.

One of our charges against the local director was "Doubletalk". He'd say one thing and mean another. On June 25, 1953, Mr. Eginton stated in a weekly newspaper that Hicksville's Plainview C.D. unit will remain intact. That was the headline. The story quoted Eginton as saying, "Plainview is not ready to go on its own." July 16, 1953, a headline in that same weekly read, "Plainview Split From Combined C.D. District". The story quoted Eginton as saying, "Plainview is ready to stand on its own." I'm glad it was a paper other than the Herald that printed these conflicting reports.

Inefficiency was another of our charges. The test alerts of June 9th, 1953, was a prime example of that. County C.D. spends your tax money to draw up directives which set the pattern of behavior of each unit for the test alert covered. Our own local director chose to disregard most of this directive. A copy of this directive is available and we can point out at least 12 points of this directive that were completely ignored, and still, the township director said, "Fine job." Incidentally, the Township Director was put off the streets during the last two tests for lack of proper identification.

A letter from a private citizen in Valley Stream called the last test "An invisible success." She was right, if the test proved nothing else, it pointed up a definite need for more volunteers in almost every phase of C.D. but still there has been no move to bolster the membership. This is the Center Civics call "inefficiency".

This association sent a committee to Mineola during the week to meet with the County director, but he was not there. His assistants gave non-committal answers to all our questions, and assumed a "smug" attitude saying, "You're quite C.D., you're on the outside. What are you going to do about it?"

We went directly to the State Director of C.D., General C. Huebner, and gave him the whole story. His direct order for a full-scale investigation is what we are "doing about it."

Mr. H. Stecker and I were in the General's office when he spoke to Ryan on the phone. "Get this mess straightened out," he said. "Meet with these men and see what can be done. If the trouble lies with one man, get rid of him." That is a direct quote from the General.

That phone conversation took place on Monday, Aug. 3, 1953, and at this writing we are still waiting for a meeting to be called. We





## Current Comment:

# Why Not Let People Vote?

**WITHIN THE NEXT** nine days we can expect Oyster Bay Township Supervisor Charles E. Ransom to officially announce that he has received a proposition for the incorporation of the area of Hicksville School District as a village with its own locally elected officials and local government.

The notice must be posted in five public places in the area of the school district and must be published at least twice in each newspaper in the territory. This notice will fix the date not less than 20 or more than 30 days hence for a public hearing upon the proposition. At the same time provision is made for public inspection of the proposition at a specified place until the date of the hearing.

Because some newspapers seem to persist in repeating a false notion, it must be stressed that the entire action on this proposition up to and including the hearing is the sole action of the Supervisor—not the Oyster Bay Town Board. The Supervisor gets the proposition, he gives notice of the hearing, he conducts the hearing and listens to objections on certain specific grounds, and he determines if the proposition and other filed papers comply with the Village law.

Curiously, Supervisor Ransom has had considerable experience in the receipt of applications for incorporation of villages. He was Oyster Bay Town Clerk during the period when several North Shore villages were incorporated. After serving the township, Mr. Ransom became County Clerk and returned to the Township as its chief executive a little less than two years ago.

The preparation of the petition, proposition and other papers asking for a vote on the question of home rule for Hicksville as a village has been a monumental task and those who brought the proposal to this point deserve commendation for their persistence and unselfish effort. We personally had relatively little to do with the actual effort of canvassing and enrolling the signatures of property owners, so this cannot be considered as self-applause. The men and women of our community with the energy and determination to bring the task to this stage, despite spiralling total district valuation and the tremendous influx of new population, have worked sincerely and earnestly to comply with a law which probably never contemplated that an area the size of Hicksville today would have to get home rule "the hard way".

For example, it was necessary to file with the documents a list of the inhabitants of the area—just to prove that the community has a population of at least 500 persons! The list of petitioners filled contains names of OVER 25,000 persons.

Particularly distressing in the midst of this tremendous task has been the sniping tactics by certain individuals who, for reasons known best to themselves, would rather keep Hicksville in the category of an unincorporated hamlet with portions of its important municipal services controlled by Oyster Bay and others by Mineola. All efforts of this minority but powerfully entrenched opposition element are now directed toward preventing the question from ever coming to a vote.

While the village law clearly and definitely states that the petition to the Supervisor must be labeled as a "consent," the Anti-Home Rule Committee has attempted to milk important signatures off the petition by inferring that the "consent" does more than bring the question to a vote. The "consent" has now been filed with the Supervisor and the question MUST STILL BE BROUGHT TO A VOTE.

Whether signatures can now be withdrawn is a legal question. The Home Rule Committee has found that the last time that an effort was made to prevent a vote on incorporation by attempting to depress the valuation represented by signatures took place about 1910.

The Home Rule Committee finds it strange, indeed, that it has received ONLY ONE request from a property owner who signed the proposition and consent—and that among 242 who did sign—to have his name deleted.

Fairminded people are not afraid to let the taxpaying resident voters of Hicksville decide this question in the only way which can be considered decisive and conclusive—at the ballot box.

## We Can Be Proud

We can all be justifiably proud of the well-kept appearance of our homes and grounds. A tour through South Hicksville area tells the story that practically all our neighbors take great pains to care for their lawns and shrubbery. With this kind of care the attractiveness of our homes is bound to increase with the passing years.

## Thoughtlessness Of Children

Reports of childish carelessness and disregard for the property of others continue to come to our attention. In one case a family with much pride in their home, purchased some expensive plants only to have them seriously damaged to the extent of more than \$100 by rampaging youngsters. In another recent case, the damage amounted to about \$15 and the work of many hours was destroyed.

## Parents' Responsibility

It is sometimes pretty difficult to keep some youngsters within bounds. But the great majority of parents do. It is only the very small minority who seem unable to teach their youngsters respect for the property of others. It will be unfortunate if these parents have to see the need for restraint by being present with a bill for damages.

## Summer Playground

The summer playground operated by the Hicksville School Board at the Fork Lane, Dutch Lane, Old Country Road and other schools are going into their final weeks with attendance still at a high level. Very frequently projects like this interest of the youngsters drop off and it is to the credit of Chester Jaworski and his staff for the manner in which they conducted the program. The playgrounds are open to children from five to 12 years of age with activities suitable for different age groups and boys and girls.

Perhaps the most popular activity is the handicrafts. The children work hard at the many projects in plaster molding, rug making, Indian head work, basket weaving, pot holders, raffia, leather objects, and the like. Most popular are the daily contests in art work and games. A highlight was the costume contests recently held in all of the playgrounds with a parade around the neighborhoods, in costume.

## More Controversy About The Hall

The current controversy raging over who shall have the right to meet in Levittown Hall, which is in Hicksville, is very interesting—in many ways. It seems that some of those who were so active fighting Bill Levitt's fight for him to have taxpayers assume the burden of operating the Hall, haven't found things very pleasant when they appear not to agree with Levitt's ideas. Five members of the Hall Advisory Council found it necessary to resign rather than have Dick Levitt, Levitt's paid Hall manager, overrule their recommendations. Terms like the Council's recommendations are fine just so long as they agree with the boys.

## Levitt Still Owns The Hall

Regardless of the merits of the case, it is very evident that Levitt still owns the Hall, and what he says goes. The Joint District is not scheduled to take over until January 1, 1964.

There is a very good possibility, of course, that the Joint District will not come into being after Hicksville is incorporated. The law specifically states that a joint district of this type may not be established embracing any portion of the area within an incorporated village.

## Teen Canteen Dances

The dances sponsored by the Teen Canteen can prove to be a very worthwhile venture for the youth of all parts of Hicksville. It fills what has been for a long time a serious gap in local recreational affairs or teen agers. The decision to extend the invitation to teen agers in all parts of Hicksville was a wise one and we hope that our young people will encourage their friends from other neighborhoods to attend with them.

## Swimming Pools

The swimming pools are deservedly popular as they have always been. It is good to see evening use extended permitting swimming meets and practice. But it does seem a shame to have the pools practically empty and unused in the early evening hours. If a shortage of lifeguards is the reason for excluding children with parents after 5 o'clock, why not shut down one pool completely and have all the guards on evening duty at one pool so that more people can take advantage of them during weekday evenings?


