



The above is a copy of the "Analysis of Escrow Account and Revision of monthly payments" form recently mailed to each resi-dent by the mortgagee bank. This analysis clearly gates forth your current, escrow balance and future

current escrow balance and future payments. The analysis covers the three tems usually collected by the bank from you and deposited into a so-called "escrow account". These items, namely insurance, town tax and school tax, com-prise your escrow payments which, combined with your mortgage p in-cipal and interest, make up your total montly payments to the bank. This escrow payment is required in order to enable the bank to have sufficient montes on hand to pay the bills for the 3 items mentioned above when they become due and above when they become due and payable. In the event you sell your home and the buyer assumes your mortgage, said buyer will

reimburse you for any escrow monies held by the bank as of the time of closing of tile. The Fire Insurance item refers for the fire insurance on your building. In many cases it covers which includes many items of coverage in addition to the fire coverage of your home. The insurance premium for the full term of the policy is stated in the column marked "estimated term amount". licy becomes due. The next item listed on the analysis is Town Tax. Actually this item includes not only the town

tax but also the State, County and Special District taxes as well. As a matter of fact, it includes all taxes except school and water taxes. The encrow analysis you received this year anticipates the payment of town tax hased upon last year's town tax. The bank mailed you a copy of your paid town tax, together with you escrow account form. A glance at the town tax will immediately show that they are projecting their needs for next year on the same town tax as last year. Please note that in view of the fact that the 1961 town tax has been increased, we are in effect paying an In-adequate sum to our escrow fund. On an average, we will be short approximately \$25,00, which will be reflected on next year's analy-sis statement. The reason the bank computes the town tax at last year's rate is that the follow-ing year's town tax had not as yet been afficially announced. It is build alsobe pointed ou that while the tax rate for each resident not be the same because of (a) difference in assessment, (b) venerans tax exemption. 3.0

The School Tax is the third item on the analysis. The school tax estimated escrow is based upon the actual rate for the cur-rent period. However, the school tax runs from July 1, 1960 to June 30, 1961, and therefore this estimate will not be accurate, in the event the school tax is in-creased as, of July 1, 1961.

creased as, of July 1, 1901. The current school tax is \$3.59 per one hundred for Jericko and \$4,688 for Syosset. Multiplying the rate times your assessment should equal the school tax as listed on your analysis. Please bear in mind that no Veterans Tax Exemption is allowable on school tax. ol tax.

school tax. Column 4 of the analysis in-dicates the current amoun re-quired to meet the bills when they become due. This total is carried over to column A. Col-umn B represents the actual monies on hand as of the date of the analysis. Column C repre-sents the surplus or shortage to be adjusted. This surplus or shortage is reflected on your new payments by dividing same by 12 as indicated in Column F, and finally G indicates your total mon-thy payments for this coming payments for this coming thly year.
