Promises To Be Torrid Summer:

Election Campaigns Get Into Motion

Political activity almost matched the unseasonable, torrid weather this week as candidates for election on town and county levels of government were designated and recommended. Highlighting the week was a meeting of the full Oyster Bay Town Republican Committee with almost 300 attending at Bethpage State Park, Monday, and a cheering, enthusiastic convention of the County Republican organization at Garden City Hotel, Tuesday night, attended by thousands.

Gov Nelson Rockefeller was the principal speaker at the boisterous vigorous session Tuesday night when Robert Dill was named as GOP candidate for County Executive. His name was placed before the meeting by A. Holly Patterson who is not seeking re-election, Thomas R. Pynchon, Oyster Bay leader, was among those who seconded the designation.

Philip Robinson, Hicksville GOP leader, placed the name of Francis Anderson of Hicksville before the cheering county meeting for re-election as County Clerk. Bands played and the hall was filled with placards and banners for favorite sons. The Hicksville Republican Club took its mobile float to Garden City after a quick trip around the community.

Joseph F. Carlini, the new County Republican leader, hurled challenges at the Democrats and pledged a fighting campaign right up to November. He predicted, as did J. Russel Sprague and other speakers, the return of "traditional" Republican pluralities.

Monday night saw the business of the Town GOP Convention concluded in an hour at Bethpage Park. Among other Town officials design-

Westbury Hills Backs Park

The Westbury Hills Civic Assoc last week joined a growing list of civic units supporting the creation of a Nassau County Park on the former Press Wireless acreage in the northwest corner of Hicksville. The Nassau County Board of Supervisors has taken action to formally acquire the property, embracing 125 acres, for a park area.

The executive committee of the Birchwood Park Civic Assoc of Westbury, more commonly known as the Westbury Hills Civic Assoc, adopted a resolution June 14 praising the County Supervisors for their action on acquiring the land.

A spokesman commented on the opposition attributed to the Westbury Hills Jewish Centre, said to focus in Imperial Gardens, declared "The only connection between our community and the Center is that a small number of our residents are members of the Center."

Already on record in favor of the acquisition are the Hicksville Board of Education, Birchwood at Jericho Civic Assoc, Northwest Civic Assoc and more than 1200 persons who signed petitions in favor.

Shift 660 3rd Graders, Asst Principals in Fall

The Board of Education has approved the District Administration plans for the transfer of third grade pupils for the 1961-62 school year, which involves 660 students. It was learned this week. The fall term will also see several assistant principals get different school assignments.

Four hundred forty third graders will go to Nicholas St. School as follows: 198 from Lee Ave., 130 from Woodland Ave. and 113 from East St. In addition, 223 will be assigned from other schools to Dutch Lane School. They include 81 from Burns Ave., 56 from Fork (Continued on page 6)

Blues Surprise Golds

The ancient biblical drama of David and Goliath was replayed on Sunday evening, June 10th, to an overflow crowd at the Junior High School Field. The Goliath in the baseball rendition of the biblical drama was the St. Ignatius Gold team that had swept all opposition before it in all their previous games this season. The David was the "junior" St. Ignatius Blue entry in the Bantam Division of the C.Y.O.

The "Juniors" are the junior varsity of the Gold team, made up of those players who couldn't quite make the "first" team. In their first meeting of the season, the Golds boldly asserted their superiority in the seasons opener by soundly trouncing the Blue upstarts. With the big bats of Alfy McGunnigle, Gus Reinhardt and Butch Acerra cannonading opposing pitchers the Golds, confident struck fear into the hearts of the rest of the league. With Bobby Heartt tossing his fire-balls at the opposition, the experts predicted an undefeated season for the Ignatius Behemoths. Despite their proven power at the plate, their skill at field and their mound talent, unlike their biblical namesake the Golds displayed remarkable modesty and reticence about their weekly conquests. They disdainfully and mysteriously shied away from all publicity. It was practically impossible for Commissioner Lew Grosnik to glean even a meagre summary of their weekly conquests.

The Blues refused to be disturbed by their initial setback at the hands of the Golds. Confident that they could overcome their physical handicap of size and power they resorted to skill and resourcefulness. Little "Davey" Glibowski sharpened up his pitching arm and selected a white shiny horse-hide sphere to destroy his opponents as he strode to the mound on Sunday evening. Tommy Blazer offered a target to this Giant killer who proceeded to sling, shot his deliveries past the bewildered Golds. Eight of the mighty league leaders succumbed to his baffling pitching assortment. He allowed only four widely scattered hits and otherwise silenced the mighty bats of the Gold's murderers row. Only once did Glibby experience difficulty - in the fifth inning when a pair of fielding errors on the part of his teammates allowed two runs to score.

In the third inning his teammates had scored three times on a hit batter, a walk, an infield hit and a

throwing error. Two outstanding fielding gems by Ed Doyle and Bob McGregor saved the Blue cause in the third and fifth innings. In the third inning Healy brought the crowd to its feet with a long blast to right field. However, Ed Doyle, running like a deer, leaped high into the air to rob him of a certain homer. In the fifth Healy again blasted an even deeper belt into center field that was marked "homer" from the moment it left his bat. After a long run Bob McGregor leaped into the air to snare the ball over his shoulder and retire the side.

Suburban Gardener by Ralph Pignataro

Leaf spot disease on most lawns has become worse instead of better. If your lawn suddenly looks brown or yellow, check the individual blades of grass. If they show small tan colored spots you have the lawn fungus which is causing all the brown on the lawns. At this point, you should spray with a general purpose lawn fungicide. Consult your local nurseryman, as to what type and how much. This disease (Helminthosporium) is caused by moist cool periods characteristic of our Long Island spring seasons. In spraying lawns, a good practice to follow is to spray on a preventative basis. In past week suddenly all maple trees have been attacked by aphids

The Syosset School Budget for 1961-62 was approved by the slim margin of 186 votes out of a total of 3,982 cast on the resubmission of the budget. The separate proposition for Librarians to the Elementary School was defeated by 454 votes. The total votes cast on the resubmission was once again in greater numbers than ever turned out for a Syosset School Budget vote in any previous year.

The approved budget will bring our taxes to \$5.36. This is an increase of .76¢ per \$100.00 of assessed valuation. It will increase our taxes by \$68.40 (based upon an average of \$9,000.00 assessment).

LEGAL NOTICE

AMENDMENTS TO THE BUILDING ZONE ORDINANCE OF THE TOWN OF OYSTER BAY

BEFORE ORDAINED, by the Town Board of the Town of Oyster Bay, County of Nassau, State of New York, the Building Zone Ordinance of the Town of Oyster Bay, as amended and revised, be amended in the following form:

ARTICLE I. DEFINITIONS, SECTION 1. (WIDTH) shall read as follows:

"The width of a lot shall be measured at right angles to the front line of the lot, the direction of its average depth, such measurement, for the purpose of determining the required width of a lot pursuant to other provisions of this ordinance, shall be made at the required minimum front yard setback line."

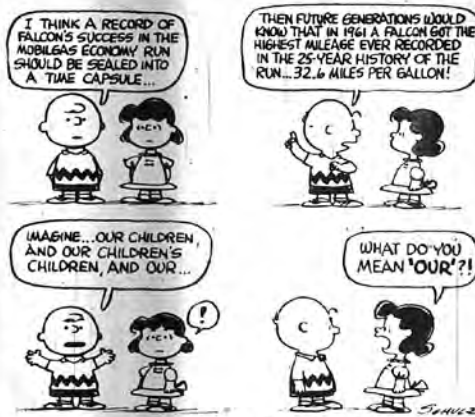
