# Hicksville Public Library 169 Jeruselom Avo. 13 Since 1855 Were Men: th Postmaster n 106-Yr History

Irene L. Murphy of 85 Blueberry Lane, Hicksville, became the 14th postmaster in the 106-yearhistory of the Hicksville Post Office when she was sworn in Friday evening by Postal Inspector Louis Bader. Her 13 predecessors were all men. The Hicksville office is one of the largest on Long Island and it is among the 300 largest in the nation.

"Ind it is among the 300 larg Mrs. Murphy who grew up in Bayville and has had broad exper-ience in publication work and pub-lic relations was, prior to her ap-pointment by President John F. Kennedy, active in Democratic politics. She has resigned as co-leader of the 4th Assembly Demo-cratic Zone and former Hicksville Democratic leader. Her appointment is subject to confirmation by the United States Senate. She succeeds Harry C. Cotler of Park Ave. who retired as of Friday, July 7, after 35 years in the postal service including postmaster of Hicksville since 1955. She is the wife of Francis P.

posimilar of ficksville since 1955, She is the wife of Francis P, Murphy an economist, and the mother of two small children, a boy aged 4 and a daughter, 11, who is in the 6th grade at the Waldorf School, Garden City. Eight Nassau Post Offices have lady postmasters; Jericho, Massa-pequa, Atlantic Beach, Glenwood Landing, Lynbrook, Roosevelt, Rossiyn and Woodmere, but none are as large as Hicksville (which in-cludes Plainview) from the stand-point of revenue and business. Mrs. Murphy is a veteran of World War II and served three and a half years in the US Navy. She holds a master's degree in public law and government from Colum-bia.
