



# Herald Editorial Opinion The Dec.12 Library Referendum

Now Election Day has come and gone, there will be increased attention in the upcoming referendum upon a bond issue for \$298,500 to finance an addition to the Hicksville Public Library on Jerusalem Ave. between Second St. and Old Country Road.

We will attempt to publish as much material about this project as comes to our attention, both for and against. The HERALD has long supported the local Public Library, going back to the days when it occupied a single, second floor classroom in Nicholai St. School. We witnessed at least two proposals to build a library structure rejected, partially we suspect because they were somewhat elaborate.

We first promoted the suggestion to acquire the Duerk house at Jerusalem Ave and Second St., a substantial brick structure, and this somewhat more modest proposal was carried. It seems the price was about \$30,000 if memory serves correctly.

Then came a tremendous expansion in our population and along with it the major addition which is today's library. Back files of the HERALD disclose that the corner stone for this \$312,000 project was set in place on June 6, 1957, slightly over five years ago. At the time it was pointed out that this building would take care of community library needs in this generation.

Then more than a year ago, a bookmobile was acquired to further expand the services and facilities of the library.

Now we have no doubt the library trustees and administration can make out a tremendous case why a new addition is needed at this time and the voters of Hicksville are going to have their chance to agree or disagree on Wednesday, Dec 12. However, it seems a little odd that in less than five years time a building designed for the community needs "for a long time to come" requires a major addition which nearly matches the cost of the "long range" construction of 1957.

Or maybe five years is a long time. If it is, then a span of 20 to 30 years is a couple of lifetimes -- and that is the probable period of time in which the bonds will be paid off by the taxpayers if they approve on Dec. 12.

# Library Explains Need for Extension

The Hicksville Public Library has released the following material about the Dec 12 referendum on an expansion bond issue. The statement is offered as received:

Teccelvec: There are over 30,000 regis-tered borrowers who borrowed more than 350,000 books in 1961. Circulating books, however, is solly part of our service. Reference service, homograph records, and films, art exhibits, and special programs for children and adults are all part of our efforts to make our library a true influential and are all part of our efforts to make our library a true intellectual and cultural center of the community. In order to sustain this program, we are arking you to support a referendum we are presenting to the people of the district on Dec. 12, 1962. The cost of the addition will be \$298,500.

#### WHAT WILL REFERENDUM PROVIDE?

The library has purchased perty on the north side of the present building and plans to con-struct an extension there. The new struct an extension there. The new wing will have two floors, the up-per floor to be an extension of our present main floor, providing space for 40,000 additional vol-umes and seating capacity for 82 readers. The seating space will be used largely by Young Adults, with an office for a Young Adults, ubrarian in the extension. In the basement, we plan to construct a community room sest-ing 185 that will be used for or ganization meetings, special li-

ing iso that will be used for of-ganization meetings, special li-brary programs, children's story hour, and displays and exhibits, We also propose a small exten-sion on the south side of our per-holical momentable with continue iodical room enabling us to continue binding periodicals for reference purpo

#### WHY DO WE NEED MORE BOOKS?

MORE BOOKS? A sizeable subtroan community such as Hicksville, needs a strong high quality book collection to meet the damands of a relatively sophistic ated public. Several years ago, we converted one of our main stack rooms to a children's li-brary. We now have a specious children's library but we have loss space for 40,000 adult books in the process, Consequently, we are nearly out of stack space in the early out of stack space in the dult reading room. We need 120, 100 - 125,000 volumes to adequ-

ately serve all age groups. At present we have 70,000 with little space available to add to this fig-urc. At the same time we are purchasing 10,000 volumes a year. The population explosion in the 13-19 age group plus expanded and ambitious educational pro-grams have placed heavy respon-sibility on library services. An expanded book collection is the cornerstone of our long range plan to ret our responsibilities in this area. We have already created the post of Young Adult librarias in order to concentrate on this age group and serve them more effic-iently. WHY DO WE NIFFD

WHY DO WE NEED MORE SPACE?

MORE SPACE? It is as important to have read-ing room facilities as stack space. Every alternoon, Saturdays, and most evenings, the library is filled with high school, junter high school and college students, with seats at a premlum. This is difficult for adults, children and staff. In order to serve our adults and young peo-ple adequately? we simply must have a larger seating area for these youngsters. Purthermore, if we are to continue the growth and development of our book collection we must provide the stack space. If we have no adultional stack space. we must soon begin to use the pre sent browsing area in the reading

### WHAT IS PURPOSE OF PROPOSED

MEETING ROOM?

MEETING ROOM? The new commanity room will be used for organizations to hold public meetings, for children's programs, art exhibits and library sponsored films, book talks, lec-tures and concerts. Many of these programs are now held in the read-ing room of the library since our present room is sometimes in-adequate to accommodate the crowd. This is very often true of our mastical programs which have generally attracted 150 to 200 people, We plan to use our present meeting room for storage of supmeeting room for storage of supreference

This is important as we will event-ually be forced to discard many still useful volumes if we do not have space available for this type of material. Please bear in mind that excavation would be near a statistic that excavation would be near a statistic to a degree to install heating and to make a safer entrance to the children's tibrary. The library and the Hicksville Public Library Association have been presenting Association have been presenting these special programs for several years and we are anxious to con-tinue and expand this community

#### DO WE NEED EXTENSIVE PUBLIC LIBRARY SERVICE TO STUDENTS?

This question is often asked in the light of school library ma-brials. The answer is that the changing nature of the school pro-grams and the type of student use, place demands on school and public libraries that were not conceived of 20 to 25 years ago. Many ref-erence questions are of a compli-cated and involved nature that re-quire professional assistance and advanced material to answer. As advar ed material to answer. An effective public library by virtue fessional assistance and availabilfessional assistance and availabil-ity serves as a centralized source of material to students of all ages. Of course the function of the public library goes beyond immediate academic needs. We'are trying to introduce children of all ages to material that will enrich and fur-ther develop the aubjects on which individuals are undertaking formal education and enable them not proindividuals are undertaking formal education, and enable them to grow into mature, responsible citizenas. This is a challenging age group that needs special attention. At least 65% of our reference work is with this group.

### WHAT IS THE REASON FOR PERIODICAL ROOM

SUPPORTS LIBRARY BOND To the Editor: One of Hicksville's finest insti-utions, the Public Library, has outgrown its quarters. Its services to the community have increased renorrically in-the lass several years: nearly 30,000 residents have established borrowing privi-leges and its annual circulation new exceeds 350,000 items. The library, which adds nearly 10,000 new items a year, is now out of stack space. Even worse, its modest reading room no longer can pretend to hold the ever-growing number of young people who use its extensive and valuable research facilities in their snucles. EXTENSION. Periodicals have been most use-ful in helping us to find material an current problems. There is no area in the library that has grown faster in use and efficiency than this area. Since we have been binding many periodicals and have develop-many periodicals and have develop-many periodicals and have develop-mentiving. area, since we have develop-ed micro-film service, the re-sponse has been very gratifying. The space problem, however, needs to be rectified in order to continue this necessary service. We are currently receiving 182 periodicals and binding 88 of them. We are receiving the New York Times on micro-film and filming some of the local papers. Bound periodicals are indispensable to a public library but they require con-hiderable space. who use its extensive and valuable research facilities in their studies. A proposal to build a substan-cial addition on adjacent property will come before the voters in Decombers. The new wing will more than double reading room acco-modations and will provide stack space for years to come; it will particularly benefit the rapidly growing teen-age population of the city. 
