Budgets Passed In Light Verse . **Seeking Recount Of School Voting**

A formal request for a recount in the Hicksville School District vote on the school and library budgets and election of trustees was filed, Wednesday night. The last previous request for such action took place about ten years ago. In the relatively light voting this week, the voters approved both the school and library budgets by thin margins. Only 3900 out of 6600 registered cast their ballots.

The election was seen as a sharp rebuke to School Board member William A. Bruno Jr. His three personally-sponsored candidates were rejected at the polls.

Jackson, incumbent member completing his first three-year term, was re-elected by 2,606 votes to 1,062 for George M. Martin making his third unsue-cessful bid for election in the district.


