

## **Fire District Acquires Property on E Marie St**

The Hicksville Board of Fire Commissioners have brought the former garage-service station of George Neder Jr. on E Marie St., Hicksville, adjacent to the main fire headquarters, it was learned this week and will take title shortly. The purchase was effected by the use of reserve District funds.

The garage and adjacent parking area will be used to enlarge the operating capacity of the Main fire headquarters. It will also provide off street parking for volunteer firemen answering alarms.

The completion of the LIRR grade crossings elimination program will no longer make it neces sary to consider, at this time, relocation of the Main firebouse to dispatch equipment promptly, a Board spokesman indicated. 
