By comparison, only 89,436 voted a year ago in the race for Town Supervisor which Pettio won with 45,836 over Thomas R, Pynchon with 43,600. Favorite son candidates, gen-erally, did fairly well in the 10 Oyster Bay districts re-ceived 64,138 and his opponent 61,753. 
