In the past months, I have often cringed at the tone and language of the material sent to residents multical from the point-of-view of the public which was being asked to read and understand it. It seems incredible that this should have been overlooked or ignored.





On cash advances, a service charge of 1 per cent will be made each month on the balance. A 25-cent charge will be made for each cash advance and card-holders will be required to pay at least 1/24 of the original balance monthly. 7
