

# **GOP Pledges To** Achieve Economy

Town Board Majority Leader Ralph J. Marino said that the majority members of the Board will continue to direct their ad-tention toward achieving economy of operations in local government in 1968. of operation in 1968.

in 1968, "Our major problem in 1968 will be to make certain that the tax line is held without sacrific-ing essential services," Marino said. He pointed out that the Board will continue to review the Supervisor's spending programs, eliminating those it feels are un-necessary to the efficient opera-tion of the Town. "We have made a fine start

tion of the Town. "We have made a fine start toward this goal," Marino said, "in effecting an \$181/2 million reduction in the Supervisor's capital expenditure program and in having held the tax line by catting his proposed operating badget for 1968.

"This slash in the Supervis-or's operating budget gives our or's operating budget gives our tarpayers a ten per cent across the board tax reduction for this year and stabilizes the rate of expenditures for capital im-provements over the next five years, eliminating peaks and val-leys in Town payments for boad-ed indebtedness, "Marino added,

ed indebtedness," Marino socras-The capital program planned by the Board also provides fiscal flexibility enabling the comptrol-ler to take advantage of favorable interest rates in this bond market. The Board's 1968 capital finan-cial program provides funds to strack a number of complex prob-lems confronting the Town.

attack a number of complex prob-lems controuting the Town. One million dollars has been examarized for conservation pur-poses including and l-out assault on the eel grass problem on the South Shore. These funds will pergram of installing new nets nearer the mouths of the canals to prevent eel grass from drift-ing into the residential areas. Monies will be provided to pur-chase additional equipment to more efficiently collect and dis-pose of floating eel grass. An-other plase of the program in-cludes the dradging of shoaled canal mouths which face block-age by sodiment as a result of wind, waves and tide action. The plan calls for the elimination of these mavigational hazards to permit fuller utilization of exist-ing canals and all tides. Re-cently, the Board acted together with the N.Y. The law will require all appli-casts for zoning changes to re-veal the corporation's principals to the Town Board. Consideration for the estab-lishment of a Board Majority has requested the Commissioner of Fublic Works to present it with a plan for the conversion of the old Fourth District Court-house in Hicksville to a Town museum, and H is boped that federal aid will - be obtainable for this project. "The problems of the Town of Oyster Bay are complex but not insurmountable," Marino said, "I am confident we can accom-plish much of the local govern-ment level without imposing ad-ditional taxes, All department heads have been instructed to economize wherever possible and to effect further reductions in operating costs without sacrific-ing essential services,"

Town Councilman A. Carl Grunewald in a New Year's message recommended that the Oyster Bay Town Board urge the Governor and the State Legislature to produce and pass an adequate bill "providing a full uniform disclosure for all municipalities throughout the state,"

Grunewald said despite efforts of local governmental agencies, the entire dis-closure concept, whereby all applicants for zoning changes must reveal the corporation's principals to the torm boards, would be best accomplished by a statewide disclosure law,

a statewide disclosure law. "A law governing all munici-palities in the state and ap-plicable to everyone would strengthen the disclosure ordinances that have been ad-opted by some town boards," said Grunewald. He added that alleged recent developments in







# Margiotta Succeeds Senator E. Speno As G.O.P. Chairman

Assemblyman Joseph M. Margiotta of 924 Hempstead Blvd., Uniondale, rated throughout the state as a "master political technician," is succeeding State Sen. Edward J. Speno of East Meadow as Chairman of the Nassau County Republican Committee.

Margiotta, who has been chairman of the Hempstead Town Republican organization and a close associate of Speno, received the unanimous endorsement of the party's 100-man Executive Committee at a meeting on Dec. 27 at Republican headquarters in Garden City.

Margiotta, 40, was unopposed for the county's top GOP post. His name was placed in nomination by State Senator John D. Caemmerer, Chairman of the North Hempstead Town Republican Committee, and won support from all three town units.

The full 2,000-man County GOP Committee is expected to ratify the succession at a meeting this Thursday, Jan. 4, at 8:30 p.m. in the Garden City Hotel.

Margiotta, has been open and candid regarding his intention to make the chairman's job a "career". In accepting the unqualified support of the Executive GOP Committee, he declared:

"I consider it a high honor and a rare opportunity for service to my Party. The Nassau Republican organization is one of the largest and most powerful political units in the nation, and I intend to do everything I can to keep it this way."

Close associates and political opponents have no doubt Margiotta means what he says. He is considered a tireless worker and a master political technician whose steady rise to the top of the Nassau GOP hierarchy began as a committeeman in Uniondale's 62nd Election District.

Since then he has achieved success in both political and governmental spheres. An attorney who rates himself as a "moderate" Republican, Margiotta was elected an Assemblyman in 1965 from the 12th Assembly District, but was a seasoned Albany veteran before that.

He acted as legislative consultant to the Nassau County Board of Supervisors, counsel to the Joint Legislative Committee on Highway Safety and Motor

Vehicles and legislative counsel to Senator Speno before he was tapped by his party as a legislative candidate.

As a legislator, he has compiled an enviable record in Albany through hard work and skillfully applied expertise. He has battled against New York City's income tax on commuters and has waged a vigorous fight against compulsory busing of students away from their neighborhood schools. He has been in the forefront of campaigns to increase state aid to schools.

Margiotta is Vice-Chairman and the only Nassau Ašsemblýman serving on the prestigious Joint Legislative Committee on Education and in his short time in the legislature has emerged as the second ranking minority member of the Assembly Education Committee. He has also served on the Real Estate and Mortgage and Penal Institutions Committees.

In the political sphere, Margiotta rose through the ranks. From committeeman, he rose to president of the community's Republican Club, and won the confidence of his fellow committeemen when he was chosen Uniondale's Republican Executive Committeeman.

Closely associated with Senator Speno, Margiotta served as Deputy Hempstead Town Republican chairman when Speno held both the office of Nassau County and Hempstead Town leader. Subsequently, Speno relinquished his town post and Margiotta was overwhelmingly elected chairman in June 1967. In November, Margiotta's organizational ability was demonstrated when he masterminded a landslide victory for the entire GOP township ticket headed by Hempstead Presiding Town Sopervisor Ralph G. Caso.

Margiotta has lived nearly all of his life in Nassau County and Hempstead Town. He is a graduate of the Uniondale Grade School System, Hempstead High School and Hofstra University. He obtained his law degree from Brooklyn Law School.

A former trustee of Hofstra University and past president and board chairman of the University's Alumni Association, Margiotta was named outstanding alumnus of the year by the Hofstra Alumni Association in 1966.

Active in the community, Margiotta is a founder and past chairman of the Uniondale Library Board. He is a forner commander of the Uniondale VFW Post, past director of the Central Island Mental Health Center and former chairman of Boy Scout, Cerebral Palsy and Cancer fund drives.

He holds memberships in the Nassau County Historical Society, Nassau County Bar Association, Hempstead Elks, Uniondale Kiwanis and Uniondale Knights of Columbus.

Margiotta maintains a law office at 955 Front St., Uniondale. He and his wife, Dorothy, have two children, Michael, 10, and Carol Lynn, 6.

#### New Postage Rates

New PUSING KAIES Nearly 10,000 postage vending machines, including those at Hickswille and its Plainview Branch Post Office, will be con-verted over the new postage rates, Postmaster Ralph G. Cascardo said today. New postage rates go into ef-fect January 7, 1968, the Post-master noted. The new rates raise first class postage to b-cents an ounce, and postal cards to 5-cents.

to 5-cents. The job of converting the thou-sands of vending machines found in post office lobbies from coast to coast is so massive that it will take several months to com-plete, the Postmaster said. Five different rypes of machines are involved, he noted.

Involved, he noted. Most of the machines now pro-vide S-cent and 4-cent stamps for nickels, quarter or dimes. After the conversion, the ma-chines will provide S-cent and 6-cent stamps. A new model will offer 1-cent, S-cent and 6-cent

stamps. The Postmaster said that the vending machines located in the lobbies of post offices are not to be confused with commercial stamp vending devices found in many stores. Such commercial machines provide a margin for profit and are not controlled by the Post Office Department, he Post Office Department, he \*\*Post office vending machines

can be a big convenience to postal patrons," Mr. Cascardo said, "The devices permit mail-ers to ignore waiting lines at stamp sales windows or to buy stamps to mail letters after the vindows have closed."



### State Sen. Caemmerer Proposes Surplus Textbooks Depository

A bill to establish a state sur-plus textbooks depository will be prefiled in the Legislature by State Senator JohnD, Caemmerer of Nassau's Fifth Senatorial District. It amends the State ed-ucation law. Under the provisions of the proposed legislation, the Com-missioner of Education would be authorized to establish a surplus textbooks depository, hea ledby a director and such staff as deemed "necessary for the proper opera-tions of storage places for the surplus textbooks is left, to the surplus textbooks is left to the discretion of the Commissioner of Education

The bill requires each school district in the state to forward its surplus textbooks to the deposi-tory for storage, The textbooks

will be made available without cost to any e ucational institu-tion requesting them. Transport-ation costs, however, must be borne by the educational institu-tion requesting them. "I believe this legislation will fuffil a pressing need by supply-ing textbooks to schools and other educational institutions that can put them to good use." Senator Caenmerer said. "It is in-wed a shame to deprive students who can use such text-

"It is inneed a share to be prive students who can use such text-books and that is the principal aim of this proposed legislation." Senator Caemmerer said that otherwise the textbooks would be otherwise the statuous would be burned or destroyed in some other way. "Many of these test-books are practically brand new and certainly further use can be made of them," "Up until now."
