## **Herald Report: Hicksville School District**

The Hicksville School Board has set up an open forum meeting for Monday, Sept. 9 at 8 P.M. in the High School Auditorium. Members of administration and the board will be on hand, in an informal setting, to answer the public's questions about the proposed budget, austerity and other school matters.

Registration for the third budget vote is scheduled for Saturday, Sept. 7 from 10 a.m. to 9 p.m. in the Administration Building on Division Avenue. The vote is Thursday, Sept. 12 from 10 a.m. to 10 p.m. in the local schools. The school board meeting will be held that night at 8 p.m., recessing at 10:30 to go to the High School cafeteria dn accept the election results.

At last Wednesday's meeting, the board approved a limited

selection of sandwiches. Depending on the outcome of the budget vote, the cafeteria will gradually increase the program as warranted.

The board confirmed its vote to reduce the school monitor staff by half – 25 of the 52 monitors will be laid off (in reverse order of district - wide seniority), but will district - wide seniority), but will be placed in priority positions on the substitute list. This action is due to the reduction of \$30,000 in the monies budgeted for monitors. In compliance with this action, all schools will have half as many lay help personnel as last year.

The board of education also made some revisions in the school-day opening exercises. A variety of patriotic songs will be played, instead of exclusively using the national anthem.

However, an administrative recommendation to delete a moment of silent meditation (except at general assemblies)

moment of sitent, meditation (except at general assemblies) was not accepted.

The board approved various bills, awards, personnel appointments and a transitional class at Woodland Avenue. For the latter, BOCES will rent our facilities for a maximum of 10 special education students per class (some from Hicksville, the rest from other districts.) Students will be kept in this class until they are able to return to their own schools. As vacancies occur, Hicksville students will have priority in filling the facancy. BOCES will pay for the Leaching, guidance, psychological and other supportive services and \$3 per square foot for the use of our facilities.

Last week marked the completion of another successful Supervisor's Summer Intern Program. During the past two months, nine college students were assigned to various departments to work on projects matching their particular in-terests and abilities and which contributed to the needs of the

These interns were selected from more than 150 candidates based on their superior academic standings, demonstrated desire to learn more about local government and a willingness to contribute their talents to its

In addition to their assigned duties, the interns attended meetings of the Town Board and the Nassau County Board of Supervisors and toured a number of Town and County Departments and facilities

Working with my staff were Donald Carbone of Plainview and Daniel Squire from Syosset. Both young men carried out extensive and assisted in the

preparation of several proposed Town Ordinances.

Tulinda Deegan of Locust Valley completed an assignment in the Office of the Receiver of Taxes and then worked on several projects for the Town's American Revolution Bicen-tennial Commission.

Two interns were assigned to the Department of Community Services. James Drake of Hicksville, a victim of cerebral Hicksville, a victim of cerebrai palsy himself, worked on program analysis and development for the Town's various programs for the han-dicapped. Michael Ingha of Farmingdale assisted with a reevaluation project of Town Youth Programs and also researched various Federal and State sources of funding assistance. assistance

The Planning and Development Department put Brian Miller of Massapequa to work on statistical analyses of com-munities in the Town. The planning and programming of the many and varied sports programs at the Town's parks was the assignment of Andrew Curtis of Massapequa Park for the Department of Parks and Recreation.

### Regents Exams

The State Education Departnt's College Proficiency and gents External Degree Regents External Degree examinations will be given November 7 and 8, at testing centers throughout New York State and several other states The application deadline date is September 30. The examinations cover areas of the arts and cover areas of the arts and sciences, business, foreign languages, nursing, and education, including health education and reading instruction in the elementary school. Over 60 proficiency examinations are administered four times a year in February, May, August and November. The winter ad-ministration will be Frbruary 6 and 7, 1975 with an application deadline date of December 30,

Proficiency and deadline date of December 30, College Proficiency and Regents External Degree Examinations provide an op-portunity for people to validate college-level knowledge gained outside the formal classroom. The outside the formal classroom. The tests may be used to gain college credit, earn Regents External Degrees, meet certain teacher certification requirements, or for job advancement. Over 65,000 job advancement. Over 65,000 credits for passing grades have been granted by colleges and teacher certification units. New examinations are being developed in Anatomy and Physiology, Introduction to Criminal Justice, Criminal Investigation, and for the Reading Teacher.

One of the major blockades to offshore drilling in the Atlantic off Long Island fell last week when a Federal judge ruled that the Federal government, not the individual coastal states, have jurisdiction over the seabed and the right to control exploitation of

Although the ruling was only reliminary to an eventual Supreme Court decision on the matter, it is unlikely to be matter, it is unlikely to be reversed when the high court convenes again in October.

Interior Secretary Rogers
Morton and other U.S. officials
had long promised that there
would be no movement toward
any Atlantic drilling until the
jurisdictional dispute was settled
by the court. by the court,

The case stems from a claim by the State of Maine that it had jurisdiction over its coastal seabed and resources because of grants made under colonial charter. Twelve other Northeast coastal states joined Maine in petitioning the court for dwnership of their respective undersea lands, but last week's ruling appears to have dealt a major setback in our long fight to

block Atlantic oil probes

block Atlantic oil probes.
Should the Supreme Court, as seems likely, uphold the findings of Judge Athert Maris, the Interior Department would, in all probability, proceed with steps leading up to offshore drilling.
The Council on Environmental Quality has alredy pointed out the dangers of drilling close to Long Island shores in an exhaustive report and study they conducted in 1973. Notwithstanding our present spergy shortfall, we

in 1973. Notwithstanding our current energy shortfall, we should not be stampeded into accepting potentially-dangerous oil exploitation.

If last winter's acute shortage pointed out anything, it was that there are clean energy forms which are entirely feasible if we will only device the needed at-

which are entirely feasible if we will only devote the needed attention to bring them to commercial application.\*

Already, huge strides have been made toward finalizing some forms of energy production that the oil companies would have had us laughing at three years ago in derogating commercials.

# Caso Invites Soviet Jew To Nassau

Nassau County Executive Ralph G. Caso has issued an invitation to a Jewish woman, recently released from a Russian jail, to visit Nassau County.

The woman is Mrs. Sylva Zalmanson, a prisoner whom Caso attempted to aid by twice sending packages of clothing and medicine.

On receiving news of the release of Mrs. Zalmanson, Caso, the first Nassau recipient of the Greater New York Conference on Soviet Jewry's "Freedom Shield" for his support of Jews in the Soviet Union struggling to express their religious beliefs, conferred with representatives of the Long Island Committee for Soviet Jewry and immediately issued the invitation to visit Nassau.

Mrs. Zalmanson, her husband Mrs. Zaimanson, her husband and two brothers were sentenced to 10 years at hard labor in the Potma Labor Camp. Her deteriorating health, loss of hearing and the inhumane conditions at the prison were brought to Caso's attention by the committee nearly, three years

Initially, Caso sent a package Initially, Caso sent a package containing a heavy coat, other warm clothing and vitamins. The package was rejected and returned to Long Island with the notation that the prisoner was "inconnu" or unknown.

A second package, sent in December, 1972, was similarly rejected and returned to Caso, last week, simultaneous with the Soviet announcement of the release of Mrs. Zalmanson.

"We never accepted the
Russian claim that Mrs.
Zalmanson was 'inconnu,' Caso
said. "It is heartwarming to
receive this absolute proof that
she is, indeed, alive."

After speaking with Mrs. Inez Weissman, committee president, and Mrs. Lynn Singer and Mrs. Tobie Newman, vice presidents, Caso issued the following statement:

"Mrs. Zalmanson's release is a victory for freedom-loving people

everywhere. We in Nassau County are proud of the role we played in trying to improve Mrs. Zalmanson's condition while in prison and in keeping the fact of her cruel imprisonment before the community and the world at large.

"It is my hope that when Mrs. Zalmanson leaves the Soviet Union she will pay a visit to the United States and Nassau County so that we may welcome her and recognize her courageousness with suitable ceremonies."

"We will continue to assist in the freedom struggle of the remaining 45 'prisoners of conscience' in Soviet prisons."

Mrs. Zalmanson has indicated a desire to emigrate to Israel but steadfastly refuses to leave Russia until her husband and two brothers are released.

Caso is seeding the mailgram invitation to Mrs. Zalmanson care of Andrei Sackarov, the remowned Soviet scientist at whose Moscow home she is staying.

## **Survey Questions County** Services For Elderly

Twenty-thousand senior citizens will be asked to take part in a county-wide survey to determine the effectiveness of existing services to the elderly and the gaps that may need filling. The Nassau County Department of Senior Citizen Affairs has mailed a questionnaire to a random list of some ten-thousand residents age 60 and ten-thousand residents age 60 and over. An additional ten-thousand questionnaires will be distributed through the Department's six Nutrition Sites and 160 senior citizen clubs and centers. Information obtained from the

tabulation of responses to the 16 questions will help structure a comprehensive and coordinated system of services to the elderly unprecedented in Nassau County's history. The New York State Office for the Aging has designated the Department of

Senior Citizen Affairs as the "Area Agency on Planning" in Nassau, and has awarded it a grant of \$474,873 under Title III of the Older Americans Act of 1965. The County is matching the federal grant with an additional \$70,809, bringing the total program value to \$\$44,682. Under the proposed plan, the Department of Senior Citizen Affairs will regionalize the County into eight Sub-Areas on Aging whose objective will be to eliminate duplication of services, draw commitments from public draw commitments from public

eliminate duplication of services, draw commitments from public and private agencies to meet the needs of the elderly population and to provide adequate supportive services so that the elderly can maintain maximum independence and dignity in home environments. In addition to a field staff, the Department will operate a mobile unit to bring

"one-stop" services directly to the senior citizen community. Commissioner Adelaide Attard of the Department of Senior Citizen Affairs urges seniors who receive the questionnaire to complete and return it promptly. "This is a unique opportunity for the seniors of our County to have direct input into the development of a master plan, which will not only improve the quality of their

of a master plan, which will not only improve the quality of their lives, but will make life better for the senior citizens of the future," said the Commissioner.

HICKSVILLE VOTERS go to the polls for a third time on Sept. 12 to decide on a school budget. The question is: will they support it or defeat it again? What is included in the budget for them to support?

WHAT IF you're a parent of a student in the Hicksville schools-what is there for you to support? This budget offers you a full educational program, complete with the "basics" (reading, writing, math, complete with the "basics" (reading, writing, math, science, social studies, English, physical education, etc.). The "specials" (music, art, foreign language, etc.), the supportive services (guidance, health care, psychology, speech, learning disabilities and extended readiness classes, etc.), and all the supplies to carry out these programs. This budget offers you transportation, cafeteria, extra-curricular activities and interscholastic sports.

WILL YOU support it? If you feel your children will

WILL YOU support it? If you feel your children will benefit from a full program of scholastics and co-curricular activities—you will. If you have priced school supplies and found that buying your own for each of your children may cost you more than an increase in real estate taxes (there will be an increase in the latter even on austerity)—you will. If you have in-formed yourselves of education law and have con-firmed that losses of transportation, cafeteria and other aspects of the school program are not threats used by the board of education and school administration to secure a budget approval, but are, in

reality, requirements of the law-you will.

WHAT IF you're a homeowner in Hicksville with no children, children in private school or children out of school, what's in the budget for you to support? This budget offers a full Adult Education program, an Evening High School for those students who may have dropped out before graduating, Community Chorus and Orchestra, and public use of school buildings and

WILL YOU support it? If you planned on driver's education or a sewing class or that course on oil burner repair-you will. If you've worked with Boy Scouts, 4-H or Little League and don't know where you'll be meeting this year--you will. If you've been annoyed by vandalism and wonder why the young people don't have someplace to go and constructive activities to

have someplace to go and constructive activities to keep them busy-you will. If you've attended football games, enjoyed watching school bands march in the Memorial Day parade, or looked forward to the plays and musicals at the High School-you will.

WHAT IF you're an older resident of Hicksville, living on a fixed income, what is there for you in this budget? Will you supportit? If you participate in Senior Citizens activities and realize they are sponsored under the auspices of Adult Education-you will. If you pay as a "Senior Citizen" is granted by the school board and that though they may vote this lower rate, they are not required to-you will. If you have attended plays and other school activities at a reduced rate for "Senior" Citizens" or received free bus transportation -you will. ## Saladino: Hedges, Fences Hazardous to Motorists, Cyclists

Oyster Bay Town Councilman Joseph J. Saladino issued a statement this week urging all residents to cut hedges that obscure the view of cyclists and motorists or block street and traffic sign.

motorists or block street and traffic signs.

"With school starting soon and darkness coming earlier every day," the Councilman remarked, "it is most important that driving hazards be cut to a minimum. Also, the rising number of cyclists on the road make it imperative that they and motorists alike have a clear and unobstructed view of intersections and signs."

Saladino reminded all corner lot owners that hedges and fences may be no more than 30 inches

nay be no more than 30 inches high measured from the crown or the center of the road. If a homeower is found to be in violation of this regulation, a letter will be sent from the Building Division requesting that

the offending hedge or fence be fixed. Failure to do so will result

fixed. Failure to do so will result in a court summons and possible fine.

Saladino also reminded residents that the Town's Highway Division has jurisdiction over trees that obstruct signs or intersections. Low hanging branches are trimmed regularly so as to permit maximum visibility. He commented that homeowners may, if they wish, trim their own trees if any branches are hanging over

they wish, trim their own trees if any branches are hanging over sidewalks or signs, but to call the Highway Division at WA 1-1030 if the job is too large.

"I think that giving out motorists and cyclists unobstructed view of intersections and street and traffic signs will measurably cut down on the number of accidents," Saladino stated, "and if the residents and the Town work together, this can be easily accomplished."

"As in other areas throughout the state and nation, revenue sharing has given back to the taxpayers some of the tax dollars they send to Washington, so that their local officials, who know local priorities best, can do such thinge as refurbish the Onondaga War Memorial Building, develop and improve the county's parks and recreation system and begin the design of a facility such as the Hillbrook Detention Home for juvenite delinquents," Caso stated.

Mulroy pointed out that many programs and projects in Onondaga County are being financed either totally or in part with revenue sharing funds.

"Any cut in our revenue sharing money would force us either to severely curtail these programs or raise local taxes to continue them," Mulroy asserted.

"By passing the general revenue sharing program in 1972, Congress voted its confidence in

the ability of local gov-ernments to manage their own affairs and set their own priorities. This confidence must be continued," Caso and Mulroy concluded."

### Levine Bills Become Law

On Sept. 1, four important bills, sponsored by Assemblyman Stuart R. Levine (R-Bethpage) to met day-to-day needs, become

Assemblyman Levine said that Assemblyman Levine said that many daily living needs will, be met by providing increased consumer and environmental protection, fire and public health safety and prohibition of discriminatory abuse against the blind.

blind.

Through Levine's legislation, licensed pharmacists are now required to wear ID badges while on duty, the Attorney General is empowered to seek injunctive relief for serious sanitary violations of the Public Health Law, the Nassau County Fire Marshall will be able to cut down the length of time between violation of the Fire Prevention Ordinance and compliance with the law and care service facilities are prohibited from discrimin-

Ordinance and compliance with the law and care service facilities are prohibited from discriminting against the visually handicapped who seek admittance. These four bills were part of Levine's legislative program which was enacted this year.

The practice by licensed pharmacists of wearing ID badges while on duty will provide basic consumer protection by assuring prescription drug customers that their orders are, in fact, being filled by qualified pharmacists and NOT by other drugstore personnel. Now, when a customer enters the pharmacy, he will be able to immediately identify the pharmacist who will be wearing a black and white chest badge, Levine said.

"Under the new Public Health Law, restrictions are established."

on water supply to temporary residences, including children's camps and other temporary dwellings such as hotels, motels and trailer parks. Significant environmental protection will be provided by alleviating unsanitary conditions which always create ecological hazards.

"The Commissioner of Health can now request the Attorney General to seek injunctive relief in addition to the presently provided \$1,000 penalty. This will be extremely effective in forcing violators to quickly correct unhealthy conditions and is also consistent with existing legal provisions which control water and air pollution, Levine continued. and air pollution, Levine con-tinued.

"Another bill will encourage voluntary compliance with Nassau County's Fire Prevention Ordinance. Until now, compliance has been achieved through the cooperation of offenders. Unfortunately, though, some persistent violators have created severe savety problems by being allowed to wait long periods of time before court appearances.

"My new law authorizes the Nassau County Fire Marshall to issue appearance tickets to violators so that rapid action can be taken.

"Another new law will also help to geliminate the tragic and Another bill will encourage

"Another new law will also help to eliminate the tragic and inhuman abuse against the blind who must seek admittance to propietary nursing homes. Numerous constitutents have told me that either they, themsleves, or their relatives have been refused admittance to adult or convalescent homes due to visual

handicaps. This discrimination is now spelled out by law and is strictly prohibited. The State's blind who are incapable or adequately providing for their own care will now be protected against this thoughtless abuse," Levine concluded.
