Referendum Set On Public Works Project

A resolution calling for a special referendum on a public works project was adopted by the Hicksville Board of Education at its meeting last week. The date has been set for September 15. The passing of the referendum would authorize the school district to receive and expand federal funds for forthcoming. A referendum is required by state education law for expenditure of public works funds.

Mr. Greg Guercio, associate of school attorney Joseph Campanella, informed the Board that a bill has been passed by the legislature that would no longer require a referendum on public works projects. Governor Carey, however, has not signed the bill into law. According to the governor's legal counsel, said Mr. Guercio, "we won't find out until on or about August 15 if the governor has signed the bill."

Mr. Richard Weigand, Business Manager, told the Board that there was a "99% chance of receiving the federal funds" which could amount up to \$385,000. The funds are to be used, as a first priority, for the construction of a maintenance garage and, as a second priority, for the construction of a ramp at the public library.

The Board also approved the staff for the evening high school as well as adult education in-

structors and courses. The Board approved an increasing of fees for arts and crafts courses and a registration fee of \$5 for out-of-district residents.

Two executive sessions were held by the board to discuss personnel matters. They later approved assignment and transfers for forty-seven teachers; part-time appointments for buildings and grounds; and various clerical appointments.

Also approved was the appointment of Mr. William Willner as District Treasurer at an annual fee of \$2,500. Trustee Niel McCormack questioned the Board's action of appointing an out-of-district resident. Mr. Willner resides in Jericho. Also approved was the appointment of Arnold Sparr, as consultant-coordinator of the Curriculum Materials Center, with salary to be negotiated.

The Board approved the continuance of the district's remedial reading program in the public and non-public school for 1977-78. The program, is federally funded under Title I, ESEA, at a cost of \$72,596.

The Board accepted the notice of retirement from Mr. Erwin Rozran, Assistant Superintendent for personnel and pupil personnel services. Trustee Iris Wolfson, who made the motion,

expressed the sentiments of the Board: "We're going to miss you." Mr. Rozran, who has served the Hicksville school district for twenty years, begins his retirement on September 27.

Also approved was the hiring of Applied Data Services as transportation consultant. "The consultant" explained Mr. Richard Helfont, Assistant Business Manager, "will evaluate our existing transportation system and look at possible questions such as loading and routes." They would then prepare and submit "alternate viable schedules." The final report, which will cost \$1,950, is due October 15, as required by the Board. Trustee Neil McCormack asked that all schools be placed on uniform school hours.

The Board awarded bids totaling \$159,191.03 for the purchase of various music supplies and for building and maintenance supplies. The Board also approved the authorization to purchase equipment for the Special Education Department.

The next meeting of the Hicksville board of Education is scheduled for August 24, 8:15 p.m., in the conference room of the Administration Building. The public is invited to attend.

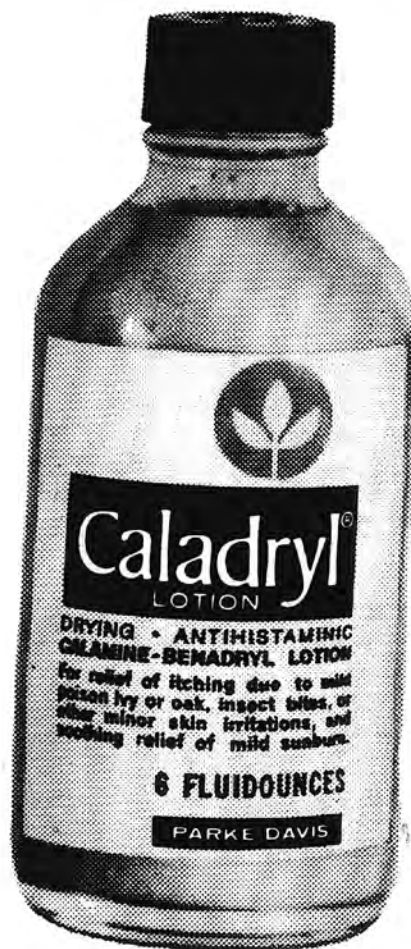

Senator Ralph Marino Joins Purcell Camp

Saying that it's difficult not to support an incumbent county executive for re-election, "but I must," State Senator Ralph J. Marino today accepted the honorary chairmanship of the People for Francis T. Purcell for County Executive campaign.

"The self-serving attitude of the present county executive is not the image of the future that the Republican Party must portray if the party is to be successful in the years ahead," Marino said.

"The present county executive is indifferent to the real needs of the average county homeowner. He takes credit for opposing pay raises for local policemen and municipal employees, but fails to remember that his administration earlier negotiated the contracts with these service groups granting them the huge pay increases they were entitled to.

"In Oyster Bay Town, as well as the other two towns and cities

here in Nassau, the present county executive has incurred a great negative job performance rating. Too many indicators point to the fact that the people want an alternative to him.

"As for State Senator John R. Dunne, my colleague in Albany, who is also seeking the party's designation, I must also oppose his candidacy, as he personifies the liberal policies of John Lindsay, the former Mayor of New York City.

"State Senator Dunne is very much of a liberal like John Lindsay, and his liberal attitude wouldn't be acceptable to the majority of conservative-minded, middle-income residents of this great county.

"Finally, Senator Dunne's mishandling of the no-fault insurance legislation which is costing individuals higher car insurance payments, makes his candidacy fragile at best.

"My alternative and the only alternative that I believe the people of this county can choose,

is Francis T. Purcell, a former businessman with a fiscal conservative philosophy of administering government.

"A vote for Senator Dunne would be a wasted vote and could only prevent our party from selecting an alternative to Ralph Caso," Marino said.

"In my opinion, Fran Purcell is well-qualified to be county executive. He's honest and has done a good job for the people. He's capable of restoring honesty and trust to government. He's the only alternative to Ralph Caso - the decision is clear.

"Fran Purcell was overwhelmingly selected by the committeemen of the party to be their candidate for county executive. The vote was 1,697 for Purcell, 90 for Caso, and 16 for Dunne.

"I believe that there must be an alternative to Ralph Caso and when selecting that alternative, the choice is clear - Francis T. Purcell," Marino concluded.

Advisor On Energy Conservation Named

Francis E. O'Connor of Locust Valley, who was the top energy administrator in Nassau County government during six years as head of the Department of General Services, was named today as Energy Advisor to the Nassau Board of Supervisors.

O'Connor's appointment to the non-salaried post will be formally approved by the Board at its meeting on Monday, August 8th, according to Hempstead Town Presiding Supervisor Francis T. Purcell, who said:

"The Board recognizes that there are serious problems facing county residents relative to critical fuel and energy shortages. There have also been many changes in legislation he created the Bureau of Energy

Resources which instituted a broad-based and successful program of energy conservation at all county buildings and facilities.

Under O'Connor's direction, the county developed one of the first municipal solar energy projects in this region, designed to cut heating costs at the county's largest office building at 240 Old Country Road, Mineola. County officials are optimistic regarding federal funding of this project.

O'Connor was appointed Commissioner of Oyster Bay Town's Department of Planning and Development in April, shortly after he resigned from county government.

- Aid-Weighting for Secondary Students.

- Expungement of Records of Certain Marijuana Law Offenders.

- Inclusion of School District on Income Tax Forms.

- Three issues that PTA opposed

Transportation Law Requiring Roof Hatches on School Buses was not delayed.

Two weeks ago, I read in the Herald, accounts of three children on bicycles who had been hurt that week by collision with automobiles. This has disturbed me ever since, for I think back a few months ago to a time when a child, riding on the wrong side of a divided highway ran into my car as I started to make a right turn. Fortunately, neither child nor his bike were hurt, though I felt as if I might have a heart attack. I love children and would never get over it if I hurt one. Besides that, I might have been in trouble with the law, even though the child was on the wrong side of the road. So there are two reasons to worry about children on bicycles: what it does to the child if hit by a car, and what it does to the motorist.

I have recently read that 85% of the cases the child is at fault. This seems inexcusable and that something can be done to correct or at least improve that percentage. After considerable thought and consultation with friends, several suggestions evolved. I pass them on as a possible step in the right direction. Perhaps you, the reader, may think of ways to improve or add to these beginnings. If so, I hope you will give your suggestions to the Mid Island Herald.

First, there should be a course in the schools about the 5th grade which teaches the traffic rules that pertain to bicycles. No child should be allowed to go on to the next grade who has not passed that course. I hear a friend reply, "they already know the safety rules. The police send someone every year to talk about bike safety." This I know is true, but it is not emphasized enough by the parents, the schools or the police.

If a certificate of passage were issued (a sort of unofficial preliminary license) it could be used not only as proof of having passed the course, but as the first step toward and eventual car license. It could be required for riding the current moped which is in a sort of legal limbo at present and offers the possibility of even more danger than the bicycle. This certificate could later become a help in obtaining an official driver's license - the dream of so many American kids.

Parents in the home can help tremendously if they take an active interest in the bicycle safety course and how it is applied in actual bike riding by their children.

The PTA could well afford to make bicycle safety one of their projects in co-operation with the schools. It would be an excellent thing (as well as good public relations) if the police would give the same bike safety talk to the PTA's that they gave in the schools, with a question and answer period at the end.

There is a great deal that the police can do. First of all the police should stop bike-riding children when they see violations explaining what the child has done wrong and what the results could be.

In addition, a yearly demonstration of safe riding by the police in conjunction with the schools and the PTA's would be a great help. Young children usually look up to the police with great respect, so that the Police Dept. has a fine opportunity to capitalize on that feeling and to strengthen it.

These suggestions are only a start. If the idea is good, it could perhaps spread from Hicksville to other towns, the county and even the state. But whatever is done, let it be something and soon. Let us cut down on deaths and injury to children—and trauma to motorists.

Jacobs And Polansky To Run On Yevoli Ticket

Judy Jacobs, who already has the Democratic Party endorsement for Oyster Bay Town Council, and Michael Polansky, Democratic candidate for the Oyster Bay Town Council, have both announced that they will seek their respective offices on the Yevoli Independent Line.

"I feel very comfortable running on an Independent line," Mrs. Jacobs said, "as I have always maintained a strongly independent position on all civic issues no matter what politics were involved. During the last six years as President of a large civic association, I have represented home-owners of every political label. My in-

dependent viewpoint will certainly continue if I am representing all the homeowners of Oyster Bay on the town board next year."

Mrs. Jacobs has long been associated with Assemblyman Lewis J. Yevoli, who heads the ticket as its candidate for County Comptroller. Mr. Yevoli also has Democratic endorsement.

Volunteer workers for Polansky will be circulating petitions for the Yevoli Independent Party candidacy between now and mid-August. While only 1500 signatures are needed to qualify, Polansky expects that "we should have no trouble collecting more than 3000."

Seven Vamps Injured At House Fire

Seven Hicksville firefighters were injured as they battled a general alarm fire on Sunday July 31 at 123 Brittle La. The 11:08 AM alarm brought out 80 Hicksville vamps, 9 pieces of apparatus under the command of Asst. Chief William Ferber.

The fire was situated on the second floor. The vamps were injured as they attempted to gain access via the interior stairway. They were stalled for several minutes by locked doors at the head of the stairway. The fire caused \$25,000 damage. Four adults, and four children escaped unharmed. The Levittown F.D. was called for mutual aid assistance to help transport the injured vamps to the hospital.

gain - with your help, this vicemen's Election information can be made available to many servicemen who are aided by their family, how to obtain a military ballot.

A viceman may file an application or he may write a letter giving his full name and rank, his date of birth, his home residence address and his military address. Applications and letters must be signed by the serviceman but need not be sworn to nor attested. The spouse, parent or child of a serviceman who accompanies him may similarly vote a military ballot.

The Election Law has been amended to provide a special form of application (Form 1a) for members of the Armed Forces serving OUTSIDE the continental limits of the United States, which may be signed by the spouse, parent, or adult child, brother or sister of the ser-

viceman. This signature must be subscribed and sworn to before a Notary Public or official authorized to administer an oath.

For the necessary forms write to Division of Servicemen's Voting, Albany, N.Y. 12231.

To the Editor:

Last week I received a copy of Director of the Office of Management and Budget Bert Lance's comments before the House Committee on the Budget regarding the mid-session review of the 1978 federal budget. In addition to the mind-boggling fact that every single figure in the entire 11-page statement is in billions of dollars, I was dismayed, as a taxpayer, by Mr. Lance's blithe remarks on the present and future deficits.

For example, he notes that "For 1977, our current estimates show... a deficit of \$48.1 billion." And then he adds, with what seems to me a touch of pride, "These estimates are within a billion dollars of the estimate that we sent to you in April."

Imagine: to have budget

estimates vary by a billion dollars in a three-month period and be able to brag about it. I am well aware of the spiraling costs facing all levels of government and the nature of budget estimates in general, but for the federal government to accept increased deficits this year and actually plan for an even greater deficit of \$61.5 billion in 1978 is difficult to comprehend.

Admittedly, we deal with much smaller numbers on the local level (our entire 1977 budget is only about one one-thousandth of the federal government's estimated 1978 deficit), but our policy has been, and will continue to be, that we will only budget for and spend what we expect in revenues. This Town is on a fiscal diet, and the budget officer is working full time on a line-by-line review of the budget with our department heads to develop an operating plan and budget for 1978 that will not produce a tax increase or a budget deficit.

I only wish this philosophy was more apparent in the present federal administration.

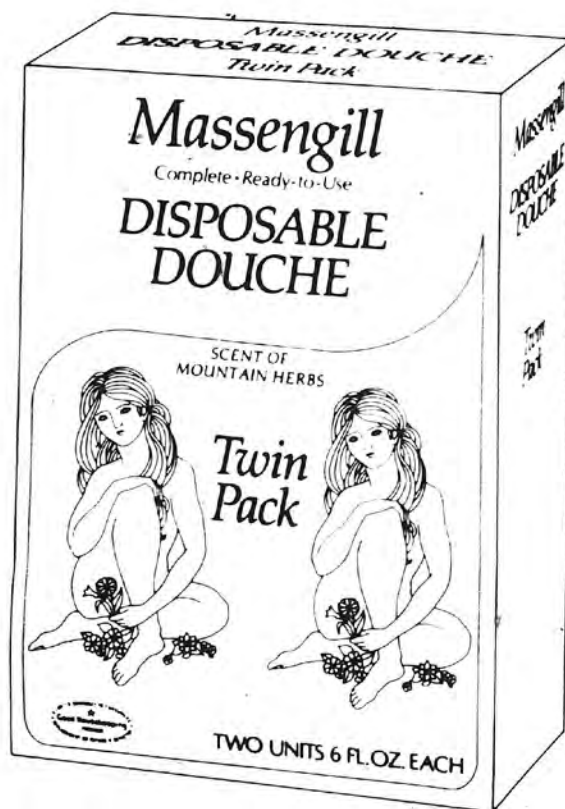

More On Bus Transportation

The Nassau County Bus Transportation system has petitioned for a dial-a-bus project in the Hicksville-Bethpage area. If we would be able to obtain it, the county would be given \$1,000,000 to buy 20 vehicles for our area.

Dial-A-Bus is a project that would work on the same premise as the taxi companies. After a telephone call, you would wait between 20 and 30 minutes for a

mini-bus to come to your door. There would be several other people on the same bus going in the same general direction and passengers would be dropped off one at a time - 'door to door' service. The mini-bus would be available in a community area only. Sounds great, doesn't it?

But now come the problems. The first day the system starts, it would be operating in the red, for it would have to build up clientele. Next, it is a system that could not be used for speed - such

as a specific train. And finally, due to the Urban Mass Transportation Act of 1964 and 1973 any employee in any other form of Mass Transportation (such as taxi drivers) who would lose their job because of this new project would have to be guaranteed employment with the Nassau County Department of Transportation.

It looks good on paper. But is it feasible?

PTA Ad Drive Hits Teen Alcohol Abuse

Give a wild grizzly bear a home permanent? Roller skate over a bog of quicksand? Load yourself with alcohol and then try to drive?

That's just what contestants in a mythical game show entitled "First To Do It," attempt in the National PTA's new radio spots. Released in July as part of the organization's nationwide public service media campaign, the spots promote awareness of problems stemming from teenage alcohol abuse.

The campaign consists of six 60-second radio spots, all using a preposterously funny game show format to make a serious point, and eight black-and-white print ads, which focus on situations any adolescent might face. Target market for the campaign is teen-agers and pre-teens. Alcohol is currently the

number one drug of choice among young people. The National PTA, alarmed by the increasing number of teen-age deaths involving automobiles and alcohol, and the long-term destructiveness of abusive drinking, has launched the campaign as part of its Alcohol Education Project, now in its fifth year.

Positive in tone, the campaign is not against drinking itself, but rather its harmful aspects. Both the radio and print ads suggest realistic, affirmative options to abusive drinking, and give teens credit for being able to make their own responsible choices about alcohol use.

According to Richard Spoonster, director of the PTA's Alcohol Education Project: "To our knowledge, this is the first such prevention campaign in the

country to focus exclusively on teen-agers, depicting typical youth alcohol-related situations, and offering positive alternatives to abusive behavior, instead of using the more common authoritarian or 'scare' messages."

The ads have been disseminated to national consumer and youth-oriented magazines, and youth market radio stations for public service placement. Producer of the radio spots was the Dick Orkin and Bert Berdis agency in Chicago. Both the print and radio campaigns were developed by the PTA's Alcohol Education Project team (Richard Spoonster, and Richard Bredsen, art director). Posters produced from the print ads will be placed in schools and other locations frequented by teen-agers, beginning this fall.

The specific object or purpose to be financed pursuant to this resolution is the grading, drainage and paving of the parking and storage areas located at the Department of Public Works Complex of the Town of Oyster Bay, Nassau County, New York, on Miller Road, west of South Oyster Bay Road, in Syosset, New York.

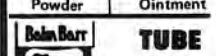

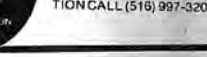

Advice For Boaters

Nassau County Police Department has issued an advisory to boat owners urging them to follow safe boating procedures and to insure the security of their boats and equipment.

In a move to promote safety on the water and to curtail potential larcenies and thefts, the department's Marine and Air Bureaus will be combining their efforts with intensive patrols.

These patrols are designed to render assistance to those in distress and prevent criminal activity. Boat owners should be alert to potential larcenies and vandalism as the season progresses and are advised to secure their property and be able to identify it properly.

They should also be aware of safety guidelines issued by the Marine Bureau which constantly monitors AM and FM international distress frequencies. For FM the frequency is 16 and for AM 2182. The guidelines include:

1. Leave word with someone where you expect to be boating and include registration numbers and estimated time of return.
2. Observe speed limits.
3. Use lights if out at night.
4. Keep up maintenance on boats and equipment.
5. Observe fire precautions.
6. Do not overload.
7. Have sufficient life preservers.
