## Post Office Welcomes Everyone To Safety Fair Sunday, October 7

"The Safety Fair is a first for the Postal Service on Long Island," says Hicksville Postmaster Anthony M. Murello. "We wanted to put together something to benefit the community and we hope everyone will learn a little more about the Postal Service and pick up some safety tips as well."

The fun starts at 1:00 p.m. Sunday, October 7th at the post office on 185 West John Street.

This is the first time the community can take a tour of our mail facility, eastern Long Island's largest and most advanced mail processing center. You will be able to see the optical character reader and bar code sorter as they process letters at split-second speed, the multi-position letter sorting machine, facer/canceller operation, flat sorting machine and more.

Postal workers will compete in a "roadeo" where they maneuver a prescribed driving course in the 1/2-ton, 1-ton, 5-ton and tractor trailer categories.

There will be over 40 safety and health displays by the Nassau County Police Department, Hicksville Fire Department, Nassau County Medical Center, American Cancer Society, Nassau County Traffic Safety Board, National Safety Council and many other organizations.

WGGB will transmit live from the fair. There will be free refreshments, rides for the children and drawings for safety prizes. The winners of the Hicksville Post Office Safety Poster and Essay Contest will be awarded prizes by master-of-ceremonies Ray Heatherton, the "Merry Mailman."

### "Getting To Know Hicksville" Course At The Gregory Museum

Registration is now under way for the Fall in-service training courses at the Hicksville Gregory Museum. "Getting to Know Hicksville," a ten session lecture and slide photo course will be held on Thursdays, starting October 11, at 4:15. The fee for the course is \$25. This course will provide 1 in-service credit.

Teachers and residents will enjoy seeing hundreds of slide and mounted pictures related to Hicksville's long, historic and colorful history. Here is a great opportunity to get to understand the roots and development of this important crossroads center. All aspects of community life will be presented for observation and discussion: the community's founding; its economic and political development; its strong efforts at preservation of

identity and traditions; its sometime controversies; its cultural history, and the problems confronting Hicksville today.

Conducting the "Getting to Know Hicksville" course will be Richard Evers, the Gregory Museum's Historian.

Also being offered at the Museum this fall is another of Dr. Charles Rockwell's informative, stimulating courses, "The Geology of Long Island." This is a ten session, twenty hour course, providing 2 in-service credits. The course will deal with the pre-glacial, glacial and oceanic stages of Long Island's geological creation. Beach erosion, ground water problems, and water pollution will be covered. The course will begin Wednesday, Oct. 10 at 4:15. Tuition is \$50. ## Local Man Arrested On Assault Charges

On Sept. 25, Nassau County District Attorney Denis Dillon announced the indictment and arrests of Michael Franzese and Frank Castagnaro on a charge of Assault in the Second Degree. Franzese, 33, of 7 Craig Street in Jericho and Castagnaro, 40, of 7 Central Avenue in Amityville are charged in connection with an assault that took place in Hempstead on September 21, 1981.

According to Dillon, "Thomas Trimboli, a businessman with real estate interests in the Hempstead area was beaten with a ball-peen hammer at his place of

business, J. Winick & Sons, a car dealership at 257 Main Street in Hempstead. He suffered lacerations to the head and leg requiring stitches. A short time after the incident, an employee for Frank Castagnaro, William Reese, was arrested and charged with the beating. He was subsequently convicted of the charge and sentenced to one and one third years to four years in prison."

The District Attorney said a continuing investigation by the Rackets Bureau and DA's Squad reveals that Castagnaro and Franzese solicited Reese to commit

the assault. Franzese was a tenant in a building owned by Trimboli. From 250 Main Street in Hempstead Franzese operated Lynn Mazda. Trimboli and a partner had gone to court to have Franzese evicted from this location for non payment of rent. Shortly before the assault, Franzese in fact was evicted.

Both men were arrested by the District Attorney's Office and were arraigned before County Court Judge Paul Lawrence. Assault in the Second Degree is a "D" Felony, punishable by up to seven years in prison.

# Federal Tax Dollar Can Come Back To Us

Thanks to the industrious effort of Oyster Bay's Department of Inter-governmental Affairs, We have developed some great programs that benefit residents throughout the Town, at no increase in our real property tax.

How is that possible you say?

Good question. Money from your federal tax dollars comes back to you in the form of federal funds allocated to local municipalities for programs that the locality has developed. One such program is called Community Development.

Under this program the Town is able to fund projects in the area of residential and commercial rehabilitation, public works, parks and recreation improvements, historic preservation and the removal of architectural barriers to the handicapped.

For the 1984-85 federal funding year, Oyster Bay will be receiving nearly \$1.5 million dollars for the Town's Community Development programs.

One of the most gratifying of these efforts is residential rehabilitation. Funding in this area enables the Town to assist eligible handicapped

residents to make their homes more accessible, both inside and out. The funds are used to construct entrance ramps, widen doorways to accommodate wheelchairs, redesign bathrooms and kitchens for greater accessibility and even to provide wheelchair lifts and stair glides.

Another part of the residential rehabilitation program permits the Town to aid the elderly and to help moderate income families maintain their single family homes. Money is made available to eligible applicants for basic

maintenance and repairs that would otherwise be left undone.

The removal of barriers that pose problems to the handicapped in public places is another on-going program. One of the most recent projects will make access to the Town Clerk's office in Oyster Bay much easier through the construction of automatic doors.

I know that you count on the Town to provide the best services at the least cost to you, the homeowner. By diligent research of the available federal programs, and by taking advantage of them, we are able to do that much more for you.

## THE PRESENCE OF THE BODY

Anthropologists have found the existence of a religious or communal rite of passage accompanying the disposal of the deceased in every society. Though these rites vary in many particulars - including religious content, method of disposition, rituals of mourning - they almost all have in common the presence of the body during the rite.

The presence of the body at the traditional funeral usually involves the viewing ritual, and the embalming of the body is an intricate part of that practice in America. Embalming for open-casket viewing of the body is a method of preserving the body for a limited period.

Embalming is routinely done by the funeral director after receiving family permission to do so. It is legally manda-

tory, however, if the body is to be transported by common carrier. In some states embalming is also required if there is more than a forty-eight hour interval between death and disposition, but basically the embalming procedure is done to allow for the open casket visitation period for the dignity of the deceased and prevention of further unpleasantness to the family.

## Consumers Alerted To Used Car Lemon Law

Attorney General Robert Abrams advises consumers who purchase a used car after November 1, 1984, that they will have important new protection provided by the used car lemon law if the used car they purchase turns out to be defective.

Consumers who have encountered any sort of consumer-related problems should take advantage of Attorney General Robert Abrams' Consumer Outreach Program which is meeting in Hempstead on the second Thursday of each month at the Hempstead Public Library, 15 Nichols

Court, from 6:00 to 8:00 P.M. The next scheduled visit will be October 11. A representative from this office will be present to take individual consumer complaints.

Under the used car lemon law, a consumer receives a warranty related to the mileage of the car they buy: 30 days or 1,000 miles on a car with over 36,000 miles; 60 days or 3,000 miles on a car with under 36,000 miles.

The warranty covers most essential mechanical components, including engine, transmission, drive axle, brakes, steering, starter,

ignition and radiator.

Attorney General Abrams said:

"The new law will require the dealer to repair certain defects in the car or reimburse the consumer for the reasonable cost of the repair. If the defect is not corrected after three or more repair attempts or the car is out of service for a cumulative total of fifteen days during the warranty period, the dealer must refund the car's full purchase price."

The consumer and the dealer may agree on a comparable used car replacement and dealers are

allowed an extra 30 days to fix the defect if the repair parts are unavailable. The lemon law for used cars exempts "classic cars" and cars sold for less than \$1500. Private sales between individuals are also not included.
