# Agway Garden Supply Center 500 G Blaze Injures 12 Volunteer Firemen

Agway Garden Supply Center at 411 W. John St. Hicksville was hit by fire on Saturday May 11th. An employee sharpening a lawn mower blade on a grinder generated sparks which ignited nearby gasoline. Employees attempted to extinguish the fire but it spread rapidly. The Hicksville F.D. was notified at 4:16 PM. Upon arrival, firefighters encountered a large volume of fire and heavy smoke.

A second alarm was transmitted in minutes followed by a third alarm 15 minutes later. Mutual aid assistance was requested from the Jericho F.D. for an

additional ladder truck. Firefighters fearing pesticides and fertilizers took precautions to avoid the toxic smoke. Rescue units from Jericho, Bethpage, Levittown, East Meadow responded. An additional Engine Co. from Plainview was called to provide additional water at the scene. The Bethpage F.D. provided a standby engine at Hicksville Headquarters. The Plainview Levittown and Westbury Departments provided additional units with manpower, air tanks. The East Meadow Haz MAT Team assisted Hicksville Team in identifying possible hazardous materials (pesticides) Cantigue.

Park Ball Fields & Golf Course was closed due to smoke.

24 pieces of apparatus, 125 firefighters responded under Hicksville Fire Chief Owen Magee. The County Fire Marshals HAZ-MAT Unit, County Health Dept. N.Y. State Dept. of Environmental Conservation, Agway Pesticide Team, Federal E.P.A., U.S. Coast Guard strike team and the Chemtree Response/Information Network worked to insure that the runoff from firefighting operations did not contaminate the local water supply. After the fire was under control at 5:45 PM investi-

gation revealed very little hazardous materials were involved. Damage was estimated at between 1/4 to 1/2 a million dollars to contents (new equipment) and structure. County Police, 1st on the scene, cleared the parking lot within minutes to enable vamps equipment easy access.

Treated and released at local hospitals were the following firefighters: Carl Shieverstein, William Sheaffer, Keith Kopinski, Richard Schmidt, all from Hicksville. Robert Hally, Chris Chazotte, M. Myer, R. Biancanello, Ted Miller, L. Bachteller Jr., E. Vallar, J. Mlynarczyk from Jericho.

# D.A. Report On DWI at MADD May Meeting

Dennis Lavalle, Chief of the Nassau County District Attorney's Anti-DWI (Driving While Intoxicated) Prosecution Bureau, is scheduled to report on progress in legal steps against drunk driving, at the May 21 meeting of L.I.-M.A.D.D. (Mothers Against Drunk Driving). The open-to-the-public meeting is set for 8 PM in the Cafeteria of Central General Hospital, Old Country Rd. and Rt. 135, Plainville, L.I.

Lavalle will report on and interpret the increase in DWI arrests in Nassau County accompanied by a significant reduction in fatalities in 1984, with further reductions expected in 1985. He will also discuss new anti-DWI legislative proposals to be presented for action by New York State legislators in 1985. The Bureau Chief will also discuss a number of legislative proposals by L.I.-M.A.D.D.

### CAN'T HURRY HEALING

Not many people appreciate how long and difficult the grief process can be. Perhaps due to a contemporary distaste for the tasks of mourning, we often attempt to hide our grief or even deny to ourselves that these feelings are real and normal. A newspaper survey of a large midwestern city revealed, for instance, that most respondents thought that a normal period of mourning for the loss of a loved one is between two days and two weeks!

While we may not be expected to wear black for a year and observe the other traditions of earlier societies, we cannot expect our grief to be handled with such modern American efficiency. However, such expecta-

tions exist and they often put undue and unfair pressure on bereaved. They begin to doubt themselves if they can't "snap out of it" promptly. Yet research in this area indicates that the grief process may last up to two years, and the most critical period is from four to six months after the death.
