And Running For The School Board

As well as voting for their school budget and two extra propositions, voters in Hicksville School District will have the opportunity to vote for two trustees to serve on their school board, as follows:

For a 3 year term ending June 30, 1986.

Incumbent Charlene Anci

I have been involved in effecting positive changes in all areas of our district:

-Raised the ceiling for senior citizen exemptions to \$10,500 of income.

-Expanded adult education programs at no cost to the district.

-Supported the Gregory Museum.

-Increased graduation requirements to include one extra year of science, math, computer literacy and study skills.

-Active on negotiations committee; instrumental in avoiding a teacher strike.

-Responsible for resuming negotiation talks after a stalemate of 13 months with the Council of Administrators, which resulted in a rapid settlement.

-Was responsible for the addition of one psychologist to effect a more favorable ratio.

-Was instrumental in the creation of an additional 4th grade class at Willet Avenue to eliminate overcrowding, and the creation of a 3rd grade class at Dutch Lane to avoid having three sets of twins in one class.

-Responsible for the present organizational structure which is more effective, sensible, and more responsive to the curriculum needs of the district.

-Chaired the Gifted and Talented Committee in 1980-81 and 1981-82, which resulted in development of the In-Depth Study Program for grades 4, 5, and 6.

-Instrumental in the development of the Primary Enrichment Program which has been prototyped as a model by the State of New York and is responding to the needs of all classroom children in grades K-3.

-Instrumental in the development of a 9th period enrichment program in the junior high school designed to stimulate youngsters of all academic abilities.

-Advocate of diplomas for handicapped students.

-Responsible for arranging to have the Hicksville School District host a holocaust in-service course which was attended by our staff as well as 26 neighboring school districts in March and April, 1983.

-Responsible for presenting resolutions which were passed unanimously by the

Board opposing changes in P.L. 94-142, the law for education of handicapped students, and opposed to block grants which would seriously affect federal funding for handicapped and remedial students.

-On March 15, 1983, personally represented the Hicksville community in Albany which resulted, through lobbying efforts, in saving the district \$1.7 million in state aid.

Arlene Rudin

My decision to seek election to the School Board has its roots in over 12 years of active educational activities on behalf of the district.

I have devoted that entire period to improving the quality of education in the district. I have directed much of my energies to School Board Committees (i.e. Goals and Objectives, Long Range Planning, Budget Advisory, Gifted and Talented) and to PTA.

I have served as President of the Dutch Lane PTA. I have served in leadership positions on the Boards of the Junior High and Senior High PTSA's. I am a member of SEPTA. I have a working knowledge of both our elementary and secondary schools and how they function.

This year I was the recipient of the PTA Council's National Honorary Life Membership Award for my service to the Council and to Hicksville's youth.

This year I am serving on two Board Committees, Budget Advisory and Goals and Objectives. I am also the Council Delegate for the Junior High PTSA, Program Co-Chair for the High School PTSA and Recording Secretary for the Hicksville Council of PTA's.

I hold a Bachelor of Science Degree in Education. Before moving to Hicksville I worked for 10 years in the NYC School system serving in various capacities. I was a teacher of English as a second language, a language arts specialist teacher, and a teacher of the intellectually gifted. Although no longer a teacher in public education, I do teach religious school on Sundays.

In addition to my educational qualifications I have a strong interest in finance, budgets and their administration. I manage a credit union which has tripled in size in the past three years, and with my husband operate a corporate and personal tax service. I am familiar with the tax burden the educational system has placed on the residents of the dis-

trict. I would use my educational and fiscal expertise to see to it that the residents of this district get the best possible educational system for the dollars that are available.

For a 3 years term ending June 30, 1986, last incumbent, Daniel Arena

As a resident of Hicksville for twenty four years, and like my fellow neighbors have tried to uphold an excellence of education within this community.

Yet, my neighbors and I found the Hicksville School Board of Education with weak leadership, no purpose, no guidance or direction in the pursuit for the betterment of our educational goals. I have found that the harmony between our community and the school board is very weak, thereby affecting and hindering the educational needs of our children and community.

Therefore, my past experience in the business society, my educational background, both within and without the educational system, my experience as a teacher, college level professor, and school administrator of education is my qualification to acclaim that I can provide ability and leadership for our school community and Hicksville Board of Education.

In a like manner, keep and maintain the high excellence still afforded to the Hicksville Public Schools.

I further feel that I can provide an educational environment that is needed within our district. In brief, I believe changes must begin in the clinical supervision of our Board of Education in planning, updating and implementation of board procedures, community involvement, careful analysis/reevaluation of our curriculum and goals, the affect it has upon our education system, and to

other matters of administration contingency that can lead us to budget inadequacy.

Finally, as a neighbor, I will heed your continued support in resolving these inadequacies. This can be done if you allow me to become an effective member of our Hicksville Board of Education.

Pamela Kemmlein

For the past three years, I have been very active with the Hicksville Public Schools at both the Board level as well as the PTA level. I have served on the Citizen's Budget Advisory Committee for three years, the last two of which I have been the Co-Chairperson. In 1981, I was one of four parents appointed by the Board to the original committee for the Gifted and Talented. I was also one of the original committee to serve on the Board's Public Relations Committee. At the PTA level, I have been a member of the Fork Lane Executive Board for the past two years and presently serve as Community Relations Chairperson. In addition to my participation on the aforementioned committees, I am in regular attendance at the Board of Education meetings. I feel that as a member of these committees, I have shown my concern and determination to fight for changes in the Hicksville Public School system that will benefit the children and the entire community.

When my husband and I moved to Hicksville in 1974, one of our reasons for settling there was the excellent educational programs offered in the Public Schools. I am concerned about the kind of cuts in educational programs being made and their impact on the future of our children. It is for these reasons that I have decided to run for Mr. Arena's seat on the Board of Education. I welcome your support, my friends and neighbors.

Dear Friends:

Each residence in the Hicksville School District has received a summary and an explanation of the school budget upon which you will vote next Wednesday, May 25th.

The school budget is not a luxury... it is vital in order to keep Hicksville the strong community that it has been in the past... a community which combines an excellent education for its young people with efficient operation so that each dollar goes as far as is possible in these rough economic times.

Out students, no less than those in other districts, deserve bus transportation for public and parochial school students, they deserve an interscholastic athletic program and the replacement of outdated equipment and textbooks, and they deserve computer equipment to keep pace with the educational offerings of other districts. Also, our gifted and talented programs require implementation.

As to the two separate propositions, one requiring a minimal amount to keep our fine foreign language program in the same grades that it was provided last year, and the other proposition for a like minimal amount, to provide guidance counseling services to the same extent that such guidance counseling services were provided for last year, we believe that they are really needed and should be kept intact. No adequate study has been done in either area, to allow them to be removed.

By passing our school budget and the two propositions that are offered separately, we are approving programs of educational excellence important to our students. It is important both to our school system and to the value of the homes in our school district.

Austerity hurts everyone.

Only your "Yes" votes can provide our students with the benefits a passed budget provides. We urge every eligible voter to support this budget and the two propositions on Wed., May 25th.

We wish we could speak as clearly regarding those who are running for our Board of Education. We have heard each of them speak (except Mr. Bommarito) at the May Hicksville Community Council meeting, we have read all of their "Letters" and as much of their literature as is available at press time. We hope that those who may not make it this time will maintain their interest in school affairs and consider running next year. Frankly, we are lucky here in Hicksville, to have so many well-qualified candidates. We have given space to all the letters and news releases which have been received, in order to help you make your decisions on May 25th, except, of course, those few which were controversial and presented for publication this week. Most of you know that our policy of many years standing, has been to refuse to print last-minute charges which cannot be answered in this publication before an election. This policy protects everyone. We will not change it. We do not believe that thinking voters are deceived by last-minute charges. They certainly can be presented at least one week before... or, if necessary to be continued, one week later, after the election. We do not play those games. We hope that you are not taken in by them, either.

But, most of all we hope that you all mark your calendars... two important dates are Monday, May 23, the Hicksville Council of PTA Units Candidates Forum set for 8 pm in Cafeteria A of the Senior High School... and, of course, next Wednesday, May 25th, when, from 10 am to 10 pm you will be casting your vote in your election district.

If it's obvious that there will be money in your estate - in the form of savings insurance, cashable stocks or bonds, or other liquid assets - that's probably all the protection your survivor needs. The money you would otherwise tie up for funeral payments could be invested or put into savings instead.

The disadvantage of this course is that your estate may never be so large as to cover the funeral costs adequately & provide something for the survivors. Another possibility is that even if you are well off now, your financial for-

tunes may change to such a degree that there won't be much money in the estate when you die. In such cases, your survivors would be under great financial strain to meet the cost of your funeral and burial. It may require going into insurance money or other resources more urgently needed to live on. Prepayment does allow for these possibilities and the removal of concern at the time of the funeral.

BE IT RESOLVED, by the Town Board of the Town of Oyster Bay, Nassau County, New York, as follows:

Section 1. The specific object or purpose to be financed pursuant to this resolution is the reconstruction by the Town of Oyster Bay, Nassau County, New York, of the existing sea wall at the Roosevelt Memorial Park boat basin in and for said Town.

Section 2. The maximum estimated cost of such specific object or purpose or purpose is \$224,000, and the plan for the financing thereof is as follows:

a) By the issuance of \$212,800 serial bonds of said Town, hereby authorized to be issued pur-

suant to the Local Finance Law; and

b) By the issuance of \$11,200 capital notes of said Town hereby authorized to be issued pursuant to the Local Finance Law. Section 7. Upon this resolution taking effect, the same shall be published in full in Massapequa Observer, Mid Island Herald, Oyster Bay Enterprise Pilot and Locust Valley Leader, together with a notice of the Town Clerk in substantially the form provided in Section 81.00 of the Local Finance Law.

Section 8. This resolution is adopted subject to permissive referendum in accordance with Section 35.00 of the Local Finance Law.

War Hero Faces His Most Dangerous Mission

Central Genral Hospital today joined an urgent appeal by all area hospitals for a lung to save the life of Lt. Col. Vandell Bell, hero of three wars, who is fighting for breath at Montefiore Medical Center in The Bronx. His only hope to survive a fatal lung disease is a transplant.

Winner of six Distinguished Flying Crosses for Combat Duty and recipient of 16 Air Medals for Combat Missions, Lt. Col. Bell logged 2200 combat hours as an Air Force pilot in World War II, Korea and Vietnam. His bravery in battle was further recognized when he received the Asiatic-Pacific Theatre Ribbon with battle stars and the Vietnamese Cross for Gallantry.

Now he faces the toughest

battle of his life—a battle against time to find a donor lung to replace his diseased lung. Doctors at Montefiore Medical Center, where Lt. Col. Bell was admitted on April 10, say this operation is urgent since the patient's own lungs are deteriorating daily. Oxygen is constantly administered to Lt. Col. Bell, who can no longer breathe efficiently on his own.

Dr. Frank Veith, director of Montefiore's lung transplant program, the only single-lung transplant program in the United States, said Lt. Col. Bell's pulmonary function has deteriorated to the point where a transplant is the only alternative to save his life.

Since the lung is the most perishable organ, a donor would have to be a patient

who has suffered irreversible brain damage and is in a hospital being maintained on a respirator so that all body organs are still functioning. In such circumstances, when the family is grieving the loss of a loved one, many physicians are reluctant to ask them to consider the donation of a lung. However, physicians are willing to cooperate if family members indicate that they want to donate the lungs of the brain dead person to keep another human being alive.
