My Opinion

Our schools are supposed to be the agency through which we teach our youth the basic rules of democracy and fair play. To establish these principles the teachers in our school system should be assured of freedom from intimidation, pressure or retaliation for non-compliance with dictates from school administrators or Board members.

Whenever literature is permitted to be prepared and distributed through the assistance of the teaching staff, or through the printed or mimeographed brochures expressing the opinion of the then majority of a school board or the Superintendent of schools, with the attendant expense of personnel in setting-up, in distribution and in mailing, without the opportunity being afforded to a contrary opinion to answer back, we have a stark example of lack of faith in our democratic processes and a repudiation of what our country stands for.

Within the current school year we were treated to triple-barreled versions of our School Administrator's comments, a so-called Board letter signed by certain members of the Board, as well as the use of teaching personnel instructing pupils to go home with certain literature and to tell their parents how to vote with respect to certain matters affecting the District.

The failure, omission and refusal to afford the presentation through the same vehicle of communication of the opportunity to answer, to explain or to justify, is a neglect of the first element of fair play, and a suppression of opinion, and the

The trophy was presented by an official from the Irish American Center in Mineola, on Sun., March 24.

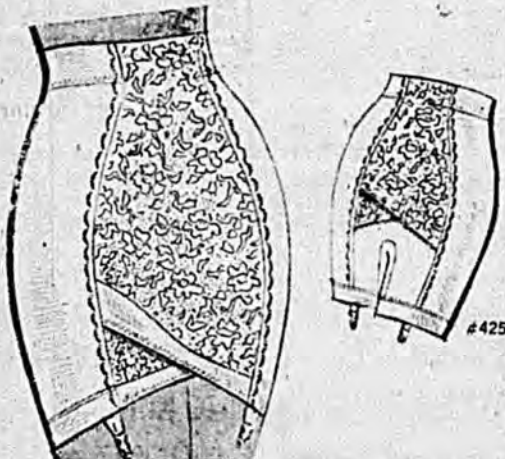

Thinking It Over

While there are all sorts of campaigns under way this year regarding the school budget, we want to point out one that is strictly an appeal to the emotions.

The proponents of the budget are already speaking of what will happen if an austerity budget comes to Hicksville. They are making all sorts of dire predictions of what will happen to transportation, school lunches and text books, under an austerity budget.

All of this fakery is designed to stop taxpayers from thinking. They are supposed to recoil in fright from voting against the budget for fear of losing some of these vital services.

But the truth of the matter is that an austerity budget would only come if the Board of Education did not pare down the budget enough to get approval of the voters. And one vote would not decide this. Generally after a defeat a new vote is held on a scaled down budget and even if that doesn't go through a third vote could be held if new Board members, for instance were seated in July and saw the light of how to make sensible and effective cuts in the budget.

But then if an austerity budget did come along after these referendums failed, children still would not necessarily lose any of the services that the voters wanted. Transportation, free text books and other services could be submitted on separate referendum and if passed the district would have the same services in those categories as it now has.

The one trouble is that school authorities and other people circulating the austerity budget hysteria propaganda know all of this -- We wonder why the distortion? Can't the high budget be justified on facts?

opportunity to the receiver of the literature distributed to weigh the facts and to come to an unbiased personal conclusion. At the School District level, where Board members supposedly pride themselves upon their services without compensation, the desirability of presenting all viewpoints should outweigh the urgency of "winning" regardless of principle.

When it was originally decided by the School Board that the books used in our school system should be reviewed to determine whether they contained matter which contained inaccuracies or statements derogatory to our American Heritage, or whether they were slanted towards Communist principles, the action was not of a single Board member, but the action necessarily of a majority. When, following the attendance of most of the School Board members at the Annual Meeting of the School Board Association, the Board by vote, retracted its majority previous action. The Board saw fit to make as if it had never adopted the previous resolution and sought to "hang" a disapproval on the Board member who had not initiated the resolution originally, by characterizing such original action, in effect, as a "witch hunt". Assuming that the Board majority had a right to reconsider and to retract, the attempted transfer of responsibility for accepting the original proposal as desirable, and necessary, was neither an act of courage, nor an act worthy of example for the students under their care and guidance. The responsibility for the books used in our school system is a prime duty of the Board. Having accepted that responsibility, the Board should not have surrendered so easily its prerogative. Furthermore, it should not have precluded the presentation of the explanation of the original proposal and its reason.

As regards the use of teaching personnel to influence district voter opinion: Basically, the cardinal rule should be recognized that a teacher stands in a special relationship to his pupils. The teacher constitutes in effect, the substitute for the parent. To use the teaching staff, or to have the teaching staff use the aura of the teacher to influence the parents of a pupil, through the pupil, as to a

certain position concerning school district affairs, constitutes a violation of impersonal teaching and an unwarranted abuse of position or of office. This is but a short step to indoctrination of any special "ism", and certainly not Americanism.

An administrative and teaching staff should be engaged in educational pursuits, free of intimidation by any member of the School Board, or of the Superintendent, and secure in position. To this proposition I pledged myself and will continue to so pledge myself. To secure this principle teachers must not be used or permitted to use their position to influence school district opinion in the school room or through their expressions of opinion. This is significant when they are not residents of the district.

Fact Or Fiction?

In July 1962, Mr. Bruno recommended the following motion to the Hicksville Board of Education: "Hicksville Public Schools -- To: Board Members, From: William A. Bruno, Jr. -- I move that the Superintendent of Schools be directed to see that the 1963-64 Hicksville gross school budget, now in preparation, shall not exceed 90 per cent of the 1962-63 gross school budget of \$10,327,080.62. -- Submitted by, William A. Bruno, Jr. 7/26/62

At that time it was explained to Mr. Bruno that such action was impractical and impossible since our needs had not been fully estimated. He informed the Superintendent that he was familiar with budgets and that it could be cut 10%. This would mean that the 1963-64 budget should be \$9,294,372.56. The Superintendent's budget as recommended was \$10,975,964.83. A simple matter of subtraction would mean that Mr. Bruno should be able to cut \$1,681,592.27 from the Superintendent's proposed budget. Was his motion based on wisdom or fantasy?

In his column, "My Opinion," on Thursday, February 21, Mr. Bruno said, "But it is bound (School Library Tax) to skyrocket at least another 40 cents because the 6-1 majority on the School Board wants to hike the budget over \$600,000 next year, edging expenditures toward a total budget of \$12,000,000." Now Mr. Bruno, as a Board member, had the original proposed budget of \$10,975,964.83 of the Superintendent. Why such inaccuracy? What is the purpose of talking about \$12,000,000? No one has been talking about \$12,000,000 except Mr. Bruno. He used the same type of language in his article of February 28, 1963, "If this budget passes this Saturday, it could fall anywhere between \$11,000,000 and \$12,000,000." Is it possible he hasn't read the proposed budget? Why does he continue the inaccuracies? What is his purpose? Does Mr. Bruno write fact or fiction? Fact or Fiction?

In recent weeks Mr. Bruno has made public his case outside the Board meeting room against the proposed 1963-64 school budget as it was being prepared. On Thursday, Feb. 21, 1963 and Thursday, Feb. 28, 1963, he proceeded to take Codes 2 and 3 and break them down into their component parts in newspaper press releases. He identified the code and listed the Superintendent's recommendation, the Board of Education action and amount of cut, and, finally, his recommendation and amount out. Below each code he stated his reason for his recommended revisions. The administration has studied these press releases.

At the Board meeting of Thursday, February 21, 1963, the Superintendent of Schools asked Mr. Bruno if the newspaper article was accurate. He said yes and that he intended to read from it. This is recorded on the official tape of the meeting. He did not make the recommendations at the Board table. I would like to take this opportunity to examine Mr. Bruno's claims, in order that the people may decide whether Mr. Bruno is ignorant of phases of school budgeting, or has inaccurately reported for purposes specially known to him.

I wanted the opportunity of discussing with him, and the Board of Education, his ideas on Saturday, March 2. However, after lecturing the people of our community, again by press release, "I am giving up a day of work to be at this Board meeting, what are you doing to cut your taxes?" -- Mr. Bruno left the meeting before the Board could hear his alleged budget cuts. Is it possible that he is fearful of having his so called opinions tested and measured in official forum? Will his statements be recognized as fact or fiction?

Code 2-7 (Supt's. Salary) Mr. Bruno offered no cut. Reason--No cut here--The Board majority 2 years ago gave a 5 year contract--\$1500 increase to \$22,000; in two years \$25,000." Fact or fiction? About a month ago Mr. Bruno demanded a copy of the Superintendent's contract. If he properly read it he would know the salary is as follows: 1961-62 -- \$19,000; 1962-63 -- \$20,500; 1963-64 -- \$22,000; 1964-65 -- \$23,000 and 1965-66 -- \$24,000. Why does he state \$25,000? Is his statement fact or fiction?

Code 2-72 (Bus. Mgr.) Mr. Bruno claims a cut of \$600. Here he cuts back the Business Manager's salary. Reason--\$800 is too much in my opinion. I recommend \$200. It is to be noted all the administrators have received raises every year." Fact or fiction? Mr. Madden, the Recreation Director, and Mr. Gorozoyki, our Business Manager, have not received a raise each year. Is Mr. Bruno's statement fact or fiction?

Code 2-73 Mr. Bruno offers no cut. Reason--New man on the job. No raise was recommended." Fact or fiction? A raise was recommended. A memorandum from Superintendent's office dated 11/30/62 listed every administrator with the 1962-63 salary and a recommended 1963-64 salary. Under code 2-73 the memo showed a present salary of \$5400 and a recommended salary of \$9000 for 1963-64. Doesn't Mr. Bruno read significant budget material and memos? Perhaps he relies on information and advice from other sources?

Code 2-75 Mr. Bruno claims a cut of \$4400. Reason--During the budget, the Superintendent of Schools was silent. In a secret memorandum he recommended this cut." Fact or fiction? This is part of the truth. The Superintendent did make this recommended cut because it represented a secretary for an Administrative Assistant in Code 2-71C. What Mr. Bruno did not tell the people is that in this same secret memo the Superintendent recommended the very same cut of \$14,000 (2-71C) that Mr. Bruno claims he recommended. When one returns sections of material back in the full context one seems to get a different view. Fact or fiction?

Other points of interest in Mr. Bruno's recommendations are in Code 2-6. Here he cuts \$1,100. Reason--The administration wants to print and mail the School Budget (\$15,000) --(I'm sure he means copies) -- \$850 plus a \$250 increase over last year." Fact or fiction? Fact: It seems Mr. Bruno prefers to print only a few copies of the Budget brochure and place them in the library --(Motion 617). He proposes this despite the fact there were about 5,000 registered voters last year. Doesn't Mr. Bruno want the people to know and have budget facts? What happened to his cry that the people must be informed! No secrets?

Code 2-9 Here Mr. Bruno claims to cut \$3125. Reason--I recommend to cut 'in-district travel' (10¢ per mile), administration junkets, and reduce supplies expenses." Fact or fiction? Mr. Bruno knows the Superintendent has never claimed in-district travel. Does Mr. Bruno wish to cut off the Superintendent's communication with the public since this code provides the money for the Bulletin Board? Why does he want to keep the Superintendent quiet at Board meetings and now stifle him by taking away monies for publishing information? Has Mr. Bruno tried this before? Fact or fiction?

Code 2-71A (Admin. Ass't.) Mr. Bruno claims a cut of \$2000 here. Reason--I voted against a \$32250 raise, in my opinion this is too much. I recommend \$250." Fact or fiction? In July 1962 Mr. Bruno voted a salary of \$14,250 for this man for 1962-63. The proposed salary for 1963-1964 is \$15,250. Where does he get the \$2,250 raise? What are the purposes of these inaccuracies? Why the fiction?

Code 2-71B Here Mr. Bruno cuts another \$2000 for the same reason as stated in 2-71A. He simply compounds his errors. How could he make the same mistake twice?

Finally, we call attention to Mr. Bruno's accuracy with arithmetic. At the end of his comedy of errors on Code 2 he provides a finale by totaling the list he claims the Superintendent recommended. He comes to a total of \$250,090.61. If he had added his claims pertaining to the Superintendent's recommendations he would discover that the sum would be \$265,340.60. The Superintendent's proposed budget was \$250,090.60. Is this responsible reporting? The public record will prove whether his claims are fact or fiction.

Code 3 Mr. Bruno's comparison of codes for Code 3 is all the more interesting. Here he compares the budget of 1963-64 with 1959-60. Why?

Code 3-1 (Supervisors and Assistant Principals) In this code Mr. Bruno recommends a cut of \$17,740. Reason: 12 Supervisors cost \$134,300 (1959-60 budget had 10 Supervisors at a cost of \$89,900.) 1

Large Crowd At Mother's Aux.

The March open meeting of the St. Ignatius Mothers' Auxiliary attracted an unusually large crowd to hear Mr. Joseph Peterson lecture about the life and work of Padre Pio.

Padre Pio, a Capuchin priest living today in Italy, has borne in his body the stigmata, i.e., the five wounds of our Lord, since 1918. Mr. Peterson of Yonkers, N. Y., met this unusual priest during the last World War while stationed in Italy. Since then, he has devoted a great deal of time to the study and work of Padre Pio, revisiting him frequently.

After a brief outline of Padre Pio's early life, Mr. Peterson showed some very impressive slides of the priest, his stigmata and his daily life at the Capuchin Monastery of San Giovanni Rotondo. Although Padre Pio would prefer a life of seclusion, his fame as a stigmatist is world wide, Mr. Peterson explained. Not only do the faithful flock to see him but also many scientists and tourists as well as the curious. Padre Pio, of course has been examined by many doctors who, the lecturer said, have been unable to explain the wounds. Mr. Peterson, giving an insight into Padre Pio's personality, stated that although he is in constant pain, he never shows his suffering; he is always quick to tell a joke; above all he is humble. His greatest interest lies in the promotion of a high, modern hospital, built in San Giovanni in 1956, which administers to rich and poor alike.

A question and answer period followed this lecture.

At the conclusion of this program, there was a brief intermission followed by the regular business meeting.

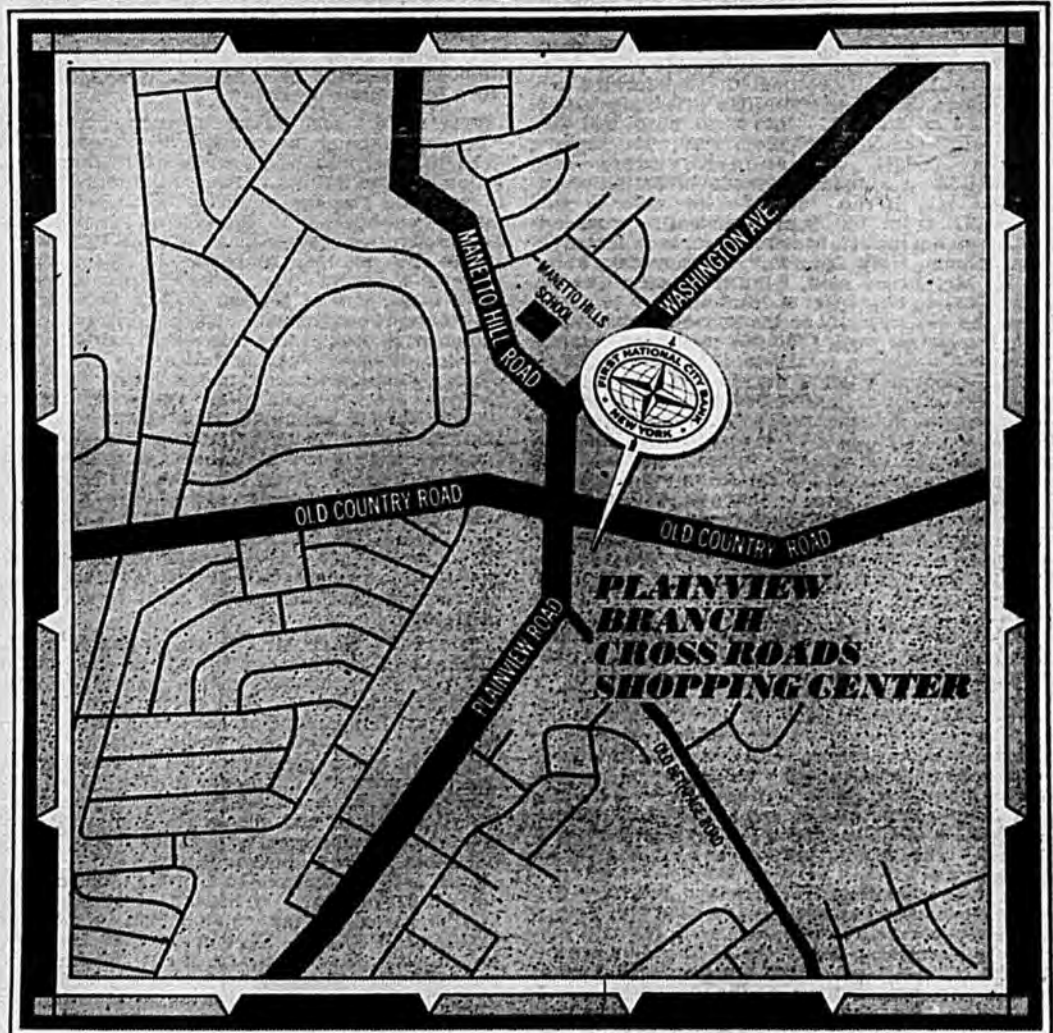

feel certain Supervisors are paid too much for their job (\$6,140--plus a Chief Psychologist of \$11,600). Note: Supervisors and Assistant Principals are requesting a raise over their annual raise, just received, and normal increment raise in their salaries. (14 Assistant Principals \$154,600, 1963-64 budget) (12 Assistant Principals \$108,500, 1959-60 budget).

I understand that he wants to eliminate another psychologist at \$11,600 -- but where is he cutting the other \$6140? Where does he get this amount of money -- no salary listed in this code has a figure other than zero in the second digit. Is the cut a "secret" one? Why did he suddenly change his mind on this code? He voted "Yes" on the budget review (Motion #690). Is the \$6140 fact or fiction? Does he receive his instructions from other sources and do these sources influence his opinion?

Code 3-3 (Principals' Salaries). When this question of principals' salaries was reviewed by the Board, Mr. Bruno voted for the Code 3-3. Fact or fiction? Fact: Motion #691 records his "aya" vote.

Code 3-4 (Salaries of Clerical and other help). Here Mr. Bruno claims a cut of \$3,800. "Reason: \$3800 could be reduced in this section if a future vacancy were not filled and reduced the overtime by \$800. (\$7,900 in this section is an increase in salary scale for 48 clerks). \$4,600 remained here for overtime and part-time help. This section is requesting a raise. (1959-60 - 40 clerks cost \$129,308.33)."

Here we see Mr. Bruno changing his mind again, after his vote. Mr. Bruno voted "no" on a motion made by Mr. Kunz to cut \$800. for overtime. Fact or fiction? Fact: Motion #962. Mr. Bruno then seconded a motion to leave the \$800 amount in this code. Fact or fiction? Fact: Motion #963. Now he is changing his mind and wants the \$800. out of Code 3-4. Why?

Code 3-11 (Supplies Used in Instruction). Mr. Bruno claims a cut of \$15,157.75. "Reason: Too many personal magazines requested by the teachers and administrators. A general reduction of expenditures \$5,157.75. In a 'Privileged and Confidential' memorandum the Superintendent suggested a \$10,000 reduction in the supply area." Fact or fiction? The section dealing with a recommended cut of \$10,000 from the Superintendent is fact. The bit about the magazines for \$5175.75 is fiction. There are no professional magazines in this code. They are in Code 9. I can understand Mr. Bruno's confusion since children's current events periodicals are in this code. When we check the amount, however, we see \$2157.75. Now just where did Mr. Bruno get \$5175.75? What did he cut? Is it a secret?

Code 3-12 (Other Expenses of Instruction). Mr. Bruno claims a cut of \$11,132.80. "Reason: This area includes reduced expenditure for purchase and rental of films and postage \$2,000. Eliminate Junior High School diplomas (\$2,032). Attempt to reduce expenditures of summer school by \$2,000, by either large class size or increase the fee. The summer band costs \$4,000. I do not feel so many taxpayers should pay for so few participants. This program should pay for itself. Summer textbooks and supplies (\$11,000) should be drawn from the regular supplies." Fact or fiction? Fiction! Here he cuts \$11,000 for summer school textbooks and supplies when the budget only contained \$650 for such expenditure. Where did Mr. Bruno find the \$10,350 for his cut of \$11,000? Why the inaccuracies? What is the purpose of inaccuracy?

Code 3-91 (Teachers' Salaries K-6) Mr. Bruno claims a cut of \$92,000. "Reason: This is for salaries for teachers from Kindergarten to 6th Grades. These teachers are applying for a raise over the last raise they just received. The board, if it approves this raise, could roughly cost us \$200,000 to \$250,000 increase in the budget. The Superintendent wants at least one guidance counselor in every elementary school. I do not see the need for guidance counselors in elementary schools and request the elimination in all but the Junior High School and High School. (Estimate: 5 guidance counselors at \$8,000 equals \$40,000). Reduce the summer school curriculum work (\$5,000) by \$2,000. What amazes me, at our expense, all the summer jobs that are recommended which we pay for. In a 'Privileged and Confidential' memorandum, the Superintendent suggests a possible \$40,000 additional saving." Fact or Fiction? Since when does \$40,000 + \$40,000 = \$2,000 add up to \$92,000?

The recommendation of the Superintendent was for a counselor in each elementary school servicing K-6. It was not for all elementary schools (Nicholai and Willet would be excluded since they are primary schools). Now isn't this correct? It was amazing to me to learn that after printing his opinion about elementary guidance counselors in February 28 that he sought professional advice on the question on March 21.

Code 4
In the past I have tried to understand Mr. Bruno's articles "My Opinion." I have also attempted to show the people the "errors" in Mr. Bruno's reporting. I'm still undecided why Mr. Bruno takes this medium of inaccurate reporting rather than at the Board table. I shall continue to point out the realities of the budget with facts rather than opinion.

Code 4 represents costs of Operation of School Plant. The Board has placed \$630,707.25 in this entire Code 4. -- Yet when Mr. Bruno speaks of a sub-code -- Code 4-5, it sounds as though this sub-code has \$631,000 as he "reports." It is also interesting to note that he labels Code 4-5 as Custodial Supplies (Fact for a change) but then speaks of salaries which he claims increased \$20,000. Now he should know, if he really studied and helped make the budgets, that Code 4-1 (not 4-5) represents custodial salaries and that the Board placed an additional \$9,100 in this code for a new salary scale effective January 1964. Is Mr. Bruno's \$20,000 fact or fiction? His adding of supplies and custodians is a simple violation of elementary arithmetic. -- You can not add apples + oranges and get apples or oranges as an answer.

I was amazed however that after all Mr. Bruno's gibberish about holding the salary scales he did not comment on Code 4-1, the code which actually does reflect the cost of a new salary scale. Why the deletion? -- Or is it just another error?

Now let us look at Mr. Bruno's fantastic cut of \$311,000 for all of Code 4. The Board of Education cut Code 4-5 by \$8000 due to inventories. The Board also cut 4-11 by \$600. If Mr. Bruno had attended the budget meetings he would have known this. Thus, of Mr. Bruno's claimed cut of \$11,000, we find \$8500 had been taken out of budget by the Board of Education -- at the Saturday meeting Mr. Bruno refused to attend in the afternoon. Thus out of \$630,707.25 Mr. Bruno's recommended cut amounts to \$2500 for telephone calls of a personal nature. How he arrived at this sum would be of interest. As a board member, he must know that every school has pay phones (except Nicholai and the new Willet Avenue School). He must also know that outgoing calls from the regular phones go through the switchboard operator. If the call is of a personal nature, the person making the call is charged for the call. Is it fact or fiction that Mr. Bruno checked the reasonableness of his proposed cut by checking with the Business Offices of the District. -- Fiction -- Does he have a secret source suggesting that employees are making \$2500 worth of phone calls at the expense of the District? Last year the District received \$241.90 for personal calls made through the switchboard. The District collected \$662.09 in commission from the telephone company for the pay phones in our schools. The final figures are provided by the accounting department of the telephone company. The location of the booth and the frequency of the collections also enter into the calculation. Why didn't Mr. Bruno inquire? Why was he so certain of his opinion that he recommends a \$2500 cut for this purpose? Is his "opinion" fact or fiction?

Code 5
Mr. Bruno talks of the Superintendent's recommendation for total Code 5 as \$208,275. If he had looked at the budget he would know the Superintendent recommended \$210,181.34 for the entire code. The Board of Education, however, cut this figure to \$208,275. In Code 5-1 (\$75,100), Mr. Bruno recommends a cut of \$2,000. He says "Reduce this figure (\$75,100) by \$2,000 (approximately a 20% reduction) by sheer economy, maximum work effort and reduction of overtime allowance." Now 20% of \$75,100 is \$15,020. Fact or fiction? If it is fact, then Mr. Bruno's \$2,000 must be fiction. Why did Mr. Bruno change his mind when he voted "yes" on \$75,000 for this code on January 19, 1963 (Motion #723).

In Code 5-2 it appears that Mr. Bruno took an arbitrary 10% off supplies. Is his logic and arith-

metio as sound here as it is in Code 5-1? Why has he changed his mind again? On January 19, 1963 he voted "Aye" on the amount of \$55,450 (Motion #724).

In Code 5-3 Mr. Bruno says the Superintendent recommended \$38,850. The Superintendent's recommendation was \$35,500. Where did Mr. Bruno find the other \$3,350. What budget is Mr. Bruno looking at?

In this Code 5-3 Mr. Bruno's saying and reasoning goes like this: "(I recommend a reduction of \$11,350.) Reduce this section by not hiring additional help, reduction of overtime and of stock piling surplus." He probably means supplies. Now if we do as he suggests and do not hire another plumber, which we need, we would save \$400.

We could take out the \$1000 for overtime for plumbers and electricians, if Mr. Bruno could guarantee that all emergencies would only occur when these men were on duty. Thus we would have saved \$5400. But Mr. Bruno claims a saving of \$11,350 -- therefore \$5950 must be taken from plumbing and electrical supplies. The budget contains only \$8000 for these supplies. If we deduct \$5950 from \$8000 worth of supplies, we would have \$2050 for supplies for \$20,000,000 worth of plant. Economy? Common sense? Why the change of opinion again? He voted "aye" for Code 5-3 in the amount of \$35,300 on January 25, 1963 (Motion #726.) By the way, Mr. Bruno, you offered the motion #726. Why the change? Secret?

Mr. Bruno recommends a cut of \$13,977 in Code 5-4. His cuts are basically aimed at instrumental music and audio-visual aids. These monies represent repairs and replacement of capital equipment, not new equipment. The Administration simply believes we must keep our equipment in repair.

In Code 5-11 Mr. Bruno cuts \$874 but doesn't explain whether he wants to cut out the in-service workshops for custodians, or from the emergency fund. It is difficult to tell how Mr. Bruno would have voted on this code since the action was on February 2, 1963 and Mr. Bruno absented himself again. Fact or fiction Mr. Bruno?

Why is it that Mr. Bruno in July of 1962 offered the motion to direct the Superintendent to see that the 1963-64 budget not exceed 90% of the 1962-63 budget and now his literature states of the 1962-63 budget: "I would return to the near level of the 1962-63 budget - on which the school district operated successfully." From flyer dated 3-12-63 from William A. Bruno, Jr. Fact or Fiction? Has Mr. Bruno changed his mind again?

IS CHILD BEARING A BAR TO PUBLIC EDUCATION? -- If a high school girl in her early teens becomes pregnant without benefit of matrimony, leaves school to have her baby, and then wants to return, should she be allowed to do so?

That is the problem reportedly confronting the Syosset School District. Under the compulsory education law, there is no question that this student has the legal right to return to school. Morality or the lack of it is not one of the yardsticks for determining who shall or shall not go to school. Nor is the school district the arbiter of the morals of its charges.

A local citizens group is said to be studying the matter. Why? No local group of citizens can give anyone rights that are NOT legally his, nor can it take away any rights that ARE legally his.

Yet, I must make this concession: The Buttinskies are always with us.

SPEAKING of honesty, the School Board has turned down a request of the Hicksville Committee for Honesty in Public Education to meet in the schools. Why? Because no member of the honesty group was present at last week's Board jamboree.

Apparently notarized statements as to the nature and character of the Honesty Committee were not enough for the Board, which, incidentally, has never adopted a code of ethics.

I've said it before and it bears repeating: The very name of that Honesty Committee scares the bejabbers out of the Board.

HICKSVILLE school super Donald F. Abt has been defending his budget which will raise the school tax to about \$6 for each \$100 of assessed valuation.

Where does Abt defend it? As usual, before the PTA which can be depended upon to do almost anything the school administration wants, without regard to the pocketbooks of the taxpayers.

SUPREME COURT JUSTICE JOSEPH SUOZZI reserved decision Friday after hearing arguments in the case of George Martin and others against the Hicksville Library and School Boards. The case attacks the legality of the purchase by the Library Board last year of a \$24,000 piece of property without a referendum. When a vote was held last December, months after the initial purchase, the voters turned the proposition down.

Arguing the matter before Judge Suozzi were attorney Harry Goebel for the plaintiffs, Joseph Catalano for the defendant School Board, and Kendrick Smith for attorneys Robinson, Shepps & Doolittle, attorneys for the Library Board.

Two library trustees have quit since the action was started.

LAUGH OF THE WEEK -- Teachers at Sewanhaka High School are belly-aching over guidance counselors sitting in judgment on their competence.

That knowledge practically makes me chortle, for many teachers have opposed my efforts to keep public school authorities honest by requiring them to show school records to parents and to get parental consent before they brainpick school children.

Now the shoe is on the other foot down Sewanhaka way, at least. And the teachers are screaming to the heavens.

Could it be that some of their own sins are coming home to roost?

These teachers probably don't know how much heat can be put on them by guidance counselors, psychologists, and other verminous forms of psychesnoop. They likely don't know that there is at least one psychological test in existence which evaluates teachers. (Peculiarly enough, there don't seem to be any for evaluating psychologists.)

As a matter of fact, there are several psychological tests which ask the STUDENT to tab the teacher. Science Research Associates Youth Inventory, a personality test used to pick the brains of some 75,000 school kids in the U.S. each year, contains these and other indirect questions on teachers:

"My teachers give me no encouragement."

"My teachers make fun of me."

"My teachers don't make assignments clear."

"My teachers are n't interested in me."

"My teachers play favorites."

"Class periods are not well organized."

Actually, all teachers aren't quite so dense as to the "headshrinking" threat posed to their own jobs. A number have signed the psychological petition asking for laws to curb psychological testing abuses in this state.

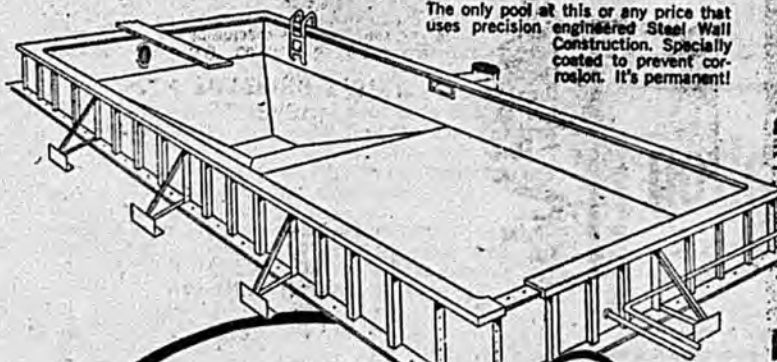
