Is The \$2,276,862 School Bldg. Plan Necessary

Acting on a tip last spring, this reporter spilled the story of a \$2 million building program in prospect in the Hicksville School District.

A cost estimate sheet prepared by Hicksville School District architects Knappe & Johnson which then fell into this newspaper's hands set the cost of contemplated construction at the senior high school at \$1,535,000, including a \$270,000 swimming pool. It also estimated that eight elementary school classrooms and a gymnasium would cost \$395,000.

About a week later, School Trustee Cornelius McCormack, then running for re-election, tabbed this newspaper story a "lie."

Was the story a lie? Hardly. For now that part of the truth is out, we find, from an authorita-

tive source, that the proposed building program was actually in contemplation since August, 1962.

The truth will out, of course, even in public school districts, especially if someone digs deeply enough to unearth it.

And so it is that we find the Hicksville School Board contemplating a 22 classroom addition to the senior high school, to cost \$1,570,000, in principal and interest, and a 28,000 square-foot administration and storage building, to cost \$821,700, in principal and interest.

What happened to the idea of a swimming pool? Apparently all official hopes for a school natatorium, as the Uniondale School District grandiloquently calls the swimming pool in that district, was torpedoed by public opinion.

And what about the proposed elementary school construction? Hicksville elementary school enrollment has already dropped. More, the report of Dr. Felix McCormick of Columbia University College, released early this year, predicted a steady population decline in Hicksville. Twin reasons for this decline are the aging of the population and the fact that only limited residential construction is possible in the future.

Dr. McCormick foresees not only an ever-increasing number of older persons in the district; he said:

"...The present school district population of 48,580 persons, after a slight increase over the next few years, will gradually decline to approximately 47,200 persons by 1970 and 45,000 persons by 1980."

Hicksville High opened its 1963 football campaign with a 27-20 victory over pressing Island Trees, Saturday, before 3,400 Homecoming Day fans at the local gridiron.

Hicksville took a 3-2 edge in this gallant series on the passing of Bruce Damm and the receiving of Bruce Cerone, who combined to carry the Orange and Black colors into the end zone three times.

The first strike came on a 39 yard play the second time Hicksville had the ball. Charlie Triolo hit for the extra point and it was 7-0.

On the next Hicksville scrimmage play, Larry Welsko hit over the right side and with surprising speed for a 195-pound fullback outraced the secondary 67-yards for a score.

With Steve Schuster and Allyn Lewis aiding in a fine running attack Hicksville worked the fans into complacency. Hicksville traveled 64-yards for its third score in the second quarter. It came on a 7-yard toss from the Damm-Cerone team.

An inspired comeback by Island Trees made a day of it. Steve Samberg ripped off a 46-yard TD run early in the third and a 60-yard march was capped eight minutes later by Samberg again. His one yard charge into the endzone made it 20-13.

Hicksville fumbles made the Trees danger real. The visitors went 43-yards to the Hicksville four in the fourth period before the Comet forward wall braced and won the issue on downs.

Damm handled the task coolly in taking the Comets 94-yards for another score. He first called on veteran Triolo four times to gain running room on the 16. Welsko picked up 5 and Damm kept for 9. Welsko made 3 and Damm passed to Triolo for 34 more. Two plays later he found the elusive Cerone again for 32 yards. Welsko plunged to make it 27-13.

A Hicksville interception late in the game stopped the losers on the winners 23. CLEATMARKS -- Alumni Homecoming awards to Damm and Cerone as MVP for the day...Hicksville found running easy. Comets had 229 yds. rush. Welsko had 115 in 10 attempts. Schuster had 13 in 3. Triolo 45 for 7. Damm 31 for 5 and Lewis 25 for 3. Island Trees gained 166 yards on the ground. 7 completions in 12 attempts for Damm gained Comets 170 yards. Trees had 3 of 14 for 46 yards. Cerone had 5 pass receptions for 118 yards.

Hicksville travels to MacArthur at North Wantagh, Saturday, for the first league assignment of the season. The Generals showed signs last year in the final game by holding Comets to a 14-0 win. This year they are reported loaded and dumped Farmingdale in the opener to underscore the point. Coach Jim Grantham wasn't exactly happy with the Island Trees showing and heavy drilling was indicated to sharpen the Comets. The week's work should be enough to do it.

Lower Taxes Shown In Budget Report

Homeowners and taxpayers of the Town today were assured of an average 9 cents per 100 dollars assessed valuation reduction in overall Town taxes in 1964, according to the preliminary budget filed today by the Town Board with Town Clerk William B. O'Keefe.

The 1964 budget with its promise of positive tax reduction for homeowners makes good the pledge voiced by supervisor Thomas R. Pynchon back in September, based upon preliminary studies. The

preliminary administrative budget is estimated at \$4,907,362.30 as compared to the 1963 budget of \$4,651,583.16, representing an increase of \$255,779.14. \$179,000 of the increase was brought about by mandatory salary increments for employees under the various civil service classifications, employees' retirement, social security and hospitalization, and \$62,000.00 for Bonded In-

debtedness.

"This budget has been the subject of a thorough-going fiscal analysis and review by the Town Board over many weeks," Supervisor Pynchon said, "and it will enable us to function without any cutback of necessary and desirable municipal services. The Town administrative tax has been dropped from \$.19 per hundred dollars of assessed valuation to \$.19 per hundred dollars of assessed valuation. The Town highway tax has been reduced to \$.10 per hundred dollars of assessed valuation from \$.69 in 1963 to \$.59 in the proposed preliminary budget. Under State law the cost of the Building Dept. must be separated in the budget exempting incorporated villages. The Building Dept. rate stands at \$.033 the same as in 1963, and the Zoning Board of Appeals has been reduced from \$.015 in 1963 to \$.012 for 1964.

According to the Hicksville Postmaster Irene L. Murphy. The building will be approximately 4,500 sq. ft. with a parking and maneuvering area of 12,000 sq. ft. Under the Department's Lease Construction program the successful bidder will lease the building to the Department for a basic term of ten years with four 5-year renewal options.

The Old Bethpage Office will be a carrier branch of the Main Hicksville Office. Delivery and window service will be provided patrons in the community. The ZIP Code number for the Office will be 11804. "Members of civic groups made their wishes known to the Department over a period of time with the belief that the community could best be served by a separate carrier branch," according to Postmaster Murphy. "I know that residents of this long-established community are pleased by the Department's action."

Thinking It Over

This newspaper has long found it difficult to obtain news of the workings of the Hicksville Board of Education and for a number of years fought a losing battle to get information that should have been made available. In recent months we have been able to get some information and one member of the Board often contributes a column to this newspaper. We don't often totally agree with this column but we do feel that the writer should be given a chance to present his views. Several school board meetings ago a move was started to stop the school board member from giving us information and it appears that the Board is considering making a motion to try to stop him from writing a column for this newspaper. The idea sounds unbelievable, but it is probably true.

The Board takes an unfavorable attitude towards people who do not agree with their building programs and with a means justifying the end approach the members feel that freedom of the press should be suspended at least until their large scale building program is voted upon. In light of the fact that a former board member wrote for more than a year about things favorable to the Board in another publication without censure the latest effort of the Board is transparent.

A group of people who obviously are out to do away with the public school system in Hicksville calls itself TEACH. Translated the organization is the Taxpayers Educational Assoc. For the Children of Hicksville. This group would like to see Hicksville undertake a building program twice the size of the one now being pushed off on taxpayers. If TEACH gets its way the school system would have the best set of buildings on Long Island, the highest taxes and the worst educational program because there wouldn't be enough money left for such unglamorous things as text books and teaching tools. Several of the School Board members now serving were backed by this group but they didn't say a word about their big time spending ideas at election time. This must be another case of the end justifying the means.

Flu Epidemic Due Be Prepared, Wary

MEDITORIAL: A few years ago we experienced a severe epidemic of viral influenza, Asian type. As is customary, and for reasons as yet unknown, the flu virus goes into hiding following epidemics. After staying in seclusion for about 3 or 4 years, it again appears, ready to make people sick.

Enough time has elapsed since the last flu epidemic to alert us to the possibility of another. We must prepare for this. Although present measures of prevention are not ideal, they are at least partially effective.

First in the program of prevention is the flu vaccine. This is effective in protecting 60 to 70 per cent of the people who receive it. This vaccine should be used in those persons comprising what we consider the high risk group -- the aged, invalids, pregnant women and other seriously ill persons. Anyone working in close contact with others, public servants and factory workers should also have this protection.

To be of value, the vaccine must be given in advance of any epidemic, since it takes 10 to 20 days for immunity to build up after a shot. Several different types of vaccines are available, some requiring only one shot, others two. Some are given just under the skin, some into the skin and some into the muscle, so don't be surprised at the different routines when you start comparing your shots with your neighbors.

Other aspects of flu prevention include avoidance of large gatherings and maintenance of good, general body health. These are not as clear cut as vaccination but often are just as important in the control of a given epidemic.

Pontifical Mass Holy Family Asst. Pastor

A Pontifical High Mass was offered Monday for Rev. Romolo J. Fisichelli, assistant pastor of Holy Family R.C. Church in Hicksville.

Father Fisichelli died Wednesday in French Hospital in Manhattan after a brief illness. He was 43.

The Brooklyn-born priest had been assistant pastor of the 3,200 family congregation in Hicksville for three years. The Rt. Rev. Msgr. Martin O'Dea is pastor of the church.

Father Fisichelli, a member of the Mercy Fathers, served as a missionary in Canada before coming to the Hicksville church in 1960. In Hicksville, he was moderator of the Confraternity of Christian Doctrine and the teen-age club and spiritual director of the Holy Name Society.

He leaves his father, Gerard Fisichelli of Brooklyn; two brothers, Gerard Jr. of Brooklyn and Vincent of Floral Park; and three sisters, Mrs. Anthony Marchisotto of Massapequa Park, Mrs. Louis Tarranto and Mrs. Violet De Lisi, both of Brooklyn.


ion Ave.) in the May's Shopping Center on Thursday, October 17, beginning at 8 p.m.

My Opinion

By Hicksville School Trustee William A Bruno, Jr.

Do you remember my warnings about that loud and noisy pressure group called TEACH (which could stand for "teaching everyone about cost hiking")?

TEACH, which has three of its own high spenders on the Hicksville School Board, the Lawrence-Sabatella-Jackson trio, wants the Board to overbuild, despite being forewarned against that very thing by Dr. Felix McCormick in the very thorough McCormick Report released in January.

Not long ago, TEACH's pet, Board President George Jackson, admitted that the proposed \$2 million-plus building program has been under study (unbeknownst to the public, of course) for over a year.

The first the taxpayers of Hicksville were let in on the big secret was several weeks ago when the Board majority and its boss, Superintendent of Schools Donald Abt, who treats me like a leper when I ask for school district information, started a campaign to sell the people on the need for additional school construction.

In spite of Dr. McCormick's prediction that the Hicksville school enrollment will drop after a slight increase in the next few years (and it has already dropped this year), TEACH, ever magnanimous with other people's money, wants not 22 or 24 classrooms built at the high school, but some unannounced number, probably 26 or 30 classrooms.

Moreover, TEACH cites the McCormick Report as stating the high school will remain overcrowded for the next 15 years. But cutely and cunningly, TEACH neglects to tell the public what Dr. McCormick further said on this subject.

He said, at page 50 of the Report:

"Within a year, enrollment at the high school will exceed available maximum capacity by close to 1,000 pupils. After that, the gradual decline in grade 10 through 12 enrollment will lessen the impact to some extent, but certainly not to the point of comfort for at least ten years hence."

But -- and this is a large BUT -- Dr. McCormick said the whole high school enrollment picture was clouded because exact parochial secondary school building plans were not known at the time of the Report.

"Thus," said Dr. McCormick, "the survey staff recommends the maintaining of permanent construction at the senior high school level at its present capacity range through the next 5 years. In this time, parochial secondary school construction plans will become known and their exact impact can be reckoned with."

Then, very importantly, he added:

"When these data are known, a permanent addition to the senior high school might become a defensible necessity. Until such data are known, a permanent addition to the senior high school might prove an UNJUSTIFIED expenditure and burden to the district...." (Emphasis mine.)

Since the Report was issued, the Rockville Centre Diocese of the Catholic Church has announced plans to build a 2400-pupil parochial high school in Hicksville. But remember, Dr. McCormick advised against further public high school building in Hicksville until the exact impact of parochial building is known.

By the way, two of TEACH's pets, Messrs. Jackson and Abt, have been invited to a public meeting sponsored by TEACH at Levittown Hall on October 17 at 8:30 PM.

This is all part of a massive huckstering campaign to convince the taxpayers of Hicksville that they should completely ignore the \$8,000 McCormick Report. It is aimed, further, at convincing them that a \$821,000 administration building is needed at the high school.

Still another puppet of Teach, School Trustee Irving Lawrence, was a panelist at the recent teachers' conference. The subject: Curriculum Development - Whose Job?

Could this have something to do with the scuttlebutt around town that a new teachers' hike is being

worked on by TEACH representatives, to be presented to the Board by none other than the one and only Irving Lawrence, bent, apparently, on becoming a teachers' as well as TEACH's pet?

A word of warning to all Hicksville taxpayers: If you want to protect your own tax interests, you'd better take a far more active interest in Hicksville School District affairs. (More next week.)

Significantly, Dr. McCormick also forecast a declining birth rate, a

natural concomitant of an aging population. He cautioned that the downward drop in population, however, "might be reversed by substantial changes in the zoning or---- to encourage the erection of large, high-rise apartments buildings -- a possibility which makes many local residents and not a few politicians see red every time it is mentioned."

A "moderate" enrollment projection of the McCormick Report predicts a very slight rise in enrollment to a total peak of 13,265 students in 1963-

1964. After that, the total enrollment is expected to drop continuously "for at least 17 years."

Actually, on September 7, 1963, the total enrollment of the Hicksville School District was 12,977, a 21-student enrollment drop since last year.

By 1965, said Dr. McCormick, "the K-12 (kindergarten through 12th year of school) should approach 12,675 pupils; by 1970, be near 11,000 pupils; by 1975, be down to 9,813 pupils; and by 1980, should be between 8,800 and 8,850 pupils."

Probably few parents indeed know that 2,954 Hicksville School District children attend parochial and private schools, according to the August, 1962, school census. This

2,954 figure, said the McCormick Report, "represented 18.6 percent of the total school-age population enrolled in public, parochial, and private schools at the time of the census tally."

Since the McCormick Report was issued, the Rockville Centre Diocese has announced that a parochial high school will be built in the Hicksville

area. This new high school is expected to siphon off about 400 public school students, freeing about 14 classrooms.

Are the 22 additional classrooms the School Board contemplates taking onto the senior high school actually necessary?

Dr. McCormick said in his rather comprehensive Report: "Facts and data are unmistakably clear that the crest of the (Hicksville population) wave has passed...It is imperative that the folly of excessive school plant capacity already evident in some unfortunate school districts does not occur in District 17. In some districts, the excesses of capacity are increasing at alarming rates, long before the debt retirements on the plants has been completed."

Very significantly, the McCormick Report added: "...The survey staff recommends the maintaining of permanent construction at the senior high school level at its present capacity range through the next five years." McCormick said only after parochial secondary school plans became known would a "permanent addition to the senior high school become a defensible necessity."

Since then, the building of the 2400-pupil Catholic high school in Hicksville has been announced. And, if as anticipated, it siphons off 400 public school students, lightening the public school load in years when a population decline is expected, can the School Board justifiably ask the people to add 22 more classrooms to the Hicksville Senior High School?

Moreover, if the School Board ignores Dr. McCormick's cautionary warnings and asks the people to saddle themselves with 30-year bond issues for schools that could eventually become white elephants, what valid, sound, prudent educational practice will be served?

Dr. McCormick nevertheless preferred a good, far-less-expensive alternative to help solve whatever secondary-schooling problem Hicksville may have over the next few years before the population starts to nose-dive in earnest. He raised the possibility of using pre-fabricated temporary classroom units at the high school until the late 1960's or early 1970's when a permanent addition might be "more defensible."
