P.O. Units Move

The Hicksville Post Office incoming and outgoing mailing units will move to a new Annex at 10 Commercial Street off New South Road on Dec. 1, according to Hicksville Postmaster Irene L. Murphy. The new facilities have been made necessary by a continuous increase in mail volume, particularly parcel post.

In accordance with the Nationwide Improved Mailing Service the Postmaster urges business firms to continue to mail early in the day. The new Annex has a loading platform and improved facilities for receiving mail, although no window service will be available. All permit bulk mailings must still be brought to the Main Post Office on North Broadway.

The Postmaster stressed that occupation of the new Annex on a short term lease will in no way interfere with plans for the new facility on West John St. All of the operation of the Post Office will be under one roof when the West John Street building is completed in approximately two years.

Voting Sat. On School Ref.

Qualified voters in the Hicksville School District will vote Saturday, November 23, between the hours of 7 A.M. and 8 P.M. on three bond issues totaling \$1,665,000 plus interest.

Proposition Number one would authorize an addition of about 24 classrooms to the senior High School and the erection of an administration building.

Proposition Number two would authorize the demolition of building on the Lumm Property now owned by the school district and Proposition Number three would authorize the purchase of 2.85 acres of land at the site of the Willet Avenue elementary school.

Mother Can't Get Help

(First of a Series)

To the question, "Are you animal, mineral, or vegetable?" 13-year-old Tommy Larsen of 32 Violet Lane, Levittown, might well answer:

"I am a vegetable. Society has so decreed."

Tommy might well answer that question that way, that is, if he could form the words and give utterance to coherent, intelligible speech.

But Tommy can do none of those things. For, by sheer accident of birth, he has twin afflictions — cerebral palsy and deafness — which make him, and others like him, society rejects.

Should this unfortunate child be a "society reject" simply because a coarse, crude, calculatingly callous society has so willed? Judge for yourself.

At 13, Tommy can dress himself, feed himself, and attend to most of his own personal needs. He can even play outside for short unsupervised periods, though his mother, Mrs. Robert Larsen, keeps a watchful eye on him most of the time.

A loving mother, Mrs. Larsen has been shocked almost beyond words by the unfeeling recommendations of several governmental and "do-gooding" authorities who have suggested she institutionalize Tommy. She believes, instead, that children like her son, rather than being consigned to societal scrapheaps in poorly run governmental institutions, should receive even more tender, loving care in their own homes than is accorded normal children.

At this point you may

ask, what about those charitable organizations that constantly bang on our doors asking us to shell out moneys that some of us can ill afford to help them aid the afflicted like Tommy?

Right now, Tommy goes to the Association for the Help of Retarded Children in Brookville one day a week for three hours, according to his mother. Tommy has a bright, new, shiny hearing aid. But there's one drawback. Denied the gift of hearing from birth, Tommy must be taught to use it if he's ever to completely comprehend the speech of other humans around him. And there appears to be nobody either qualified enough or willing enough to tackle the task of teaching this boy.

Nor has the Cerebral Palsy Center in Roosevelt been of much help, says Mrs. Larsen. For a time Tommy went to nursery school there. But much to his parent's disappointment, he received no auditory training there either.

Can Tommy without auditory training of a specialized nature be led out of the darkness of ignorance into the wonder-world of knowledge? He can, Mrs. Larsen staunchly believes, if she and her husband can but find one wonderful, altruistic person or agency willing to meet the challenge Tommy's twin congenital afflictions present. Letters

To the Editor:
At the public hearing at the High School on Nov. 12th which the Hicksville Board of Education held in regard to the building program referendum, the Hicksville Parent Teachers Associations, in general, and the Woodland Avenue P.T.A., specifically were accused by Mr. George Martin of practicing censorship. He stated that Mr. William A. Bruno, Jr. was not being allowed to speak at the Woodland Avenue P.T.A. meeting, to be held on the following night of Nov. 13th in regard to the referendum, that written questions from the audience would be screened and that our P.T.A. was practicing censorship to suppress the opposition. Mr. Bruno has also made statements claiming that he has been denied the right to speak. He agreed with Mr. Martin's state-

ments at the public hearing. After the public hearing he even telephone a reporter on the Long Island Press, and an article appeared in that newspaper the next day, saying that Mr. Bruno was not being given an opportunity to speak as a member, but he was going to try to speak anyway. As the School and Community Relations Chairman of the Woodland Ave. P.T.A., and a member of its Executive Board, I feel that I want to set the record straight as publicly as Mr. Martin and Mr. Bruno have made their false statements and innuendoes. In September Mr. George Jackson, as president of the School Board, sent a letter to all P.T.A. units advising us of the forthcoming referendum, and offering the services of Board members and administration personnel to supply our members with information concerning the building pro-

gram. At our subsequent Executive Board meeting this letter was discussed. We decided to have an informational meeting on November 13 inviting Mr. Jackson as president of the Hicksville Board of Education to be our speaker of the evening to present the Board's views. After the formal presentation we were going to have written questions answered by the speaker, followed by an open discussion period with a three minute limitation on statements from the floor. The purpose of this format was not only to give all members an opportunity to hear the proposals but to make sure that people who preferred to write questions rather than get butterflies standing up could do so. Anyone who preferred to speak from the floor could also do so, all within a sensible closing time for a P.T.A. meeting.

Mr. Bruno did request special time as a speaker to present another point of view. This would not be in accord with the School Board's code of ethics which expects each member to uphold the decisions of the majority. Therefore we could not properly invite Mr. Bruno as an opposition speaker. He was sent a letter in reply, informing him that we already had a guest speaker for the evening to present the Board of Education's proposal to our membership, and that he, as a member of our P.T.A., was invited to attend the meeting, ask any questions and participate in our discussion as all members were entitled and urged to do. Instead, we became subject to the abuse of being publicly accused of a censorship that was in no way intended, and a screening of questions that was in no way planned.

And what happened to Mr. Bruno's participation at our informational meeting on November 13? And Mr. Martin's who is also a member of our P.T.A.? Nothing. After making a vow to demand his right to be heard, Mr. Bruno did not attend our meeting. Neither did Mr. Martin. The truth of the matter is no one denied anyone the proper channels to bring out their points of view. Mr. Bruno, as a member of the Board of Education, can assert his views at their meetings. As a member of the Woodland Ave. P.T.A. he had a right and a duty to attend and participate in our meeting. The Nassau District of P.T.A.s sent a representative to ob-

Thinking It Over

On Saturday the voters of Hicksville School District will go to the polls to decide whether they wish to authorize the large scale expansion program they are being given by the School Board.

What has struck us in the entire thing is the indecision on the part of the school board to put the propositions together and to project a plan for both a short range program and a long range one.

It is perhaps understandable that the long range planning would be difficult, particularly if you completely discard the McCormick report which attempted to conduct the survey with scientific methods. This report denies that there is need for any large scale building program as proposed by the referendum.

But on the short range scale it does not take a fortune teller to see that there is some overcrowding at the high school level, but a slackening off of enrollment in the elementary schools. But the Board, although willing to spend more than a million dollars on expansion, has ignored this problem.

Then too there is the Nicholas Street school and the new administration building. There should be no doubt in the minds of voters that the district should make better classroom accommodations for the children at Nicholas Street before it builds an administration building. While Nicholas Street school is probably a safe building, it is old. It would make an adequate administration building with far less alteration expense than will be incurred by putting up a brand new building.

We sense that there is more of a split on the School Board on this matter, than is evident. William Bruno has voiced his total objection to the referendum and School District Clerk Fred Noeth has written that he does not favor the expansion of classrooms or the administration building proposition (which is proposition No. 1).

We feel that with so much money at stake, with the many uncertainties, including that of the Board, that the District voters should turn down this referendum in total by voting "No" on all three propositions.

My Opinion

When you go to the polls Saturday to vote on the \$2,276,000 (including principal and interest) school referendum, ask yourself these questions:

1. Is a 24-room addition planned for the senior high school actually necessary AT THIS TIME? Ask yourself that question as you keep in mind the \$8,000 report of Dr. Felix McCormick, which recommended the district postpone any building plans for at least five years, pending the completion of parochial school construction in the Hicksville area.

2. Do we need a frilly, air-conditioned (\$821,000 including principal and interest) administration structure which will likely be palatial in its appointments but costly indeed to taxpayers for the next 30 years?

3. Do we need any kind of new administration building in face of the fact that the same McCormick Report recommended the phasing out of the Nicholas St. School and "its ultimate modification into a school administration facility for the district"?

The McCormick Report said the conversion of the Nicholas St. School into an administration building would cost only \$50,000 to \$100,000. Weight that sum against the \$821,000 you will spend if you vote yes on Proposition 1.

4. Do we need to buy 2.85 acres (\$116,200 including principal and interest) more at the Willet Ave.

School site? Or is the school administration and majority School Board faction planning to spring plans for a Willet Ave. addition on an unsuspecting uninformed public AFTER they get an okay for this land?

In that connection, remember two things: (1) The McCormick Report says the crest of the Hicksville population wave has already passed and predicts a steady population decline in the future; and (2) elementary school enrollment in Hicksville has already dropped by over 331 students.

Ask yourself these questions and any other weighty questions that may occur to you. Weigh each proposition carefully before you cast your vote.

Remember, too, that the exact number of classrooms planned is not spelled out in the wording of Proposition 1. You will find the number in the propaganda of the administration and the Board majority. But only the propositions themselves are binding on the school district. And you definitely will not find the number of classrooms in the wording of Proposition 1.

Is this an oversight? If it is I think it's a pretty important one, for you, the voters, are entitled to know precisely what you are voting for and are binding yourselves to for the next 30 years.

As another example of how close-mouthed the Hicksville School Board majority is with respect to the expending of your tax moneys, the Board's Grievance Committee is now studying salaries. Yet, not one word of this move that will surely up your school tax next year if teachers and principals are given a juicy raise have they given out to the press or to you, the people.

Right now, the news of prospective salary increases in this district is actively being suppressed. Not even in school administration-controlled publications will you find one word as to what this committee plans to do with YOUR money next year.

Of course, it is only YOUR money that they're whacking up, so if you don't care, surely neither the administration nor the Board majority is going to care.

Finally, I have done my best for you in bringing the public notice as many facts as I could dig up about the \$2,276,000 referendum. Admittedly, the school administration and majority Board faction have been miserly with information except that which they can give you in pre-digested, canned fashion.

Study all their propaganda which your money paid for, and study all other facts at your disposal before you vote. Vote wisely. Vote for what you think is in the best interest of the children of Hicksville.

Then, in true American fashion, once you, the voters, have spoken at the polls, let the chips -- and the taxes -- fall where they may.

No matter what the outcome, please accept my sincere thanks for the intense interest you, the people of Hicksville, have shown in these columns in the past.

Van Allen Writes For Mag.

The American Mercury has accepted an article tentatively titled, "The Case Against the School Snoops" written by freelance writer and newspaper reporter Edward J. Van Allen.

The article, slated to be published shortly, exposes invasions of privacy of whole families through psychological tests, questionnaires, and other devices used in many public schools. It quotes John H. Daniels, winner of the East Meadow school records case in which Van Allen "nailed down" the right of all parents to see their children's cumulative public school files, as saying that public school psychologists cannot "lawfully" use public moneys for any records on school children which they keep secret from parents. "I hope I don't have to go into court again to prove it," says Daniels.

Fact Or Fiction

Last year when Mr. Bruno attacked the proposed 1963-64 school budget in his column 'My Opinion', I found it necessary to write Fact or Fiction in order to correct his gross errors. It would seem that Mr. Bruno is at it again. This time his target is the building referendum of November 23, 1963.

Every person is entitled to his opinion; however, when his opinion is in error and set to print to influence other people's opinions, it is dangerous. I believe Mr. Bruno's opinion expressed on November 14 to be in error. Let us examine the facts and see if Mr. Bruno is still talking fact or fiction.

I note that Mr. Bruno again has resurrected his "reliable source". This mysterious "reliable source" of Mr. Bruno has spoken again: "my information from a reliable source is that an addition is planned for Willet Avenue in the future." Fact or fiction? Fiction! The brochure of the Board of Education specifically states that "The Board of Education does not plan to expand the Willet Avenue School."

If Mr. Bruno has a "reliable source" that is perceptive to the point of knowing what the Board and Administration do not know, should he not make this source available to the Board of Education and the community? Why keep it a secret and hidden? Perhaps this Ouija Board only speaks to Mr. Bruno or one of his oracles in the land of fiction.

At least Mr. Bruno has realized and approved the need of an administration-storage building: "I am for the conversion of the Nicholas Street School into an administration and storage building that will completely wipe out the need for the ornate roocco \$821,000 administration and storage building, which one writer in town has already nicknamed 'Abt's Palace'." The terms "ornate" and "roocco" seem redundant yet interesting. It certainly suggests that Mr. Bruno must have had another vision. The only drawing submitted by the architect of this proposed building is the preliminary drawing produced for the brochure. The image he draws of the building would lead one to believe Mr. Bruno is still in a world of fantasy and is under the influence of Walt Disney's wonderful fables.

Mr. Bruno states, "Transferring the present 360 regular third grade and 19 special students at Nicholas would be as simple as A-B-C. The other schools could easily absorb these children..." The ease of transferring is fact -- the absorption he speaks of is fiction. Or is Mr. Bruno advocating a return to double sessions in the elementary schools? Can he be serious in suggesting double sessions for the children in order to make room for storage and the administration?

Mr. Bruno talks as though his suggestion will not only obviate a building program, but will also save the salaries of the present teachers, etc. at Nicholas: "... you taxpayers could save as much as \$171,000 a year ---" Does he really think that by arbitrarily removing the children from Nicholas we no longer have these children and, therefore, we do not need teachers for them? Such dreams belong to fiction; each of the 379 children he disposes of so readily is a complete, real, factual individual entitled to a education.

It would also be a matter of interest to know where Mr. Bruno would put storage facilities at Nicholas. Would he have us dig a new basement under a 66 year old building?

The people want the true facts. Why does Mr. Bruno write "All in all, rather than payout \$821,000 in principal and interest over 30 years for 'Abt's Palace' or status symbol, you, the taxpayers of Hicksville, could see to it that the Nicholas Street School . . . is converted to an administration-storage building." \$821,000 for an administration building? Did Mr. Bruno forget that this cost includes the building of 24 classrooms, a gymnasium-cafeteria, as well as an administration-storage area?

If one is going to use facts and figures, shouldn't he report them accurately?

Freedom Group Against Expansion

The regular monthly

meeting of Freedom Education, Woodland Ave. Chapter, was held this evening (Nov. 11) in the home of Mr. George Martin, Chapter Presi-

dent, with the proposed Hicksville School Building Program as the topic of discussion.

The following statement was issued as a press release:

"The Hicksville taxpayer is about to be taken on a financial sleigh ride once again. While the school district continues to grow larger and larger out of local tax dollars, individual pocketbooks continue to become emptier and emptier.

Proposal: The school administration desires to spend in excess of \$2,250,000.00 on a building program.

Fact: It is not now needed, and it will not be needed in the foreseeable future.

Proof: For over eight years the school district has employed, at great expense, Dr. Felix McCormack, a prominent educator, to investigate our continuing school needs on the basis of student enrollment. Dr. McCormack's projections have proven to be almost 100% correct. This is a man whose words carry great weight, and who can be trusted to be impartial.

Dr. McCormack states, in reference to our present classroom needs:

1. Senior High School enrollment should continue at about the same student total through 1964.

2. Senior High School enrollment should decline from the present 2915 students to 2481 by 1970.

3. Senior High School enrollment should decline to 2300 by 1975.

4. Senior High School enrollment should decline to 2000 by 1980.

Conclusion: There is no justification, for any reason, for a building program in the foreseeable future.

Fact: The new parochial high school in Hicksville will further decrease our high school student enrollment.

Fact: The school administration is well aware of this fact, but they are suppressing the information since it runs contrary to their plans. This is proved by their massive propaganda attempt to brainwash the district's voters by presenting only the one side of the story -- theirs -- and the suppression of all attempts to present the opposing viewpoint. This is further proven by the fact that the local PTA units have presented only the administration viewpoint. Which, to their everlasting disgrace, is tantamount to Censorship. Is the PTA a mouthpiece for the school administration, or is it representative of the parents of the district?

Fact: Dr. McCormack concluded that: "We should maintain our present (student) capacity for the next five years. A permanent addition to the SHS might prove an unjustifiable expenditure and burden to the district."
