## Citizens Comm. To Review Town

The Town Board today adopted a resolution creating a four-member Citizens Committee to institute a comprehensive review of the Suburban Town Law and the Home Rule Amendment to determine their effect on the Town and to recommend changes wherever necessary to meet the future needs of the Town of Oyster Bay.

Councilman Edward J. Poulos, Majority Leader of the Town Board, said the four-member Committee will join with similar committees being appointed by the Town Boards of North Hempstead and Hempstead who will act as a unit for the purpose of conducting the study. Mr. Poulos said the Town is fortunate in securing four distinguished citizens who already have a substantial knowledge of Town Government and have demonstrated in the past their interest in improving the administrative functions of Town Government.

### BOND RESOLUTION DATED DECEMBER 23, 1963.

A RESOLUTION AUTHORIZING THE ISSUANCE OF \$76,000 SERIAL BONDS OF THE TOWN OF OYSTER BAY, NASSAU COUNTY, NEW YORK, TO PAY A PART OF THE COST OF THE PURCHASE OF CRAWLER TRACTORS FOR USE AT THE TOWN INCINERATOR PLANT.

BE IT RESOLVED, by the Town Board of the Town of Oyster Bay, Nassau County, New York, as follows:

Section 1. To pay a part of the cost of the purchase by the Town of Oyster Bay, Nassau County, New York, of crawler tractors for use at the Town incinerator plant, there are hereby authorized to be issued \$76,000 serial bonds of said Town

pursuant to the Local Finance Law.

Section 2. The total estimated cost of the aforesaid class of objects or purposes is \$97,000, and the plan for the financing thereof consists of the issuance of the \$76,000 serial bonds herein authorized, with the balance in the amount of \$21,000 to be provided by a trade-in of used equipment.

Section 3. It is hereby determined that the period of probable usefulness of the aforesaid class of objects or purposes is five years, pursuant to subdivision 20 (a) of paragraph a of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized will not exceed five years.

Section 4. The faith and credit of said Town of Oyster Bay, Nassau County, New York, are hereby irrevocably pledged to the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. There shall annually be levied on all the taxable real property of said Town, a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

Section 5. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Supervisor, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Supervisor, consistent with the provisions of the Local Finance Law.

## Ambulance Should Not Act As Taxi

When the wail of an ambulance siren is heard you think that a mission of mercy is being done. But is it? Recent analysis of the number and type of calls for ambulance crews responded to point out some disturbing facts.

On the whole, it is true, ambulance services are performed for a good purpose, i.e. they transport the ill and injured to places for treatment, rest and recuperation. Too many, however, have been found to perform functions that would be expected of a taxi. For example, more than once a person has called, claimed he was seriously ill, been carried to the hospital for "emergency" treatment, then has decided to walk home, so he could shop on the way. Then there is the patient who owns a bicycle and called the ambulance for transportation to the hospital physiotherapy room for exercises on a -- you guessed it -- fixed bicycle.

Such persons don't realize the seriousness of such practices. They don't appreciate that while they are using the ambulance as a taxi, a genuine emergency may arise and someone will be deprived of emergency care and may die as a result.

There are times, of course, when ambulances are not on emergency missions, but rather are transporting persons home or to other hospitals for further care. Many of these trips can be planned in advance and done without a strain on the available equipment. Railroads and airplanes can also be used for this purpose, when long distances are involved.

If a question of an ambulance's services arises, make sure it is a genuine one. In most cases there is time enough to contact your doctor and let him make the decision. Also remember that in many areas, ambulances are manned by volunteers who give up much of their spare time to do this marvelous work.

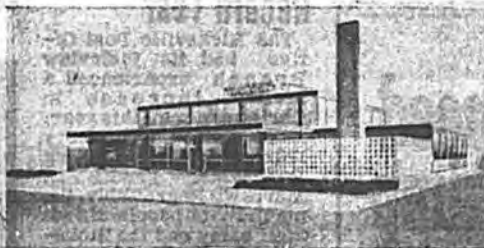

Hicksville High surprised everyone with a 51-47 upset over Great Neck North to win the Clarke Invitation tournament on the eve of the New Year.

It was unexpected since the Orange perennial does not merit even moderate victories this season. However, the Comets followed Coach Ed Petro's scheme of play soundly and pulled it off.

After a 17-1 1962 Campaign and repeat championship last year one would think Petro, if he did not know him, would review the '64 material, sigh and just play out the schedule.

He is pouring more work and energy into this club to gain it respectable standing.

This has been his mark for the past decade at Hicksville where he has compiled the third best won loss record in the County - Hempstead and Mineola are tops - over that span.

Petro's formula for this club is only the one good shot and an interesting non-fouling position press on defense.

Since he can substitute quickly because of uniform effectiveness Hicksville survived occasionally burst

of Flashmanship. This factor made a snambles of an 11 point lead in the first round contest. The Comets thus underminded barely held off East Meadow 50-49.

Great Neck skipped to a 12-7 quarter lead as Hicksville made six mechanical floor errors.

Hicksville had a 24-21 half lead and 39-34 at three quarters.

The Comets open the league season with Plainview this Friday (tomorrow night) and are rated underdogs again. Plainview has one six-eight performer and a six-six companion.

It will be interesting to see if the Comets keep to the Petro formula. Without it they will bedreadfulbellar dwellers.

## P.O. Has Record Year

The Hicksville Post Office and its Plainview Branch experienced a healthy increase in Christmas mail this year, more than 19 percent over 1962, according to Acting Postmaster Irene L. Murphy. Regrettably, the majority of people did not mail early and the Hicksville Post Office handled almost a million pieces of mail on the peak day, Thursday, December 19. By Monday, December 23, clerks and carriers were still struggling with a load of almost 700,000 pieces of mail. The children's letters were turned over to local service organizations for further action.

MR. AND MRS. FRITJOF AANONSEN of 15 Ellen Street, Bethpage, wish to announce the engagement of their daughter Eileen Sylvia to Mr. Richard A. Carlsen son of Mr. and Mrs. John Carlsen of Haugpaug.

Miss Aanonsen is a senior at Hofstra University majoring in Elementary Education. Mr. Carlsen, an accounting major, is also a senior at Hofstra. No date has been set for the wedding.

It is further understood that it is the intention of the County Executive, Eugene Nickerson, to propose that the franchises of all bus lines in this County be extended for only one year rather than the five year terms that had been previously granted and the ten year franchises which the bus companies have requested.

We further understand that the one year extension is proposed by Mr. Nickerson to enable him to study a survey prepared by the Traffic Research Corporation which is referred to as a "Bus Route Planning Study."

We wish to advise that we have studied the survey above mentioned and this survey was discussed in detail at a special meeting of our Executive Committee called for this purpose and held on Dec. 26th, 1963.

As a result of the above mentioned facts, I have been directed to advise you of the following matters:

1. Our organization strongly opposes that part of the survey that refers to Map Number 14 of recommended franchise bus routes, which if adopted would eliminate practically all existing bus service in the Plainview area with the exception of service on Old Country Road which is only one of the main thoroughfares in our community. It was at the insistence of this organization that the first bus route was established in the Plainview area. It was with the cooperation of this organization that additional bus services were extended to the areas around South Oyster Bay Road, Woodbury Road, Manetto Hill Road, and the Old Bethpage area.

It was as a result of a three month study and survey of all of the industrial plants in Plainview made by this organization that a proposed route was set up for the Plainview Industrial Park which route has been filed for by the Star Bus Lines. Map Number 14 referred to above does not call for any bus transportation in or out of any bus service is badly needed in the morning and afternoon hours when 3,500 automobiles enter and leave this area which is continually growing in size.

We firmly oppose the recommendations of the study above mentioned as persons living any distance from Old Country Road in Plainview would be unable to reach the Hicksville Railroad Sta-

tion or Hicksville and Plainview and surrounding shopping areas without undue hardship. In effect, if this study is adopted, it creates a bus transportation void in Plainview that will cause great hardship to the residents and business and industrial concerns in this area.

2. This organization realizes that there are transportation problems existing in this County and we are certainly in favor of any recommendations that will give better service to the residents of our County so long as we do not have to forfeit all bus transportation in our area as a result. We wish to point out that the existing bus transportation routes in Plainview are presently inadequate in that the service to the Industrial Park as above mentioned has not as yet become a reality and no action has been taken to grant a franchise for this area. The study you are going to consider will cause the total destruction of 10 long hard years of work by this organization to obtain the existing service and the proposed service to the Industrial Park. We wish to also advise that bus transportation to this area has been of such grave concern to our residents that we have, as a free service to the community, distributed bus schedules without charge to business concerns of our area, in quantity, so that patrons of business establishments could pick up schedules while doing their shopping. All of the work above mentioned has been of great importance to us because we know that bus service is of major importance to Plainview.

3. Bearing in mind that we are not opposed to changes for betterment of the public that are based upon sound reasoning and public necessity, we do, however, oppose granting a one year franchise extension. It is impossible to conceive that any bus company will improve service or purchase more modern equipment knowing that only a temporary franchise exists and also knowing the company itself may be absorbed involuntarily and put out of business.

We believe that stability should be given to the bus companies of Nassau County by granting longer franchise periods than presently granted. By means of closer supervision of the activities

and regulations of these companies, we believe the public could obtain better bus service even under the longer franchise periods.

4. This organization has been further advised that the implementation of the survey above mentioned would cause taxpayers of this County approximately \$1,800,000.00. This, we understand, would mean that every taxpayer would be paying for bus transportation regardless of whether or not they used bus services. We, of the Plainview area, are already overly burdened with a high school tax rate and we firmly oppose any additional tax burden on the residents of the area without giving the taxpayers themselves the opportunity to vote by referendum on any proposed matter after full disclosure of all facts.

BE IT RESOLVED by the Town Board of the Town of Oyster Bay, Nassau County, New York, as follows:

Section 1. The acquisition by the Town of Oyster Bay, Nassau County, New York, of approximately 26 acres of land in Bethpage adjacent to and south of the existing incinerator plant, as an addition to the site of said plant, consisting of all of Lot 5 and all of Lot 30, except a 100 foot strip parallel to Clarion Street, in Block B of Section 47 as shown on the Nassau County Land and Tax Map, is hereby authorized at a maximum estimated cost of \$300,000.

Such capital notes shall be sold at private sale and all further powers in connection with the details and the sale thereof are hereby delegated to the Supervisor in accordance with the Local Finance Law. Pursuant to Section 107.00 of the Local Finance Law, the proceeds from the sale of such capital notes will be provided prior to the issuance of the bonds herein authorized or bond anticipation notes.

Section 3. It is hereby determined that the period of probable usefulness of the aforesaid object or purpose is thirty years, pursuant to subdivision 21(a) of paragraph

2 of Section 11.00 of the Local Finance Law. It is hereby further determined that the maximum maturity of the serial bonds herein authorized will exceed five years.

Section 4. The faith and credit of said Town of Oyster Bay, Nassau County, New York, are hereby irrevocably pledged to the payment of the principal of and interest on such obligations as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such obligations becoming due and payable in such year. There shall annually be levied on all the taxable real property of said Town, a tax sufficient to pay the principal of and interest on such obligations as the same become due and payable.

Section 5. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the serial bonds herein authorized, including renewals of such notes, is hereby delegated to the Supervisor, the chief fiscal officer. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Supervisor, consistent with the provisions of the Local Finance Law.

Section 6. The validity of such bonds and capital notes may be contested only if:

1) Such obligations are authorized for an object or purpose for which said Town is not authorized to expend money, or

2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or

3) Such obligations are authorized in violation of the provisions of the Constitution.

Section 7. Upon this resolution taking effect, the same shall be published in full in Bethpage News-gram and Observer together with a notice of the Town Clerk in substantially the form provided by Section 81.00 of the Local Finance Law.

Section 8. This resolution is adopted subject to permissive referendum. BN #1734-1T-Jan. 2



**Letters**

To: The People of Hicksville.

As Trustees of the schools - and as parents - we issue this appeal to our community. During the months of November and December our schools had to be evacuated fifteen times due to bomb scares. Fourteen of the scares involved the Senior High School and the other one took place at Junior High. As a result, our educational program has been interrupted and the children have been subjected to unnecessary exposure to inclement weather.

It is obvious that the person or persons calling in the bomb scares is determined. There is no other conclusion we can draw. To bring the perpetrator to justice, various steps are being taken by the Administration, Police authorities, and the Telephone Company. As far as your Board is concerned, this is no game that's being played - it is far more serious than that. The perpetrator will receive the full penalty of the law.

Our main responsibility, of course, is seeing that our children get an uninterrupted education. The law requires that a student attend a minimum number of classroom hours. To comply with this means that whatever time is lost as a result of a bomb scare must be made up before the term ends. At the moment, we are considering two possibilities for our secondary students if there is any further disruption of classes. One is to cancel the winter recess scheduled for the week beginning February 10th. The second possibility is to extend the school term beyond the closing date in June. If the bomb scares continue, either or both plans will be put into effect.

It is regrettable that no many must suffer from the pitiful stupidity of a few, but until the problem is solved we have no alternative. In the meantime, we urge the students and the community to consider it their civic duty to come forth with any evidence that may lead to the arrest and conviction of the perpetrators.
