MY SCHOOL PRAYER AMENDMENT would permit recital of a non-compulsory, non-denominational prayer in public places. I've introduced bills on civil rights, for a secret ballot of union members before a strike is called, to improve ethics in government, and to bar unauthorized "backdoor" spending.

Human Rights Studies Housing

On November 4, a meeting open to the general public will discuss a problem now confronting almost all suburban communities. The topic for the evening will be "How Should our Community Face the Law on Housing Discrimination?" The urgency of this issue is underlined by the Metcalf Baker Law, enacted in the New York State Legislature in April, 1963, which bans discrimination in practically all housing. The meeting, sponsored by the Hicksville Committee on Human Rights will be held at 8:30 p.m. at the Holy Trinity Episcopal Church, Old Country Road, & Jerusalem Avenue, Hicksville.

The evening's program will include a movie entitled "All the way Home", which pin-points the problem. A panel discussion of the housing program will follow. The panel will consist of prominent members of the community. Guest panelist for the evening

will be Mr. Farrell Jones, Executive Director of the Long Island Commission on Human Rights for Nassau County. Mr. Jones was formerly regional director of the New York State Commission for Human Rights. In addition to these posts he has an impressive background in social work.

The Hicksville Committee on Human Rights is comprised of a group of local residents, business civic and religious leaders, who are deeply concerned with all matters relative to human rights in the community. The Hicksville Committee on Human Rights is a non-political organization dedicated to aid the cause of civil liberty and the general welfare of all citizens as guaranteed by the laws of our democratic society.

The Hicksville Committee on Human Rights extends an invitation to the public to attend this important discussion program and to join in asking questions or in presenting any individual point of view. Free admission to all.

Regis. Date For Football

If you are between the ages of 10 and 14 and weigh no more than 125 pounds soaking wet, you are eligible to join the Hicksville Football Association's Midget Football Squad, according to an announcement by Milton Prvor, League President. Depending on the turnout, during registration and the amount of parental support that is volunteered, both men and women, it will then determine the number of squads, and age classifications for next season.

This season the league will field one 35 man team only, and participate in about two games depending upon the team's progress, and length of time it takes to develop proper training and physical stamina.

The registration fee will be \$7.50 per applicant which will cover an insurance charge of \$5.00 and a complete physical examination of \$2.50. Boys will be expected to supply their own football shoes,

and supporters. The league will supply everything else. Boys must also sell raffle books, make door to door collections to help defray the tremendous costs of the uniforms, safety equipment, training aids, and transportation costs when they play other towns, and states. If you are not prepared to give this your maximum effort, officers say do not come out as you will be dropped from the squad.

Sisters and classmates will be eligible to join the cheerleader group. Registration is to be held at the Lion's Den at the Mid Island Shopping Center Monday, November 2, at 8 p.m. This will be the only registration this year. The league is open to all boys who attend the Hicksville School districts or have a Hicksville mailing address. A parent must accompany each registrant.

THINKING IT OVER

We see that endorsements have been almost a dime a dozen this year and some have been as vague and inconsistent as could be imagined.

This week we will join with our own endorsements. Each will be followed by a prediction of who will win regardless of our pick.

For County Executive we feel JOHN BURNS is the right choice. Although County Executive Eugene Nickerson has done a fair job, he cannot measure up to the record of John Burns. In his three years as Supervisor of this Township, Burns was a source of despair to Democratic rivals. His record was always clean. He did the right things and there wasn't a chance that any contender could come close to unseating him.

While Mr. Nickerson can point to some accomplishments, which were generally a continuation of programs already underway when he took office, he has made some mistakes in his single term in office and we fear that if he were in office as long as Burns was in Oyster Bay that there would be plenty of ammunition for a challenger to use.

Among the Nickerson mistakes can be included the skeet shooting range in the path of highway construction also the appointment of a new Nassau Police Commissioner when no reason for a replacement other than politics was evident. A short time later the previously well run County Police Force had a scandal from within (not involving the whole department which still is exceptionally good) that rocked the county with convictions of members of the police force for stealing. Also the Milton Lipson appointment which gave a job to a long time political friend who in turn has assumed such personal authority that a short time ago he demanded a patrolman who was writing his regular daily police report to show him the private contents of the book. The request was backed up by threats which smelled of the type of special privilege for politicians that are generally resented by taxpayers.

We have known Burns, seen him under fire, have attempted to put him under fire at times, but still feel strongly that he is the man to be County Executive. Prediction: We believe Nickerson will be re-elected.

In the Contest for the Third Congressional District we see a clearcut choice of STEVEN DEROUNIAN. Mr. Derounian has not made a secret of his ideas. He has stated them openly in easily understood language in newspapers throughout the district. He makes no promises of handouts from the government nor does he say that the government should not aid those who absolutely need it. His opponent Lester Wolff has made some wild assertions and appears to stand for nothing but outdoing the giveaway policies of the most ardent liberals. Wolff also has engaged in the smear approach. If you are against Medicare, implies Wolff, you must be against helping older people who have problems getting medical assistance and if you vote against a half-cooked poverty plan you are against the poor and although Mr. Wolff is against guilt by association as practiced when Senator McCarthy was fighting Communists, he feels that Derounian is guilty of guilt by association with Goldwater because they were associates in California.

Without a doubt STEVEN DEROUNIAN should be returned to Congress. Prediction: Derounian will win.

We don't feel that much urging is required for voters to understand that ED FEHRENBACH is the logical candidate to be returned to the Assembly and that HENRY CURRAN should be back in the State Senate. Both of these men have made impressive records and their challengers have done practically nothing to buck them. Prediction: Both Fehrenbach and Curran will win easily.

Political 'Advance Men'

Whenever the Democratic and Republican candidates for Presidency and Vice-Presidency, on tour, plan to speak in a city, the way is cleared for their hasty appearances by "advance men." Many of these functionaries are political amateurs; others, particularly on the Democratic side, professional politicians. Their task it is to arrange for lodging for the candidates' entourage, to hire the hall, to manage transportation, to inform the press, to marshal local dignitaries and zealots, to establish relations with the police, and to perform a multitude of necessary services.

Many of President Johnson's advance men are Signal Corps officers -- of recent vintage -- with ranks from lieutenant to lieutenant-colonel. Often they pay their bills, I am told, with checks and warrants drawn on the Signal Corps. These gentlemen actually are not true military people at all, but political agents (several being former assistants to Congressmen) abruptly awarded commissions in the Signal Corps. They joke about this sham among themselves: "Did they mail your commission to you yet, Jim? I haven't got mine, so I can't prove I'm an officer and a gentleman." Though they know next to nothing about military communications, they are sufficiently expert in the minor arts of political management.

Isn't this using military funds for partisan purposes? Of course. But if accused of such shenanigans, these Johnson advance men are prepared to declare, with straight faces, that the President needs many Signal Corps officers ready at hand, wherever he goes, for maintaining communications with the Pentagon. And some of the Presidential entourage actually are bona fide communications-experts.

Some odd and arrogant characters are numbered among these advance men. When, recently, Senator Humphrey was to speak in Los Angeles, one of his advance men entered into an altercation (concerning where busses were to be parked) with a policeman. In a fit of temper, the advance man struck the officer. The Humphrey agent was put into a squad car, where he promptly kicked the police driver in the head. Two officers got him to police headquarters, nevertheless -- where, with some reluctance, the authorities decided not to book him, because of his exalted office. What particularly irritated the policemen concerned was the interesting fact that when they examined the advance man's identification, they found he was employed by the Justice Department -- not merely by the Democratic National Committee.

Being unable to draw free help from the armed or civil services, Senator Goldwater and Representative Miller have to depend upon volunteers from business or political associations, mostly. These Republican advance men frequently are distressed by disunity among Republican factions, and the inefficiency of local helpers. They have to manage personally most details of their candidates' appearances, from hiring whole floors of hotels (where the total bill for lodging and food sometimes is \$2,000 a night) to finding tomato juice for Mrs. Goldwater. Mr. Miller's campaign-tour organization is said to be more efficient and more genial, than is Mr. Goldwater's.

Playing John the Baptist to a Presidential aspirant has its jolly moments, however, and these gentry are almost a band of brothers, frequently encountering their opposite numbers of the other party. These scouts of either side complain that party organization -- whether Republican or Democratic -- is wretched on the local level, almost everywhere. Many are their tribulations. But what glory to announce the coming of a secular messiah!

For County Clerk FRANK ANDERSON of Hicksville, should be returned to office. He has been a lifetime resident of this area and is known to many people personally. This is not the reason he should be returned to office. The reason is that he has spent over 20 years in the County Clerk's office as an assistant and later as clerk and he knows the job and gets things done. Countless people from the county who need help with many types of records have sought his aid in the past and will agree that the County Clerk and his staff have been courteous, understanding and at times have gone far beyond the call of duty to be helpful. Prediction: Anderson will win.

At Random

LANGUAGE IN THOUGHT AND ACTION, by S. O. Hayakawa, published by Harcourt, Brace & World, Inc. Inescapable are two questions raised by this book, now used as a tenth-grade text in the Hicksville school system, according to a School Board source:

1. Is the book really a serious study of semantics, the effect of words on people (or, in the author's pretentious lingo, "the study of human interaction through the mechanisms of linguistic communication")? Or

2. Is the book actually a cleverly devised but clumsily disguised instrument for the eradication of racial, religious, and other prejudices from the minds of school children?

If it is the former, though it is worlds away from being a comprehensive study on the subject, it is at least a passable one.

If, on the other hand, it is the latter (and I, for one, think it precisely that), then the author should have honestly said in his foreword that one of the main purposes of this text is to make preachments against racial, religious, and other prejudices.

Should I say, "let's be honest and call this book what it is, not what you say

it is," the author might think I were being as semantically clever as he himself is. But in a world in which sugar-coated words mask truth in naked form lest it shock its beholders speechless, I still prefer homely, "sinful" spade-is-a-spade frankness to the forms of intellectual dishonesty one describes in the world of the educator today.

Witness these quotes from this book to show plainly and exactly what I am talking about:

Page 206: "7. Some Jewish merchants in the Negro community unfairly exploit their Negro customers."

Page 207: "18. Negroes are rarely very intelligent."

Page 203: "The prejudices on the part of Negroes against Jews represents the ultimate confusion resulting from such socioeconomic facts as have been mentioned. In New York, Detroit, and Chicago, many shops in Negro neighborhoods are owned by Jews, Negro neighborhoods being marginal business areas and Jews being often in marginal business..."

Page 53: Write an essay, says the author, on such subjects as "The National Association of Manufacturers: a Threat to Democracy."

Write several hundred words, he says, on these subjects: "Harry Thompson

visited Russia in 1935"; "Kox Davis is a millionaire"; "Betty Armstrong does not believe in God."

Noteworthy, when the author talks about the "godlike impartiality of one's thinking and writing," he unwittingly underscores the semantically poles-apart difference between the words: "godlike" and "God-like."

One gets some good clues as to the "why" of the author's viewpoint expressed in this objective-subjective study of the use of semantics. Further, one can readily discern how a book masquerading as one thing can very effectively be used for quite another: the propagation of the author's own peculiar sociological notions or ideological beliefs.

For four years the author was a columnist for the Chicago 'Defender', a Negro weekly. Hence, presumably, the emphasis on the plight of the Negro in a book concerned with the study of English. Beyond that, Hayakawa says he is indebted to the "writings of numerous psychologists and psychiatrists with one or another of the dynamic points of view which stem from Sigmund Freud." On ingesting this semantic mouthful, one remembers that Fred's obsession with sex has produced the school of "undercover" psychologists responsible for the use of psychological sex tests on public school children without the knowledge and consent of parents.

The chapter on slanting is especially interesting since the author himself engages in the game rather skillfully.

Of course, the recent race riots in which stores owned by Jews were ransacked or looted by Negroes give credence to the author's statements about the prejudice of Negroes against Jews. There's nothing surprising about it, however. For some years ago a policeman told me that if I wanted evidence of the exploitation of Negro labor by Jewish businessmen, all I would have to do is watch the latter hiring Negroes on Freeport streets of a Monday morning at less than the minimum hourly wage.

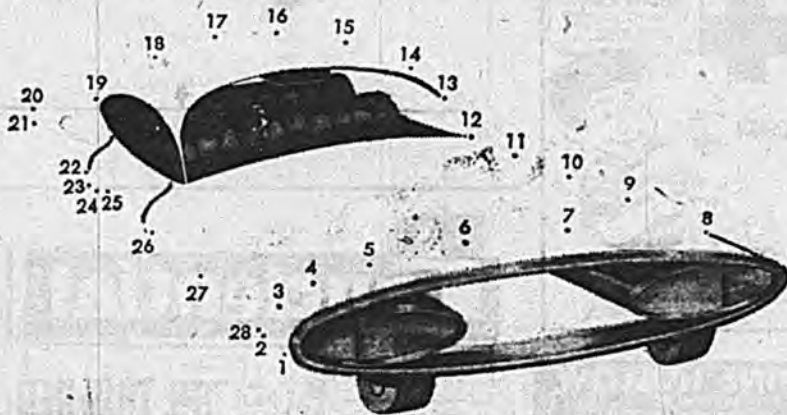
No one is saying the prejudices don't exist. Nor is anyone saying the Negro isn't being and hasn't been exploited with appalling frequency.

But what is a book more concerned with sociology than it is with English doing in a high school English class?

The parents of Hicksville school children should take the time and trouble to read this book and assess it for themselves. I think it is a semantically clever study in how a study in semantics can be artfully used for another unstated purpose.

And, trite though the statement may be, I still prefer to call a spade a spade and a book on sociology a book on sociology, no matter how semantically clever the author or publisher may be.

The Notebook

By Robert L. Morgan

In addition to voting on candidates, voters this year will be asked to express approval or disapproval of two state constitutional amendments and one proposition. Very little is known by the average voter concerning these questions. We have studied all three and find that only Amendment Two is worth passing. It simply eliminates excess verblage from the constitution. The opposition to the other two questions is summed up in the following reprint from a Taxpayer's Committee report sent to us recently. This clearly states the opposition:

AMENDMENT NO. 1

This would change the state constitution so that politicians could play Santa Claus with your money for people with incomes higher than you earn.

The taxes on your home or the rent you pay would be increased to pay part of the rent of people with higher incomes in more expensive apartments than most people can afford for themselves. This hurts you because the State would not help everyone earning the same income. It would help a selected few. You and all others with the same or less income would be taxed to pay for it.

PROPOSITION NO. 1

This is a tricky little number with more curves than a baseball pitcher can put on a screw-ball pitch! It asks you to approve part of Chapter 272 - the Law that puts into effect exactly the same proposal which the voters of this State overwhelmingly voted down in 1962. Did you mean it when you said NO the first time?

Unless you vote NO this time, the State will borrow another \$165,000,000 to build more government-owned apartment houses. The apartments will be rented at below-cost rents and the State will give away another \$7,500,000 a year of your tax money to make up the difference.





Don't let anyone kid you about where all this money comes from. It comes from you. Whether you are a renter or an owner of taxpaying property, you are paying more for your home so that other people can pay less for theirs under these government housing programs.

You pay in two ways. You pay in your state taxes and you pay in property taxes on the house you own or rent. That is true for two reasons:

1. The cash that the State gives away to subsidize government housing must be collected by

the State through the state taxes that you pay.
 2. The exemption from local taxes that the government-owned housing does not pay must be made up by additional taxes on the homes and other taxpaying property that you own or rent.
 Under present law, the State can give away \$42,050,000 cash of your tax money every year for housing subsidies. Proposition No. 1 would increase that give-away to \$49,550,000 a year. Since the law requires an equal amount of exemption from property taxes for local governments and schools, the total that you would have to help pay is \$99,100,000 a year.
 Half your higher housing costs by voting NO!

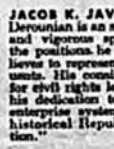

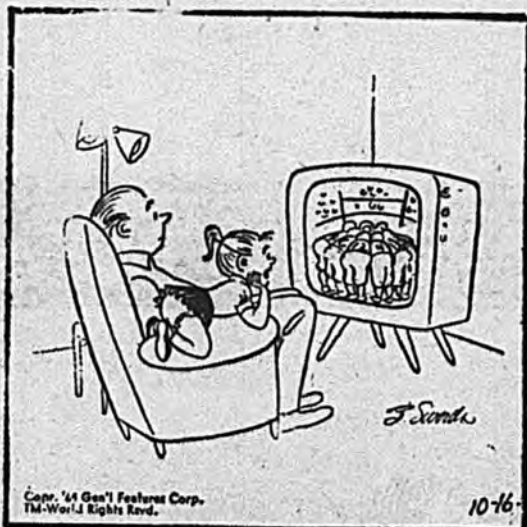
