Budget Up \$ Million In School District

The Hicksville school budget will be over one million dollars higher this year than last year, it was revealed this week by the Hicksville School Board.

The budget was presented to the district residents in a brochure prepared by the school board. The total budget would be \$12,462,408.00. Although there will necessarily be an increase in school district taxes this year again, the school board did not go on record as stating what the increase would be since the state legislature has not as yet enacted some proposed legislation which could give additional revenue. The increased figured

percentage wise was figured at about nine percent.

There will be a hearing on the budget on April 23 at 8:15 p.m. in the senior high school. Residents of the district can vote on the budget on Wednesday, May 5, if they are registered to vote in the school district special elections. Persons who voted in last years election and registered at that time are eligible to vote on May 5. Unregistered voters can become eligible by registering on Saturday, April 24 or Wednesday, April 28 at the school building in their area.

School Board Attorney Catalano stated that the T.V. cameras had not taken any film of the meeting. School Board President Kunz read as follows from "The Hicksville Citizens League Bulletin" a portion of the evening was televised, and the film is expected to become part of a doc-

umentary of the Long Island School system. Attorney Catalano further explained that the cameramen were busy interviewing individuals, many who came from outside of the district. 3. The school board publicly directed Attorney Catalano to file stiff protest with A.B.C.'s legal department. (The public was informed that the cameramen simply pushed their way in ... Through locked doors? Where did they get their electricity? ... Or did they bring

their own generators?) Throughout Mr. Catalano's explanation the school board and Mr. Abt remained silent. Never once did the school board make an attempt to establish its role as a positive force.

Two Launch Board Campaign

(Submitted for the candidates)

At a meeting held at the home of Leon Silver, 77 Thimble Lane, Hicksville, James E. Anderson and T.E.A.C.H. Coalition candidates for the office of School Board Trustee, Hicksville School District, launched their campaign with the announcement of a platform that promises to restore dignity and efficiency to School Board Meetings.... In a joint statement the Coalition Candidates stated "The American public school system, its staff and students, must remain forever free from political forces which would use education as a means to self-serving political ends.

The platform further called for: "Improvement of school - community relations through the development of effective and regular channels of communication among all participants: administration, faculty, parents and school trustees.

Continuing and expanding use of citizens advisory committees composed of qualified residents to assist the school trustees in the gathering and transmission of research information and community opinion.

Strengthening our present program in the vital area of vocational and technical education by actively seeking non-district facilities and by adding to our staff guidance counselors specifically trained in this field.

Practical solutions for easing the school tax burdens on local prop-

erty owners through support of such measures as the Education Conference Board Bill (Bronston Kottler Bill).

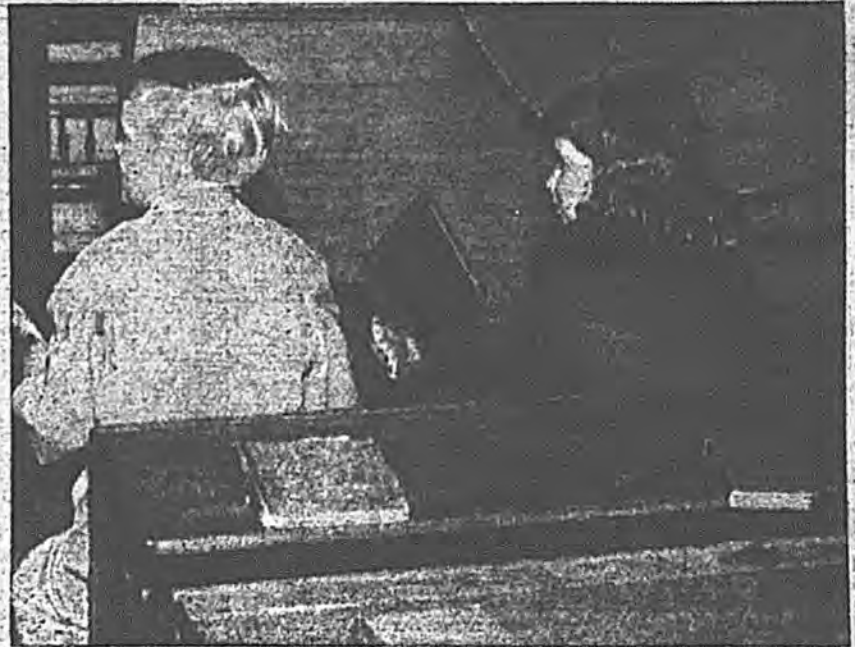
A continued professional evaluation of our track curriculum by a qualified educational agency for the purpose of determining the future course of our educational program.

Support of the school and library budgets to insure the continued progress of the inseparable partners in good education for our children.

To promote the right of the School District professional staff to pursue their duties without fear or prejudices within the framework of the policy of the Board of Education and the laws of the State and Nation.

Both Mr. Anderson and Mr. Goldberg then appealed to all citizens of Hicksville for their support in this campaign. In their joint statement, the candidates defined extremism in education as a restriction upon our children's opportunity for freedom of thought; that extremism whether it be ultra left or ultra right leads to censorship and undue pressures upon our entire system of education.

Passover Starts At Sundown

This Friday at sundown, Jewish community, together with Jews the world over, will usher in the festival of Passover, commemorating the exodus from Egypt over 3500 years ago. Passover marks the emergence of the people of Israel from slavery into freedom, and their birth as a free nation. The holiday is observed for 8 days by Orthodox and Conservative Jews, and for 7 days by Reform Jews.

During the entire week, the Jew is commanded to abstain from "Chametx, from eating any bread or bread products, and to eat "Matzoh, unleavened bread, as a reminder of the haste with which his ancestors left the land of Egypt. Perhaps the most colorful part of the Passover observances is the Seder Service on the first two nights of the holiday. The family gathers around the traditional holiday table and retells the wonderful story of the Exodus as detailed in the "Haggadah, the Seder service book. This is followed by the festival holiday meal.

The Bethpage Jewish Community Center will usher in the holiday with services each evening and morning. Services on Friday evening, April 16, will begin at 6:45 p.m. on Saturday and Sunday, April 17 and 18, morning services will be held at 9 a.m. Junior Congregation Services at 10 A.M. and evening services will begin at 6:30 P.M.

Too Much Thyroid Causes Nervousness, Weight Loss

(Q) Some time ago you wrote on the danger of taking too much thyroid medicine, but I can't remember exactly what they were. Could too much thyroid cause the loss of hair, change in the fingernails and skin? Mrs. F. M.W.

(A) Too much thyroid causes nervousness, insomnia, tremor of the hands and a weight loss in spite of a good appetite. The signs you mentioned could occur with either too little or too much or they may have nothing to do with your thyroid problem.

(Q) "Can you tell me about rheumatic heart disease and whether it can be cured without an operation? Is a normal life possible? Mrs. M. K.

(A) Rheumatic fever is an infectious disease involving the muscles, joints and heart. It is not contagious. The exact cause is unknown except for the fact it usually

follows an infection caused by a certain streptococcus germ (strep throat or scarlet fever). Thus it is always important to get early and adequate treatment for "strep" infections.

In many cases a first attack of rheumatic fever does not incur any significant heart disease. The heart may be involved during the acute illness but it seems to heal without any damage. If a second attack occurs there is much more of a chance for permanent heart trouble. Thus, if any person has had one attack of rheumatic fever, he should take medications to cut down on future "strep" infections which might be followed by a second attack.

Once the heart has been damaged by rheumatic fever, surgery can give excellent results, whereas a few years ago no definite treatment was available. A relatively normal life is possible for most victims.

The Fruits Of 'Neutralization'

Nearly everybody in Washington believes that the Johnson Administration means to cash in its chips in Southeast Asia. Although the forces of South Vietnam have been more successful, during the past several weeks, against the Viet Cong guerrillas than ever they were before, many people in the American state and defense departments, and some influential senators, think the game no longer worth the candle.

The ravens are gathering -- if one may mix metaphors. The latest South Vietnam government detests Ambassador Taylor, suspecting that he and his principals mean to abandon their country through "neutralization", perhaps in agreement with Russia. Cambodia, wanting to be in at the death, openly declares her intention of attacking South Vietnam's frontier, ignoring the United Nations. In Laos, General Phoumi Nosavan's attempt at a military coup probably was a last desperate effort to seize the reins of power and oppose the Pathet Lao Communists before the United States withdraws from Southeast Asia.

If American troops and aid are soon withdrawn from the whole region, doubtless the face-saving device of "neutralization" will be employed. South Vietnam, in effect abandoned to the tender mercies of the Viet Cong and North Vietnam and Red China, will pass into the hands of a "neutral" regime -- for a little while. Laos will be wholly overrun by the Communists. Cambodia will fall altogether within the empire of Asiatic Communism; it is doubtful whether Burma can retain even a slight degree of independence, or whether Thailand and Malaysia can hold out long. India will stand in peril.

It should be emphasized now that the fatal American error was made four years ago, when President Kennedy "neutralized" Laos. That folly gave control of more than half of Laos to the Pathet Lao forces, fully opening the Ho Chi Minh Trail to unimpeded passages of arms and guerrillas into South Vietnam. Thus the South Vietnam government and its American allies had to fight a losing battle, like the French earlier, against guerrillas supplied continually from a privileged sanctuary.

The Communist powers -- North Vietnam, China, and Russia -- agree to "neutralization" only in mockery. They are justly confident that no "neutral" regime, deprived of American assistance, can find the will or the resources to stand against the "armed doctrine" of Communism. In a matter of months, probably, the Communist conquest of the "neutralized" territories would be complete -- to be followed by a massacre, in accustomed Chinese style, of all "reactionary elements," the folk who had trusted in the promises and the might of the United States.

It still may be possible to escape this catastrophe by decisive action. The Ho Chi Minh Trail might still be blocked by a defensive line running from the Thailand border through the narrow middle of Laos to the coast of Vietnam. But it would be necessary to employ, coherently, the armed forces of Thailand, a de-neutralized Laos, South Vietnam, perhaps Formosa, and whatever other support might be scraped up. This, Washington fears, might mean "escalation" of the struggle in Southeast Asia; and "escalation" is a word terrifying to the timid.

The alternative is the abandonment of allies and an enormous gain for the Communist powers. But Washington's cocktail parties will continue undisturbed -- for a time.

School Board Attorney Catalano explained, that both Mr. Kunz and Supt. Abt were uneasy as to the legality of such an action, and had instructed Attorney Catalano to seek a directive from the State Department of Education.

Attorney Catalano further explained, that Mr. Hahewe, of the State Department of Education's Legal Division, had commented as follows: 1. The pamphlet was not a proper expenditure for the Hicksville Board of Education to consider. 2. If such literature had been distributed with taxpayers dollars the school board would have been open to a taxpayers law suit. 3. The "Extremist pamphlet is too controversial, and can only create dissention. (Very clever of our T.E.A.C.H. affiliated P.T.A. officer to engineer such a distasteful campaign.) 4. The school board "must remain neutral in such situations. (I wonder how the State Department of Education will react to the information that the P.T.A., in violation of the New York State Educational Laws, is sponsoring School Board Candidate Anderson, and that School Board Trustee Johnson heads the United Group coalition?)

In truth, the pamphlet has created a hostile atmosphere in the community. The P.T.A. has allowed itself to become a willing dupe of T.E.A.C.H.

Thank goodness, we are privileged to have intelligent lawmakers safeguarding our educational system.

Bus Running To World's Fair

The Schenck Transportation Co. of Floral Park will resume bus service to the Worlds Fair along three major lines that carried over 150,000 passengers to the Fair during its first year of operation, according to Howard E. Schenck, President. Service will commence April 21, and continue on through closing day in October.

"Based on our experience with the first year of the Fair, we've made some adjustments in the schedule to fit public demands," said Schenck. Buses to the Fair will start to run on each of the main routes between 8:15 and 8:30 daily, serving those who work at the Fair, in addition to early bird visitors. Service continues on through the day with return service starting about midday and continuing on till shortly before midnight.

Schenck's Worlds Fair Bus service was the subject of an intensive survey last year, when the company retained a special group to interview riders on their reac-

tion to the Fair bus service. Responses indicated that riders were generally very satisfied, and that people from many parts of Nassau and Suffolk had taken advantage of the bus service in order to avoid traffic into the Fair and consequent parking problems and expense at the Fair. When the Schenck coaches arrive at the Fair they are able to let passengers off right at a convenient Fair Gate. In the course of the survey, Schenck also found that many out-of-town visitors were riding the bus into the Worlds Fair. Officials speculate that many of these people were staying with relatives in nearby communities, while others were at motels along the route.

The three main departure points are from Glen Cove, from Roosevelt Field and from Hicksville into the Fair. The Glen Cove Worlds Fair route begins at City Hall in Glen Cove proceeding along Glen Avenue to Northern Boulevard and on to the Fair with a stop at the Main Street subway station in Flushing. The Roosevelt Field Worlds Fair route commences at Roosevelt Field, west along Old Country Road to Mineola Boulevard, north to Hillside

Avenue. The route then goes north on Lakeville Road to the Long Island Expressway and direct to the Worlds Fair.

The Hicksville Worlds Fair service commences at the Mid Island Shopping Plaza in Hicksville north along Broadway with limited stops along the Long Island Expressway service road. Special pick-ups are arranged at several of the motels along the route.

Speno Speaks To Education Group

State Senator Edward J. Speno of East Meadow will speak in Hicksville on April 19, at the first annual Freedom in Education Day, a unique project sponsored by Citizens for Educational Freedom (CEF). He will appear together with Judge Francis J. Donovan of Hicksville, judge of the Nassau County District Court, and Jeremiah D. Buckley of Massapequa, executive director of CEF, at the evening session of this precedent-setting event. Senator Speno's address will climax a day-long program devoted to enlightening the public on the fundamental importance of protecting the basic right

of parents to choose their children's education.

School representatives from each of the three major faiths, Jewish, Protestant and Catholic, will be present together with representatives of CEF from 12:00 noon to 10:00 P.M. in separate booths at St. Ignatius Loyola School Hall, periodically giving talks to the visiting public and standing ready to answer specific questions and dispense literature.

The basic element of the program will be a two-hour presentation (further divided into four half-hour units shared respectively by each of the participating groups) in which the participants will show the contribution their schools are making to the community; the type of citizen they are forming; the money they are saving other taxpayers; and the small amount they are receiving in return for support of their efforts.


This two hour presentation will be given two times during the day (2 p.m. and 7 p.m.) to allow maximum exposure of this critical issue to all members of families, societies and educational groups wishing to attend. According to Daniel Sullivan, President of the Nassau - Suffolk Chapter of CEF, "CEF is a fast growing, grass roots, national organization of parents and others dedicated to the cause of securing freedom in education. It is a non-sectarian, non-partisan, and non-profit. At present the national membership is over 150,000 and we hope to at least double it this year.

Invitations to attend have been sent to all non-public schools of all denominations, as well as to various civic and parent groups throughout New York State in a sustained effort to arouse public support and sympathy for non-public schools.

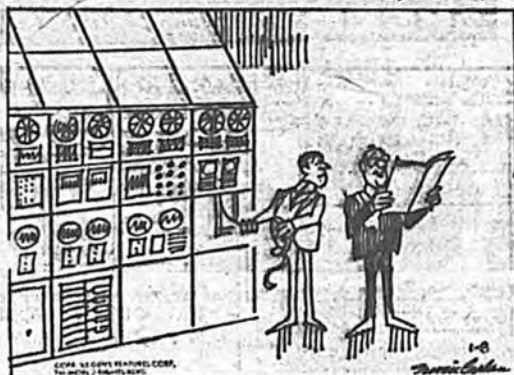

Personnel Comm. Rejects Board

The Bethpage District Personnel Committee voted to reject the Board of Educations proposed salary schedule. In spite of this rejection the Board adopted its budget with no revision. The proposed increases raise the first years teachers salary \$200.00 and the most experienced teachers \$100. The Board, however, estimates an increase of over \$300,000 in state aid under the anticipated revision of the state aid formula.

According to the Committee the board in its newspaper release stated that the \$330,120 increase in the total budget is due to teachers salary, instructional services plus \$105,000 in teacher retirement benefits. From the information furnished by the Board to the Personnel Committee, the cost of increases for teachers amounted to only \$300,051. This figure includes 12 additional teachers, the existing schedules step increment, retire-

ment, social security, and health insurance costs. Only \$42,000 of this amount is labeled for salary increases.

In addition to the above, the committee said, the Boards statement indicates an increase of \$105,000 in teacher retirement benefits contributed to the budget increase. The 3 percent reduction in the Boards retirement costs made by the State Retirement Assessment Board is not accurately reflected in this \$105,000 increase in retirement benefits. The District

Personnel Committee feels that of this discrepancy in budgeted figures gives the impression to the increase in the budget is caused exclusively by teacher considerations.
