## You Can Be A Flight Stewardess

For the first time, Eastern Air Lines will recruit flight attendants in Hicksville and local residents need not go into Manhattan for a personal interview.

Eastern is setting up a booth at the Mid-Island Shopping Center, right outside of the Gertz store, Wednesday, April 28, through Saturday, May 1. It will be staffed daily from 3 to 7 p.m. and on Saturday from noon to 3 p.m.

Girls who are accepted will be flown to Miami for the five week, all-expense training course. There they are trained in everything from the care and attention of passengers to personal grooming and will be based at one of seven Eastern cities and, after the probationary period, be eligible for generous travel privileges.

Applicants must be 5'2" through 5'8" in height and weigh 105 through 135 pounds, in proportion to that height. They must have at

least 20-40 vision, although contact lens wearers are eligible.

Prospective stewardesses must be at least 20 years old, although girls 19½ may apply now for future classes. They must be single. Widows and divorcees without children are considered.

Above all, an Eastern Air Lines stewardess must be neat, attractive and really enjoy meeting and serving people.

## Safety Law By Fehrenbach

A bill sponsored by Assemblyman Edwin J. Fehrenbach, Republican of Bethpage, was passed today.

This measure amends section 513 of the Vehicle and Traffic Law, and would provide that upon the conviction of any person under 18 years of age who resides with his parents or guardian, the trial court or clerk shall notify such parent or guardian of the conviction.

Mr. Fehrenbach said, "The passage of this bill would apprise a parent of the fact that their children were operating the family vehicle in violation of law and would afford the man opportunity to take disciplinary measures against the teenager."

Under the existing law there is no provision for notification to the parent of traffic violations incurred by their offspring.

## Two More Run For School Bd.

Two more candidates have declared their intentions to run for the Hicksville School Board. The two are Mrs. Florence Infantino who is running for the seat presently occupied by George W. 'Esau sold his birthright for a mess of porridge. Hicksville is being asked in the coming May 5th school board elections to sell its right to have individuals elected as members of its School Board, who will serve without tarnish or without questionable alliances.

Two individuals, have previous to this publication, announced their candidacy for the office of member of the Hicksville Board of Education. These individuals are party to what I feel is an unwholy alliance. This alliance is the result of the formation of a coalition. The parties to the coalition have per-

mitted the good name of the Parent - Teachers Association to be used as an endorsement of them selves by the P.T.A. movement in Hicksville.

The P.T.A., as a State-wide and country - wide idea and concept, is based upon the theory that local individual school organizations of parents of students within the schools can be a helpful adjunct to the educational process. Without being nameless, faceless or characterless, they must be impartial and neutral because the children of diverse, opinionated parents cannot be made the individual scapegoats or victims of their parents venom or partisanship. They are organized to promote education and interest in the local school systems. These local groups, sometimes join as a federation, as in Hicksville, where there are a number of schools, have, as a cardinal and inviolate principle of operation, the non - engagement in political activities of any kind. This is so whether the activity be on political party level, or for the promotion of candidates for any office, including that of School Bd. Trustee.

Anyone who violates this tenet of restraint and the requirement for impartial behavior, saps the very foundation of a sound school administration. The violation betrays the impartial cooperation intended to be the very basis for P.T.A. support for Educational progress and the advancement of education itself.

All P.T.A.s including those within the Hicksville Community, and the Hicksville P.T.A. council are subject to, and are supposed to adhere to the doctrine of impartiality and non-political involvement.

The P.T.A. manual states: Article III - Basic Policies

Sec. 2. The P.T.A. - "I shall not endorse a commercial enterprise or a candidate."

Sec. 3. "The association shall not, directly or indirectly, participate or intervene in any way, including the publishing or distributing of statements in any political campaign on behalf of or in opposition to, any candidate for public office."

This is the basic law which governs all P.T.A.s. It is the Bible which establishes their rules of conduct. It is the cornerstone for propriety and behavior of all members, in spirit and action.

In this coming election our

Hicksville School District Voters are being asked by the coalition made up of the T.E.A.C.H. group and a group especially formed for his election, calling itself the United Group, to vote for their jointly and bargained endorsed candidates. The United Group is the special formation of partisan individuals made up of some P.

T.A. groups within the community. This is a flagrant violation of the spirit of P. T. A. impartiality. A P.T.A. Member (named signed but withheld )

# Two Candidates Comment On Budget

Statement prepared for candidates  
A joint statement concerning the 1965-66 Proposed School Budget for Hicksville was released today by James E. Anderson and Marvin Goldberg, the UNITED - T.E.A. C.H. Coalition Candidates for the Office of School Board Trustee. It reads:

"As Hicksville residents and parents of children attending its public school system, we wish to commend those members of the School Board and the Administration for the time and effort they have spent in compiling a proposed budget for the coming school year. It is evident that they have utilized their knowledge and experience to the best possible advantage in order to keep the cost of operating our schools at a realistic minimum.

"The Proposed 1965 - 66 School Budget is \$12,462,408.00, an increase over last years budget of \$1,027,537.00, or approximately 9 percent. The major portion of the increase consists of compulsory obligations which constitute expenditures mandated by State Law, particularly in the areas of salaries, employee benefits, and building improvements required to comply with new State regulations on fire safety. These State mandated expenditures exceed 60 percent of the total proposed increase. In addition, there are fixed charges, such as interest on indebtedness, which are incurred annually in the normal operation of a school system. The remainder of the proposed budget increase includes sums allocated for expanded school services, such as transportation, public relations, and additional services for handicapped children.

"One particular item which we heartily endorse is the appropriation allocated for curriculum evaluation by an outside educational agency. This evaluation will include an analysis of the track system which is presently being utilized in the Hicksville School System. Since its initiation nearly 8 years ago, its merits have not been appraised objectively and we believe that a complete review should be made now and periodically by an outside educational agency to determine its educational worth.

"We urge all taxpayers to vote "yes" for the proposed school Budget. A defeated budget would make it necessary for the School District to operate under an austerity budget. Some of the facilities, services and equipment which would be drastically affected by such a budget are:

## Ext. Service Monthly Meeting

Bethpage Unit, Nassau County Extension Service, monthly meeting, Wednesday, May 5th, 8 p.m. at John F. Kennedy Junior High School, Bethpage. Program for the evening will be a Penny Sale. Refreshments will be served after the meeting.

**Text-Books:** No books can be provided free to pupils if there are not enough old books for all students. No new library books, supplementary books or enrichment materials can be purchased.

**Cafeterias:** Cafeterias will close. Funds needed to operate them must be provided by a separate Referendum. The District would lose the Government subsidy per lunch or any free foods. Lunches must, therefore, be provided by parents.

**Transportation:** Bus transportation will be limited. Kindergarten to Eighth Grade, in both public and parochial schools within the area will not be provided unless students live beyond a 2 mile radius of the school. From Ninth to Twelfth Grade, bus service will be provided only to students beyond a 3 mile radius of the school. Transportation to parochial or private schools outside the Hicksville limits would be provided for only 10 miles instead of the 22 mile now in effect.

**School supplies:** Instructional supplies, such as maps, paper, visual aids, etc., must be furnished to teachers. However, paper and other supplies are not furnished to students for assignments and other work. Every student supplies his own. A high school student in science or other special subjects must pay for all his own supplies.

"In addition, school facilities may not be used by organizations other than the P.T.A. Inter-school athletic programs would be eliminated.

"It must be apparent to everyone that the ones who would suffer most under an austerity budget are the children.

"Although we urge a "Yes vote on the proposed budget, we cannot help but note the tendency in

## THINKING IT OVER

Too often our English language is divided up into good words and bad words. In the past election we saw words like "extremist" become bad and "moderates" become good although the usage of both words was most unusual.

A current bad word which is growing in badness is the word automation. I have just returned from a newspaper convention in N. Y. where this word was used in all of its ominous connotations. Yet at that very convention were many who have greatly benefitted by automation as a saving force for newspapers.

There is always an emphasis on how many people will be replaced by a machine but the horizon seems to end in panic at that point instead of exploring how the automation could make more jobs for more people.

In the newspaper business (and the actual publishing end of it is a business) automation has made it possible to employ more people.

It has taken jobs from slow craftsmen and automated them so that more pages could be printed and more copies distributed. The fact is that in the face of competition from TV and radio the newspapers of the country would have been lost had automation not eliminated the slow drudgery work and increased the size of the product. So what we have today is a newspaper industry in tact and TV and radio also in tact employing thousands more than ever before.

In the field of community newspapers the introduction of automatic typesetting equipment, automatic engraving equipment and even photo offset techniques have made it possible for local newspapers to exist and grow. As more automation enters the field there will be more community type newspapers and more people working on them.

Automation is not always the bad guy - it's half and half. But we fear automation will be branded bad and that will be that.

## Teenage Diets Lead To Rundown Health

**MEDITORIAL:** With an increasingly large number of teenage marriages, we are developing a large group of families who eat poorly, not in amounts but in kinds of foods.

It all begins with the teenage girl and her desire to be slim. It's not all her fault, mind you, for the boys are often more impressed with looks than with intelligence. The teenage girl I'm referring to is the one who eats on the run. When she does eat, her meals consist of snacks (buns, sodas, donuts, pizzas, candy, french fries, etc.) Her main meal at home with a family usually results in the vegetables or salad being left on the plate while a dessert is eagerly consumed. As she puts on a few pounds, no-calorie drinks come into practice and the well-balanced diet is still neglected.

All of a sudden the teenager is a bride and a year or two later a mother. Now we have her, a husband and a child all

eating the same way. Pacifiers are "out" for kids and sticky buns are "in". The farmers should take to baking pastries instead of growing vegetables and we would have the farm problem solved.

The answer is simple - proper instruction in dietary habits early in childhood. If children develop good eating habits when they are young, they will keep them all through life. The rewards are many - fewer colds, increased strength and durability, better complexions and stronger teeth. (Q) "What causes thickening of the large toenails? ## As We Go Marching

To this commentators surprise and pleasure, 300 enthusiasts for the ballot actually managed to walk all the way from Selma to Montgomery - albeit by short stages. True, footsore Dr. King took time out to fly to Cleveland for a speech; but some zealots tramped all the way, including a one-legged gentleman from my native Michigan.

I'm all for more marches and fewer sit-in demonstrations. As the old lady remarks in the play "Harvey" (apropos of psychiatrists), "Those people ought to take long walks in the open air. Temper cool somewhat in the countryside, and, ones sincerity is put to the proof."

Had Alabama authorities been far-sighted enough to permit that march without a federal court order, this whole fracas wouldnt have been stirred up, and we all might have been spared an ex-

treme and mostly unconstitutional "voter registration bill. For goodness sake, besides, let any Americans walk that still are sufficiently energetic. The nations calf-muscles are atrophied.

We nearly lost the Korean War because most of our soldiers, jeep bound and unable to pursue guerillas in the hills, were sitting ducks. Even our farm children are made sedentary by rural school busing.

If any civil-rights zealots were willing to tramp all the way back from Montgomery to Selma, I'd be tempted to award them "two votes: if they accomplish the feat in one day, anyway. Though this commentary never has walked 50 miles in a single day, he has done 40 more than once; so the feat scarcely is inconceivable.

And if we are to abolish literacy tests, perhaps pedestrianism would be a tolerable substitute for voter-qualification. We no longer care what sort of heads voters possess, but theres much

to be said for a good pair of feet. Perhaps Democrats and Republicans could engage in marching competitions; indeed, we might abolish the ballot box altogether, relying upon the ordeal of political walking as a trial of civic virtue.

This patriotic device might revive the old torchlight political parade, complete with brass band. How splendid!!! Its a real opportunity for the "Give It Back pacifists who urge us to flee from Southeast Asia. They might chant this forgotten refrain:

"I'm not at all frightened, you quite understand,  
"But if I am going to fight for my land,  
"I mean to be ready to play in the band,  
"Boom tiddley boom!!!

Like the little man who bought himself a jolly big drum, the "peace through flight demonstrators might endear themselves to the public by low comedy. Few will come to love them otherwise.

During the last campaign, Mr. Lester Wolff, candidate for Congress, denounced "extremism and indicated he was for a determined guarantee of human rights to all. These words were most eloquent, but what happened when it came time for Congressman Wolff to put these words into action?

Recently, the House Committee on Un-American Activities sent Committee investigators to the South to gather facts about the notorious Ku Klux Klan, as a basis for a later probe of Klan

activities. As this preliminary study was in progress, Congressman Wolff rose in the House of Representatives to denounce what he called the Committees "egregious (flagrant) infringement of the guaranteed rights of Americans. After attacking the Committee he made his attempt to scrap the Committees budget by voting to withhold all funds from the Committee pending the outcome of "public hearings at some unspecified future date (never?)"

Fortunately for the American people, 333 Members of the House, Democrats and Republicans alike, opposed the position taken by Congressman Wolff. If he had succeeded in his effort, the Comm-

unist and the Klan would have benefitted. No money - no Committee - no investigations.

After his attempt to scrap the Committees budget was defeated by fellow House Members, he then switched his position and consented to the release of Commit operating funds. This was indeed a fancy attempt to confuse the people.

### Juvenile Movie Star, Or— WHATEVER HAPPENED TO LEE STANLEY

**NINE YEARS AGO**, Uniondale's Lee Stanley, then 19, and scheduled for the star role in "The Blackboard Jungle" accidentally drifted in a rowboat over a waterfall, and wound up in a hospital for six months, much of the time in a coma. ### Junketing Journalists

By PAUL HARVEY

Arkansas' Senator Fulbright is not always right but he's not always wrong, either. He said he thinks the gentlemen of the press have been a little hypocritical in their criticism of junketing congressmen while they, the reporters, are so often willing to accept free trips to sporting events, resorts and nightclub launchings.

Recently movie producer, Stanley Kramer, brought 250 reporters to Hollywood, all expenses paid, for a four-day-whing-ding. The last day of which was a preview of his new picture. Transportation, food, liquor, all paid for by the movie maker.

Naturally, producer Kramer's picture got a lot of free press coverage as a result.

Was it "objective" coverage? Or was there a conflict of interests which might have caused the junketing journalists to favor their generous host?

Senator Fulbright does not challenge the integrity of the movie critics. What

he does say -- and it's time somebody should say this -- is that the reporter has the same obligations to the public that the congressman has: honesty, integrity. And he believes that the profession of journalism should take a good look at its own junketing.

I am inclined to agree with the premise but to dispute the comparison.

The junketing congressman most subject to criticism is having his fling on taxpayers' money. And lots of these trips which purport to be "investigations" are "flings."

Too often, your public servant is goofing off and sending you the bill.

So in order properly to appraise each practice, let's first understand that they are not the same thing.

Scarcely a day goes by but what my own office receives an invitation for me to accept some such gratuity. Anything from a free cocktail to a free trip to the Middle East. In between there are free airplane rides, offers to ski or shoot skeet, to play golf at some or - another resort which doubtless expects public mention.

I don't go unless I pay my own way. When I am invited anywhere on a speaking engagement each host organization pays the same fee as any other. That covers the considerable costs of moving my microphones around the country. If there is nothing of interest there, I don't mention being there. I visit very many cities which I do not mention. But, as I say, every day there are invitations.

It has been standard-operating procedure for as long as I can remember for the members of the press corps to be offered free tickets to sporting events, theatre openings, ship launchings, inaugural flights and the like.

I would not presume to suggest how others should handle these offers of "something for nothing" which are usually intended to net "something for something."

But Senator Fulbright's having raised the question, maybe all "hitchhikers" should re-examine the practice.

If we are to avoid even "the appearance of evil," then the junket at somebody else's expense is as unwise for representatives of the free press as it is for public officials.
