Memorial Day, which is on a Sunday this year, will be observed as a legal holiday on Monday, May 31st, in the Hicksville Post Office and its branches, according to Acting Postmaster Irene L. Murphy.

There will be no delivery service on that day except for Special Delivery. There will be no window service provided in the Main Post Office or any of its branches.

New Golf Course To Be In Plainview

Boys Choruses Present Concert

Councilman Edmund A. Ocker today proposed the 101 acre Shattuck estate on Washington Ave. in Plainview for development as a regular 18-hole golf course for Town residents.

Councilman Ocker's proposal included the recommendation that a feasibility study of the proposal be made by the Board's Development and Action Planning Commission. If the Board approves the idea Mr. Ocker will present his proposal to the Planning Commission this evening (May 18) at their regular meeting.

Cost of acquisition and development of the land is estimated at approximately \$2 million. The site, formerly the home of the late Frank Shattuck, principal in Schrafft's, has a large colonial-type mansion on it which could be used as a clubhouse.

Councilman Ocker pointed out that additional vacant land contiguous to the estate is available should it be needed to construct the golf course. "If the feasibility study shows that more acreage is necessary to conform the property to a regulation golf course I will recommend that it be purchased," Ocker said.

"There's a real need for this type of facility for Town residents and the land is ideally located and easily accessible from all parts of the Town," Ocker added. "I am making this proposal," the Councilman continued, "because of the great desire on the part of our residents to participate in this form of recreation and the present over-crowding on existing golf courses. Secondly, I consider this a most appropriate one for the town under its Comprehensive Zoning Plan," Ocker declared.

Councilman Ocker, Chairman of the Board's Standing Committee on Recreation, Beaches and Waterfront, long an advocate of increased recreational facilities, conceived the idea of a community park and pool complex, including the award winning Plainview - Old Bethpage Park. Other similar type community parks in Bethpage, Syosset - Woodbury and Massapequa are under construction and scheduled for opening this year.

The present 100 acre tract, the Councilman noted, contributes approximately \$16,000 in taxes to the Town and County. "It is zone one-acre," he said, "and could produce approximately 65 buildable plots for homes. This would place an increased burden on the school district far in excess of what could be realized in taxes from these homes. I believe the development of a recreational facility of the type I have proposed for use by Town residents, operated on a self-supporting basis through fees, or possible seasonal memberships, would provide the greatest benefit to the entire Town."

DRIVE SAFELY

The boys' choruses of the Hicksville Junior High School have been invited to present a concert program in the New York State Pavilion at the World's Fair, May 29. There are three boy choirs at the Hicksville Junior High - the Seventh Grade Chorus, the Eighth Grade Chorus and the "Jubilees." The Seventh Grade Choir numbers sixty and is a treble choir. These boys have been selected from the elementary schools and must be recommended by their previous music teachers. They rehearse one hour during each school day. The highlights of their program will include "The Erl King" and the "Twenty-third Psalm" by Franz Schubert, "O'er Death" from "Christ Lag in Dornenland" by J. S. Bach and Johann Strauss, Jr.'s "Tales from the Vienna Woods." Accordion accompaniment will be rendered by Gary Enos.

This group is directed by Mr. Gerald Barker. Its student accompanist is Kenneth Rubin.

The Eighth Grade Boys' Chorus numbers sixty-five boys who sing four parts, soprano, alto, alto-tenor and baritone. Its members are previous seventh grade choir boys or are recommended by their previous music teachers. This choir is exceptional because of its unique vocal color, due to the boys' changing voices. A quality of resonance and warmth is reached just as the voice begins to change.

Among the featured numbers of their program are, "O For the Wings of a Dove" by Felix Mendelssohn, treble solo by Elliot Thau, "Grieve Not the Holy Spirit of God," composed by T. Tertius Noble, treble soloist, Peter Abramson, and a medley of arranged American folksong with instrumental accompaniment. This choir is also directed by Mr. Barker and their student accompanist is Robert Salak. Attention was given to this chorus last year when they were invited to sing in Westport, Conn. They have presented a number of programs at local schools and will sing Wednesday evening, May 12 during "Fine Arts Week," at the junior high school.

The "Jubilees" are a selected group of twenty-one boys from the seventh and eighth grades. They are auditioned by Mr. Barker and picked as a result of their audition and their past musical experiences. They meet after school and are an all treble choir. This choir will sing the "Echo Song" of Orlando di Lasso and a medley of calypso songs with instrumental accompaniment. The concert will conclude with two selections sung by the combined choirs.

Mr. Barker, their director, is very much involved with boy choir work having studied with the "Vienna Choir Boys," and the "Columbus Boy Choir" and the choir of men and boys at the St. Thomas Church, New York City.

To the Editor:

In his 1964 campaign for Congress, Mr. Lester L. Wolff worried about the slack in Long Island's aerospace industry, one of our biggest sources of income and employment, highly dependent upon government contracts.

He promised, if elected, to do something about it.

Today, as Congressman, he is still worrying aloud. In a House speech on April 27, 1965, he viewed with alarm this area's "already serious" and "growing" unemployment problem.

But what has he done about the situation?

The answer must have shocked those employed in (or laid off from) our aviation and space-related firms as much as it has shocked me:

On April 18, 1965, a veteran Washington newsman reported in a local daily that Wolff -- who was named to the House Science & Astronautics Committee precisely because of that field's importance to Long Island -- had actually recommended a 5 per cent, \$8,500,000 CUT (that's right CUT) in the National Aviation and Space Agency's budget for advanced research and technology!

This is almost incredible: A Congressman concedes that there is serious and growing unemployment in his District while at the same time attempting to reduce funds or an agency directly related to the District's economy -- not to mention the future scientific development of the U.S.!

Mr. Wolff has willingly voted vast sums in aid to foreign countries. On the same day he sounded of about "growing unemployment" in Nassau, he voted for a \$1 billion raise in the U.S. contribution to the International Monetary Fund.

Why must he pick up on our aerospace industry to feel the first blow (and perhaps the last) of his new found economy axe?

MID ISLAND BANK is being chartered in Hicksville. It will be a new savings institution according to talk around town.


J. M. MCCLINTOCK is president of Estey Music Co. in Hicksville at 201 West John St. It will continue manufacturing of home organs.

THINKING IT OVER

This week was marked by Teacher Recognition Day on Tuesday, and we were duly notified by School Administrations that this day was coming up and that we should do something about it.

But as the day approached it was marred by the Plainview teachers voting to join a union which means simply that they do not want to be thought of as anything other than a labor force and labor already has the first Monday in September set aside for it.

And then second on the list is the massive mislabeled "Teachers" in which a number of liberal thinking college professors were all set to expound their philosophies in the guise of teaching - if the Johnson administration had not wisely decided to send emissaries to tell the nation's side of the story.

But to anyone who watched the "Teach ins" on TV it was apparent that many of the well-learned teachers who spoke deserved anything but recognition. Some of them didn't even know much about the

subjects they claimed to be masters of. Much of the unprofessional ranting of these teachers made no less a liberal than Arthur M. Schlesinger Jr. seem like a reactionary.

But it is a shame that all of this happened on or near "Teacher Recognition Day." The actions of a very vocal fringe minority has and is giving teaching a black eye. She was the one who donated extra hours and minutes of her time to see that her job was done as perfectly as possible. There are still some teachers of this type around and to them a Recognition Day has meaning.

To all teachers of that ilk we say thanks for a job well done. But, don't be led astray by the neophytes who have entered your profession to see what they can get out of it.

Orphan Virus Now Placed In Homes

(Q) "I had what I thought was the flu recently but my doctor said my illness was due to an 'orphan virus.' Could you tell me more about this? How did they get the quaint term?" Mrs. R. P.

(A) In searching for the virus of common colds a great number of other interesting and apparently unrelated viruses have been found. In fact, so many were uncovered that it was hard to find a name and disease for them all.

Since they weren't known to produce illness the group was designated as 'orphans' since a virus without a disease is supposed to be like a child without parents.

Further investigations have placed many of the group in homes. They are now known to produce ailments similar to flu, colds, measles, intestinal grippe, poliomyelitis, like illnesses and many other diseases. As you might suspect, there is no effective treatment as yet. Perhaps what we now need

is an 'orphan antibiotic.'

(Q) "What does a bland diet consist of? I have had one for my colon condition which causes diarrhea." M.A.

(A) A bland diet is one that is mild and soothing to the intestines. It is especially useful in treating colon disorders. The foods included will depend on the type of illness present.

Generally two classes of bland diets are used; one for colon conditions with diarrhea and the other for those with constipation. For the latter, patients need to exclude only fried foods, certain spices and nuts. Otherwise, their diets can be normal.

In patients with diarrhea restrictions are greater. At first only carbonated drinks, bread, crackers, cooked cereal, custards, gelatin, ice cream, butter, eggs and broth are allowed. As the patient recuperates more foods are added so that eventually a full diet is taken.

Will Medicare Help Or Harm

Having emerged from the House Rules Committee, the Johnson Administration's "Medicare" plan now is debated by the House of Representatives. Almost certainly, some sort of "Medicare" act will be passed this session. But will this legislation actually rescue the elderly people who can't pay for adequate medical attention? And will much of the American public now have to pay double for medical insurance?

Some one million Americans more than 65 years old probably need assistance in paying their hospital bills. The "Eldercare" bill backed by the American Medical Association would concentrate on extensive help — extending at beyond hospitalization — to this segment of the elderly.

But the "Medicare" plan is a scattering design — offering free hospitalization to everybody over 65, regardless of financial need. Within two or three years, the cost of "Medicare" might amount to more than \$6 billion dollars annually. Social Security payroll taxes,

so pay for this system, probably will have to be doubled — amounting, like enough within a few years, to a tax of 15 per cent on the first \$3,000 of individual incomes!

The majority of "senior citizens" do not require federal subsidies to pay hospital bills. Some 60 per cent of people over 65 already have their own medical insurance. Families over 65 have larger capital assets than do younger age groups; indeed, the average head of family over 65 is worth about \$31,000. And the incomes of elderly Americans have been steadily increasing. According to the President's Council on the Aging, between 1950 and 1961 the number of people over 65 increased 40 per cent, but their total income increased more than 130 per cent. (This contrasts with an increase of 80 per cent in the total income of the entire American population during that period.)

So the considerable majority of elderly Americans can pay their own hospital expenses. Moreover, as the years pass, a higher and higher percentage of the population should be able to manage

very well without federal medical subsidies. Not only is private income increasing, but 78 per cent of the American population (including all age groups) now possess some form of medical insurance — private, company, union, fraternal and professional association, and the like.

Thus nearly 4 out of every 5 Americans are already paying, directly or indirectly, for medical insurance. Upon these do-it-yourself citizens, "Medicare" would impose a double burden: they would pay the greatly increased Social Security taxes, willy-nilly, even though already saving to provide for their own medical needs.

To aid temporarily, one million elderly citizens, the Johnson "Medicare" scheme makes eligible for assistance all the 18 million Americans more than 65 years old. Its practical benefits are much inferior to those of "Eldercare." Why, then, does President Johnson insist on "Medicare"? Well, 18 million citizens may think they are getting something for nothing; and they will vote in 1966 and 1968.





To the Editor:

The Library Board does not subscribe to the notion recently advanced in the public press that the bookmobile was the cause of the recent budget defeat. A bookmobile is undoubtedly one of the most useful and inexpensive ways possible to bring library service to the people who find it inconvenient or impossible to visit the library regularly. The bookmobile is now five years old; the expense of maintaining and operating the vehicle including staff, books, insurance and maintenance is less than \$19,000 a year, about 1/15 of the budget. This ratio is maintained or even lowered year after year. For this cost, 75,270 books were circulated last year nearly all of them to young children who very often cannot visit the library due to lack of transportation or safety concerns. While it is not possible to measure the monetary value of book to these youngsters, if books have other values, the bookmobile has certainly more than paid its way in the community. We have ample evidence that it has fulfilled its purpose. The bookmobile circulates 22 per cent of the library's total circulation. We hope taxpayers are not misled by the figure quoted in the local press of \$30,000 expense per year. This is simply not so. This vehicle was purchased as a practical, inexpensive method of making library service available to all of the taxpayers in the community. It has been a success.




