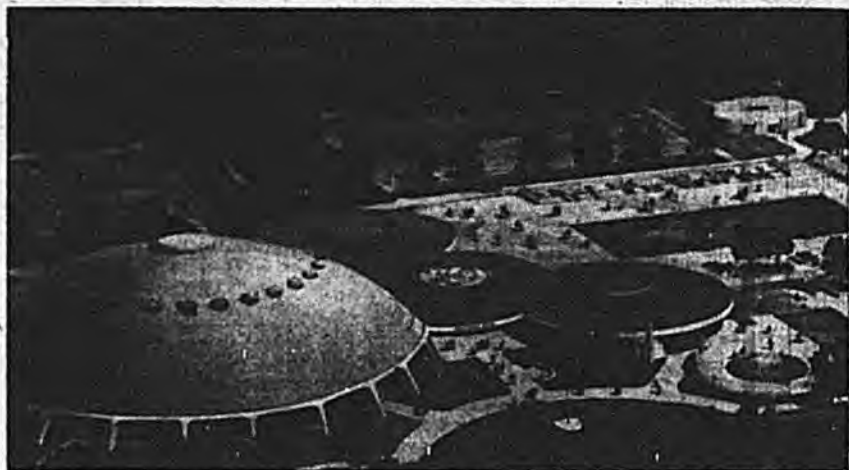

hockey plus theater - in - the - round and other competitive and recreational purposes, bath houses, dining facilities and a large sun deck containing four swimming pools including a full olympic-size

pool. Total cost of the project, designed by Frederick P. Wiedersum Associates, Architects-Engineers of Valley Stream, is approximately \$1,800,000. Anticipated completion date is September, 1966.

Swimming Pools Here By 1966

Within recently - dedicated Cantiaque Park, the 125 - acre Nassau County development in Hicksville, construction is now underway for the new Cantiaque Park Swimming Pool and Skating Rink Complex. The project, scheduled for completion in September 1966, will include an indoor skating rink which is convertible to other activities, four swimming pools, bath houses, dining facilities and sun deck areas.

Major structure in the complex, designed by Frederick P. Wiedersum Associates, Architects - Engineers of Valley Stream, is a circular domed building housing an indoor skating rink 210 feet in diameter. The rink will be used for competitive hockey, with bleachers for 1,000 spectators, and also for public recreational activities whereby it can accommodate approximately 700 ice skaters at one time. In addition, the building will be used for non - skating activities including theater - in - the - round indoor tennis, track meet events and horse shows.

The circular building, hub of the complex, has a structural steel frame and a concrete dome with neoprene hypalon roofing rising from precast buttresses with T - form construction. The Wiedersum firm selected a domed circular shape, rather than designing a more conventional rectangular building, on the basis of cost, function and aesthetics.

A low acoustical block wall runs inside the perimeter of the buttresses but does not connect with the kove, leaving a void space of approximately 2 feet. The main function of the wall is to protect the rink and spectators from inclement weather such as a driving rain

and snow and interrupting winds. Since the building will be used throughout the year, this void space, combined with an opening in the top central portion of the dome, permits adequate air movement by convection and gravity to achieve a comfortable climate within the structure. This plan eliminates the need for air conditioning the building were it to be completely enclosed.

Two cast - in - place concrete bleacher sections at opposite sides of the rink have capacities of 465 and 560 respectively. Men's and women's dressing areas and storage are situated beneath one of these sections. Dining service, including vending machines and a grille are situated under the opposite bleacher section.

During the winter months, spectators sitting in both bleachers will be protected by overhead infra-red heating units. The only other necessary heating provided will be for the dressing rooms, toilet areas and dining facilities.

Mobile lighting units, running on a trolley suspended from a circular overhead track around the central portion of the dome, will be used for spot and accent lighting.

Prime flooring in the structure is non-skid concrete, which can be covered with various materials depending on the activities to be accommodated. These include ice, produced in the normal fashion by pumping chilled brine, removable sections of board and dirt track for athletic events, tarbark for horse shows and portable stage platforms for theatrical events. When the building is used for ice skating events, interlocking rubber floor mats will be used in all traffic areas to permit skaters to trav-

THINKING IT OVER

Reapportionment is here. This is the system whereby it was said that we would attain the goal of one man one vote.

Now that it is here let's just see what has happened. Locally the state Senatorial district has not shown much change. The Township of Oyster Bay and a part of Westbury make up the Fourth Senatorial district we are in. This area normally is Republican and a normal vote would show about 49 percent of the vote going GOP and a little less than 49 per cent going to the Dems. The balance of power will be with the Liberal Party which can attract up to 1.3 per cent in good years.

In the Assembly we now have three districts covering what used to cover the one district. In the North, Syosset straddles the line of the new 11th district and Jericho is inside its boundary. This district should be about 54 per cent GOP and 45 per cent Democrat. The Liberals here will bring in about 1.2 per cent but should not be a factor in the outcome of the

election.

Plainview and Bethpage, formerly Ed Fehrenbach's district now also includes Woodbury and Locust Grove and Farmingdale. This District will be about 45 per cent GOP and 52 per cent Democrat. But a strong Liberal Party vote sometimes comes from part of Plainview and may be the deciding factor.

In Hicksville and part of Levittown the new Assembly District is District 8. In this District it is expected that the vote will be 49 per cent GOP and 49 per cent Democrat with the Liberal Party getting as much as 1.2 per cent of the vote. So once again the Liberal Party may decide the outcome of who should be in the Assembly.

The box score on reapportionment locally is that in all but one race for Albany the extremely small Liberal Party can decide who will represent the area.

So where oh where are the lofty cries for one man one vote? Or is this only reserved for situations where the GOP is in power?

Athletes' Foot Should Be Cared For Properly

MEDITORIAL: Athlete's foot is usually a minor health problem but it can be widespread and at times cause great discomfort and even disability. Athlete's foot is a skin infection usually seen around and between the toes but may be on other parts of the foot. It is caused by a fungus germ which can be found scattered everywhere, even on the feet of people who have never had athlete's foot.

Recent studies were made to determine the true effect of using disposable slippers, disinfectant foot baths, keeping persons with athlete's foot out of public swim-

ming pools, etc. Attempts were made to produce fungus infections of the feet by deliberately exposing the feet of volunteers to a solution known to contain potent fungus germs. Of all volunteers tested, none got athlete's foot.

Thus, it is now recommended that foot baths and the like not be used in shower rooms or swimming pools. Their value is negligible, and they soon become dirty, unsanitary and unattractive. In most cases the cause of athlete's foot is not "catching" it from some place or person but rather a lowering of resistance to the fungus germs which are already present on the skin.

Teaching Teachers About Politics

With here and there an honorable exception, American schools do a miserable job of instructing the rising generation in the practical functioning of the American political system, at every level. The average secondary textbook in "civic" or "social studies" or "problem of democracy" is full of vague sermonizing, but conveys small apprehension of how this republic maintains a high degree of order, justice and freedom.

In Ohio, a few years ago, Professor Raymond English conducted a survey of the state of knowledge of government in typical high schools - this with a grant from the Fund for the Republic. Though Ohio is scarcely a backward state, the results astounded Dr. English: even young people with excellent grades and strong native intelligence were almost illiterate in the realm of political theory and practice.

When the great majority are ignorant of the workings of their commonwealth, power slips into the hands of the self-seeking, the fanatic and the corrupt. Just where do we commence the revival of sound teaching about federal, state and local government?

Well, one begins with the secondary school teachers, who themselves have been insufficiently instructed in political disciplines. Many of them need to learn precisely the function of a primary; the composition of political conventions; the intricacies of party machinery. Most high school teachers are quite willing to learn, but graduate courses in pedagogy, or even standard graduate courses in political science, are not exactly what they require.

Now the Robert A. Taft Institute of Government (420 Lexington Avenue, N.Y.C.) a tax-exempt, non-partisan foundation, has set about this special task. Named after the great senator, the Institute agrees with Robert Taft that politics is an honorable calling, and that theory divorced from practice is perilous. (Taft, recognized by nearly everybody as a pillar of integrity, "disliked being called "public servant"; he was, he said rightly, a politician.)

The Institute's largest activity so far is the sponsoring of summer seminars in practical politics, most of them conducted on college campuses, for secondary school teachers. This commentator recently lectured to such a seminar at Macalester

College, in Minnesota; others have been held at C. W. Post College, at the University of Rochester, at the Detroit public school system, at Ridgewood, New Jersey, and other centers. At a typical seminar, some 50 teachers attend. The speakers generally are qualified both as competent scholars and as people with some experience of practical politics.

The Coe Foundation, with its American studies programs on selected campuses, also does something in this neglected field. In connection with the Coe program at Pepperdine College, Los Angeles, your servant will spend six weeks discussing with 30 teachers the large subject of "Contemporary Political Movements."

In recent months, some political behavior has more nearly resembled that of Communist or Nazi gangs than it has seemed like the American achievement of liberty under law. Such is the consequence of enthusiasm coupled with ignorance of tested political forms. If we are to escape the clutch of fanatic ideology, we must begin very early to instruct young people in the practical principles of the civil social order: how we count heads instead of breaking them.

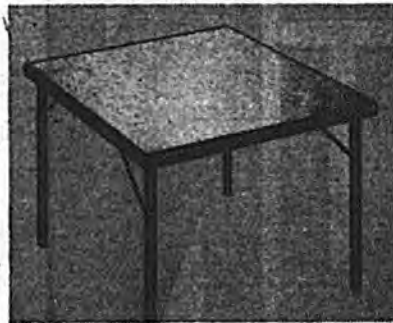

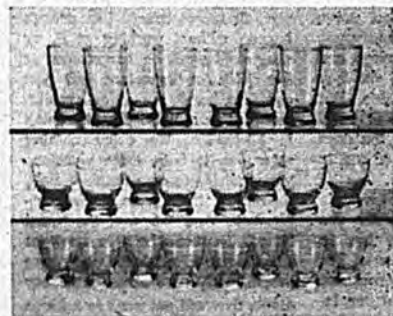

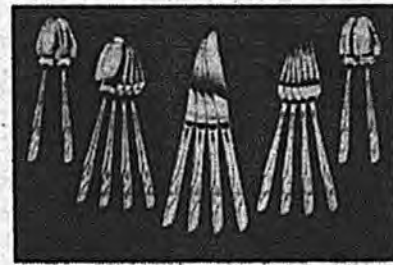

el from dressing rooms, toilets and dining areas without removing their skates.

Two smaller circular buildings, containing men's and women's locker rooms, are inter-connected by another structure whose curved shape continues the circular design of the buildings. This connecting building, whose roof has a central opening, will be used on an indoor-outdoor dining area. In contrast to the larger, domed rink structure, these smaller buildings will be of flat slab and flat plate construction.

An area adjacent to these structures contains four pools situated within a reinforced concrete pool deck, with several raised sun decks at the perimeter of the swimming pool area. Raised planters add a decorative touch to the landscaping.

The swimming area includes an olympic-size pool, 164 feet 1 1/2 inches by 82 feet 1 1/2 inches; a diving pool 45 by 60 feet; a 75 by 36 foot wading pool and a 38-foot diameter circular sprinkler pool. Total capacity of the entire pool area is approximately 2,100 people.

Total construction cost of the special Long Island project is approximately \$1,900,000. The complex will be the first to be built and

operated by Nassau County. Also, admission will be charged on a daily basis rather than the advanced subscription method used by other local pools in the area.
