Assessed Valuation Of Dist. Up

The assessed valuation of the Hicksville School District increased over three million dollars according to the new valuations released by the County Assessors office this week.

The total amount of land valuation in the Hicksville School District is \$101,509,263. Last year the assessed valuation was \$97,896,382.

The significance of the increase in assessed valuation is that the amount of taxes to be paid by each taxpayer is set by a rate which is determined by the amount of the School and Town Tax budgets divided by the amount of the assessed valuation of property. As the assessed valuation increases the tax rate decreases.

The assessed valuation of Central School District No. 4 (Plainview and Old Bethpage) is \$76,471,590 up from \$74,208,665 last year.

He is presently undergoing summer training called "plebe summer" at the Academy in preparation for joining the Academy's Brigade of Midshipmen in the fall.

The two months of military indoctrination during the summer is designed to teach the new plebes the ways of Navy and Naval Academy life. They are taught to march and to wear the Navy uniform correctly. They learn terminology and begin some academic work. When the upperclassmen return in September the new plebe class will be ready to enter its first academic year at the Academy.

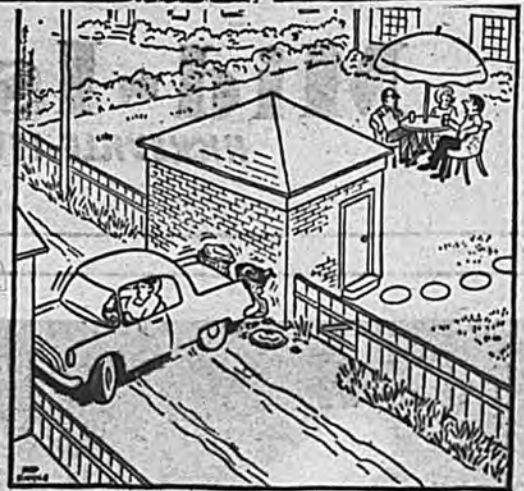

The Grumman A4A Intruder recently completed an extensive series of catapult fatigue tests designed to prove airframe durability under the conditions imposed by the "nose-low" method of launching. . . .

The tests utilized a structurally-complete A-4A fuselage including the nose gear tires and wheels to which all stresses that occur during a catapult launch cycle were applied. A unique test

structure, incorporating hydraulic and compressed air cylinders for the simulation of the many various cycle loads, was constructed at Grumans Bethpage facility. . . .

The nose-low method of launching developed by Grumman and the Navy results in greater usage of an aircraft carrier's catapults by reducing the launch cycle time and requires a minimum handling crew.

This method eliminates the use of the standard "bridle" hookup to the catapult shuttle. Instead the link into guides which are installed in the carrier deck. The tow link rides over and automatically engages the catapult shuttle. The rear holdback fitting is then coupled full takeoff thrust is applied and the holdback fitting breaks releasing the plane with the necessary thrust and catapult

force for launch.

The limit of the fatigue tests originally had been set at 1000 launch cycles. However the Bureau of Naval Weapons approved Grumman's request to extend the limit to 2400 cycles - more than twice the number that would be required throughout the minimum design life of the aircraft.

THINKING IT OVER

THE RIGHT TO VOTE

A valid reason for runaway costs in our public schools is that only a handful of people literally speaking vote in school elections. Bond issues sometimes draw a larger number but still a proportionately small percentage of those eligible. It is amazing how many people will tell you that they have never voted for school board members or on the school budget. Many people do not realize that in suburban and rural New York State voting for school board members is not on a political basis.

There is definite reason for the apathy and ignorance about school elections. The biggest reason is that the education laws governing voting procedures were written for the day of the little red school house. Another reason is that defeated bond issues are often brought up again for a vote without a change almost as if in defiance of the public will. Citizens thereby arrive at the conclusion: "What's the use. The School board will get what it wants. Both of these reasons which flaunt the franchise are an insult to democracy.

In the days of the little red school house an annual meeting would be

called in the evening. Citizens would gather at the nearby school to vote on the budget as well as for board members. If more than two candidates were running for the same position the people would re-vote until one of them received a plurality. This worked for the little red school house.

However this is the day of the large centralized district which takes in many school houses and often thousands of people. Strangely enough some of these centralized districts are still voting as above even though to cover the agenda the annual meeting lasts until one or two in the morning - until someone gets the plurality. In addition these centralized districts usually vote in one central place regardless of the size of the district. Consider an area for example where 16000 eligible voters must come to the high school in a district that stretches for four to five miles and has no public transportation for a large segment of the area. This situation is repeated with variations throughout the State. Is there any wonder that many people do not get out for school board elections?

Rumors Prevail About Hot Weather Habits

MEDITORIAL: The average person hears many rumors about hot weather habits. I'd like to clear up some of the more common fallacies.

More vitamins are not necessary during the summer. Desert experiments gave no evidence that increased vitamin intake is required.

It has been suggested that hot drinks in the summer make one feel cooler and cold drinks make one warmer. There are no scientific facts which bear this out. Cold drinks usually make one feel somewhat cooler.

A fallacy which is extremely dangerous is the belief that a good tan will increase your ability to work in the sun. A good tan will prevent a sunburn but it does not prevent heat exhaustion or sun stroke.

Wearing a hat in the sun does not prevent sunstroke. Usually you're better off without a hat so that the air can reach your skin and

help cool it.

Another controversy exists about the proper hot weather foods. Usually you feel better if you eat a light meal as heavy eating may make you feel slightly warmer for a while. However if your work requires it your diet should contain as much meat and potatoes as it did in the cooler months.

(Q) "I have a problem of gaining weight. I am five-feet nine-inches tall and weigh about 120 lbs. My legs and arms seem to need the weight most. I would like to know if the product I've seen advertised will really help a person gain weight." Miss L. S.

(A) It is very difficult for many overweight persons to reduce but it is even harder for underweight persons to gain. Most products that claim to add weight are of no help and I would advise ignoring them. I suggest more exercise plus second helpings.

He would have us when we are about to die from natural causes popped into the freezer and preserved like corn-boters in a some spark of life presumably lingering. Stored away in caskets somewhere we would await resurrection by future generations whose vastly improved medical science - yes that's what this gentleman says would enable them to cure our afflictions and resuscitate us.

THEY'RE SIMPLY GREAT

DIZZY AS THE ARTIST?



IT IS TO BE expected that admirers of Surrealism (or perhaps Anti-Art) will profess to understand this drawing above.

"What a striking likeness!" they may exclaim. "See how he walks with his eye always on the ground, his head full of illusions and elementary mathematical! Marvelous! If we met him in the street we should know him instantly."

The problem for the ordinary reader, however, is not to recognize the artist but to unravel his illusions.

In presenting this clever creation in *Mazes and Labyrinths: A Book of Puzzles* (pub. by Dover), Walter Shepherd stipulates that the viewer is on his honor to do the untangling by eye only, unaided by pencil or other pointer.

Pick up the thread at the arrow marked "O," and follow it through all the obstacles till you arrive at one of the numbers along the top of the picture.

THEY'RE IN THE BAG

HUBERT PHILLIPS included the following in his collection, *My Best Puzzles in Logic and Reasoning* (pub. by Dover), that is, posers which demand no mathematical knowledge, but call for clear thinking and an ability to establish the logical relationships which the data presented imply:

A bag contains twenty marbles. They are of three different colors. There are eight blue ones, seven red ones, and five green ones. You are invited to close your eyes and draw the maximum number of marbles consistent with your leaving in the bag: (1) at least four marbles of any color, and (2) at least three marbles of any second color. How many marbles should you draw?

Answer: 17. (If you draw eight marbles, the probability is 100 per cent that you will have at least four of one color and only two of the other color. To do better, however, opens an interesting puzzle.)

Exercise the Muscles of the Mind on These

SUPPOSE that on the day before yesterday, the weather forecaster broadcast, "Today's weather is different from yesterday's. If the weather is the same tomorrow as it was yesterday, the day after tomorrow will have the same weather as the day before yesterday. But if the weather is the same tomorrow, as it is today, the day after tomorrow will have the same weather as yesterday."

Let's assume it is raining today, and it rained the day before yesterday. Also that the forecaster's prediction proved correct. What was the weather like yesterday?

Answer: It was raining yesterday.

BENJAMIN FRANKLIN, Galileo, Lord Byron, Edgar Allan Poe, George DuMaurier, George Ohm, C. L. Dodgson ("Lewis Carroll"), Francis Bacon, August Mobius, Leonard Euler and Lord Macaulay are among the notables in literature and science who have delighted in composing and solving puzzles.

They would have agreed with A. L. Barbauld, the English poet and author, that "Finding out puzzles is the same kind of exercise for the mind as running, leaping and wrestling are for the body. Just as the latter prepare the body and make it alert and active for anything it may be called upon to perform, so does the finding out of good puzzles give quickness of thought, and facility for turning a problem every way, and viewing it in every possible light."

Along with an expanding public interest today in science, puzzles and "brain teasers" based on mathematics, physics or logic have come to enjoy greater popularity than ever. Significantly, the Scientific American Magazine has a regular monthly department devoted to puzzles. Compilations of great posers of the past are in demand, and the creations of Sam Loyd, H. E. Dudeney, Hubert Phillips ("Calliban"), Gerak Kaufman, Jerome Meyer, M. Kraitchik and other master-makers of puzzles are available again in inexpensive paperbacks. Noteworthy new collections are coming out in hardcover editions.

It's in the Cards

SAM LOYD, who was to become one of the immortal names of puzzeldom, attracted attention with his problems based on whist and the then novel game of auction bridge. Indeed, it has been claimed that Loyd's bridge puzzles did much to popularize the game in the United States, into which it was introduced from England in the 1890s. It was relatively little known in the United States until two decades later.

An Englishman, Hubert Phillips, who uses the pseudonym of "Calliban," is a modern composer of intriguing contract bridge brain-teasers. The following is from Calliban's Problem Book: Mathematical, Inferential and Cryptographic Puzzles (pub. by Dover).

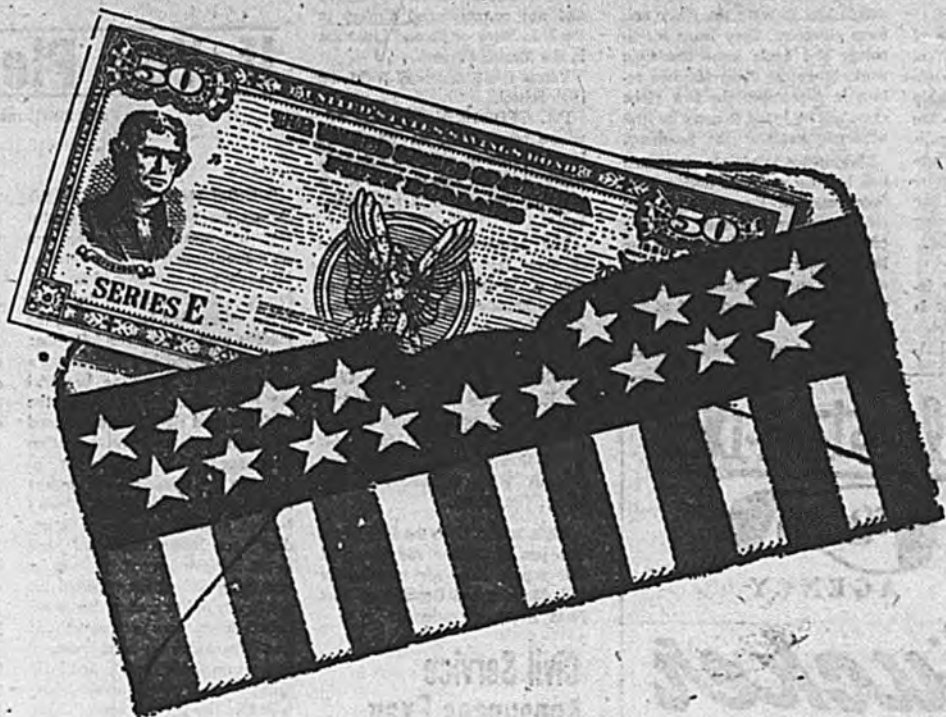

Letter to the Editor

In the Federalist Papers James Madison wrote that the essence of a republican form of government is that it "derives all its powers... from the great body of people." Today the people of Nassau Co. and the citizens of Hicksville have the opportunity and in fact the obligation to preserve and perpe-

tuate the fundamental principle of representative government; a principle based on the standard of "One Person One Vote - One Vote One Value."

In the majority report of the Nassau County Commission on Governmental Revision pertaining to Article 1 of the Nassau County Charter the majority concluded that the present make-up of the County Board of Supervisors does not provide "one man one vote"

and since this system is the only way to have equal representation the majority advocates that the present board of six members be "replaced by a board of 15 county supervisors elected for 4 year terms from 15 districts of substantially equal populations and of compact and contiguous territory with each Supervisor having an equal vote." Under the present system the two supervisors from the Town of Hempstead control 57 per-

cent of the total weighted vote of 125 thereby making it possible under weighted voting for a small number of legislators from the most populous areas of the county to dominate completely the entire board of supervisors. Weighted voting preserves the existing framework of malapportionment in our county making it impossible to pass legislation over the opposition of the Hempstead supervisors. It is time for you to become in-

formed and for you to demand immediate reform.

We should demand that the "one man - one vote" rulings of the United States Supreme Court (WMCA vs. Lomenzo 377 U.S. 633 "Apportionment of seats in the New York legislature failed to meet the requirements of the Equal Protection Clause of the Fourteenth Amendment;" and Reynolds vs. Sims 377 D.S. 568") be applied to our county governing body the Board of Supervisors. We should express our desire for equal representation in county affairs and abandon weighted voting which tends to prevent the free exchange of ideas hinders the legislative process and denies our legislators an equal voice in representing the people of our county.

Having attended the public hearing of the commission and studied their reports this writer strongly urges you to support the majority report for a 15 man board of supervisors based on the principle of "one man - one vote." I also urge you to write to the commission at the Executive Office Building in Mineola for their report so that you may understand their proposals. This issue of fundamental representative government affects every citizen and in our constant vigilance to preserve and perpetuate the basic principles of American democracy we must not fail to preserve this principle. Let us the citizens and leaders of Hicksville understand judge and render a voice on this most significant issue now confronting the consciences and rights of all the people of our county.

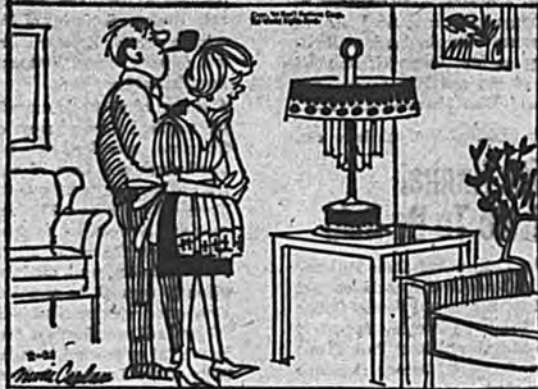

Tales Behind The Ticker Tapes

A Mystery Stock

Syntex now about \$80 a share is easily the best known drug stock listed on the American Exchange. There are two reasons for this. The first has to do with the action of the stock itself. Put simply over the last five years it has performed spectacularly. Reported earnings have skyrocketed and the market price per share has increased by 1000 per cent in that brief span. Not bad for a stock that was first offered to the public ten years ago at the equivalent of 75 cents a share.

Another reason for Syntex' popularity with the investing public is the good luck (or good management that landed the company right among the leaders in two of the most dynamic growth areas in the entire drug industry: steroids and oral contraceptives. Consumers may not be familiar with the Syntex brand label on their drug purchases but some of the company's better known licensees include such respected names as Eli Lilly (which markets Haldrona a systemic remedy for arthritis and asthma and C-Quens a sequential oral contraceptive under its trade name Ortho-Novum); and Parke Davis which sells various progesterational drugs produced by Syntex.

From any angle the Syntex is a highly successful company thoroughly accepted by its own industry and highly rated by the investment community.

In fact if it weren't for one tiny mysterious item we would certainly recommend purchase of its shares despite their volatile price action.

The mystery the thing we don't

understand about Syntex is why this company which has millions of dollars worth of manufacturing facilities in the United States a company that does nearly three quarters of its business here and in Europe why Syntex should still keep its corporation headquarters in Mexico City Mexico and its incorporation papers in all of places Panama City Panama.

In other words Syntex is legally a foreign company a company authorized by the Panamanian government to engage in business under its own peculiar laws. Just what does Panamanian law allow that Syntex couldn't do under one of the 50 state legal systems in this country? Frankly we don't know. But for their own protection stockholders in Syntex ought to.

Polaroid -Up or Down? Another outstanding performer in recent markets has been Polaroid. Currently priced around \$70 a share its been making almost a daily appearance on the New High List for the last month or so. And right along with Polaroids upward surge has been an accompanying cloud of rumors predictions and "guess-timates most of which deal with the company's rosey future sharply higher earnings and above all the unlimited profits about to spring from the new \$20 Polaroid camera.

Whether Polaroid will - or will not - do well in the near future is anybody's guess. Someone who thinks it won't is Dr. Edwin Land. His opinion about the company its prospects and its near-term profit potential ought to be of interest to anyone either already in the stock or thinking about buying some. Dr. Land is the founder/Chairman Pre-

sident and largest single shareholder in the company. On June 29 of this year less than two months ago, Dr. Land sold 31000 shares over \$17000000 worth at \$3 and a piece.

Whos buying Polaroid at today's high price stock that Dr. Land was pleased to unload 15 points cheaper?
