## Fire Damages Hicksville Rectory

Fire of undetermined origin early yesterday extensively damaged the rectory of Our Lady of Mercy Church, Hicksville.

The blaze was discovered shortly before 8 A.M. in a second floor bedroom of the building adjoining the church at 50 Froelich Farm Road and spread swiftly to other parts of the structure.

Firemen said the pastor, the Rev. Louis J. Schwedius, other priests and members of the rectory household staff escaped injury. Firemen saved many of their possessions.

## Dryness Best Prevents External Ear Infections

**MEDITORIAL:** The ear canal is a common infection site during the warm weather months. This is partly due to the excess moisture from sweat and swimming.

Infections of the ear canal are known as otitis externa. Most cases are due to bacteria. There is a misconception that fungus is usually the culprit. If fungus is found in these infections it is usually incidental. Treatment should be aimed at getting rid of the bacterial infection. Antibiotics, externally applied heat, ear drops and cleaning the external canal help in treatment. Dryness is also important, not only in active treatment,

but in prevention. This is a must for anyone who has suffered with otitis externa.

(Q) "I have been taking tranquilizers for four years for chronic anxiety. For the past year I have felt very weak and wonder if the medication could be the cause." Mrs. C. C.

(A) This type of medication can usually be taken with safety under the supervision of your doctor. However, there are side-effects that may be uncommon and crop up unexpectedly from time to time. This may be so in your case. Tell your doctor about the symptom and he will be in the best position to pass judgement on the drug.

## Conserving Our Country Through Private Action

**SOMEWHAT SURPRISINGLY,** President Johnson strongly recommends measures to preserve America's natural beauty; he plans a big Washington conference to this end. This concern is heartening, for what with the Federal Government's vast holdings in land, particularly in the Western states, Washington must have a large part in scenic and historic preservation.

But most action to retain our heritage of natural beauty and architectural history must come at the state and local level. This is a field in which private, voluntary programs can be remarkably effective.

One of the most encouraging examples of such activity is the Western Pennsylvania Conservancy, founded a generation ago, and steadily growing in its good works. The Conservancy's prime mover is Dr. Charles F. Lewis of Pittsburgh, now 75-years-old, but zealous and practical as ever. Every state and region ought to found its equivalent of the Western Pennsylvania Conservancy.

Not a penny of state or federal subsidy goes to the Conservancy; yet its accomplishments are many. Obtaining properties by bequest or gift, chiefly, the Conservancy maintains and improves their natural charms, establishes "nature trails," and restores old buildings and landmarks; then it turns these improved properties over to the Commonwealth of Pennsylvania for administration.

Several thousand conservation-minded Pennsylvanians are donating members of the Conservancy (204 Fifth Avenue, Pittsburgh). Their interests are scenic, geologic, biologic, historic, and recreational. The organization's first land was acquired around Slippery Rock Creek Gorge, in the 1940's. founded state parks; published pocket guides to scenic areas rebuilt the historic Old Stone House tavern on the Venango Trail (raising \$105,000 by public subscription for this project) as a "living museum," and done much else of high enduring benefit.

One of the more recent interesting undertakings of the Conser-

vancy was the acquisition, and opening to the public, of Frank Lloyd Wright's famous creation, "Fallingwater," in the Bear Run Valley of Fayette County. The unique and dramatic buildings and estate of Fallingwater were designed by Wright for Edgar Kaufmann; and the Kaufmann family foundation gave to the Conservancy not merely the extensive property, but half a million dollars toward perpetual maintenance and \$150,000 to support a "cultural and education" program. The Conservancy gave to the Conservancy during the first six months of its opening by the Conservancy, last year.

Really, we don't require largesse from the federal treasury to conserve much of our natural beauty and architectural heritage. As this commentator is fond of insisting, the old injunction to "brighten the corner where you are" may be platitudinous. But, the virtue of platitudes is that they are true; that's why they have become platitudes.
