## Hicksville Library Budget Vote April 11

Voting will take place on Wednesday, April 11 for the Hicksville Public Library Budget for 1984-85. The budget figure of \$1,066,344, is an increase of \$46,130 over last year and will carry an estimated .902¢ tax increase per \$100 assessed valuation.

In addition, the seat on the Board of Trustees, occupied by Mrs. Ruth Aaron, will be expiring on June 30. Nominating petitions for the five year term are available from the School District Clerk, Jane Wilder, or directly from the Hicksville Public Library. Petitions must be signed by at least 25 qualified voter of the District and should be filed no later than 5 p.m. on Monday, March 12.

Registration will be held on Wednesday, April 4, between the hours of 3 and 8 p.m. at the Hicksville Public Library, not the elementary schools, due to the Democratic Primary Voting scheduled for the same date. Residents who have voted at an Annual or Special meeting of the District within the past four years or a General Election in the last two years are eligible to vote. The Library is located on Jerusalem Avenue, opposite the Hicksville Junior High School.

Voting will take place at the seven designated schools in the district on April 11 between the hours of 12 noon and 10 p.m.

## Shopping Center Plans August Opening Date

Construction work continues on the shopping center to be located at South Broadway, Hicksville, with an August or September, 1984 opening date expected. Several major stores have signed leases and many others are pending, according to Alan Udell, spokesman for Delco Development Corporation, Developers and Builders of the area.

King Kullen, the major factor in the shopping mall will be opening a gourmet-style supermarket, occupying 40,000 square feet. Annie Sez, a clothing store for women, men and children has also signed a lease for 15,000 square feet. General Building Corp., a home improvement and accessories outlet, is already operating on the premises formerly occupied by McKeon Lumber Company. The area vacated by Meadowbrook Paper Company is being scheduled for renovation and leases have been confirmed for a Hallmark franchise store, drug store and dry cleaner. Pending agreements involve various shoe, optical, auto accessory, mens' and childrens' wear stores.

The builders have obtained approval for installation of a traffic signal on Broadway, Route 107, to control the flow of traffic both north/south and east/west on Old Country Road. Provisions have been made to allow left hand turns into the shopping area which will accommodate parking for 600 automobiles.

Originally expected to open in April of this year, Mr. Udell said that an August or September date was more realistic. Delco Development Corporation is located at 61 Jericho Turnpike, Jericho.

## Letters to the Editor

To the Editor:

A recent flyer mailed to members of St. Ignatius Loyola parish stated that since funding was no longer given to C.Y.O. by Hicksville Youth Council each family would be required to pay \$15.00 at registration. While true that funding is no longer available from our agency for umpires and referees, the Statement made in the flyer is at best misleading as it does not present the reason for the termination of the funds and implies that Hicksville Youth Council willfully ended the program.

In fact, the Board of Directors was forced to terminate these allocations in May of 1983 when we were notified by our primary funding source that the use of funds to pay referees, umpires or similar sports officials was forbidden and in direct violation of the funding guidelines of the New York State Division for Youth. C.Y.O. was one of the groups receiving an allocation for umpires and referees and was notified that although we could not pay for sports officials we would continue to support them through allocations for other job functions which were allowable.

For many years, the Youth Council has enjoyed a very positive and productive relationship with the groups that we were able to provide small youth employment allocations to and it is deeply distressing that we are no longer permitted to fund these programs. The staff and Board of Directors have always been committed to youth employment and community service and will continue to remain so.

To the Editor:

The issue of the right of our students to "Mediate" at a prescribed time of day, is very basic, and is protected under the Bill of Rights, and the Constitution of the United States, and has been lost in the world of legality.

The central core of our issue, as it relates to our Policy, is clear: 1 - We have a State Law that permits the free exercise of Silent Meditation. 2 - It has never been challenged in the courts, since its enactment in 1971. 3 - The United States Supreme Court has not ruled on the constitutionality of Silent Prayer or Meditation, and no legal body or government, or school board, or board attorney, can act on behalf of the highest court in the land. And finally, as citizens of the United States NO ONE can prevent an adult or child the freedom to think, be it in a public school or public park. act of displaying reverence towards our Creator, an act of love

and compassion for others - why stop a good practice in the face of a world that often rejects the values that we want our students to build on. We want our students to be tolerant towards others, practice brotherhood, the very things that the American Civil Liberties Union proports to Defend! In a material world that has gone crazy, with declining moral values, disrespect for authority, use of profanity, by some of our young students - must we now take away from our students the right to reflect and meditate on the good things of this world? Perhaps this is Hicksville's opportunity to turn the tide? and follow our example of starting the day with a meaningful practice.

Why not allow our community to VOTE on the acceptance or rejection of our policy on this issue? The public will not be deciding a legal question, for after all, we have a State Law that permits silent meditation, and the community will be letting the Board of Education know where they stand, and perhaps the Board will follow the wishes of the people that elected them?

I propose to make such a recommendation to my fellow board members, this coming Wednesday, February 29, at the Senior High. And will also request that the Board Majority, Mr. Ayres, Mrs. Singer, Mrs. Rudin, and Mr. Wolfson, reconsider their June 13th annual vote. The people want to vote Now, not June 13th.

Our Board last year allowed two special propositions dealing with education to be placed on the ballot, and they, the Board, agreed, and the people voiced their opinion, and the people Won, perhaps, we can again use our democratic process, and Win This One for our children and their teachers. Come to our Board Meeting on Feb. 29, at 8:15 p.m. at the Senior High School, and Voice Your Opinion.

To the Editor:

I am outraged by Mr. Bennett's letter which appeared in your paper last week. Mr. Bennett accused Mr. Ayres, Mrs. Singer, Mr. Wolfson and me of, "derailing a very sound, carefully prepared educational plan for 1984-85," by selecting June 13 for the Annual Budget Vote.

Balderdash! Our stand on June 13 took into account the following:

1. The proposed budget reflects a \$2.14 increase, the highest in Hicksville's history. It needs line-by-line review. When we bring it to the community we should be confident that it is as cost efficient as possible. To do that we need all the information necessary to make intelligent decisions. At present, for example, we have not received the complete staffing needs for next year.

2. Assemblymen Yevoli and Parola in letters dated Jan. 27 and Jan. 30 notified us that we are in jeopardy of losing 5.13% of our current State Aid. This could add an additional 376 to the budget figure, or could be taken from programs, or staff.

3. The Regents Proposals will be finalized in late March - early April. Any proposals that are mandated for next year would impact on the budget.

4. June had been the month for our budget votes in 9 of the past 12 years without harm to our educational system.

For a man who claims to be a fiscal conservative, who believes in a line-by-line approach to the budget, why is Mr. Bennett in such a rush to railroad this budget through? I believe there are reasons, but that they are political in nature rather than educational.

When elected, I promised to see to it that budget brochures reached the community in a timely manner, and that the community would have the opportunity to be heard in the budget process prior to the adoption of the final budget. Central Administration has been requested to aid this process by holding "Road Shows" in each elementary school to give the public this opportunity. The June 13 date gives us the time to achieve that, and I will continue to support that date.

To the Editor:

Under normal circumstances, it is not good practice for Board of Education Trustees to write letters to the editor regarding issues currently before the Board. However, the decision we now face concerning the elimination of the period of silent meditation in the Hicksville public schools, has affected the community so deeply that I find it necessary to share my thoughts as a Board trustee, parent and community member with all of you.

For some reason, the issue has become considerably distorted. At no time has the Board majority disagreed with the community regarding the value of prayer or meditation. We are as deeply concerned as you are that the moral fiber of our society has been eroded to the point where the traditional values we were raised with seem to be almost non-existent. Mr. Ayres and myself are practicing Christians and Mrs. Rudin and Mr. Wolfson are active members of their synagogues. We all believe in the power and importance of prayer and uphold the religious traditions. But the value of prayer is not the issue here. If it were, we would all be together in this.

The problem is this: We are facing a lawsuit brought by the ACLU and a plaintiff parent in our district unless we remove that portion of our opening day policy which allows for a period of silent prayer or meditation. At the present time the courts are ruling that silent meditation or moment of silence have the same intent as prayer (which was ruled against by the United States Supreme Court in 1962).

Our respected school district attorney, Mr. Joseph Campanella who is an expert on such matters, has strongly advised us to withdraw the policy in question or face a costly court battle which he assures us we will lose. In light of

this sound legal advice, I believe it would be irresponsible for me as a Board trustee to vote in such a way as to put our community in legal jeopardy.

In addition, Superintendent of Schools Dr. Catherine Fenton and staff have presented the Board with the projected School Budget you will be voting on in June. At this time the budget projects the highest increase I can recall (well over \$2 per one hundred dollars of assessed value). We are also facing a considerable cut in State Aid and will be mandated to pay for whatever proposals the State Board of Regents hands us. It will be extremely difficult for many of our homeowners to pay such increases. How can we heap on additional costs for a no-win court case? Remember, the taxpayers will pay for this case no matter what the final costs are. (Did you know that 95% of the more than one hundred school districts in Nassau and Suffolk Counties do not have any official prayer or meditation in their public schools? Surely they care about the moral values of their children as much as we do; but they know that given the current court rulings it would be foolhardy for them to risk the lawsuits such policies would engender.)

To those members of the community who firmly believe that prayer or meditation should have a place in our schools, I submit that this is not the forum for getting results. While it is idealistic to proclaim "We will fight even if we lose!", it is an exercise in futility. An extensive letter writing campaign to your congressmen and senators and putting pressure on the federal government is the only way to eventually achieve that goal.

In closing, may I make a plea for better understanding between all of us, no matter what our beliefs. We have worked too hard in Hicksville building up a caring community to see it divided, ironically over an issue like prayer. When it comes down to it, we know that prayer is a very personal thing between each one of us and our maker.

the exact scenario and notoriety that lone individual instigator (as well as the good old ACLU is seeking???)

Setting aside such cynicism as above, two indisputable facts should be pointed out (and added) that board members, letter writers, and school officials have completely overlooked rhetorically: 1) the pitiful and poor example shown school children in Hicksville by "wimps" on the school board and "give up without a fight" attitudes among their school officials and advising attorneys. Hopefully someone among them will consider with "reverence" the immortal words of Supreme Court Justice Douglas when he wrote "The struggle is always between the individual and his sacred right to express himself...and...the power structure that seeks conformity, suppression, and obedience." 2) America is supposed to be a country proud of its freedoms, progress, change, innovation, and open minds. America's magnificent Constitution was written brilliantly with the implicit idea that it must always remain flexible and would for that reason constantly be tested by the people in the court systems. Why should Hicksville taxpayers be intimidated by the power structure? Why should taxpayers be made to feel they cannot afford to use their own state and federal court systems?

Years ago, Hicksville won world fame for its efforts to find a legal way to acknowledge the importance of God and spirituality in its public schools. A Newsday writer did make fun of Hicksville in 1962, calling it the "Bible belt" because its school board tried to substitute a verse from the National Anthem when the U.S. Supreme Court banned the New York Regents' optional prayer from school morning exercises. But, I remember reading newspaper letters from all over the nation and the world praising that earlier Hicksville school board which put spiritual needs of children above any question of materialism or dubious constitutional law.

It is not too late for the School Board to rescind its recent ban on "meditation" and, if necessary, let it be defended by the Board's highly paid and successful school attorney. It is not too late for Hicksville to retain its outstanding reputation as a village of spiritual, tolerant and courageous people.

## Our Children

### To spank or not to spank

By Willard Abraham

**Q.** Our little girl goes to a pre-school which she enjoys very much. Everything about it appeals to me — except for one thing.

Her teacher there is very emphatic about one idea related to discipline. She says that a child should never be hit, and she stresses, "Never, never, never!"

I tend to agree with that basic idea, but not to the same extent that she does. There just may be a situation (not often) when a slap on the hand or on the rear may be necessary.

**What do you think about that?**

**A.** A highly respected authority in the area of child development once told me the same thing your youngster's teacher said to you. I accepted that idea until we had children of our own, and then I realized there could be rare exceptions to almost every rule of child rearing.

A little child who runs into the street in front of an automobile, grabbed by a parent in the nick of time, may create a nerve-wracking experience for that parent. So a well-controlled, limited spanking may provide an emotional release for the parent as well as help toward an important lesson for the youngster. The words "well controlled" and "limited" are important.

Not everyone agrees with me (or you), I know. I'll be glad to hear from them and share their ideas with others.

I'll also send a copy of my article for parents of young children titled "Discipline and Punishment—Where Do you Stand?" Just forward your request to me with a stamped, self-addressed envelope.

**Q.** We have never had children of our own, so I don't know how to cope with what a neighbor's 4-year-old does every time he sees me. He sticks out his tongue and makes funny faces at me.

My wife says I should just ignore him.

**A.** Why not follow her advice. If consistently followed, it may turn him off.

**Q.** We are really worried about our 8-year-old son's back. It doesn't seem to bother him at all, but it's a little deformed or at least looks as though it is. It's just not quite straight.

We haven't even mentioned it to our family doctor or to anyone else because with a shirt on it isn't at all noticeable. But just telling you about it without signing our names (I hope you don't mind) makes us feel a little better.

**A.** That's not enough. I'm not a medical doctor, but the next step seems quite logical, and I hope you'll consider taking it.

Either your family doctor should check your son's back or recommend an orthopedic physician who will do so.

There may be no problem at all, but for your son's health and your peace of mind that possibility should be considered.

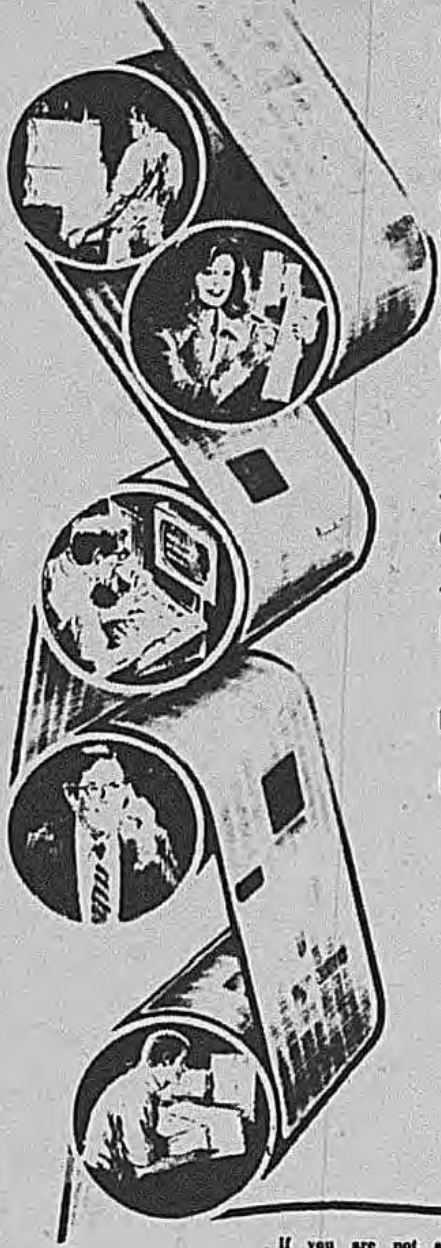

Members of a Hicksville-Bethpage Community organization which has been active for the preservation of local drinking water quality recently announced their participation in a national campaign to protect citizens from hazardous waste problems.

Bill Steinmetz of Bethpage and Ernest and Josephine Buckner of Hicksville represented the local chapter of the New York Community Action Network (New York CAN) at a Mineola news conference earlier this month. Local residents declared their support for the National Campaign Against Toxic Hazards which will focus attention on passage of a federal Superfund Cleanup program which will allow citizen participation in cleanup schedule, emergency relief and studies on health effects for people who have been exposed to toxic wastes.

The national campaign, which was endorsed earlier this month by the Woman's Club of Bethpage, is supported by over one hundred national organizations, including the American Public Health Association, the Audubon Society, the Sierra Club Consumer Federation of America and the National Education Association.

Mr. Steinmetz and Mr. and Mrs. Buckner, who have been engaged with Bethpage and Hicksville New York CAN members in pressing for comprehensive cleanup of the Hooker Chemical Company site on New South Road in Hicksville and the Old Bethpage landfill, stated that the national campaign seeks to guarantee "every American's basic right to lead a safe and healthy life."

"Town of Oyster Bay residents and all Americans will benefit from passage of the federal Superfund bill, known as HR-4813", said Mr. Steinmetz. "The bill's vital amendments will provide excellent protection for communities throughout our state and our country, and we estimate that the \$9 billion five-year plan will more than double the federal

contribution to New York State's cleanup costs."

"And the vast majority of federal Superfund dollars will continue to come from large firms using hazardous chemicals," the New York CAN members declared.

New York CAN members from the area have met with Congressman Norman F. Lent's staff to seek his support for the national program and to urge him to become a co-sponsor of the HR-4813 bill, including the amendments providing for a cleanup timetable, citizen suits, victim's compensation and health effects studies.

The National Campaign Against Toxic Hazards will seek to secure the following "Citizens' Rights" by law: the right to be safe from toxic exposure, the right to know about the presence of hazardous chemicals, the right to cleanup of hazardous sites, the right to compensation for damages due to toxic chemicals, and the right to protection and enforcement of toxic chemical laws.

The national effort is being coordinated by the Clean Water Action Project and Citizen Action, a national federation of statewide citizen organizations with which New York Community Action Network is affiliated.

# Your Social Security



## Sign up for medical insurance

**Q.** I didn't take the Medical Insurance part of Medicare (Part B) when I was eligible two years ago. I've changed my mind and would like to have it now. How do I go about it? — F.W.

**A.** You can sign up between now and March 31 at your local Social Security office. The first three months of each year are open enrollment periods for those who neglected to sign up when first eligible.

People who sign up during an open enrollment period are covered beginning July of that same year.

**Q.** When I was 62 last year I lost my job and filed for Social Security. I've been receiving monthly checks ever since.

My old boss wants me to go back to work. Is this permitted? — B.H.

**A.** You are free to return to work anytime you choose. If you expect your earnings to exceed \$5,160 gross you must notify your Social Security office.

Keep in mind also that your earnings could result in an over-

payment even for the months you did not work this year.

**Q.** I haven't worked under Social Security since 1971. I recently became disabled as a result of a heart attack. I am 53.

Will I be eligible for disability benefits? — L.T.

**A.** No!

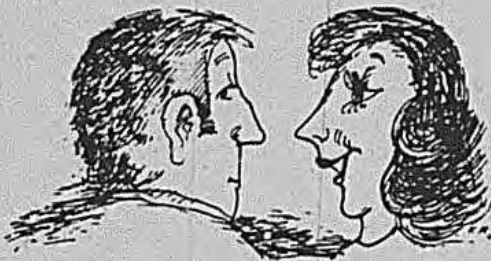
Anyone age 31 or older must have worked at least five years during the last 10 years prior to becoming disabled in employment covered by Social Security if they are to be considered for disability benefits.

**Q.** The increase in Social Security checks was postponed from July 1983 to January 1984. Will there be another increase in July 1984? — J.W.

**A.** No!

The annual increases from now on will be paid in January. The next increase will be in January 1985.

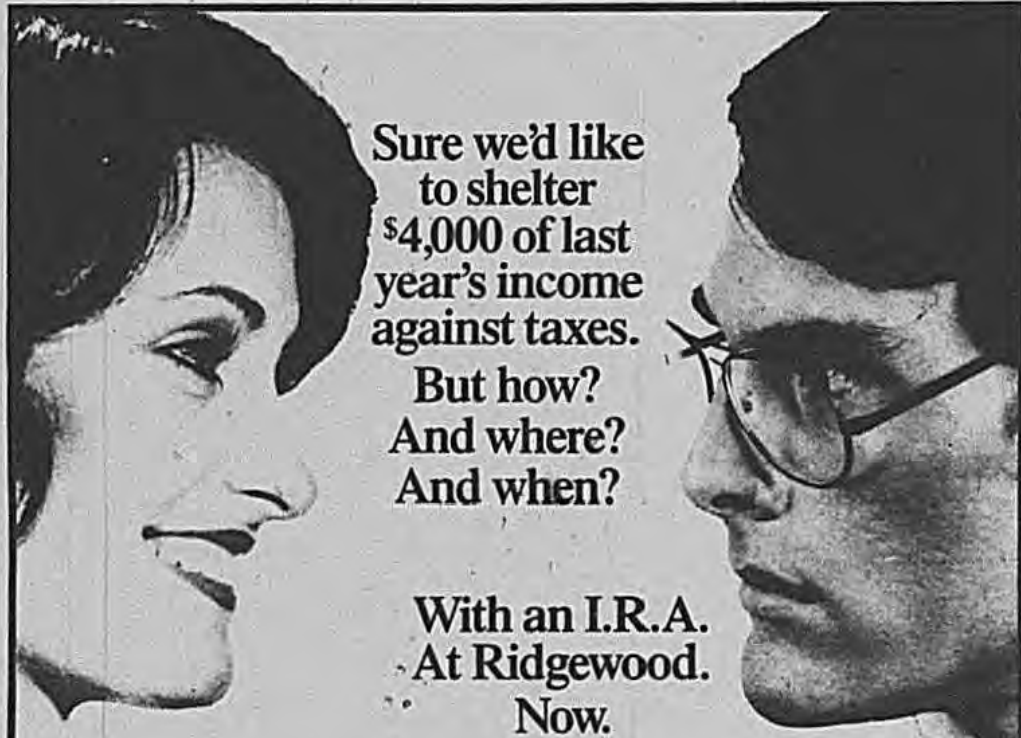
