### Hydroponic Farm At Dutch Lane

The children in Denis Stamp Yannon's fifth-sixth grade at the Dutch Lane School are growing tomatoes without using soil! They are studying the science of hydroponics, which is the practice of growing plants in a solution of water and nutrients instead of soil. "Hydroponics" is a Greek term meaning "water-working", and was coined by Dr. W. F. Gericke at the University of California in 1936. Dr. Gericke grew plants on a large scale in a solution of water and mineral salts. Since Dr. Gericke didn't have the use of a hydroponic greenhouse like the one at Dutch Lane, he has to use his bathtub!

Over 460 years ago, the Aztecs of Central America used hydroponics by growing their crops atop rafts, with the roots dangling into fresh, mineral-rich water. The Hanging Gardens of Babylon are also said to have been grown in a way similar to hydroponics over 3000 years ago!

The implications for hydroponic

farming are significant in our world here arable land is fast diminishing. Modern hydroponic greenhouses can help feed people in parts of the world where the land is too arid, or where there is not enough room for fields. Hydroponics can also help in parts of the world where drought is common, such as Ethiopia.

Scientists are currently testing the use of hydroponic farming in space. As our world's population continues to grow, and as we venture into the frontier of outer space, hydroponic farming will help feed us all.

The students are eagerly awaiting the harvest of their tomato plants. Each day they observe the growth and development of the plants, making sure enough light, water, nutrients and tender loving care are available. One of the students suggested the class make tomato sauce and have a pasta party. Another boy said, "Let's just eat them as they are, fresh and ripe right off the vine!"

### Film Tonight At Library

The Hicksville Public Library will show the film, "Racing With The Moon" on Friday, January 18 at 8 p.m. in the Community Room of the library.

"Racing With The Moon" is a film about friendship, love and the pain of growing up in a world at war. It is the poignant story of high school chums, Hopper (Sean Penn) and Nicky (Nicholas Cage), whose lives are altered forever during a six week period in 1942. The two boys await their entry in the Marines, and prepare to leave their peaceful hometown - perhaps forever. Hopper falls in love with shy, sensitive Caddie (Elizabeth McGovern) and the idyllic courtship that follows is both sweetly serious and almost impossibly gentle. Reckless Nicky is not so fortunate. His girl friend (Suzanne Adkinson) gets pregnant. The intelligent screenplay moves effortlessly between comedy and pathos suggesting sadness and the possibility of loss in even the most blissful love scenes. Rated PG, this film is in color and runs about 1 1/2 hours.

### Hicksville's 20th Postmaster Installed

Roger Nienaber is now official Hicksville's 20th Postmaster. On Friday, January 11, as a gentle snow fell, he was officially sworn in as Hicksville Sectional Center Manager/Postmaster by Regional Postmaster General John G. Mulligan.

Mr. Nienaber thanked a group of large business mailers, local civic leaders, postal officials and employees of the Hicksville Post Office for joining him on the proudest day of his postal career. "I hope to build on the already fine productivity record of Hicksville by creating and sustaining a climate of increased communication, mutual trust and improved understanding. Improved mail service bears a direct relationship to the increase of postal worker involvement. My goal is to balance the needs of the community and those of our employees," says Mr. Nienaber.

"Together we can continue to improve and build on the strong foundation postal reorganization has provided the Postal Service." He also thanked Mr. Murello, his predecessor, for years of fine Postal Service and for leaving him such an excellent staff of postal employees.

Teri Nienaber, his wife, held the family Bible while Mr. Mulligan administered the Oath of Office. Their three children Rusty, Mark and Sara were also on hand to witness the swearing-in ceremony.

Master of Ceremonies, Peter P. Goodwin, Long Island District Manager, gave a brief history of

the Hicksville Post Office. He said, "Hicksville has grown remarkably since it was opened in 1855 in the railroad depot. Today it is one of the largest post offices on Long Island."

In his remarks, Mr. Mulligan told the audience that Hicksville serves almost 2 million people within its 784 square mile service area, manages operations in 71 associate post offices and 34 stations and branches and handles over one billion pieces of mail annually. Mr. Mulligan said, "The Postmaster General and I are confident that your new Postmaster, Roger Nienaber, a professional postal manager with 17 1/2 years of experience, can meet the challenge in the years ahead. His postal experiences help make him a most qualified candidate for the Hicksville assignment. I know that he will complement the future goals of the Hicksville area both in postal and civic roles."

## News From Road Runners

Applications are now available for the eighth Annual Plainview Police Boys Club Long Island Championship 10,000 Meter Run, to be held on the roads of Plainview-Old Bethpage on Saturday morning, March 30. The event is once again being sponsored by the Plainview-Old Bethpage Road Runners Club in conjunction with the Plainview PBC.

The race will begin and finish at H.B. Mattlin Middle School, located on Washington Avenue in Plainview. The starting gun will go off promptly at 9 a.m. on the morning of March 30.

The 1985 edition of the race will once again be administered by Finish Line Promotions and will feature a Giant Digital Clock and Plate Display at the finish line. Time splits will be given at each mile marker and police traffic control will be provided throughout the race. There will be a water station at the halfway mark.

The Plainview course was professionally laid out by David Katz of Finish Line Promotions, assisted by members of the Plainview-Old Bethpage Road Runners Club. It provides a dramatic combination of demanding hills and level straightaways through some of the most pleasant and scenic roads in central Long Island, including a mile-and-a-half stretch along Round Swamp Road past the Old Bethpage Village Restoration. The course has received formal TAC certification, so that personal times achieved in the Plainview race may be used as qualifying times for TAC events throughout the country.

The Plainview PBC run started modestly in 1978 with only 125 runners. The number of runners has reached 500 in recent years, notwithstanding adverse weather conditions. Previous winners include Kevin Boyle of Wantagh, Rick Jackofsky of Rocky Point, Bob Giambalvo of Bayville, Don DiDonato of Floral Park, Tom Childers of Westbury, and Steve Lubar of Port Washington. DiDonato holds the course record of 31:30. The women's record is 37:01, set by local Plainview speedstar Kim Falkowski in 1982. Margaret (Santoli) Bertram of Oyster Bay was the first woman finisher in last year's race. Race sponsors are hopeful that all previous winners will be back this year, and anticipate that many other top runners, both from Long Island and elsewhere, will be on hand to challenge them.

The PBC Race continues to be generous with trophy awards this year, as trophies will go to the top five male and top five female finishers in each of eleven age categories. Special trophies will also be awarded to the top three male and female teams and to the top male and female finishers overall. A total of 118 trophies

will be awarded.

There will be a post-race merchandise drawing, in which all race entrants are eligible to win.

Two local Long Island businesses are the major sponsors of the race: Woodbury Super Star Sneakers and Sports and Robert Auto Leasing and Rental of Hicksville. Other local boosters include Lincoln Savings Bank, Universal Fitness Products and the Pennsylvania.

The entry fee is \$7 for those who pre-register and \$8 for those who register on the day of the race. Distinctive top quality black and gold commemorative T shirts will be given to everyone who registers prior to March 28, and everyone who finishes the race will receive a special commemorative embroidered patch.

He lives with another fellow, and my son often complains because the other boy is such a slob. I find that hard to understand, based on the way he himself acts in our house. His room is a total mess, he leaves dirty dishes on the table after an afternoon or mid-night snack, and clothes are left on the floor all over the place. I don't know from where his

careless habits come, and I don't know what to do about them.

Can you help out?  
A. You love him, you want him to come home as often as he can, but it's your house too and you want it kept clean and orderly. A frank discussion along that line, without confrontation or anger, may be enough to convert him into a welcome "guest."

A convenient clothes hamper, a lesson in using the washing machine and dishwasher (if you have one), taking him with you on grocery shopping trips, and leaving his soiled clothes where he drops or steps out of them may help turn the tide.

Q. Homosexuality has been attracting so much attention these days, and I'm worried about it in connection with my 12-year-old son.

When I was a boy we never seemed to hear or think about it. We had "sissies," of course, but they were just kind of effeminate, and sometimes poor athletes. I don't remember that we ever associated sex with them. The only hint I have about my

son is that he is so orderly in everything he does, and especially meticulous about his clothing. (He certainly doesn't take after me in those characteristics!) His mother is very neat, and somehow that seems to be all right for her — but not for him.

What consolation or clarification can you provide on this issue?

A. It seems unfortunate that one kind of behavior of the type you indicated should cause concern. In another time it probably would have been accepted as an asset in either a boy or girl.

Many psychologists tell us that each of us has male and female characteristics and/or interests, but the number and intensity of them vary from person to person.

It might be worth your while to think about other qualities he has, and then perhaps with a list of them seek a competent clinical psychologist with whom you can discuss the situation.

But on the basis of only one such as "orderliness" or "care of clothing" it appears that you're perhaps jumping toward conclusions too quickly.

Q. I want to be absolutely sure that our 14-year-old son doesn't make a mistake in which vocation he selects. That's why I've met with his school counselor and insisted on several vocational tests being administered to our boy. Please tell me whether you feel I'm right.

A. Not entirely. First of all, most high school counselors are well acquainted with what vocational preference tests are available, and with their values and limitations.

Second, research seems to indicate that most adults change their careers many times, and it is getting less common for them to spend all of their working years in one occupational choice.

A third factor — what's the hurry? Does he really have to make up his mind this soon? How upset will you be if he makes a choice and then changes it?

Parents sometimes have to be reminded that children should be permitted to learn from their mistakes just as many of us did.

## What's ahead for '85?

Whichever the economy goes in 1985, there is an economist who will be able to say, "I told thee so."

Unfortunately, the long-term result of most of these short-term scenarios probably would be gloomy.

A month or two ago, everybody was talking about an economic slowdown of some kind. Now, it's almost everybody. A handful of economists think the economy will boom again — although most of them think the boom will peter out quickly.

So now we have somebody pointing a sign in all directions: Strongly Up, Moderately Up, Flat, Moderately Down, Disastrously Down (depression). Overwhelmingly, the consensus is for Moderately Up — 2 percent or 3 percent real (inflation-adjusted) growth. If that were to persist, it would be called a "growth recession" or a period of below-normal growth causing unemployment to rise significantly.

Art Smith, the savvy Houston-based economist who runs *The Econoclast* newsletter, believes the Federal Reserve's efforts to knock down interest rates will lead to "renewed economic vigor," accompanied by a slowly receding dollar, inflationary pressure and eventually higher interest rates.

The boom won't last: "This type of 1985 behavior will likely result in the Fed slamming on the brakes, resulting in a 1986 recession," he said.

But there's downside risk, he warned: One or more Latin American nations could go belly up. Ditto for a major U.S. bank or two. Such calamities could lead to a depression, he said — and everyone should keep a deflation-depression scenario in mind, although inflation is still much more likely than deflation, primarily because it's the poison preferred by the world's governments and central banks.

There are economists and stock market analysts who expect deflation, although some of the deflation talk, I suspect, is really meant to scare the politicians into doing something about the deficit.

The most optimistic view remains the "soft landing" scenario — the notion that the Fed, by holding money growth to around zero from July to November, adeptly engineered an orderly slowing of the unsustainable boom of 1983 and 1984.

"The current slowdown in business activity is merely a pause in the economy's upward climb," said Donald H. Straszheim of Philadelphia's Wharton Econometrics. "Overall, 1985 should be a year of healthy economic growth, inflation that is not accelerating,

modest declines in the unemployment rate and reasonable gains in real disposable income," he said, although the "huge foreign trade leakage" will be a problem.

Indeed, it's been more than a century since U.S. economic performance has been walloped by a high trade deficit, but that may be happening now. Since the early 1980s, the U.S. budget deficit has been heavily financed — perhaps to the tune of 40 percent — by foreigners. Our long-term interest rates have stayed unprecedentedly above inflation — a staggering 8 or 9 percentage points. And real short rates have been an amazing 4 percent to 5 percent. This has kept the dollar strong and attracted massive capital flows from abroad.

However, the flip side of a strong dollar has been incredibly strong imports and very weak exports — and those have battered certain industries (steel, autos, etc.), dented corporate profits and brought howls from abroad.

It can't last, say some economists. The Fed won't be able to resist pressures to reflate and knock the dollar down. Borrowers tolerated high real interest rates early in the recovery, when there was huge pent-up demand, but now these altitudinous rates are denting economic activity.

"Basically, the magic circle of robust growth with low inflation supported by capital inflows and a strong dollar which characterized the U.S. expansion during 1983 and early 1984 appears to be breaking

under the pressure of import penetration," said David D. Hale, economist for Chicago's Kemper Financial Services. "The increased U.S. tolerance for high real interest rates which resulted from the 1981 tax bill as well as financial deregulation is increasingly being undermined by the impact of the dollar on company profit margins."

The Fed's ease is a case of too little, too late, said Wall Street economist A. Gary Shilling. "It's probably too late for a decline in interest rates to save the economy from slipping into a recession in 1985," he said. The consumer spree is over, "much to the dismay of retailers who thought it would continue at least through the all-important Christmas season." Also, the capital spending binge is over — "high real interest rates are beginning to bite," said Shilling.

The problem with these scenarios is that only one of them — the orderly soft landing — is conducive to deficit action. In a recession, the politicians would be reluctant to cut spending or raise taxes. In a growth recession, they would be only a little less reluctant. It would be out of the question in a depression — and doubtful even in a renewed boom, because that boom wouldn't last long.

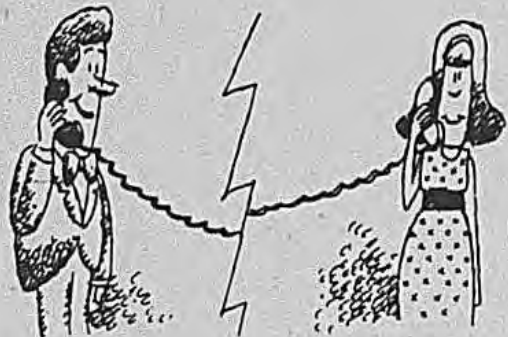

## No known cause for sarcoidosis

**Q.** A member of our family, a 36-year-old female, has been diagnosed as having sarcoidosis in her lungs.

Could you explain this illness and tell us what research is being done? How can we help her? — B.B.

A. Sarcoidosis is a disease which most commonly affects the lungs and/or lymph nodes in the chest but may affect many other organs. The cause of the disease is still unknown.

About two-thirds of the patients are under 40 years old when the disease is diagnosed and it is many times more common in the black population than in Caucasians.

Most patients have abnormal chest X-rays showing enlarged lymph nodes or diffuse disease throughout the lungs. Although patients are often without symptoms, they may complain of breathlessness or a cough. Over 50 percent of sarcoid patients with lung disease will spontaneously recover within several years. Many others will remain stable for many years and less than one-quarter will progress to severe lung disease. The fatality rate for this disease is less than 5 percent.

An organ other than the chest is involved about 40 percent of the time. Other organs which may be affected include the eyes, skin, liver, spleen, heart, joints, lymph nodes and nervous system.

Diagnosis is based on a consistent clinical picture, biopsy of tissue (the examination of which alone is not specific), and exclusion of other diseases. Since many patients recover spontaneously or do not become worse, treatment is often not indicated. However, when lung disease is severe or progressive, or disease is present in the eyes, heart or nervous system, patients are treated with corticosteroids which are cortisone-like drugs.

All patients with active sarcoidosis should be followed by a physician at regular intervals regardless of whether they are receiving treatment.

The main way a family member can help a patient is to ensure the patient is regularly seen by a physician (usually a pulmonary specialist) trained in the management of this disease.

Sarcoidosis is associated with several abnormalities of the body's immune system, particularly decreased cellular immunity. It has been suggested that some unknown event triggers a response of the immune system which then leads to sarcoidosis. Much of the research being done in this area is directed at these immune abnormalities. — Dr.

Harold Bencowitz, assistant professor of medicine, University of California, San Diego School of Medicine.

**Q.** I burned my mouth about a year ago while eating hot soup. A

lesion formed, would heal, and then form again.

I have been treated with antibiotics, cauterization and surgical removal of the lesion, but it keeps coming back. Is there anything that will help so that I am able to eat normally again? — W.W.

A. Without being able to examine this lesion and look at the biopsy material, it is impossible to make any definitive recommendations.

Generally, I would suggest that this is either a neoplastic lesion (abnormal tissue) or an inflammatory lesion.

If it is a neoplasm that is a tumor a diagnosis should be made by examining the biopsy material from the lesion and instituting appropriate treatment. If it is an infection, the diagnosis should be made by cultures for bacteria, tuberculosis, atypical microbacteria and other fungal infections.

If it is a collagen vascular disease such as Wegener's granulomatosis or midline lethal granuloma then that diagnosis is difficult to make but it is generally made through abnormal laboratory data and by examination of the biopsy material.

I strongly encourage you to seek consultation with a head and neck surgeon at a nearby university medical center. — Dr. Terence M. Davidson, associate professor of surgery, University of California, San Diego School of Medicine.

## SSI law requires proof of need

**Q.** I have been receiving Supplemental Security Income for the past six years. Every so often I get a letter telling me to come to the office and to bring my bank book, rent and utility receipts. Why is this? — A.P.

A. The SSI law requires that each recipient's case be periodically reviewed to make certain the recipient is still eligible for SSI and the payment amount is correct.

**Q.** Social Security has denied my claim. Can I have my brother represent me or must I have an attorney? — J.P.

A. You have the right to be represented by a person of your choice in any business you have with the Social Security Administration. You are responsible for paying the representative if he or she charges a fee. The fee must be approved by the Social Security Administration.

**Q.** My daughter is 50 years old and her husband is 62 years. He is

to get his first Social Security check in January. Inasmuch as they are separated, I would like to know if she is entitled to any of his benefits. She is handicapped. — E.D.

A. Nothing would be payable to her as a wife, until she attains age 62. At that time she should file for wife's benefits. She will need proof of her age and proof of her marriage.

**Q.** I read in the paper that Social Security checks are being taxed as income tax. I am a widow, age 76, and the only income I have is Social Security and a small SSI check. How is anyone like me going to get by, after I pay taxes on my home and the payment on the house? — M.H.

A. If you received Social Security in 1984 and your total income is below the base amount of \$25,000 for a single person, then you do not owe any tax on your benefits.

## Handicap Doesn't Stop Sportsman

Ted Debiak of Bethpage, a research scientist at Grumman Aerospace Corporation, doesn't let a major physical handicap stop him from being a top table tennis performer in world competition.

Ted, who lost his left arm in Vietnam in 1967, captured a bronze medal for the U.S. team at the International Games for the Disabled held in Uniondale this past summer. Competing in the table Tennis MLS category - against the least impaired athletes, and therefore the toughest competition - Ted teamed with Marcel Monastarial of White Plains, N.Y. to take third place. Ted says he was "thrilled" to take the bronze medal against very strong competition. "I've been playing table tennis since I was very young and I enjoy the competition, whether it be in a major tournament like the International Games or a Grumman tournament," he says. Ted teamed with Grumman colleague Penny Baldassare to win first place in the 1984 Grumman tourney and is a former Grumman champion of the B-division who moved up to A-division play last year.

At the International Games for the Disabled, Ted and his partner Marcel competed in the Davis-Cup-Style-play tournament in which each team member plays two games of singles and one of doubles in best-of-five match play. Ted and Marcel made short work of the Australian team, beating them in three straight to move up to the semi-finals. "In the semis we faced a team from China that turned out to be weaker than we expected, considering that the Chinese have some of the finest able-bodied tennis players in the world. Everytime someone hears that we beat the

Chinese team they seem very impressed. I guess it is something to be proud of," says Ted.

Ted and Marcel went on to beat the Yugoslavians in doubles, but dropped their singles matches, enabling the Yugoslavians to take the Silver while the Germans won the gold medal.

Ted attributes his table tennis achievements to hours of practice at lunchtime at Grumman, as well as in Grumman tournaments. He also keeps up a regular running schedule to give him added strength and endurance. "It's easier to concentrate on your game when you're in good shape", he notes.

Beside the thrill of winning the bronze medal at the International Games, Ted says he greatly enjoyed meeting athletes from all over the world. "The athletes and support people were simply wonderful. I met several people that I am really looking forward to seeing again, probably four years from now in South Korea at the Games. I'll keep practicing until then and maybe we can come home with the gold this time."

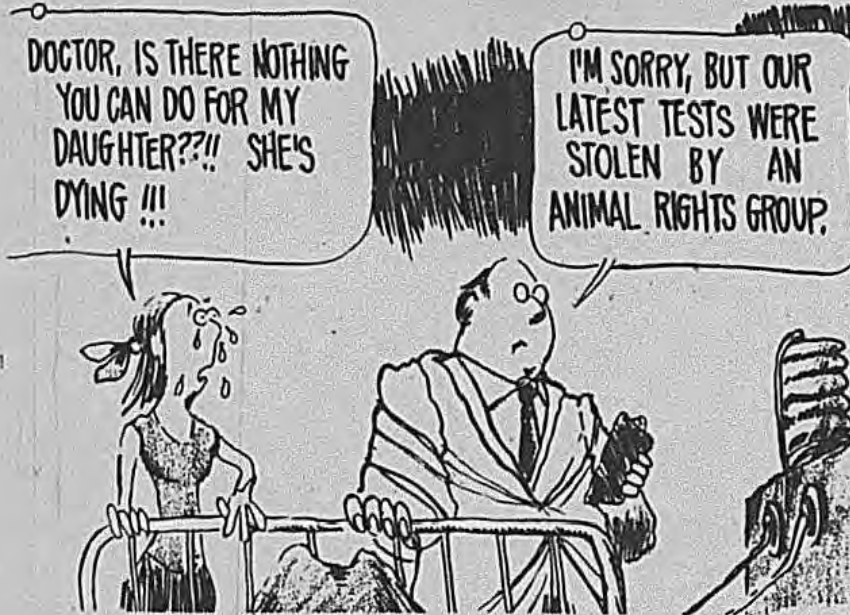

## Most Callers Think Goetz Justified In Shooting

Most callers to Input believe that the so-called "subway vigilante" was within his rights in shooting four men who accosted him in reply to this question: "A N.Y. man shot 4 young men who accosted him on the subway and is now being charged with attempted murder. Do you think, from the information in the news that he committed a crime?" Here are some of the answers:

### COMMITTED CRIME

Of course he committed a crime! He carried and discharged an illegal firearm in a public place attempting to wound or kill four people. That's the long and short of it. There's no question about what happened up to that point and it's all against the law. The question remains - was he justified? I say no. He wasn't in imminent danger - he was being harassed but he didn't panic. He spoke to the four before he began firing. The sharpened screwdrivers they had were still in their pockets. This cowardly man carried a gun and was ready and anxious to take lives when the opportunity arose. He found his chance but now he should pay. **B.B.**

### A COVER UP

No, I do not feel he committed a crime. I believe he will be used as an example to cover up for the inadequacies of our top officials: mayor, governor, etc. And the sick decisions by our judges on the bench, who tap the criminals on the wrist and free them to continue killing and terrorizing. I've watched these young punks that work in the subway cars stoned and bothering all of us. We need officials who care about the people so they are not beaten and terrorized into committing a crime in self-defense. **H.M.**

### WAS THREATENED

From what I've read about the subway shooting, I would say that Bernard Goetz was threatened by the four youths and therefore was innocent of attempted murder by virtue of self-defense. However, according to New York State Law he would be guilty of possessing an unlicensed pistol. Consideration of his record of good citizenship and no previous police record, I would give him a suspended sentence on the gun possession charge. In the final analysis I do not believe that letting Mr. Goetz off so lightly would set a bad precedent simply because the average person, even when provoked, does not have the courage and coolness to do what Mr. Goetz has done. **C.K.**

### LOST CONFIDENCE

I would first like to congratulate your publication for not referring to Mr. Goetz as a "vigilante". His actions do not fall into the confines of the definition in the dictionary of the word "vigilante". The newspaper accounts, it would appear, indicate that Mr. Goetz did overreact. However having been severely beaten and mugged it would appear that he lost confidence in the system. If the system could not protect him, who could? As a user of the subway system, I know it is unsafe. Our laws do not protect the innocent but the perpetrators. Is Mr. Goetz a criminal? No. He's a victim of not only four young hoodlums but a victim of a system that neither cares nor protects. **W.J.B.**

### COULD RICOCHET

I am against what happened on the subway train. Very simply put, a ricocheting bullet could have killed an innocent person. Just owning a gun does not mean you know how to use it properly. If a police officer, professional trained, used a gun under the same circumstances, TV, radio and other media outlets would have shouted "unnecessary force", "brutality", or "acting dangerously". Many innocent people will be hurt. On the other side of the coin there is a very good chance that punishment will not fit the crime. **A.G.**

### COMMITTED CRIME

I'll start out with a direct answer. Yes, in my opinion he did commit a crime and should go through all the applicable legal processes. We just can't have every indignant citizen going around pumping bullets into everyone he decides on the spur of the moment is about to rip him off or do him bodily injury. However, I agree, this is easier said than done in light of the free-wheeling criminal element we have encouraged through our liberal and lax jurisprudence, the unequal severity of penalties often based upon the quality and reputation of the lawyers the defendant can afford, the faulty prison system and inadequate accommodations, the revolving-door paroles, and the latitude which is apparently allowed to repeat offenders. In the present case, for example, we have already been told that the victims were repeat offenders, individuals whose previous records demonstrated a proclivity for public thievery and abuse as well as a disdain for the law. All of us know of someone close who has been mugged or robbed either in public places or at home. Within the past year, good friends have undergone both experiences while in our own case, we have had three house robberies in our experience and only this week, the theft of our hubcaps. So, it is easy to understand that people as a whole are afraid to ride the subways, scared to enter an apartment elevator unaccompanied, fearful of walking in the street at night, and overly suspicious of fellow passengers in public transport especially at night. Our government officials just can't dismiss this overwhelming uneasiness and outright fear. They must demonstrate their concern by taking real and substantial action with penalties to match. The public can't be blamed for their sympathetic reaction to the man who, in this instance, did take the law into his own hands. **P.G.S.**

### NOT A CRIMINAL

It appears that Goetz was just looking to shoot those he perceives to be preying on society. After his brush with robbers last year he decided to get back at someone and got a gun. This could hardly be condoned. It would mean that anyone who was mugged or robbed would have a free shot at those he thought were dangerous. It would be a break down in law and order much worse than the system we now have which has many things wrong with it. Goetz should be placed on probation for several years. He is not a criminal but he is not thinking right either. **L.W.**

## A New Baby-- Buy A Book

Whenever I browse through the children's section of a bookstore, visions of two little girls cuddling with their mother in a big overstuffed armchair reading a favorite book, float through my mind. With a smile playing about my lips, I recall that our mother read to us in the afternoon; and our father read to us before bedtime. Small wonder that I have a love of books and good writing that borders on a passionate obsession. I will probably spend a lifetime trying to reproduce some of the masterpieces that placed their stamp indelibly upon my youth.

Experts agree that early and regular reading to children facilitates their ability with language: oral, spoken and written. Many parents ask, "How soon should I begin reading to my child?" The answer: Immediately after birth! Begin reading to your child as soon as possible, either in the hospital or as soon as the new family member arrives home. Hold the baby in your arms and read fairy tales, poetry--anything with beautiful language--for at least fifteen minutes each day. Keep up this tender verbal ritual throughout your child's growing years. After a while you may no longer be able to hold the child in your arms, but a rocking chair or overstuffed armchair will do nicely.

In our verbal society, facility with language can only be an asset. This holds true while your child remains in school, and certainly applies to the "real" world beyond. Not all children can grow up to be published writers, but they should all be good readers, reaching their potential. I have watched youngsters kiss a favorite storybook long before they could read the words themselves. The book is special and they want to learn to read. They are motivated. Reading is pleasure and adventure, not hard, unpleasant work.

Choosing books for children can be a joyful task, and one that is easily accomplished. Start by sharing your favorite stories and tales; the treasured tomes of your youth. You will re-experience them with special magic through the eyes of a child. Your local library, and the

children's librarian are excellent resources for youthful reading material. If you are selecting books for a toddler, by all means bring the youngster along. Choose books with lively, colorful illustrations as well as a good plot line.

You might consider investing in a subscription to the "Horn Book" magazine. Libraries typically have a standing subscription, and it is rather like the Bible when it comes to ordering new books. In it you will find book reviews for picture books, stories for young readers (ages 6-8), stories for intermediate readers (ages 9-12) and stories for older readers (ages 12 through adult). Also included are folklore, poetry, non-fiction, recommended paperbacks, views on science books, and audio visual reviews (recordings, etc.).

The reviews are typically written by librarians and other specialists in the children's book field. They include the number of pages, the price, publisher, an illustration from the story when appropriate, as well as pertinent information about the plot. The "Horn Book" is a wonderful reference tool which will guide you to new publications in bookstores and libraries.

Reading is a wonderful gift to give a baby. The treasures of favorite books and stories will last a lifetime. How about purchasing a storybook or a volume of fairy tales the next time you select a shower or baby gift? Don't forget to start collecting special books for your own children. Above all, share them and the love they bring.



Manero's is a charming restaurant. It is located on the eastern end of a strip shopping center on the south side of Jericho Turnpike. It features a long, narrow lobby with a rather large bar area set off to the right. To your left along the long hallway is the retail meat shop in which the meat is displayed. Straight ahead is the big, lovely main dining room. It contains oak pieces with a charm all their own, beautiful stained glass, soft, gentle lighting, formal appointments, etc. It is a room that is much more than comfortable. It is really lovely.

As we sat down and ordered cocktails, a basket of delicious garlic bread was placed on our table - a definite plus for the meal. One of the entrees was the a la carte Delmonico Shell Steak at \$16.95. All a la carte entrees are served with a fresh garden salad and choice of potato or rice or vegetable du jour. The steak was cooked perfectly as ordered and was extremely tender, lean and delicious. I opted for the complete dinner which was a superabundant amount of food. The first course was a baked clam appetizer which consisted of two clams stuffed with a moist, seasoned bread stuffing. Next came the garden salad with a choice of dressing. Also placed on the table was a nice portion of french fried onion rings. Then there was a choice of potato, vegetable of the day and my entree, the barbecued baby spare ribs. Dessert and beverage were also included - all for \$13.95. The spare ribs that were served were a huge portion done in a very piquant sauce. They were absolutely delicious.

**Cooking Corner**

Once upon a time children wanted to be firemen, piano teachers, veterinarians and nurses when they grew up. Today, the field of intriguing and acceptable choices has expanded to include such esoteric pursuits as fashion designer, astronaut, rock star and chef.

Children today seem to be as caught up in the nation's current love affair with food as are their chanterelle-chomping, pasta-pushing elders.

Sesame Street programs and magazines include recipes for holiday fare. Junk-food eateries are branching out into croissant sandwiches, Danish fritters and Greek salads. And modern teen parties are as apt to center around pizza making and chocolate chip cookie baking as Pac-Man and Michael Jackson's moonwalk.

The Perfect Pan cooking school in San Diego currently is offering a series of classes titled "Kids in the Kitchen," with such subtitles as Pizza, Desserts, Baked Goods and Humpty Dumpty Had a Great Fall Egg Recipes. Classes cost about \$15 each, and enrollment is limited to 12 students per class.

Instructor Suzy Eisenman reports that her classes are filled soon after they are advertised. And, unlike the "charm schools" of the '50s, which many children attended with something less than great enthusiasm, today's cooking

classes are the kids' idea, not the parents'. "I don't think anyone attended our Dessert class because parents said they had to," says Eisenman. "everyone really wanted to be there."

There are logistics problems. In Eisenman's first class, several 8-year-olds had to stand on wine crates in order to reach all the burners. And there's a lot of educating to be done - Eisenman questioned her students about the foods they knew how to cook and found the 11 girls in the class limited to good old french toast and chocolate chip cookies. (The lone boy flabbergasted everyone with his answer: baked Alaska.)

Nevertheless, the class provides "a great time" for all the participants, says Eisenman, and a few tasty treats for the folks at home.

These recipes for festive sweets were perfected by the students in Eisenman's "Dessert" class.

- APPLE CRUMBLE**
- 4-5 tart apples
  - 2 tbsps. lemon juice
  - Topping:
  - 1/2 cup light brown sugar
  - 1/2 cup flour
  - 1/4 tsp. ground cinnamon
  - 1/4 tsp. nutmeg
  - 4 tbsps. butter, softened

Preheat oven to 375 F. Butter 9-inch pie plate. Core apples and cut into eight wedges. Arrange apples

in pie plate and sprinkle with lemon juice. Prepare topping by blending ingredients together with fingers until just crumbly. Sprinkle topping over apples and bake for 45 to 50 minutes or until top is golden and apples are tender. Serve warm with ice cream.

#### SHORTBREAD CHOCOLATE CHIP BRITTLE

- 2 cups sifted all-purpose flour
- 3/4 cup confectioners sugar
- Pinch of salt
- 1/2 lb. (2 sticks) unsalted butter, softened
- 1 cup real chocolate chips

Preheat oven to 350 F. Line 9-inch pie plate with parchment paper. By hand combine ingredients until smooth dough is formed. Press dough into pie plate, making sure dough lies flat and even in pan. Bake for 50 minutes to 1 hour or until pale in color, not brown. Remove from oven and allow to cool 10 to 15 minutes. Break into pieces and serve.

#### S'MORE BARS

- 1/4 cup sweet butter
- 1 cup semisweet chocolate chips
- 2 1/2 cups graham cracker crumbs
- 2 cups mini marshmallows

#### SHRIMP WITH MUSHROOMS AND SNOW PEAS

- 2 tbsps. vegetable oil
- 1 small onion, thinly sliced
- 1 clove garlic, minced
- 1 1/2 lbs. uncooked, shelled, deveined shrimp
- 1 chicken bouillon cube
- 1 cup boiling water
- 1/2 tsp. ginger
- 1/4 tsp. pepper
- 2 tbsps. each cornstarch and cold water
- 1 (9 oz.) pkg. frozen snow peas (Chinese pea pods) (Substitute French-cut green beans, if desired)
- 1 (4 oz.) can mushroom stems and pieces, drained

Combine oil, onion and garlic in 3-quart glass casserole. Cover and microwave for 3 minutes, until onion is translucent. Stir in shrimp. Dissolve bouillon in boiling water; pour over shrimp mixture, add ginger and pepper, and stir again. Cover and microwave on MEDIUM HIGH (70 percent power) for 3 minutes. Blend together cornstarch and cold water; stir into shrimp mixture. Replace cover and microwave 5 minutes on MEDIUM HIGH. Add snow peas and mushrooms. Stir gently, replace cover, and microwave 6 to 8 minutes on MEDIUM HIGH until pea pods are tender. Serve over rice.

#### QUICK SHRIMP 'N' CHEESE DIP

- 1 (5 oz.) jar sharp cheese spread
- 1 (7 oz.) can shrimp, drained
- 3 tbsps. finely minced green

pepper  
2 finely sliced green onions (green parts)  
3 dashes Tabasco sauce  
1/4 tsp. garlic salt (or to taste)

A. This doll was made by the Arranbee Doll Co. of New York during the 1930s. It should be worth at least \$200 in good condition.

A. Letter openers made prior to World War II are eagerly sought by collectors. Advertising and celluloid openers are the most popular.

## Here's How

By Gene Gary



Q. We have a wood-burning fireplace and, over the years, the red bricks above the opening have become blackened by soot. There is probably, as part of that soot, some oil and many other various chemicals.

Can you tell me, in a step-by-step procedure, how to remove the soot? — H.H.B.

A. Smoke stains are difficult to remove. A thorough scrubbing with scouring powder (particularly one containing bleach) and a stiff bristle brush works surprisingly well.

For the more stubborn stains, a poultice using trichloroethylene will pull the stain from the pores. Precaution should be taken to ventilate a closed space in which trichloroethylene is used, as fumes can be harmful. Try large paint stores or a janitorial supply outlet for trichloroethylene.

Q. I have an oak table on which I set a houseplant for Christmas. It must have been damp on the bottom. A white spot was left on the wood just a little bigger than a silver dollar. What can I do to remove this spot? — Mrs. L.L.

A. Whitish spots are often caused by something wet that's been left to stand on the wood. If you're lucky, spots may vanish when you repolish. If not, try scouring the area with a mild abrasive.

One method is to sprinkle cigar or cigarette ashes on the spot, moisten your fingertip with a little mineral oil and use it gently to rub away the spot.

A stronger treatment: Rub the spot lightly with finest grade steel wool (from the hardware store) moistened with mineral spirits. Work gently in direction of the wood grain. Then repolish the piece.

Q. I am writing to ask you about an easy way to clean wallpaper. We have a smoker in the family and the paper has become stained in spots due to smoking. Do you know of any liquid cleaner I could use?

I purchased some dough, like play putty, that is a wallpaper cleaner, but it is too hard to work with. Please let me know of anything I could use that would be easy to work with. — R.C.

A. The dough-type cleaner is the only way you can clean the paper unless it has a vinyl finish and is a washable wallpaper.

Q. After 25 years, the brass doorknobs in our home look very bad. I have tried a few acceptable methods of restoring them, but they still turn dark in a short period of time. Any suggestions for making them like new again? — Mr. E. Murphy

A. Lacquer is usually applied to cleaned brass or copper to protect the finish for a long-lasting effect. Unfortunately, it is not practical to put a lacquer finish on doorknobs as they are constantly handled and it will soon wear off.

Cleaning periodically is the only solution I can recommend. You can use a good decorative metal cleaner, or you can use the following method:

Clean away grime by washing in sudsy water. Try rubbing discolored areas with a paste made of hot vinegar and salt (together, these two ingredients form hydrochloric acid, which dissolves tarnish). Then polish vigorously with lemon oil on a cloth.

Q. How can I avoid getting a wrinkling effect on an exterior paint job I am getting ready to do? This happened to me on a similar job I did last year. — R.M.O.

A. Wrinkling usually occurs when paint has been put on too heavily and not brushed out uniformly. It also takes place when the paint is applied during cold weather (under 50 degrees F) or when the weather turns cold immediately after the painting is finished.

Assuming that you paint when the weather is right and you attempt to brush out the paint properly this time, don't go to the other extreme of overbrushing, which can result in what are known as "thin" spots on the surface. Be sure the paint is properly thinned before applying so it flows easily with the brush.

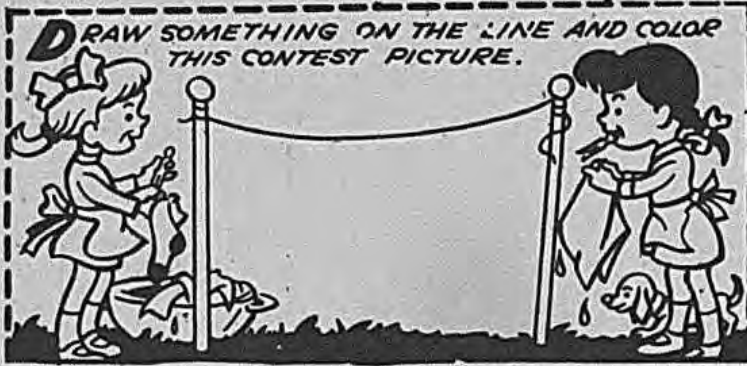
When my regular doctor showed up again I asked what the pacemaker was going to cost. He said he didn't know, but not to fret. Medicare would pay for it.

## Points on Pets

Q. We have a 12-year-old female cocker spaniel.

We recently have noticed that she has several small fatty swellings on her back and abdomen. The swellings do not seem to be painful. Apparently they are not causing her any trouble.

What are the swellings and what should we do about them?

A. Of course it is impossible to tell you what the swellings on your dog's back and abdomen are without actually seeing the dog.

One fairly common cause for single or multiple soft, fatty swellings on aged dogs is a tumor called a lipoma. Usually lipomas occur just under the skin along the back, on the chest or on the abdomen. Usually lipomas are well-defined spherical or lobulated masses.

Although these tumors grow quite slowly, they can reach very large sizes if left alone. Microscopically, the tumor cells are indistinguishable from normal fat cells. Lipomas usually do not cause the dog any problems unless they are very large, but many owners feel the lipomas are aesthetically displeasing. Lipomas can be removed by a relatively uncomplicated surgery.

Q. Our veterinarian recently diagnosed ringworm on our children's dachshund.

I am really concerned that our children might get ringworm from their dog. Is this possible? What can we do to prevent spread of the disease to our children?

Our children really love their dog and have a lot of close contact with him.

A. Ringworm is caused by fungi called dermatophytes. Most of the domestic species of animals and man are susceptible to these fungi. Some dermatophytes affect man almost exclusively; some affect animals primarily, but can affect man, and some are free-living soil fungi that parasitize man and animals only under specific conditions.

Three of the four most common organisms causing ringworm can be passed between animals and man. Transmission of infection may occur by direct contact with infected animals or man, or contact with contaminated bedding, clothing or premises. It is interesting to note that the transmission of the disease may go from animal to man or man to animal.

The spread of ringworm often occurs when animals play or fight with each other. Some authorities feel it is necessary for the skin to be scarified or scratched for infection to occur. The fungi causing ringworm usually only invade the

outer layers of the skin, hair and nails.

Typical lesions of ringworm are circular raised plaques with complete hair loss in the middle. A definitive diagnosis of ringworm can be made by examination of the lesion with a special cobalt-filtered ultraviolet light, by examination of hairs or scrapings with a microscope or by culturing the lesions for the causative organisms.

Treatments of severe cases usually involve oral medications taken simultaneously with antifungal ointments, shampoos or dips. Recovery from ringworm often takes several weeks.

To avoid spread to other animals or to humans, isolation of the infected animal until free of the lesion usually is necessary. Contaminated bedding and clothing should be destroyed. Carpets and furniture can be contaminated and must be cleaned if the infected animal is allowed to roam freely in the house.

Any animal suspected of having ringworm should be taken promptly to a veterinarian for diagnosis and treatment.

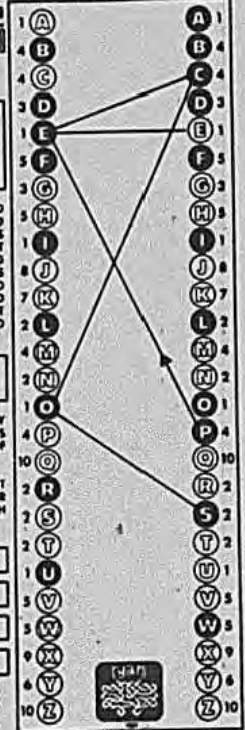
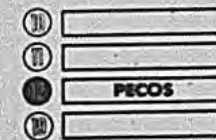

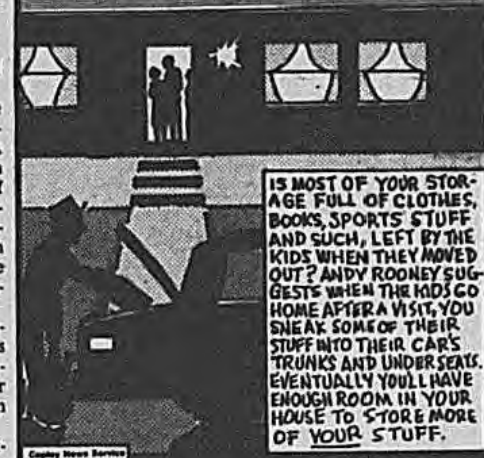
