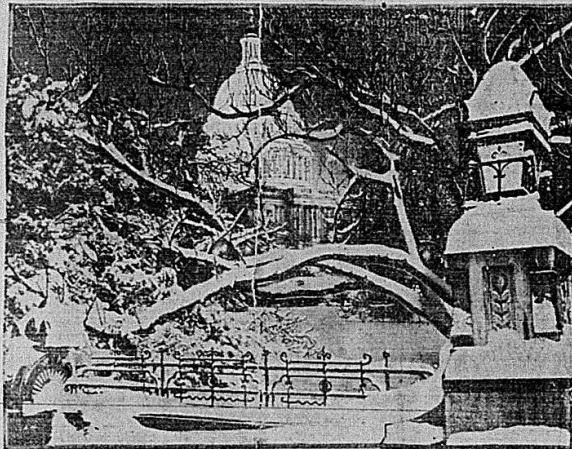

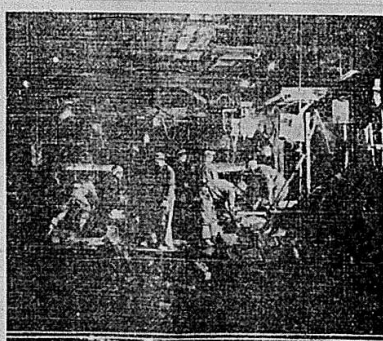

LIKE their ancestral Acadians, more than 150 years ago, most famed of whom was Evangeline, these trappers and their families are gathered awaiting transportation away from the scenes of their livelihood. Trinity Pastor Preaching At Special Midweek Service

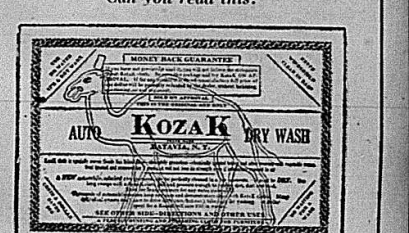

In the game earlier in the season, Mineola noded out the Aces, 23-23, in the second overtime period of the first game at the Elks court in February.

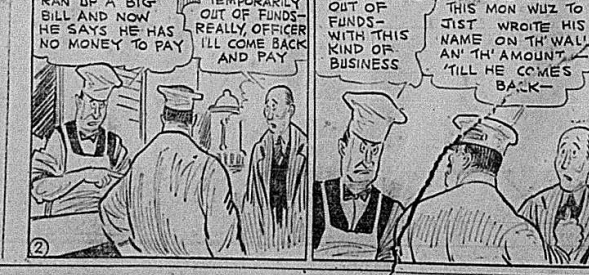
Band To Play Between Halves
