Parola Announces Intern Program

The state Assembly will again offer research internships to qualified college students this summer, Assemblyman Fred Parola announced today.

"This is an excellent opportunity to learn about state government firsthand," Parola said. "Students accepted into the program are assigned to specific research projects supervised by professional staff and research specialists."

Interns will receive a \$3,000 stipend for the 10-week program, which runs from June 13 through August 19. The program is limited to college students who will have completed their junior year by June 1988. All applicants must be matriculated in degree programs in a college or university in New York state for the fall 1988 semester, or be a New York State resident enrolled in an out-of-state college.

"The Assembly Summer Intern Program offers a unique opportunity for experience in legislative research and policy analysis," Parola said. "Up to 20 interns are selected each year. Summer interns should possess strong research and analytical skills, a definite interest in public policy development and state government and superior academic records."

Four Hicksville Hearings Scheduled By Town Bd.

The Town of Oyster Bay has scheduled four hearings in April dealing with Special Use Permit requests in Hicksville. The following will be held on April 12:

*The Wisser Company, Inc., is seeking permission to operate a used car sales and rental business in a 'G-1' business zone. The property is located on the north side of Old Country Road approximately 85 feet east of the intersection of Old Country Road and Broadway.

*Amoco Oil Company and S&W Holding Company are seeking a special use permit to modify a restrictive covenant to allow the reconstruction of an existing gas station and the operation of a convenience store. The location is on the northeast corner of Broadway and Old Country Road.

*In a companion application, the petitions, William Wisser and Amoco Oil Company are seeking permission to use a lot in a 'G-1' business zone for a parking lot in conjunction with the operation of the gas station. This property is located on the east side of Broadway directly north of the above mentioned parcel.

Then on April 19, Giovanni Riccardi is requesting a special use permit in an 'H' industrial district to maintain a grocery store/delicatessen, on the east side of Bloomingdale Road, north of Carter Lane.

All hearings are scheduled for 10 a.m. in the hearing room of Town Hall East, Audrey Avenue, Oyster Bay. They are open to the public and the Board will entertain comments from the floor.

Editor's Notebook

The State Dept. of Environmental Conservation has come up with a number of conservation ideas to be incorporated in a state water plan by January 1, 1989. Many of the programs are just for Nassau County where it is said the worst problem will exist.

The state predicts Long Island's overall water demands, without conservation, will grow from a current 460 million gallons per day to 528 million gallons per day in 2030.

Here are some of the ideas:

•That suppliers invest as much as \$518.8 million by the year 2000 to improve the reliability of their systems. Of that sum, \$167.1 million is needed to expand storage capacity; the rest would be used to replace mains and expand interconnections between suppliers.

•The Island's 34 community water suppliers should develop conservation based water rates, in which residential customers who use more water would pay more per gallon. Current residential water rates on Long Island range from \$45 to \$252 per year, with most homeowners paying less than \$140. State officials could not estimate how much rates must increase to curb current water use.

•Nassau's largest supplier, Long Island Water Corp., and suppliers for the Long Beach peninsula, Great Neck and Bayville must reduce consumption because of overpumping. Even with conservation, eight other Nassau suppliers serving 170,000 people will exceed the DEC's limits on pumping by 2000 and should study ways to cut back now.

The DEC developed the caps for each supplier based on how much water the supplier pumped from 1981 to 1986.

John Bryck, chairman of the L.I. Water conference, which is a private water suppliers group, said the caps are too simplistic because they do not take into consideration the demographics of the areas.

•Expanded water conservation is needed on Long Island, even in Suffolk. In Nassau, the DEC report urged conservation strategies that go beyond plans of County Executive Thomas Gulotta. The state plan calls for replacement of shower heads and other existing fixtures with water-stingy plumbing in homes across Nassau and in Suffolk shore areas and in all government buildings. It does not address who would install or pay for the new fixtures.

While many of the ideas will be debated as not strong enough or "too extreme," with the summer season coming up and the watering of lawns a possibility, local governments should make their plans now and let residents know what might be expected.

The deceased, Matthew McGovern 26, of 3611 Collector Lane, Bethpage was stopped at a traffic light in his 1975 Plymouth, Duster, westbound on Central Ave. A 1978 Datsun driven by Thomas Mooney 24, of 136 Sycamore Ave., Bethpage was traveling north on Hicksville Rd. and failed to negotiate a right turn colliding with McGovern's auto. Mooney was arrested for DWI by P.O. G. Stevko of the Eighth Pct. and taken to N.C.M.C. for facial lacerations. Mooney's passenger, John Mulcahy 24, of 10 Robert Ct., Plainview also had facial contusions and lacerations and was taken to N.C.M.C. for treatment.

Harry Meyers, a representative from the Town of Oyster Bay's Drug and Alcohol Abuse Program, conducted a series of substance abuse awareness workshops of kindergartners through sixth graders specifically geared to their grade levels.

On the kindergarten level, Mr. Meyers talked with students about things they do to keep healthy, such as eating right, getting enough rest, wearing seatbelts, and practicing pedestrian safety rules. He explained that people must have very good reasons for taking medications and are usually under doctor's care when using prescription drugs.

He brought a doll named Sue to

demonstrate what cigarette smoking does to human lungs. When Sue "smoked", her glass tube lungs became cloudy and yellow-stained.

At older grade levels, Mr. Meyers continued to emphasize the positive--practicing good health rules, exercising, eating nutritious foods--as well as going into greater detail about the health hazards of cigarette smoking, alcohol and drug abuse. Through the use of film strips directed to student maturity levels, he taught the benefits of healthy living.

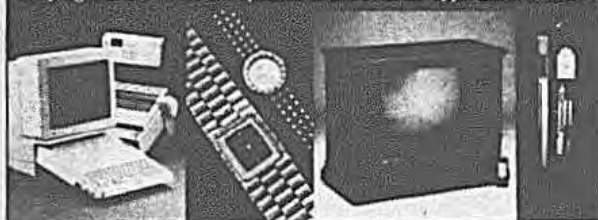
