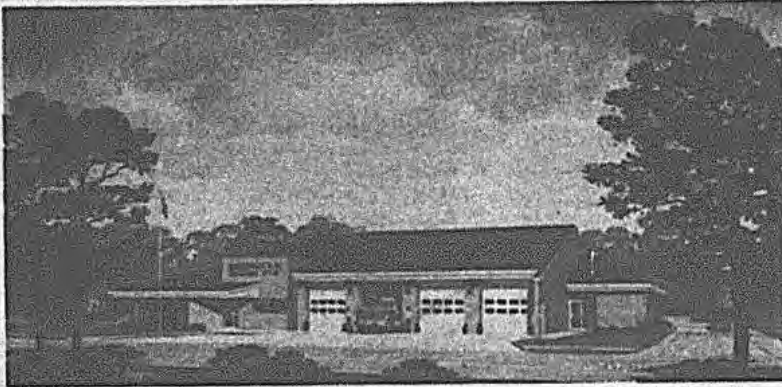

**Editor's Notebook**

The State Education commission has made a ruling which may be of monumental proportions to youngsters everywhere. It has ruled that a boy should be allowed to play on a girls team in school and vice versa. The ruling which was for a student in Harborfields High School in Suffolk County, could mean that schools will have to change their programs radically to deal with requests. The ruling overturned a previous ruling by the Public High School Athletic Association to bar a male player from an all girls field hockey team. The basis of the ruling was that no boys teams existed and therefore the student was being unnecessarily barred from participating in the sport. Although many people will think the ruling opens the way for girls to apply for football teams because schools do not provide for a girls team, it eliminates this possibility. It applies only to non-contact sports such as swimming, volleyball, golf or tennis.

The basic problem that many people fear is that boys would eventually dominate girls teams because they are bigger in size. Where size is a key it would mean that competitively girls would be serving a lot of time on the bench and this is just the opposite of what equal rights supporters want.

So while the ruling is consistent with women's rights, some people feel it may bring about a reversal of those rights by being too consistent.

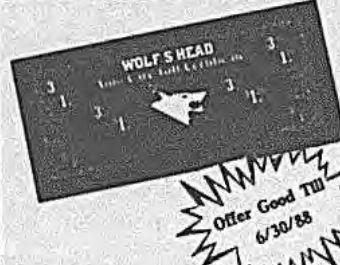



April 13 was the day Miss Saxon's second grade class at East Street School held their annual science fair.

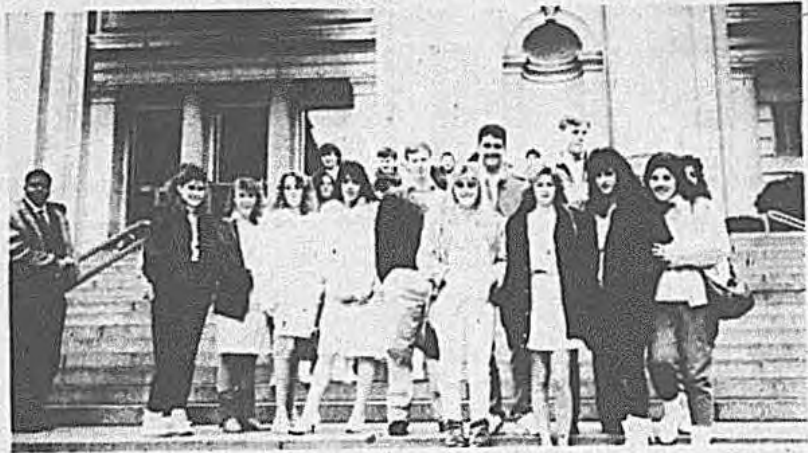
They showed the application of simple electrical battery circuits in a variety of imaginative and creative projects.

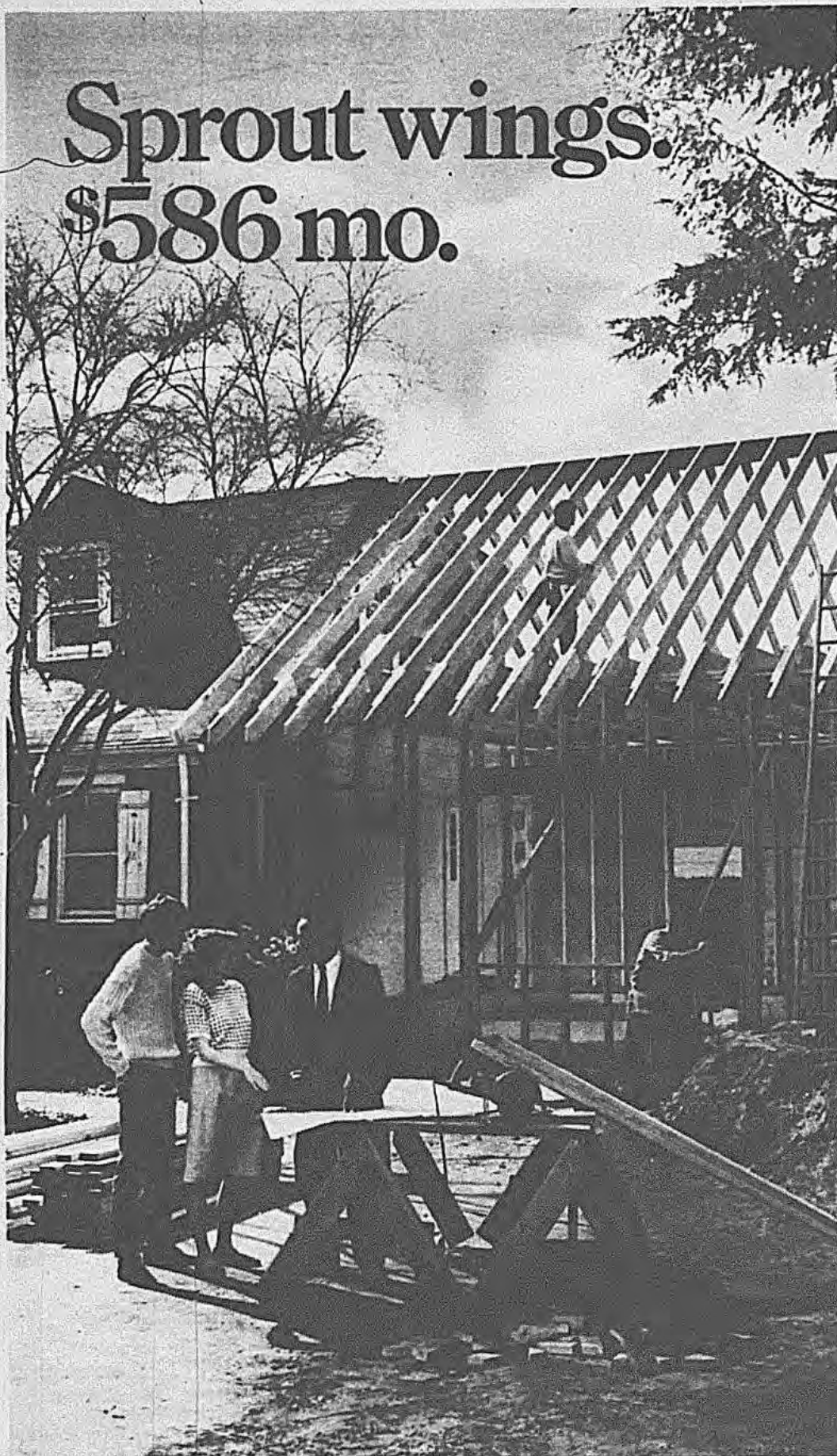

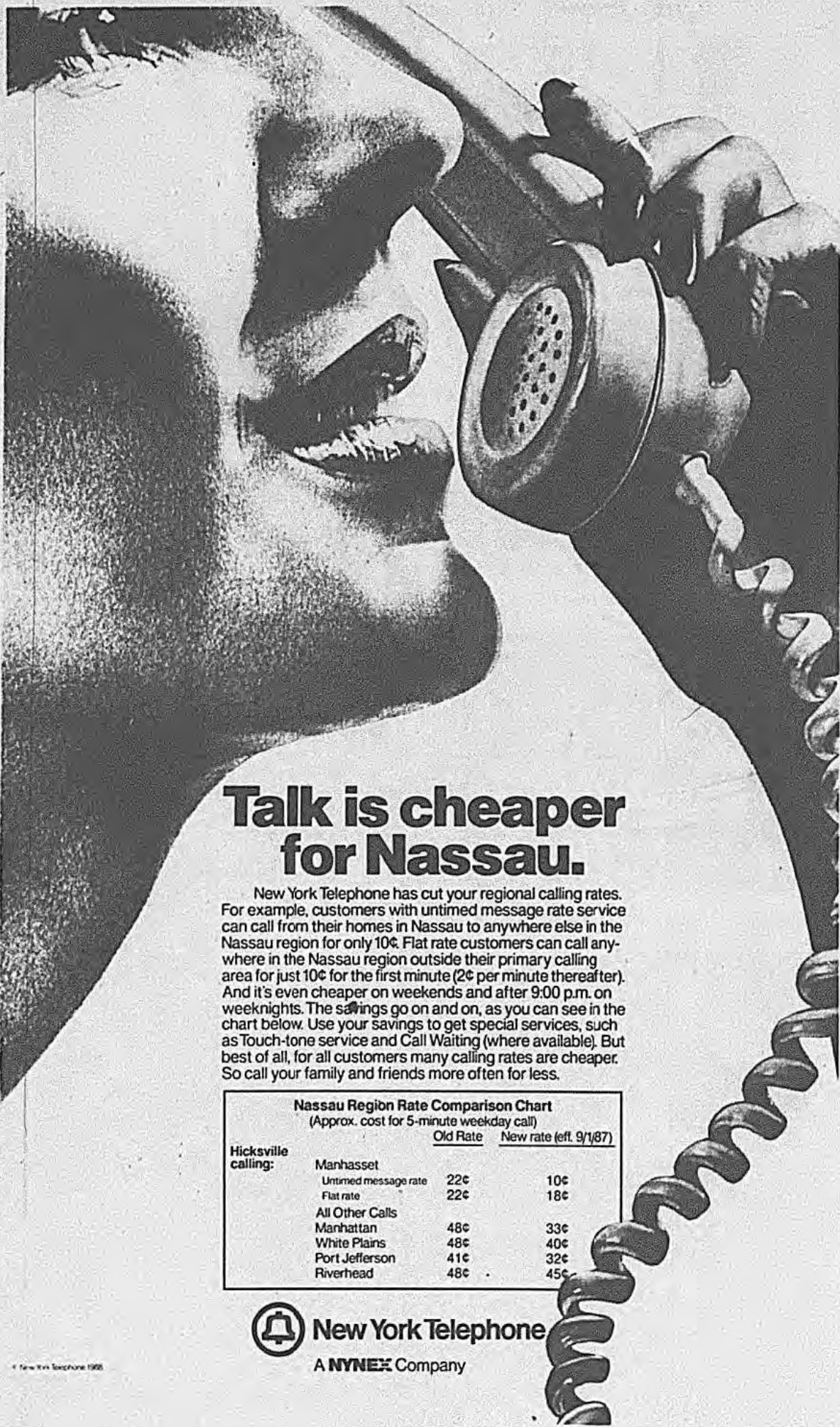
