Parents Sue School Dist. Over The Izzo Affair

Continuing to grapple with the aftershocks of former bus driver Robert Izzo's arrest and charges of alleged sexual abuse, the Hicksville School District was served on September 22, with a notice of intention to sue for negligence by the parents of nine youngsters.

The nine children, ages 5 and 6, were "repeatedly sexually abused" over a period of eight months, according to papers filed by attorney Charles Brennan, who is representing the parents. The nine boys and girls were all in the kindergarten last year and rode Izzo's bus to school, Brennan said in a Newsday article on September 23.

In a call from the Mid Island Times this week, Mr. Brennan, whose offices are in Rockville Centre, indicated through a spokesperson that he was "not interested in being interviewed at this time."

Dr. G. Robert Couillard, Assistant Superintendent of the Hicksville School District, confirmed that the district had been served with a notice of claim, the first step in starting a lawsuit against a public body. According to Dr. Couillard, he had no further information as to whether a suit will be forthcoming against any other persons or groups.

Dr. Couillard said that it is his understanding that the serving of notice is a legal process by which the parents seeking the suit keep their options open to sue in the future. He indicated that the intention did not contain monetary figures sought as damages.

The matter has been referred to the district's legal counsel, Gregory Guerico.

As part of the district's mobilization to further protect its students, it has required Harran Transportation, the district's prime carrier and former employer of Robert Izzo, to display prominently in each bus the name of the district, the route number and the phone number to call to register complaints or comments. The district also requires all drivers to wear identification badges.

The district has also approved the hiring of matrons to ride on the buses during the noon-hour runs when Kindergarteners are alone on the bus. The school board's policy committee has met to review new policy to be initiated in the district concerning child safety issues. The policies will be presented to the full board for consideration and review prior to a vote.

Robert Izzo was indicted on July 27, on 20 counts of sexual abuse involving assaults on a young boy outside the Hicksville district. The former Boy Scout Troop leader was also indicted on 15 additional charges of sexual abuse involving three young boys who accompanied him on overnight camping trips. A police investigation in the Hicksville area is on-going. Mr. Izzo was involved in many community activities, and drove buses at various schools, including Willet Avenue, Fork Lane, Holy Family and St. Ignatius. Group Home Plans To Open Soon On John St.

Central Nassau Guidance and Counseling Service is preparing to open its group home for mentally-handicapped adults at 302B John Street in the next few weeks. The site is the second for Central Nassau; a home at 499 Jerusalem Avenue was opened in May.

The 10-bed facility on Jerusalem Avenue has been filled. In order to protect the privacy of the clients, Ken Moskowitz of Central Nassau would only comment that the home contains male and female residents between the ages of 18 and 40. The residents take part in various activities during the week days, including job training school.

Mr. Moskowitz said that the homes will be under supervision 24 hours a day, seven days a week. The supervisor at the Jerusalem Avenue home has a Masters Degree, is a Certified Social Worker and has experience in the community residence field. The counselors are Bachelor Degree recipients and are currently going on to pursue their education. The homes will be supervised by two or three staff members in the evenings.

Central Nassau is in the process of interviewing prospective clients for its John Street home. They are also finalizing staffing.

Mr. Moskowitz said that as soon as the homes are officially opened, Central Nassau will seek to establish a citizens advisory board. He indicated that he has spoken to local community members near the Jerusalem Avenue site, but added, "we have not organized anything at this point."

Editor's Notebook

Perhaps the first lesson a school-bound youngster must learn is how to get there safely.

To assure that beginning students are provided with this vital information, the Automobile Club of New York has made available to parents, through local schools, a leaflet titled, "Best Route To School." A concise list of dos and don'ts, the leaflet is intended as an aid in teaching traffic safety rules to kindergarten, first and second graders.

Over 6,000 copies were distributed to Nassau County elementary schools for youngsters to carry home.

Most importantly, the leaflet urges parents to map the safest route to school for their child and go over it carefully with the youngster until it is learned.

The local AAA affiliate also stresses that children be instructed to obey police officers, school crossing guards and members of the School Safety Patrol stationed at intersections as well as paying heed to traffic signals.

In addition, parents are advised to train their youngsters to make a habit of the following safety rules:

- Cross only at corners.
- Look both ways before crossing.
- Watch for turning cars.
- Keep away from between parked cars.
- Play away from traffic.
- Be doubly alert on rainy days.

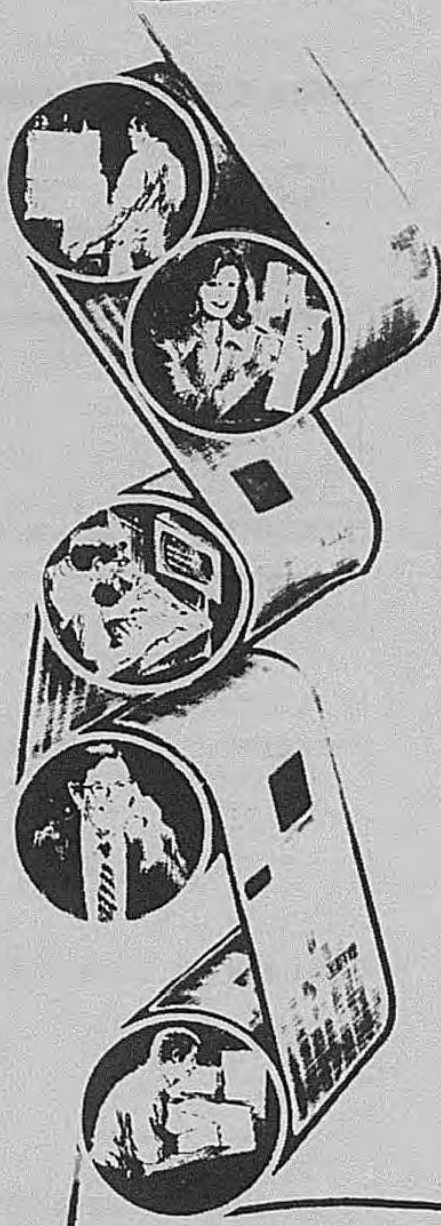

Local Golfer Wins Car

Ed Delaney of Hicksville won a \$12,000 automobile by aing the 167 yard fifth hole during the Cherry Valley Club Member-Guest Tournament at the Cherry Valley Club in New York. For his hole-in-one, Delaney won a 1989 Pontiac Sunbird valued at \$12,000 courtesy of tournament organizers. By winning the Hole-In-One prize, Delaney qualifies to play in the National Hole-In-One Association's annual Tournament of Aces Invitational to be held in March. A hole-in-one at the Tournament of Aces earns the lucky golfer \$100,000.

"We started the Tournament of Aces Invitational six years ago," says Mancil Davis, the Association's Executive Director and holder of the world professional record for aces at 49. "We wanted to reward the golfer who makes an ace, and to create some recognition for the ace-maker."

"We thought it would be a fun tournament to bring together those golfers who have made an ace at events where the National Hole-In-One Association has provided the insurance. And if a golfer duplicates his ace at our tournament, he or she will win \$100,000 in cash. Our next Tournament of Aces will be at the Woodlands Country Club, outside of Houston, Texas, next March."

The National Hole-In-One Association, a Dallas-based company, is the largest insurance carrier for tournament sponsors wishing to insure hole-in-one prizes at their tournaments.

In addition to providing insurance, the Association also collects historical and statistical data on aces in general, runs an Ace-maker Club open to anyone who has ever recorded a verified hole-in-one, and operates several golf outings for members each year.

Delaney, 47, is a police investigator and lives in Hicksville. He used a Ping Eye II 4-iron for the shot, which hit the green four feet in front of the pin and rolled straight in. Delaney has now recorded golf's "perfect shot" for the first time in his 7 years of golfing - he hopes his second will come next March when he shoots for \$100,000 at the Tournament of Aces Invitational.

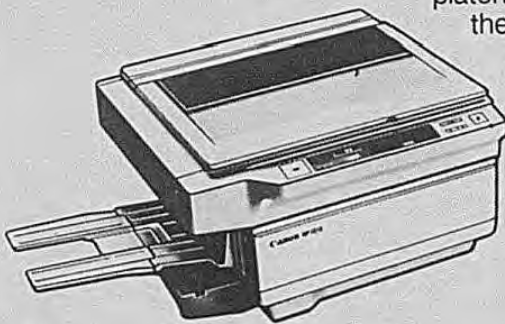
