Council Hears Update On Vietnam Vets Drive

Nation, county, town and neighborhood were all in focus at the opening meeting of the Hicksville Community Council's 1989-90 year. At the November 2 meeting, Conrad Steers of the Vietnam Veterans of Nassau County brought residents up to date on Project CATCH (Caring About The Children's Hopes); the Council was host to an array of candidates seeking political office; and Councilman Tom Clark conducted the Council's Town Forum, discussing changes on Duffy Avenue.

Declaring, "It is right that one of the richest counties in the United States should help one of, if not the, poorest in the United States," Connie Steers both thanked residents who have been so generous and urged residents to take those extra moments to gather items for veterans, their families and their community in the economically deprayed Logan County, Appalachia, West Virginia.

Mr. Steers said that the delivery date in Logan County, originally set for Veterans Day, November 11, has been pushed back to Thanksgiving. He expects volunteers to bring three full trailer trucks to the men, women and children in the former coal-mining area.

the men, women and children in the former coal-mining area.

Long Island veterans, along with veterans in four states, have taken on the task of aiding their less fortunate comrades, and their project has touched the heart of the fitchsvine community.

The Hicksville volunteers are collecting clothing, kitchen utensils, tools, books, monetary donations and the like. Mr. Steers assures residents that all offerings will reach their destination.

The veterans have secured the use of a warehouse facility at 168 Engineers Drive, off South Oyster Bay Road, and volunteers will be on hand to accept donations this weekend.

Councilman Tom Clark zeroed in on various aspects of properties on

Councilman Tom Clark zeroed in on various aspects of properties on Duffy Avenue of concern to local residents. He displayed preliminary plans for an elevated three-story office building proposed on the site formerly occupied by Meenan Oil. The builder is proposing a 40' building on stilts with ground-floor parking underneath. Mr. Clark said that a traffic control study is in the works and that it would be unlikely that the plan would come back before the town board for some six to eight months.

Mr. Clark outlined a desire by BJ's wholesale food to purchase or lease the American Waste Management facility, Duffy Avenue and Charlotte Drive, although he cited some logistics problems due to the downward pitch of the entranceway ramp. He also noted that Oyster Bay Sand and Gravel has been trying to legalize its operation, which has been converted from a storage warehouse to an office building for

Mr. Clark said that the town is working toward a change of zone for Duffy Avenue and the formulation of a "master plan." He also acknowledged that operations there were "not environmentally perfect" and that the DEC (State Department of Environmental Control) checked into the situation. In order to affect a zone change, the town must first go to the county and hold public hearings, he added, "The town is seeking an aestetic look and would like to see site plan review on all applications."

Town, State Agree On Landfill

At the Town Board meeting of October 31, Oyster Bay Town Supervisor Angelo A. Delligatti and the members of the Town Board passed a resolution executing a ten year agreement with the New York State Office of Parks, Recreation and Historic Preservation that will permit the installation of wells on Bethpage State Park property. The wells and related piping are crucial to the Town's approved remediation plan for the Old Bethpage landfill and its surroundings.

Delligatti stated that the agreement was the latest step in a process that began in 1984. "At that time, the Town of Oyster Bay entered into an agreement with the New York State Attorney General's Office and the Department of Environmental Conservation to undertake an exhaustive study of the 37 year-old landfill through implementation of test wells and analysis of test material.

"The results of that all-inclusive research led to a program for the pumping and treating of the groundwater directly below the landfill and within the perimeter of the surrounding study area," said Delligatti. "Bethpage State Park property falls within the area reviewed."

Under the agreement, which

Under the agreement, which covers the period beginning on October 1, and terminating on September 30, 1999, the Town of Oyster Bay will install and monitor water collection/extraction wells and related piping, electric and telemetry lines. As described in the remediation plan, this specialized equipment will assist in the process of removing contaminants from the non-potable groundwater so that the cleansed water can be returned to the aquifer at a level of purity that exceeds State Drinking water standards.

Delligatti noted that a large portion of the cost of remediation is being paid for by those individuals and corporations who, during the years the landfill was operational, used it for the disposal of their products and by-products. In June 1988 the Town received \$4,500,000 through legal action against those narties.

"The ten year period agreed to by the State is the time frame we feel is necessary to complete this very complicated environmental process. We are now at a point where we can see light at the end of the tunnel," said Delligatti. "I would like to thank those in the New York State Office of Parks, Recreation and Historic Preservation for sharing our environmental concern by facilitating this agreement."






