Hicksville Honored For Latin Studies

The Classical Association of the Empire State bestowed this year's George Constantou Award to Dr. G. Robert Couillard, Assistant Superintendent for Educational Services, and Donato Guadagnoli, Supervisor of Foreign Languages, for "their successful implementation and administration of the teaching of Latin in the eight elementary schools of the Hicksville School System." Dr. Couillard and Mr. Guadagnoli received this award at the Association's annual meeting in Saratoga Springs, New York, on November 3, 1989.

The Constantou Award is given to individuals who have promoted

Latin studies in the state of New York. Hicksville was nominated after a visit by Richard Gascoyne of the Foreign Language Bureau of the State Education Department, who singled out Hicksville's Latin program in the elementary schools as "outstanding."

Details of the elementary Latin program, called the Language Transfer Program, were given by Mr. Guadagnoli at a workshop during the Association's annual meeting. The program is a Latin based language arts skills builder which enriches students' knowledge of English vocabulary and syntax and is taught in the fourth, fifth and sixth grades.

H.H.S. Orchestra To Perform In Albany

The Hicksville High School Orchestra has been selected to perform at the Governor Nelson Rockefeller Empire State Plaza in Albany on March 20, as part of the observance of Music in Our Schools Month. The 70-member student orchestra, under the direction of Mr. Robert West, will perform on the South Plaza at 12:30 p.m.

Each year the New York State School Music Association sponsors school musical organizations to perform on the Plaza during two weeks in March in observance of the nationally observed Music in Our Schools Month. This is the first time a Hicksville School group will appear. The concerts are well attended by those who work at or frequent the Plaza. State officials as well as locally elected officials are also invited by NYSSMA to attend.

Woman Killed In Shooting

Shortly before 11:30 a.m., November 19, a shooting occurred at 366 Old Country Road, Hicksville, The Wascamat Professional Wash Center.

There were three females and two males in the Laundromat when a third male entered, who was an acquaintance of one of the females. A verbal altercation ensued between the two and the male left.

He returned shortly with a weapon and fired multiple shots at the victim, Maria Julemice, 33, of 203 Urban Ave., Westbury. She was shot in the head and was pronounced dead at the scene. A second female was shot in her left shoulder and she is in satisfactory condition in the Nassau County Medical Center, East Meadow. Her name has not been properly verified at present and it will be revealed later.

The suspect, known to police as Alphonse Jean Pierre, 49, fled the scene in a red Nissan, Reg. NAW 197 NY, heading westbound on Old Country Rd.

Town Bd. Takes Action On Several Varied Items

Several actions were taken by the Board of the Town of Oyster Bay during the November 14 meeting. They included:

- Approving a plan to improve the facilities of the Plainview Water District. The project, which may not exceed \$5 million, will include the construction of air stripping towers at two plants, the reconstruction of pumping units and other improvements to insure an uninterrupted water supply to residents.

- Granting a special use permit to the Exxon Company located at Massapequa-Glen Cove Road and Bethpage Turnpike in Bethpage to operate a 24 hour gas station and convenience store. In addition, a change in zoning from a "neighborhood business" to a "general business" was also granted. Twenty eight voluntary covenants and restrictions were imposed in order to insure the orderly development of the premises. They included a provision of a full service island between 8 a.m. and 6:30 p.m., and prohibiting the sale of alcoholic beverages.

- Changing traffic control provisions from reading "Mid Island Plaza" to the "Broadway Mall." These restrictions prohibit vehicles from parking where "no parking" signs are posted; state that drivers must come to a complete stop where stop signs are posted; and the designation of "one way" signs.

- Accepting the donation of a newly installed guard rail on the south side of West Barclay Street made by the Hicksville Board of Fire Commissioners.

- Accepting the waiver of sidewalks request by Rolling Hills Associates Incorporated of Woodbury, and to substitute instead, Belgium block curbs instead of concrete curbs. This was made possible because the Division of Highways has recently established a procedure whereby developers requesting such a waiver, contribute a fee equal to the fair cost of building a sidewalk. The petitioners will be billed \$132,778.56. The money will be deposited into the Highway Division Miscellaneous Revenue Account.

- Authorizing the establishment of an additional handicapped parking space in Municipal Parking Field H-2 located on West Barclay Street and Newbridge Road in Hicksville.

- The acceptance of three final site plans necessary to validate special use permits granted previously. The first was from Scappy Auto Body Associates, Inc. and Jerry Spiegel, to operate an automotive body repair shop on Duffy Avenue near Charlotte Street in Hicksville. The approved site plan depicted the size and location of lighting and signage. The special use permit was granted in April.

- The second site plan which was approved was presented by the Sun Refining and Marketing Company and depicted the dimensions of the proposed building, location and size of signs and lights, etc. The special use permit was granted in April in order to allow the petitioners to operate a retail food mart in conjunction with an existing gasoline station on West Nicholas Street and Newbridge Road in Hicksville.

- The third accepted site plan was submitted for the Woodbury Country Club depicting the type and size of fencing, gazebo, dumpsters and the location of paved areas, etc. The special use permit granted in May, allowed the petitioners to operate a country club.

- The acceptance of a preliminary site plan submitted by the Woodbury Jewish Center for the construction of a temporary house of worship and a religious school on the east side of Southwoods Road, near Syosset-Woodbury Road in Woodbury.

Editor's Notebook

Now is the time to consider those last minute end-of-the-year tax options. Not only can they help you reduce any potential tax liability, but also make it easier to file your 1989 return. Here are some basic reminders from Robert Kobel, Public Affairs Officer for the Internal Revenue Service in Long Island:

• **An increase in the standard deduction to \$3,100 for single taxpayers, \$5,200 for married couples filing jointly and \$4,550 for heads of household may make it unnecessary to itemize deductions.**

• **Medical expenses** are deductible only to the extent they exceed 7.5 percent of adjusted gross income (AGI).

• **Miscellaneous expenses** such as union dues, subscriptions to professional journals and tax preparation fees must exceed 2 percent of AGI before they can be deducted. Therefore, the decision is whether or not to bunch deductions in a given year.

• **Based on year ending vs. year ahead income projections,** it could make tax sense to postpone or accelerate receipt of certain income such as company bonuses, rental payments or capital gains.

• **Consider either paying consumer debt by January 1 or making additional discretionary purchases.** Deductibility for 1989 is limited to 20 percent on interest paid on credit cards, revolving charges, car and student loans and other non-mortgage debt. Next year only 10 percent of consumer interest payments is deductible.

• **Don't overlook maximizing retirement plan opportunities.** This could mean contributing the maximum \$7,627 in a company 401(k) plan, or establishing a Keogh retirement plan for the self-employed or those with self-employment income. Contributions to a Keogh plan can be \$30,000 or 20 percent of self-employment income, whichever is less. Keep in mind that while a Keogh plan can be funded for 1989 through the April 16, 1990, filing deadline, the plan must be established by year end.

• **Although elimination of the Medicare surcharge** eased the estimated tax situation for many elderly Americans, it is still a good idea to project 1989 taxes to ensure having at least 90 percent of this year's tax obligation paid in, or 100 percent of last year's. To avoid penalties, you may need to increase withholding or estimated payments.

• **Finally, it's never too early** to make sure all the necessary records and corroborative information for completion of an accurate and thorough tax return are on hand or being collected.

Varied Programs Offered At Museum

For Kindergarten - Grade 2
Introduction to the museums collections, and the ways of science while exploring one or two of the following:

- Rocks and minerals
- Butterflies (with a slide presentation)
- Fossils and dinosaurs
- Volcanoes (a slide presentation)

For Grades 3 - 12

Rocks: They are not just objects but stories waiting to be told about the environments where they formed, what they are, and why we find them in the places that we do. Also learn about some of their surprising uses.
Minerals: Discover what these chemicals from the earth, sea, and sky are. Find out why they have such beautiful shapes and colors and why they are so useful.
Exploring minerals: A hands-on approach to mineral identification

using properties such as shape, color, streak, hardness, density and conductivity. Each class will take home its own identified mineral collection. \$6 class fee.
Weathering, erosion, and soils: Learn why rocks do not last forever, the ways that they break down and are moved, and the importance of the rock layer between the living and non-living worlds. Weather and other conditions permitting, an outside walking tour may be included.
Water and the water cycle: Find out if we have enough water and where it comes from. Also we will explore the problems faced in conserving and protecting our water supply. The class will build and experiment with its model aquifer. \$6 class fee.

Long Island Studies

Using artifacts, maps, and slides, historian Richard Evers explores the culture and history of

Long Island's original inhabitants and the people who displaced them.

Programs for Grades 4 - 8 are:
The Algonkian Indian Culture
Long Island history.

For Grades 2 - 8

Bus Tour of Hicksville: (each bus can accommodate two class groups) Introduce your students to their community's points of cultural, economic, historical and political importance.

Also for Grades 3 - 12

Fossils: The remains of past life in the rocks help define ancient ecosystems, and unravel the history of life. See how animal forms are linked to their habitats and ways of life. Learn some of the reasons why there are more extinct species than living ones.
Fossil hunt: Using proper techniques the class will uncover and identify a set of fossils, and interpret the environments in

which they lived, died, and were preserved. The class will keep the fossil set. \$6 class fee.

Dinosaurs and their relatives: This presentation traces the development of dinosaurs, shows how and where they lived, discusses theories about why they disappeared, and shows their relation to living animals.

Slide Presentations

For Grades 3 - 12

Volcanoes: An introduction to the different types of volcanoes, why they form, and to their spectacular but deadly eruptions. Learn how they benefit and destroy the works of man and nature.

Long Island Geology: The geologic history of Long Island is explained by showing local landforms and familiar sites, and the geologic processes responsible for their formation.

Metamorphosis: Explore the life cycles of butterflies, and gain fascinating insights into the world of these beautiful insects.

For Grades 5 - 12

Crystals and Crystal Growing: Uncover the secrets of crystals, find out why every mineral is unique in shape, and grow spectacular crystal clusters in this hands-on workshop. \$6 class fee.

Why the earth moves: This look into plate tectonics will help the student to understand why earthquakes occur, how mountains form and some surprising results of all this moving and shaking.

Scavenger hunt: Explore the museum and its collections while you match wits with the curator. The hunt is designed to make students think about the basics of geology while having fun.

Other Museum Programs

Early Childhood Workshops
Preschool - Grade 2

Designed to stimulate interest and create positive science attitudes in the very young, these programs are planned and conducted by a naturalist specializing in this age group. These hands-on workshops with crafts projects to take home, will explore the worlds of birds, plants, forest and beach ecology, insects, and animal encounters. Scheduled tours of no more than 50 students may be arranged for our normal weekday operating hours - 9:30 to 4:30, Tuesday through Friday. Scout groups should reserve for after school or weekends - Saturday and Sunday, 1 to 5 p.m.

Reservations should be made at least one month in advance. Please call the museum at 822-7505. A few openings are still available for last minute scheduling.

Payment is required at the time of the tour (unless other arrangements are made in advance). The cost per student is \$2.50. There is no charge for Hicksville students, public school or private. Some programs, as noted, also require a class fee to cover the cost of materials for special projects or collections that go back to the school.

Supervision by one adult (teacher or chaperone) for every ten children is required; there is no charge for them. Any adults in excess of the number required will be charged the \$2.50 fee. Groups which by their nature require more supervision or help will not be assessed these extra fees if the museum is notified in advance.

The gift shop, often the last stop of the tour, emphasizes books and objects from our natural world.

The museum, located at Heitz Place in Hicksville, was originated by Gardiner Gregory to supplement the science curriculum in the local schools and still reflects the interests and purpose of its founder. Since moving in 1973 into the old Heitz Place Courthouse and jail, Long Island's finest mineral collection has steadily grown, and become an outstanding resource center serving school groups of all ages, as well as the casual visitor. The butterfly and shell collections form a link between the world around us and the past life of our fossils. And by providing glimpses, in photographs and artifacts, into the lives of previous generations of Long Islanders, the museum maintains the integrity of its historical home.

28 Restrictions On Exxon Store

Twenty-eight restrictive covenants were placed on the approval of a request for a change of zone and special use permit to operate a gas station and convenience store in Bethpage, according to Oyster Bay Town Councilman John Venditto.

"The applicant, Exxon Company USA, was seeking a change of zone from 'F' business to 'G' general business and a special use permit to allow the operation of a self-servicing gasoline station and a convenience store on property located on the northwest corner of Hempstead Turnpike and Route 107 in Bethpage," Venditto stated. "Pursuant to a public hearing held on July 12, 1988, the Town Board approved the request subject to twenty-eight restrictive covenants."

The Town Board covenanted that the change of zone and special use permit are granted, but do not apply to the northerly portion of the lot, which must be kept clean and landscaped until such time as it may be developed under "F" business zone. The filling station and convenience store may both operate on a 24-hour schedule, with the filling station to provide a full-service island between the hours of 8 a.m. and 6:30 p.m. All convenience store products must be pre-packaged, and there will be no food preparation except for brewed products such as coffee and tea. The Board also further stipulated that no alcoholic beverages be sold and that no vending machines, pinball or any types of games of amusement be allowed on the premises.

With regard to maintenance of the property, the Board covenanted that the area be policed at all times to present an overall clean and neat appearance. No outdoor storage of materials is permitted, and all garbage and

rubbish must be kept in closed containers. No overnight storage of trucks is allowed. Landscaping, including evergreen pines, must be installed and maintained. Two curbs cuts must be made on Hicksville Road with proper signs to prevent left turns at the southerly exit.

The Board limited the size of the proposed canopy to no larger than 48 feet by 104 feet with a height not to exceed 17 feet. There will be no external lighting on the facade of the canopy, and all lighting must be directed downward. Any other exterior lights on the property must be positioned so as not to interfere with traffic or spill over onto adjacent properties. All signs must conform with local ordinances, and the one price/identification sign shall not exceed 32 square feet on the face area not 7 feet in height.

Other covenants imposed by the Town Board include no charge for the use of air hoses and no bell hoses. Any exterior audio communication system must be maintained and monitored so as to be inaudible at any point greater than 25 feet from the location of the system.

Venditto noted that no building certificate or certificate of occupancy will be issued until a site plan has been submitted to, and approved by, the Town Board. The plan must be to scale and show the height and dimensions of the proposed building, the dimensions and color of the proposed canopy, the location and size of all signs and light poles, the size and type of fencing and dumpsters, the size, type and location of all landscaping, underground monitoring devices and tanks, the location of pump islands and parking areas, all access and egress and any other details deemed pertinent by the Department of Planning and Development.

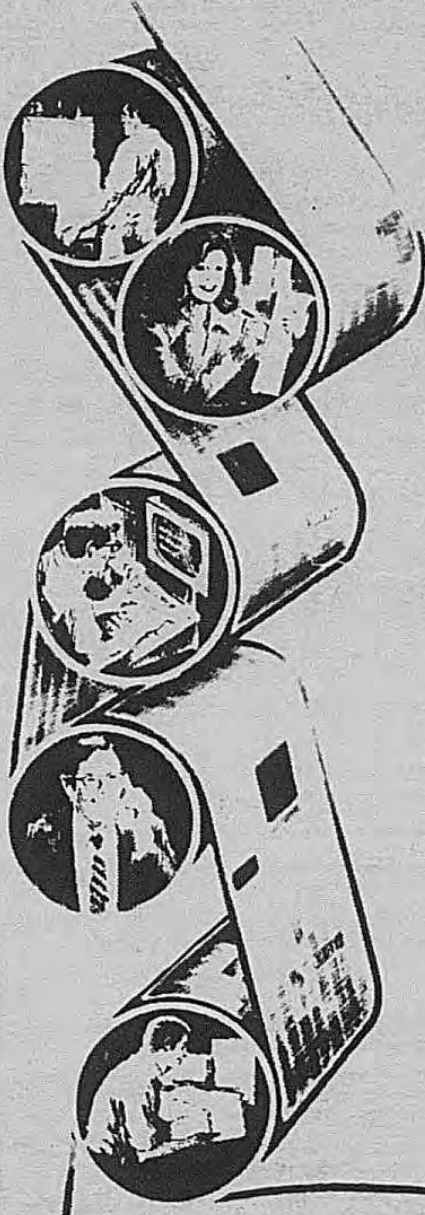

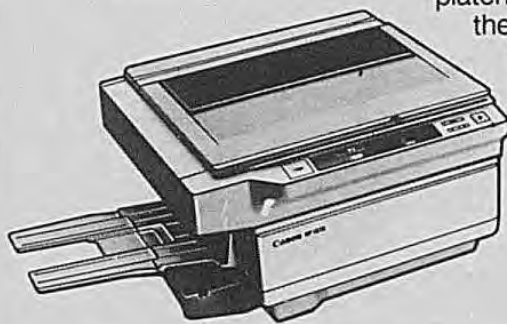

Minutemen Clinch First Place
