Art Is Ageless Exhibit Proves

Shimmering Seascapes, misty mornings, and memories of times long past highlighted an art exhibit this week at Central Island Nursing Home in Plainview, featuring the work of several of the residents.

The framed paintings, which were first shown at a preview for friends and families, were quickly purchased at \$25 each, with the proceeds going to the nursing home Residents' Council. Much of the work reflected a primitive innocence, that belied the age of the painters, some of whom are in their nineties. What was most impressive was the artistic quality of the finished watercolors, pencil sketches, and acrylics.

"This is work nobody knew these folks could produce. The residents themselves are excited about it," said recreation aide Toni Emanueto. Perhaps the residents were surprised, but not Ms. Emanueto, who holds a Masters of Arts in Liberal Studies and is a trained recreation leader, who previously worked at Maryhaven in Port Jefferson. It was her idea to offer painting lessons to the residents, who have clearly benefitted from the instruction. Following the success of this week's exhibit, Ms. Emanueto is continuing her one-on-one painting lessons, in preparation for a second exhibit in the spring.

In her spare time, Ms. Emanueto, who lives in Old Bethpage, secures garage sales for all types and sizes of frames, and welcomes donations of frames from Central Island staff members also residents' families.

"Art is a non-threatening approach," says Ms. Emanueto. "I think it helps these people rediscover something in themselves. When you allow that to break open, you reach back to the child within you. It's a form of freedom."

Bethpage Board Covers Personnel Matters

In personnel actions, the Board accepted the resignation of Senior School Physician Dr. Phillip Whitelaw and appointed Dr. Salvatore Corso as Senior School Physician. Christopher Blades was appointed to the position of part-time Stock Assistant, and Ellen Tjimos was appointed as part-time Teacher Aide, Computer. In addition, the hours of part-time Computer Teacher Aides Lois Nosowitz, Mary Pagano and Heidi Sanchez were increased to 19 hours a week each. The hours of part-time Special Kindergarten Teacher Aide Lorraine Passaro were increased to 17½ hours per week.

The Board approved a Special Education tuition contract and also awarded bids for physical education supplies. The Board also approved the publication of a Notice of Bid.

Assistant Supt. George Mann, along with Dr. Regina Cohn, Dr. Paul Cooper, Mr. Bruce Jaeger and Dr. Antoinette MacLeod, presented the Comprehensive Assessment Report. This report indicates how Bethpage students performed on various standardized tests.

Mr. Nydick made the following announcements:

- The Bethpage football team won the Long Island Championship and the Rutgers Cup. Mr. Nydick and the Board extended congratulations to the team.
- The Junior Varsity Cheerleaders took first place in Nassau County, and the Varsity Cheerleaders took second place.
- Charles Campagne student Brian Hourigan won first place in Nassau County in the Martin Luther King essay contest.
- Students at JFK participated in "Taproot," an inter-generational writing program connected with SUNY Stony Brook.
- Mr. Nydick noted that the school winter concert dates are indicated on the school calendar. However, due to illness, the Winter Concert at the JFK Middle School has been postponed until January 10 and 11, 1994.
- The Compact for Learning plan has been sent to the State Education Department for approval.
- The new computers will be delivered on December 15, 1993, and the program will begin after the holidays.
- In response to a question asked at the last meeting, Mr. Nydick indicated that High School students can get additional time on computers if they wish. There is a computer club, as well as a computer class with flexible hours.
- Regarding a substitute for the Special Kindergarten teacher aide, Mr. Nydick stated that if the aide is out for several days, a substitute will be provided starting on the third day of absence.
- Regarding the ninth-grade C-track students who were placed in

It was really festive occasion, highlighted by a ¼ mile "fun run" for youngsters 12 and under that preceded the 5K, visita from Santa Claus, Donald Duck, Bugs Bunny, Melody Mouse, and lots of costumed runners and walkers in the throng.

Jottings From Yesteryear

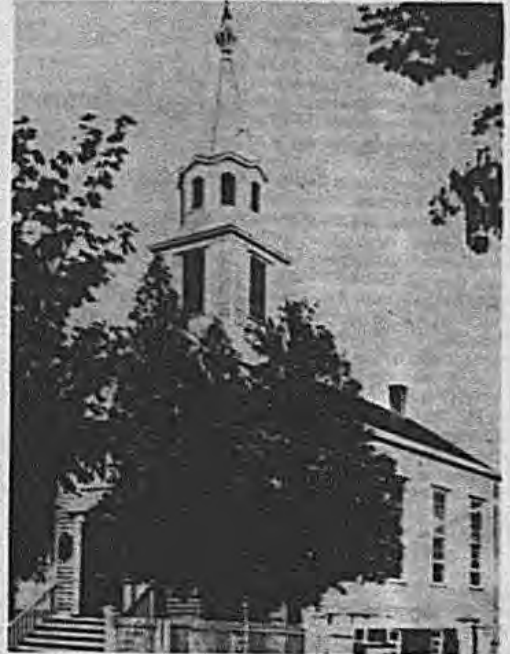

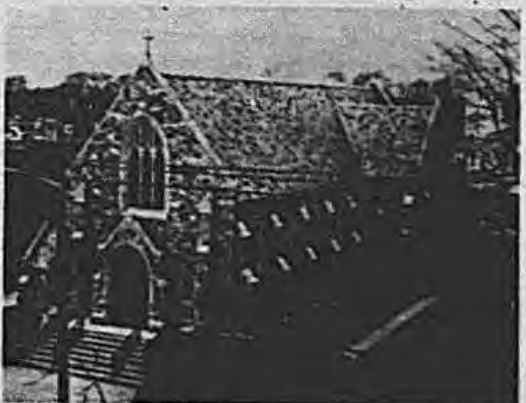

the B track. Mr. Nydick provided information on their progress, and noted that six of the nine parents of the students have been contacted and are pleased with the situation. There is a marked improvement in attitude and self-esteem in these students.

The Board then responded to questions.

There were questions regarding the substitute for the Special Ed. teacher aide. Parents felt there should be a substitute from the first day of absence, not the third. Mr. Nydick indicated that many other districts follow the same procedure, and that the classroom teacher felt that this would work.

Several parents asked if more SAT preparation could be done. Mr. Albano noted that the District offers a preparation program, and that various attempts to encourage more students to take the course have not been successful. Mr. Albano stated that the District is always looking for ways to improve test scores.

Mrs. Rewkowaki informed the Board that she had seen people roller skating and playing hockey on the tennis courts. Mr. Schaub stated that, now that the season is over, the courts would be kept locked, and that the custodial staff would watch the courts until security comes on at 6 p.m.

Mrs. Jerson asked if teachers are required to reschedule extra help sessions if they are canceled because of faculty meetings, etc. This will be looked into.

Mrs. Nosowitz reminded the Board that last season, there was a problem with people on the school track during track meets. The Board will try to have a solution to this situation before the season begins.

A representative from PAL asked the Board if basketball time for children could be scheduled earlier and more frequently. Mr. Nydick will meet with them and go over the scheduling.

Mrs. Rewkowaki asked about having an ambulance or cellular phone available at sporting events in case of emergency. The Board is looking into several options, such as using the security radios, etc. The Fire Department cannot always guarantee that an ambulance will be available.

Mrs. Harrison asked whether 11th grade students can still choose to take Earth Science, now that it will be offered in the 9th grade. These students can still choose to take Earth Science, but whether there will be a separate 11th-grade class would depend upon how many students wish to take the course, as well as scheduling concerns.

Mrs. Hurley, Mrs. Omage and several other parents were concerned that students are not permitted to take tests home after they have been corrected. They feel students could benefit from studying from tests. The Board is looking into this area, and did note that students do have access to the tests, but are not currently permitted to take them home except as indicated in the policy.

The next monthly Board meeting will be held at 8 p.m. on January 25 at Charles Campagne School.
